Three vying for one road commission seat, many millage proposals on primary ballot

In less than three weeks, voters across the state will be paring down the candidate field in the August 3 primary election.

In Alcona County there is one contested race and multiple requests for millages and millage renewals.

The contested race is that of a seat on the Alcona County Road Commission. Incumbent Richard A. Karsen and challengers Theodore R. Somers and Mike Gloré are all running on the Republican ticket for one seat. No Democrats are running.

Two county proposals are on the ballot - neither are new. The first proposal is an

ambulance millage renewal of 1 mill for four years (2010-2013) to provide funding to operate and maintain the ambulance service. If approved by voters it is estimated that \$776,051 will be raised in the first year.

The second proposal is a renewal of the Alcona County Commission on Aging millage of .375 mill for five years (2011-2015). If approved, the millage will provide funding to operate, maintain and expand programs and services and maintain Alcona senior centers - raising an estimated \$291,000 in the first year.

Five Alcona County Commissioners are running unopposed in this election. William R. Thompson (District 2 - City of Harrisville, Harrisville Township and Haynes Township), Kathleen E. Vichunas (District 1 - Alcona Township and Caledonia Township) and Carolyn Brummund (District 3 - Greenbush Township and Mikado Township) are running on the Republican ticket. Kevin Boyat Sr. (District 5 - Curtis Township, Millen Township and Mitchell Township) and Shelia R. Phillips (District 4 - Gustin Township and Hawes Township) are running on the Democratic ticket.

Alcona Township is asking for a renewal of two millages: A road millage - 1 mill for two years (2010-2011) for road maintenance and improvements with an estimated \$122,085 in the first

year if approved and a fire millage - 1 mill for one year (2011) for fire protection, raising an estimated \$122,085 in the first year if approved.

Caledonia Township is asking for a road millage renewal of 1 mill for six years (2010-2015) to construct and maintain roads. If approved an estimated \$120,498 will be raised in the first year.

Curtis Township is asking for a road millage increase of 2 mills for four years (2010-2013) for road improvements and construction. If approved an estimated \$115,138 will be raised in the first year.

Greenbush Township is asking for a fire department millage renewal of .5 mill for four years (2010-2013) for fire protection, operation and repairs of equipment and buildings. If approved \$49,705 will be raised in the first year.

A road improvement millage renewal is also on the ballot. The township is requesting .75 mill for four years (2010-2013) for road improvements and construction. If approved an estimated \$74,558.86 will be raised in the first year.

A member of the Greenbush Township Board is also on the ballot - Tracie Betty is running on the Republican ticket for the position of treasurer. She was appointed as treasurer over a year ago when then elected treasurer Tami Neimann did not take her position on the board. Betty was appointed by the board. If she is elected to the position, her term will end on November 20, 2012.

Gustin Township is asking for a road millage renewal of 2 mills for five years (2011-2015) for road construction and maintenance. If approved

Accused serial arsonist arraigned in three counties

An alleged serial arsonist has been brought back to northern Michigan to face charges in three counties where he is accused of setting fires that destroyed two homes and an automobile.

Clarence Howard Scott, 34, a prisoner in the West Virginia Department of Corrections system has been arraigned in Alcona, Alpena and Iosco counties on three felony counts and one misdemeanor count brought by respective prosecutors Thomas J. Weichel, Edward Black and Gary Rapp.

Scott has been charged with arson of a dwelling in Alcona County where he allegedly set fire to the home of friends where he was staying in Lincoln on November 8, 2009. The home was completely destroyed.

In Alpena County, Scott is charged with arson of an oc-

cupied dwelling and home invasion, first degree for allegedly breaking into a home located north of Hubbard Lake and setting fire to the residence while it was occupied on May 17, 2009.

Scott is also charged with

a misdemeanor count of setting fire to a vehicle parked outside a bar in Oscoda on October 22, 2009.

Scott's detainment and subsequent arrest was a cooperative effort by local law enforcement officials and

prosecutors. The investigations were conducted by Detective Sgt. Steve Harshberger and trooper Stuart Sharp of the Michigan State Police, Detective

Three vehicle crash kills downstate man

A downstate man died in three vehicle accident in Mikado Township last week.

The Alcona County Sheriff's Department responded to the accident at 3:30 p.m. on Stout Road, just south of F-30 on July 7. According to a report from the sheriff's department, the accident occurred when two northbound motorcycles driven by Donald Vicary, 47, and Gisele Wesson, 52, both of Redford Township, collided into one another. The colli-

sion forced Vicary's motorcycle into the southbound lane and into the path of an SUV. Wesson's motorcycle continued down the road until it crashed into a residential roadside decoration.

Vicary was transported to Tawas St. Joseph Hospital where he died from injuries sustained in the crash. Wesson and her passenger, Christine Charboneau of Wixom, Mich. were also transported to Tawas St. Joseph Hospital with non life-threatening injuries.

The driver of the SUV, Slavica Dimitrijevic, 57, of Lenox, Mich. and her two passengers, Anita and Goran Josfoska of Massadonia, were uninjured.

Alcohol does not appear to be a factor with any drivers involved. The accident remains under investigation by the Alcona County Sheriff's Department with assistance from the Alpena County Sheriff's Department. Alcona EMS was assisted by first responders from Mikado and Curtis townships.

The problem for the folks is that they are earning a living from deer hunting and anything that is going to interfere with that is not going to work, or be accepted.

The DNRE has a job to do, to wit; managing the resource, in this case, deer, for the good of the state and all

people, not just those making a buck from hunting. What they can't do is make a hunter shoot a deer, let alone many.

Michigan hunters have a "my buck" attitude, going back to my days in the late 1960s, "...did you get your buck?"

Hunters are tools of deer management and need to do what is asked of them.

The reason there is still bovine TB in this DMU is that the supplies of unlimited antlerless tags are being purchased by land owners and then not used. Why?

Because, if we eradicate the herd in the unit ridding the area of bovine TB, then how would the hunt clubs make a living selling memberships?

The problem is not the DNRE, it's hunters and their "I have to get my buck" attitude.

Until the hunter(s), the "boots on the ground" of deer management, do their job and harvest record numbers of antlerless deer reducing the herd to the point of eradication of bovine TB, then the DNRE will be forced to keep trying to come up with more palatable regulations to that end.

I haven't heard a single suggestion, from hunters, of just how to rid bovine TB from this DMU, and until someone steps up, hunters need to stop pointing fingers and do what is asked of them.

Stop telling me what won't work and tell me what you think will work.

Sgt. James McGuire of the Alcona County Sheriff's Department and officer Kevin Kubik of the Oscoda Township Police Department.

Alcona County Prosecutor Thomas Weichel explained that Scott's detainment allows him to be processed through the three court systems in northern Michigan - while he is in jail (no bond is allowed) and then, after the conclusion of the cases, he is returned to the corrections system in West Virginia to finish the prison sentence he is serving. When that is con-

cluded he will be extradited to Michigan to serve whatever sentence awaits him from these cases.

Weichel said Scott was convicted of arson of a dwelling in 1999 in Wheeling, W. Va. He served six years and was paroled in 2006. He violated his parole in 2007 and returned to prison until he was paroled again in 2008. He came to Michigan from Kentucky.

Scott is scheduled for a preliminary examination on the Lincoln arson case on July 14 in 81st District Court.

DNRE to increase patrols on AuSable River

The Michigan Department of Natural Resources and Environment (DNRE) will increase patrols on the AuSable River for the remainder of the summer season because of an increase in incidents and complaints to law enforcement officials.

Local law enforcement agencies including the DNRE, U.S. Forest Service, sheriff departments and Michigan State Police have noticed increased use over the past few years on the AuSable River, a National Wild and Scenic River. Along with this use, law enforcement has experienced increased incidents of resource damage, littering, obscene conduct, various alcohol violations, disorderly behavior and illegal drug use.

"Summertime brings increased watercraft activities throughout Michigan. Public lands and waterways are abundant with visitors seeking recreational opportunities," said Lt. Creig Grey, DNRE Law Enforcement Division supervisor in Roscommon, Mich. "The rivers within the Huron-Manistee National Forest experience an influx of recreationists participat-

ing in canoeing, kayaking and boating, and the AuSable River is no exception."

Grey said that local law enforcement will increase patrols with aggressive enforcement actions planned for those caught violating any state law or federal regulations. There have been several incidents along the AuSable River in recent weeks that required the attention of area law enforcement agencies. These combined with public complaints has led to law enforcement's need to address this inappropriate behavior for the protection of the resource and the people who use it.

Persons are encouraged to remember safety, to follow the rules and to respect the resource. Irresponsible users will affect future opportunities and experiences for all watercraft enthusiasts. Citizens who witness illegal, dangerous or disorderly behavior are encouraged to call 911.

How to keep tabs on an elderly parent

Dear Savvy Senior,
My 80-year-old mother lives alone about an hour from me and I worry about her health and safety. Outside of the telephone, what types of caregiving devices can you recommend that can help me keep tabs on her?
Concerned Son

Dear Concerned,
There are many different tools and technologies available today that can help adult children keep tabs on their aging parent when they can't be there. Here are some popular options and new products to check into.

One of the biggest concerns among families that have an elderly parent or relative living alone is them falling and needing help. For this, a "personal emergency response system" or PERS is the most affordable solution. For about \$1 a day (available through companies like lifelinesys.com, lifealert.com and lifefone.com) you can rent the equipment which includes a small transmitter (SOS button) that your mom would wear, giving her the ability to call for help any time she needs to. The drawbacks, however, are that many seniors forget to wear their SOS button regularly, and if they do have it on and fall, they still have to be alert enough to actually push the button.

If you're willing to spend a little more (around \$50 a month), there are several more sophisticated PERS on the market. One of them is

Wellcore (wellcore.com), a new device that has fall detection sensors in the SOS button that can automatically summon help without the user having to press a button. Plus, it will beep to remind your mom to put it on, and if she doesn't, it will notify you. And, when paired with a compatible cellphone, it can even be used outside the home. Halo Monitoring (halomonitoring.com) also offers fall detection products, as does Philips (lifelinesys.com), maker of the popular Lifeline Medical Alert Service who just introduced an AutoAlert option.

Another more expensive option for keeping tabs on your mom is with a "home monitoring system." These systems come with sensors, placed in key areas of your mom's home that learn her daily patterns and notify you if something out of the ordinary is happening. For example, if your mom doesn't get out of bed at her usual time, or if she went to the bathroom and didn't leave it could indicate a fall or other emergency.

The great thing about this type of system is it requires no input from your mom, and you can check in on her anytime through a password-protected Web site. You can find these systems at companies like GrandCare (grandcare.com), Healthsense (healthsense.com), and CloseBy (closebynet.com), with prices ranging from several

hundred to several thousand dollars, depending on the options you choose.

If you're worried your mom not keeping up with her medications, there are a wide variety of pill organizers, medication dispensing and alarm systems (see epill.com) that can help. One of the best new systems on the market is TabSafe (tabsafe.com). A home-based device that dispenses medicine on schedule, providing reminders to ensure she takes it on time, and will notify you or other caregivers if her pills aren't taken.

Medication reminding services like OnTimeRx (ontimerx.com) or Check-in Friends (checkinfriends.com) can also be helpful. For a small fee, these services will call your mom to remind her to take her medication. Pillphone.com offers a similar service for wireless phones only.

Videophones have become an increasingly popular tool for keeping in touch with older loved ones from afar. If you're not familiar with them, videophones are like a telephone with a built-in camera and video screen that gives you the ability to see the per-

Senior Corps

Senior News Line By Matilda Charles

More than 63.4 million Americans volunteered in their communities last year, according to the newly released Volunteering in America 2010 report. That equates to 8.1 billion hours of service.

When it came to seniors, we weren't slackers. More than 9 million of us age 65 and older contributed 1.6 billion hours. That's more than 23 percent of us. The top four categories for our efforts were collection/distribution of food, fundraising, professional/management and general labor.

All this work must have come to someone's attention, because the Senior Corp program has been awarded grants totaling more than \$1.2 million. It hopes to train 4,000 more volunteers for some specific projects: mentoring children, independent-living support for other seniors, energy efficiency and more.

There are three Senior Corps programs:

- RSVP covers a lot of ground. Volunteers work to help teen parents, build houses, tutor children, plant gardens, assist new business owners, help in natural disasters and much more. Volunteers get training and supplemental insurance while they work.

- Foster Grandparents help teenagers and young mothers care for premature infants and children with disabilities, and tutor children in reading. Volunteers might work at school or youth centers, and some are eligible for an hourly stipend that is tax-free.

- Senior Companions help other seniors — including frail adults or those with disabilities or terminal illnesses — live independently, which allows them to remain in their own homes. Some volunteers run errands or give the caregiver a short respite. Volunteers receive training, a small stipend and supplemental insurance.

Rite of passage

Every person in their own way selects a time in their life when they focus their spirit, their strengths and their mind in a combined direction to establish who they are.

This story is one of those. I had the privilege to witness how life really works and how it played out.

Around the first of June, my 18-year-old son, Den (Dennis Neveu II), who liked to rebuild older Schwinn road bicycles, heard of a man in Harrisville who was putting together a bike tour in honor of a cycling comrade that fell victim to cancer.

This bike tour would be along the beautiful shoreline route from Harrisville to Mackinaw City, Mich. another heart-inspiring location on Lake Huron, which is approximately 128 miles away.

His plans were to head south 11 miles to Harrisville, then ride along US-23 to Mackinaw City. I asked why, when he could go due west from where we live in Black River to US-23. He said with conviction, "Because it is the right thing to do."

At 5:20 a.m. in the dark and blowing rain, Den turned on his flashing taillight and small headlight. Every drop of rain that surrounded him and his hand-assembled bike gave him a spiritual glow that carried him down the drive to Lakeshore Drive to Harrisville.

As he arrived in Harrisville, he went to the traffic light in the center of town to show respect for a person he did not know, the life lost to cancer with the yellow Live Strong bracelet on his wrist.

He looked up at the light, driving rain hitting his face,

mately 40 miles from start. Unknown to him, I stopped in Ossineke, ate breakfast and watched the road for him.

It had taken a little longer than usual to go the first 30 miles — I knew that Den can average between 20 and 22 miles per hour. I called his mother at home to see if he had checked in. He had not. We both agreed we would not call him; it was his show and he would let us know if anything went wrong. Just about that time, he flew by. After I received my warm and fuzzy feeling that everything was alright, I left for Mackinaw City and St. Ignace.

As fate and "the right thing to do" would have it, while in Alpena, Den missed a turn and took another route. While on this route, he stopped at a traffic signal and his bike, "malfunctioned," causing a moment of delay. As he hesi-

Several weeks before the tour was to take place, Den started preparing an old bicycle, one he had obtained from scrap. He started by disassembling, preparing it mechanically, then painting it a light green that was as close to the original as possible. After a few short runs and tweaking, he felt it was ready.

Then he received heart-breaking news. The organized ride was cancelled due to lack of support. He disappeared into the solitude of his room. I knew through a previous conversation Den felt that a friend honoring another friend was an important issue. He felt the loss personally.

Some time later he reappeared from his serenity and stated, "I am still going to Mackinaw because I believe it is important to honor a friend that died from cancer and if I am the only one to go, so be it."

On Saturday, June 26, at 5 a.m., light rain fell. Three of us were in the garage. His mother and I watched as Den scurried about packing energy food, lots of water and all other necessary items for the trip.

said to himself, "this is Michigan and I love it" and headed north.

In planning the trip, it was agreed that I would go ahead to St. Ignace to attend the annual car show and then pick Den up in Mackinaw City. We discussed his itinerary which included a stop in Alpena, which is approxi-

tated to cross the street, another cyclist passed. Den eventually caught up to the cyclist and while biking close they exchanged salutations.

When the other cyclist asked where he was going, Den told him and why. The other cyclist said, "So am I."

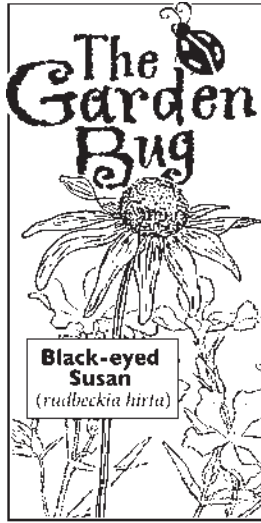

The trip to Mackinaw City took until 7:30 p.m. I returned to Mackinaw City at approximately 6:30 p.m. and took up a position on the side of US-23. The road sloped uphill for about a mile and a half and I was in a good position to take a picture when he arrived. The sign in front of me read: "Alpena 93 miles." As I waited, it struck me that Den had never attempted a trip of this magnitude. It took

stamina and courage to do this.

While waiting alone, my mind wandered until a lone, obviously racing cyclist came into view, and as he passed I called out, "did you pass another cyclist?" The cyclist held up two fingers and then a thumbs up, conveying to me that everything was okay. I offered a fast "thank you."

I took out my binoculars and scanned the horizon, such a beautiful, clear sun-filled Michigan horizon. After about a half an hour, two cyclists appeared on the road before me. I grabbed my binoculars, braced myself on the steering wheel, and there coming in what I thought was

slow motion, was Den on his unmistakable, uniquely-built bike.

I jumped into the bed of my truck, took pictures and stood in awe and silence because everything appeared to stop moving except two lone cyclists on a quest.

One of them proudly proclaimed, "That'd be my dad!" as they rode by.

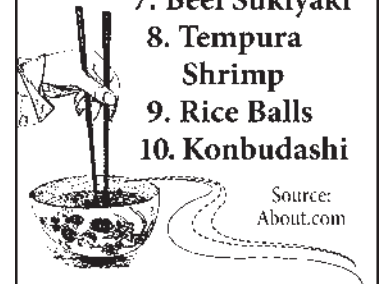

Pedal to the metal

I find I owe an apology to televised tennis. I've suggested in this space on more than one occasion that televised tennis is one of the more boring sports in the world. I was wrong, and I hope Wimbledon, The French Open, The Australian Open and all of the others will take that in the spirit in which it is intended.

That's because I spent the recent heat wave parked in front of the television and the air conditioning with my husband, who is watching what I've come to think of as LE Tour DE France.

If you're not familiar with Le Tour, it's a 21-day bicycle race, peddling its way 3,200 kilometers (about 2,100 miles) through France. Back in the day, there was a guy in the newsroom who used to say an event was "about as exciting as an eight-day bicycle race." This one is 21 days. I rest my case.

If you've never seen Le Tour, it's run in "stages," each of them lasting a day, and each of them with a day's winner. Some days, the riders race each other and some days they race the clock. Eventually, they total up all the times and declare an overall champion.

Each stage starts out with the "pacers," cyclists who start out one by one in a long, single line. Eventually, the line blurs into a pack. Given the endurance each stage requires, the cyclists tend to conserve their energy, pretty much staying in place until near the end when the "overtakers" (honestly, that's what they call them) begin jockeying for the front positions.

In the meantime (usually the better part of the day) I have to admit they ride through some pretty gorgeous countryside. It just doesn't make for particularly stimulating competition.

Perhaps I can best describe it this way. Le Tour makes baseball seem to proceed at a frantic pace. Unless someone falls off his bike or there's a crash, there are long periods of watching the riders pedal along, hunched over their handlebars. Given the helmets they wear, it's not even possible to root for the cute ones, since you can't see their faces.

Nonetheless, Le Tour has been going on since 1903. when newspaper editor Henre Desrange wrote "From Paris to the blue waves of the Mediterranean, from Marseille to Bordeaux, passing along the roseate and dreaming roads sleeping under the sun, across the calm of the fields of the Vendée, following the Loire, which flows on still and silent, our men are going to race madly, unflaggingly."

Yep, folks, that quote simply epitomizes the level of excitement here.

These days, Le Tour is narrated by a British gentleman and his color guy, in only slightly less flowery style. Between his rather strong British accent and my "interesting" hearing, I did have a moment the other day that

brought me to attention, though.

We were watching the pack lean into a curve (a nice change from pedaling along the straightaway) when out of the blue, the announcer said in his clipped British tones, "Oh dear, I've lost my lovely wife." I considered this for a moment. Just now? Had he perhaps just received the news? I know the Brits are noted for their restraint, but that seemed borderline cold. I sat forward on my couch, waiting for more information.

After a few moments of intent listening, it began to come clear to me. My gentleman's wife was fine, probably at home, making herself a nice cuppa tea. What I'd taken as an announcement or her demise had actually been a comment on the announcer's inability to locate the leader in the pack. What he said was, "Oh dear, I've lost his lime green bike." It did liven things up for a bit though, I must say.

Another bright spot, for the first little while anyway, was the manner in which Le Tour is covered. Exciting or not, they apparently have enough cameras, camera trucks, helicopters and blimps to cover all of France from any and all angles. Come to a castle (as we often do) and you'll get to see that castle from every conceivable vantage.

Given the pesky helmet issue, a good portion of the early coverage is shot from the back, behind the riders where you can see their names and numbers. The riders, you need to remember, are young men in excellent physical shape. They have what can only be described as perky little fannies, each about the size and contour of a large honey rock melon. Advertising space being what it is these days, each of their bottoms is emblazoned with a single word or two, my favorite being "Quick Step." I don't know what Quick Step might be, but it certainly is

profiting from product placement.

I enjoy this view as much as the next girl, but it can only entertain you for so long. After that, one of the more interesting elements is the film crews themselves, hanging off their pickups and vans in an attempt to get the closest, best shots. And periodically, when the tires presumably just go flat or the chain falls off, there are crews who whip their vans up behind, a driver selects a new bike from the eight or nine stuffed into its rear compartment and line it up so the cyclist can just leap off one and onto the other. Le Tour's version of the pit stop. That's kind of fun.

The rest of the time it's pretty much just pedaling and leaning and the occasional castle, all of which in the recent heat we've been having tends to lead to a rather dreamlike state of screen-staring. Eventually, as they begin to near the finish line for a given stage, things pick up a bit. The roads narrow, crowds wave signs written, for the most part in French. The "overtakers" begin to advance. And ultimately, somebody breaks the ribbon, receives a small trophy or ribbon and is kissed by the local beauty queen.

That's it, then, until the





StarWatch By Gary Becker - Moon, Planets, Stars Reveal Ecliptic

The ecliptic represents the plane of the solar system created by the Earth's orbital motion around the sun. As Earth changes its location in its yearly circuit around our daystar, Sol reflects this change by shifting its position among the stars, giving us a seasonal change in the constellations that we view. The planets all lie near this plane, making them an excellent resource for viewing the ecliptic's location during the night. Occasionally, bright stars situated near the ecliptic and the planets team up to make the ecliptic more vivid. This week, in addition to Mercury, Venus, Mars, and Saturn, the stars, Regulus and Spica, add to this line of pearls outlining the ecliptic against the western sky about 40 minutes after sundown. The waxing crescent moon plays below these objects during the course of the week. On July 11 the new moon eclipses the sun in the eastern Pacific crossing over Easter Island near day's end. The following evening, the moon is below Mercury, but too close to the sun to be seen. July 13, about 40 minutes after sundown, finds the moon centered between Venus and Mercury. July 14 sees Venus, Regulus, and the moon in close association in the west an hour after sundown. By that time Mercury will have already set. On Thursday, the moon forms a more open grouping with Mars (above right) and Saturn (above left). Keep in mind that both planets have faded greatly since becoming visible this past winter, but they are still brighter than any of the stars of the Big Dipper. By Friday evening Luna is pulling away from Saturn, heading towards a Saturday rendezvous with the blue white gem, Spica, the alpha star of Virgo. The pair will fit nicely in the field of view of standard binoculars which should be brought along for the entire week if you're planning to follow this mid-July parade. For the East Coast, the moon sets on Saturday evening just six hours shy of its first quarter phase. www.astronomy.org

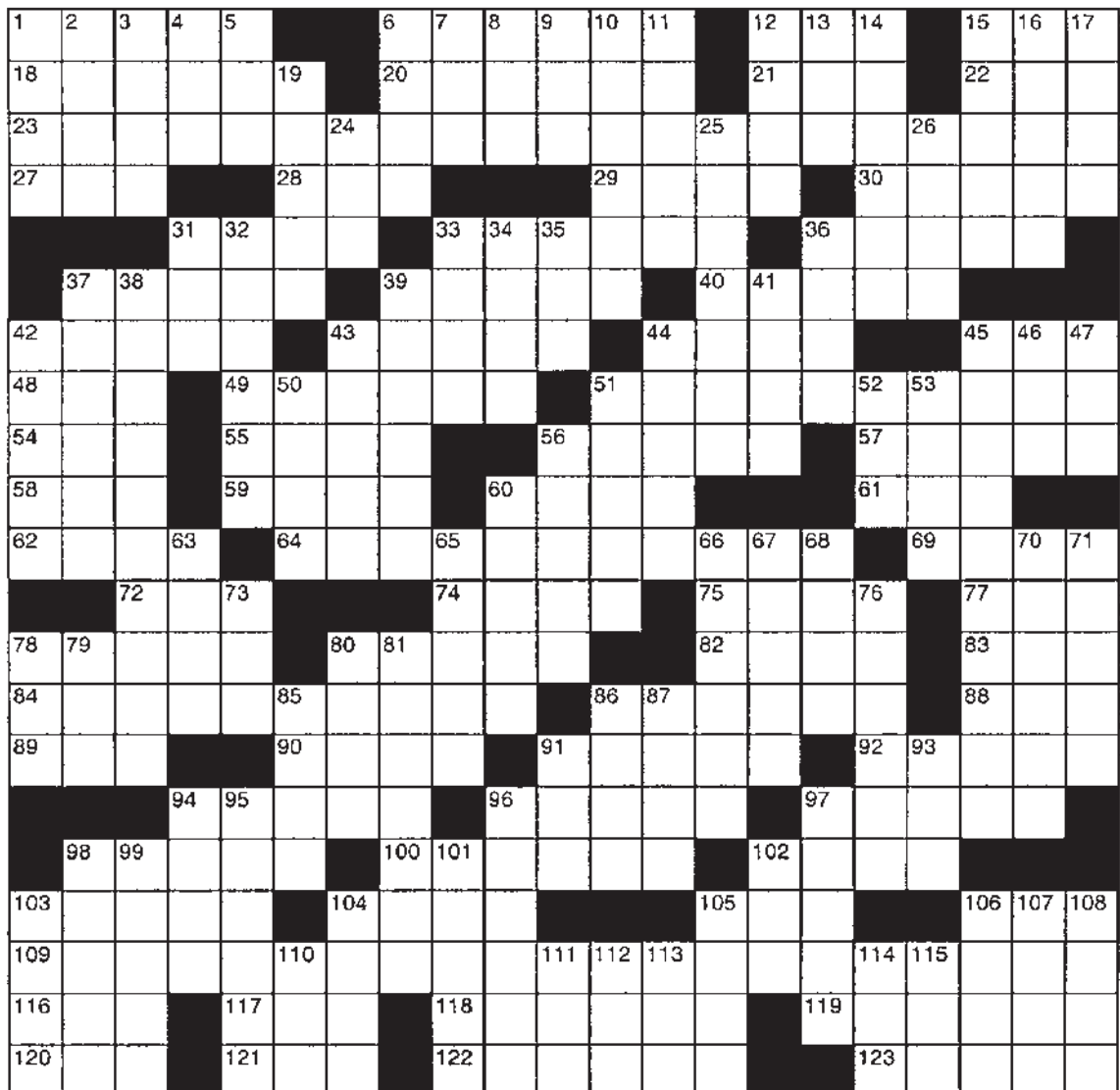

MOMENTS IN TIME
The History Channel

- On July 30, 1619, in Jamestown, Va., the first elected legislative assembly in the New World — the House of Burgesses — convenes in the choir of the town's church. Its first law required tobacco to be sold for at least three shillings per pound. Other laws included prohibitions against gambling, drunkenness and idleness. Sabbath observance was made mandatory.

- On July 29, 1909, newly formed General Motors Corporation acquires the luxury automaker Cadillac Automobile Company for \$4.5 million. In 1954, Cadillac was the first automaker to provide power steering and automatic windshield washers as standard equipment.

- On July 26, 1931, a swarm of grasshoppers descends on crops throughout the American heartland, devastating millions of acres, especially in Iowa, Nebraska and South Dakota. The swarm was said to be so thick that it blocked out the sun and one could shovel the grasshoppers with a scoop.

- On July 28, 1945, a United States B-25 Mitchell bomber crashes into the Empire State Building, killing 14 people. The freak accident was caused by heavy fog. The bomber was flying low, seeking better visibility, when it came upon the Chrysler Building. The plane swerved to avoid the building, but the move sent it straight into the north side of the Empire State Building, near the 79th floor.

VILLAGE OF LINCOLN MINUTES

The Lincoln Village Council met on Tuesday, July 6 at 7 p.m. at the village hall. The meeting opened with the "Pledge of Allegiance." Those in attendance included: President Jordan, treasurer Kossa, clerk Somers, deputy clerk/treasurer Stutzman and council members Gauthier, Lask, Naylor, Somers and Stutzman. Kennard was absent. Also present was Attorney David Cook and guests.

The minutes of the June meeting were approved on a motion from Gauthier with support from Somers. Motion carried. The treasurer's report was approved subject to audit on a motion from Gauthier with support from Stutzman. Carried. Roger MacNeill, first responder chief, stated the number one truck has problems with the batteries. He stated that the budget is a little light in that area. President Jordan stated that we will have to adjust the budget accordingly. Roger then asked about the fire department auxiliary, if it is still in existence, etcetera. Gauthier stated that there were only three people on the board along with a few other people who helped out. In the past year two board members have resigned and there are currently no people on it.

Attorney Cook stated that members of the auxiliary should not be affiliated with the council or members of the fire department or first responders. President Jordan stated that perhaps the fire department should try to find people that are interested and he will try to help find other interested individuals in the community. He asked about the ORV ordinance for the village. Currently there is to be no ORV traffic along Barlow Road from South Sleeper Drive to the south village limits. President Jordan stated that he has been in contact with the Alcona County Board of Commissioners and has asked them to address the possibility of adjusting the access points for people riding ORVs.

One bid was received from Everett Goodrich Trucking Asphalt/Paving of Alpena for work on Alger Street. The bid was in the amount of \$ 10,800 and \$1,500 for gravel if needed. A motion was made by Gauthier to accept the bid from Goodrich and award the contact to that company. Naylor offered support. Motion carried.

In old business, Stutzman asked about the lights for the Flights of Imagination play area. Jordan stated that he hopes to have something in place soon. There will be several projects to get things cleaned up there before fall. Somers presented an estimate for work along the shoulders of Barlow Road. A motion was made by Stutzman, with support from Lask, to have the Alcona County Road Commission do the work at an estimated cost of \$1,900. Motion carried. Lask questioned the lawn mowing for the village. Jordan stated that there have been some small issues and they have been addressed and taken care of. Gauthier stated that there is a spot along Main Street that needs to be taken care of. Jordan will see what needs to be done.

In new business, Naylor asked

about purchasing two new garbage cans for the Flights of Imagination. Somers will order them. Somers stated that he needs to purchase a vise and a Sawzall for the shop. A motion was made by Lask, with support from Gauthier, to allow Dick to purchase the items at a cost of up to \$250. Motion carried. Gauthier stated that she would like to see cameras purchased for the bathroom area at the Flights of Imagination. She also asked that the dock at the beach be fixed immediately. President Jordan read a letter of resignation from Joan Gonyea, planning commission chairman due to health issues. A motion was made by Stutzman, with support from Gauthier, to accept the resignation with deep regret. Motion carried. A letter was received from the MEDC that funds for the demolition of the two buildings along 2nd Street have been released. He stated that a large television was donated to the village and will be used by the fire department. Also a picnic table was donated by Pat Richardson and has been placed at the beach. Ken Manning has asked about having a flea market at the old school site. The council offered its support.

President Jordan addressed the issue of vandalism at the restrooms at the Flights of Imagination recently. Mud was thrown on the floors and walls, toilets were plugged and water left running. Jordan thanked Kent Gauthier, Larry Somers and Dick Somers for their work in cleaning up the mess. He will be working with the Lincoln Lions to see about installing cameras in the playground area soon. A meeting will be held for the planners for the Citizen of the Year Award. Jordan thanked those who attended and participated in the Memorial Day events. Jordan stated that a sewer meeting will be held in the near future. Jerry Ludwiczak Jr. contacted Jordan about having another ball tournament this year. He is requesting to have the first one the weekend of July 24 and 25. This one will only involve three teams. The other tournament will be held in August. A planning commission meeting will be held this month. Denise Cline will meet with the group and make recommendations about updating the master plan. The meeting will be held on July 21.

A meeting will be held to discuss fire contracts and what direction to take in planning for the future. Jordan stated that he and Dick will be doing a water test at the village hall tomorrow. Jordan talked about the insurance policies for the village. He stated that we will put the insurance out for bids for next year.
