

DNRE holds meetings on proposed deer regulation changes in DMU 487

The Michigan Department of Natural Resources and Environment will hold two meetings to provide information regarding recently proposed antler restrictions for deer hunters in Deer Management Unit (DMU) 487 -- which includes the six counties of Presque Isle, Montmorency,

Alpena, Oscoda, Alcona and Iosco.

The proposal -- which calls for a minimum of three antler points on at least one side for a buck to be legal -- is on the Natural Resources Commission's agenda for action in July. DMU 487 is where bovine tuberculosis (TB) in the

deer herd is most prevalent and of greatest concern, according to DNRE officials.

Meetings are scheduled for:

- Tuesday, June 22 from 7 to 9 p.m., at the Harrisville Township Hall, 114 S. Poor Farm Rd. (located off of M-72, two miles west of Harrisville);

- Wednesday, June 23 from 7 to 9 p.m., at the Alpena Civic Center, 133 Johnson Street, Alpena.

These meetings will be attended by both local and Lansing wildlife officials.

Details regarding the proposal and anticipated results will be provided and a question and answer period will follow. Time will be reserved to accommodate those interested in having one-on-one or small group discussions with DNRE staff.

"The department has been making strides towards TB eradication by reducing deer numbers and the concentration of deer at baiting and feeding locations for the past 15 years," said DNRE Wildlife Veterinarian Steve Schmitt. "But, while the long-range trends have reflected reductions in deer numbers and TB, progress has stalled over the last five or more years."

"We're aiming to take regulations further than past approaches to simply provide ample opportunity for hunters to take does," said Brent Rudolph, DNRE Deer and Elk Program leader. "The proposal is intended to work in conjunction with a recently adopted regulation change -- allowing antlerless deer to be taken under a firearm or combination license in the regular firearm or muzzleloader seasons in that area -- to direct harvest towards those segments of the deer population that will aid the most in TB eradication efforts."

VA pays \$6 million to local veterans

During the fiscal year that ended September 30, 2009 veterans and their families in Alcona County received \$6,911,000 from the Department of Veterans Affairs (VA).

Benefits in the form of disability compensation, pension, education, insurance and indemnities were paid directly to many of the county's Alcona veterans.

According to the financial report, 1,707 veterans resided in Alcona County in fiscal year 2009. Of the total \$6,911,000, Alcona County veterans and their families received \$3,755,000 in compensation and pension benefits; \$152,000 for benefits and training for disabled vet-

erans; \$2,969,000 for medical expenditures; and \$36,000 for insurance and indemnities.

Linda C. Walker, director of the Veterans Affairs Regional Office in Detroit, Mich., the office that administers benefit payments for Michigan said, "This influx of money into the Alcona County economy was a significant portion of the more than one billion dollars VA expended to serve the 723,368 veterans living throughout the state of Michigan."

"Over half of all VA expenditures, more than \$500 million, are paid directly to veterans and their families each

year," Walker said. "The rest is used to support VA medical services provided at Michigan's five VA medical centers, five outpatient clinics, and the numerous Community Based Outpatient Clinics (CBOCs) located throughout the state."

Walker reminded any Alcona County veteran "If you believe your service connected condition has gotten worse or you simply have a question about your VA benefits be sure to contact the VA Regional Office."

School board awaits state decision to set budget

With less than two weeks until its end of fiscal year, the Alcona Board of Education's 2010-2011 budget remains in development, awaiting the state legislature's decision on a per pupil allowance and whether or not it will once again "pro rate" (reduce) the district's state aid figure.

"Our legislators are currently holding those discussions, Superintendent of Schools Shawn Thornton said, "and we are awaiting their decision with bated breath." She added that the district must present its budget at a meeting scheduled for June 28 at 6 p.m.

During its regular meeting Monday evening, the board accepted the resignation of James Watts due to retirement, but granted the high school principal a one-year extension to continue his employment through August 26 of 2011.

The board also accepted

the resignation of two elementary teachers, Laura Shillair and Beth Ross, of high school teacher Wayne VanDyke and high school media specialist Pam VanDyke and of Marlene Gunderson, lead cook for the

He's my brother

There's a television advertisement, lately, that always makes me smile. In the ad, a little girl -- obviously the only girl in a house filled with boys -- goes out for a ride with her father. She climbs into her apparent designated spot in the far back seat, but dad waves her up into the middle, "where the boys sit." Once buckled in, she looks around, smiles and breathes "Wow."

Having grown up with two older brothers, I recognize that wow. As the baby and the only girl, born when my brothers were 13 and 15, I was coddled and some would even say spoiled. But getting to do what the boys did, well that was a wow moment.

I've always joked that growing up with Ben and Mike, who were entering college about the time I started grammar school, was the equivalent of having three fathers. I may have been Mama's girl, but Papa and "the boys," as they were collectively known, were actively involved in my upbringing.

Over the years, they taught me to ride a bike, load and fire a shotgun, type, write a lead, read a legal description and never to draw to an inside straight. They told me that I could be anything I wanted to be, that waving to random boys on the expressway was not acceptable and that if I was going to enter into the ongoing discussion of current events around the dinner table, I'd better be able to marshal my arguments and my facts and hold my own.

When it came to politics, they took no prisoners. But I don't remember ever calling on either of them when they weren't there for me.

Most of all, they allowed me to grow up liking men. Not in the "pick 'em up at closing time" sense of the word. Like in the trust and respect but don't hesitate to express your opinion sense. And they gave me, every single day of my life, a sense of being safe in the world -- of having my own personal secret service detail in my big brothers.

These days, I'm down to one, Papa and Ben having gone on before us. I've written about both of them and the impact they had on my life many times in this space. This year, with Father's Day looming on the horizon, I want to take a minute to write about my big brother, Mike.

Mike tends to appear in this column most often in a humorous vein. He deserves it. Nonetheless, if he teased me unmercifully (he did, and he still does) he also has the dubious honor of being my first best friend.

I don't know that he wanted to be. I suspect, as the younger of the two brothers, he may have had the role of in-house babysitter forced upon him. All I know is that many of my first memories are of Mike taking care of me.

I remember him carrying me up the stairs to bed when I must have been less than three years old, reciting a nonsensical bedtime mantra. "Did you bring me my orange

juice?" I'd ask. "It's n'orange juice," Mike would tell me. "Did you bring me my n'orange juice?" I'd correct myself. "It's orange juice", Mike would say.

I have snippets of memory of Mike pulling me on a sled through the snow, lifting me up to see the train go by, reading me stories and teaching me to play "52 Pickup" -- a game that consisted of his spraying a deck of cards across the room and instructing me to pick them up.

During the winter that I spent fighting polio, he made me tiny three-snowball snowmen to set on the porch where I could see them from the window.

To this day, the best hamburger I've ever had came home wrapped in wax paper in Mike's jacket pocket from his job as a pin setter at the bowling alley. Eaten late at night (in my opinion, any way) and dressed with Mike's choice of mustard and pickle, it was one of those "wow" moments.

So you don't get the impression that it was all root beer and skittles, I should point out that I also remember Mike offering me a stick of gum that snapped onto your finger as you pulled it from its trick package. I remember him letting me watch an episode of "Thriller" that kept me awake for months. And it was Mike, after all, who coined the famous Fritz Family phrase, "There is nothing under your bed, and if you don't go to sleep, it will eat you."

But as I approach my sixth decade on the planet, he still introduces me as "my baby sister," he shares his love of words and poetry with me and he's pretty much the only person left who routinely calls me Katy -- and who always "gets" what I'm talking about.

Growing up, he spent a good portion of his time explaining things to me and answering my questions. He taught me everything from how to turn the crank and get the operator on the phone to how to solve for x (admittedly not his easiest assignment). I've watched him muster incredible inner discipline to fight the Irish genes that predispose a tendency toward procrastination and melancholy and succeed in his field,

raise a remarkable family and face the world each day with a gleam in his eye and a wicked sense of dark humor.

And I've done my best to emulate that.

Although the in-laws will contend that we talk a mile a minute when we're together, Fritzes aren't noted for our urge to reach out and touch someone, family-wise. We phone each other at Christmas. We have lunch. Once in a blue moon, we write a letter or send a card.

But our conversations are always peppered with "I thought of you when..." or "I knew you were going to write about..." or "Do you remember..." We communicate as much, I suspect, in each other's heads as we do in person.

These days, if we held a family reunion, it would be just the two of us. Me and my big brother, Mike. And if I've pointed out in this space that he's my much older brother and told funny stories that he swears aren't accurate, I don't know if I've ever actually said thanks for being my first, longest and most loyal best friend. So here it is.

Don't think that means I'm getting soft, Michael. Not long ago, I wrote a column about the last wolverine in the state and one reader wrote to say that I'd dissed the University of Michigan and "after all, they've never found the ancient remains of a Spartan in Michigan." My immediate response was "Well, obviously, you've never met my brother Mike."

But just for today, I'll give up the battle to hold my own, long enough to tell my much older brother, "Thanks, Mike." And that, although I don't often say it, I love you. And Happy Father's Day.

Don't get too used to it. Just think of it as a small tribute, for all the "wow" moments you've given me.

Discount travel tips for retirees

Can you write a column on U.S. travel discounts for seniors? My husband and I are approaching retirement and love to travel but have a limited budget.

Discount Travelers

Dear Travelers,
Everybody loves a bargain but in today's tight economy, senior discount travel deals that have real value are getting harder to find. Here are some tips to help you find the best deals.

When it comes to senior travel bargains, an important point to keep in mind is that the "senior discount" may not always be the best deal. Hotels, airlines and cruise lines, for example, offer advanced bookings along with special deals and promotions from time to time that may be a lower rate than what the senior discount is.

Always ask about the lowest possible rate and the best deal available. With that said, here's a breakdown of the different senior travel discounts that are available today and where you can find them.

AARP discounts: If you're a member of AARP, various travel discounts are available on hotels, rental cars, cruises and vacation packages. To find them see aarp.org/travel or expedia-aarp.com, or call (800) 675-4318.

Airlines: Southwest (southwest.com, (800) 435-9792) has the best senior fare program, offering discounts on

walk-up fares to passengers 65 and older. American (aa.com, (800) 433-7300), Continental (continental.com, (800) 523-3273), U.S. Airways (usairways.com, (800) 428-4322) also offer limited senior fares to passengers 65-plus to selected destinations.

Train discounts: Amtrak (www.amtrak.com, (800) 872-7245), the nationwide rail network, provides a 15 percent discount to coach travelers age 62 and older. And a 10 percent discount to passengers 60 and older on cross-border services operated jointly by Amtrak and VIA Rail Canada.

Bus travel: Greyhound (greyhound.com, (800) 231-2222), the largest provider of intercity bus transportation, offers a five percent discount on unrestricted fares to seniors over 62. Peter Pan (peterpanbus.com, (800) 343-9999), which serves the northeast region of the U.S., offers the same deal. Trailways (trailways.com, (800) 776-7581), a privately owned bus company also provides senior discounts but they vary by location. And, most local bus lines and public transportation offer discounted senior passes.

Car rentals: Most car rental companies offer five to 25 percent discounts to customers who belong to 50-and-older organizations like AARP. Good discounts are also available to AAA (aaa.com) members. To shop around for the best

rental car deals use travel aggregator sites like orbitz.com or kayak.com.

Hotels: Most hotels in the U.S. offer senior discounts usually ranging from 10 to 30. Age eligibility will vary by hotel, usually starting at age 50, 55, 60 or 62. Hyatt (hyatt.com, (888) 591-1234) offers the biggest hotel discounts - up to 50 percent off to seniors age 62 and older.

Cruising: If you're interested in taking a cruise, there are lots of bargains available regardless of age. Before the next domino falls

No matter how fit we used to be, we have all experienced muscle loss over time.

The syndrome didn't have a name until the late 1980s, when a researcher at Tufts University, Irwin H. Rosenberg, discovered a pattern of muscle loss in seniors and decided it needed a name so other researchers would notice. Sarcopenia, he called it.

Sarcopenia is age-related muscle loss, and it can happen even if we appear to be at the right weight. Our muscles, hidden underneath layers of fat, can diminish, and we don't know it until we become unsteady on our feet. It can go downhill from there, like tipping over the first domino in a row: Lose muscle, become unsteady on our feet, fall, fracture a bone, lose independence, take on a sedentary lifestyle.

Over time, researchers determined that muscle loss starts in our 30s. This isn't something we should just accept, said Rosenberg. Muscle loss and the rest of the "dominoes" falling needn't be a foregone conclusion.

Researchers focused on resistance-training exercises for arms and legs to counteract the effects of muscle loss. Using gradually heavier weights apparently allowed muscles to "wake up" and be able to handle even more weight. In other words, it's never too late to start rebuilding muscles that have been lost through inactivity.

The details of a study done at Tufts were encouraging. Frail residents of nursing homes (ages 72 to 98) doubled the strength in the exercised muscles over 10 weeks when they worked out three times a week. Some were able to give up walkers, canes or wheelchairs.

A second study (women ages 50 to 70) was conducted with easier exercises and only twice a week. They also increased their muscle strength.

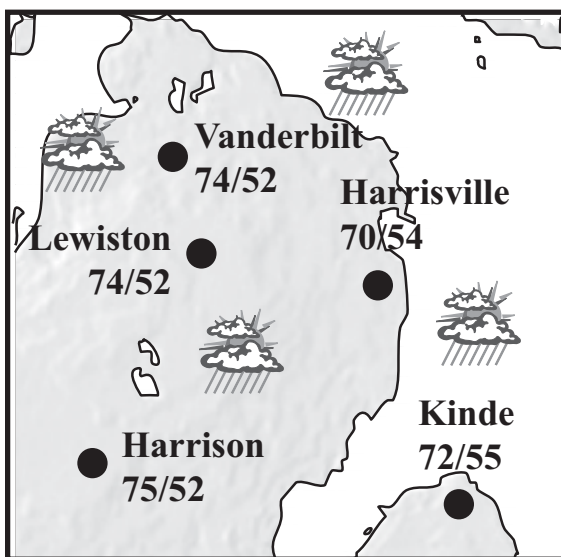

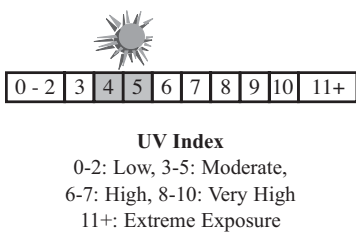

StarWatch By Gary Becker - Endless Summer

I'll be on my way to work, but still fairly close to home when it happens on June 21. The time will be 7:26 a.m. EDT, but somewhere over the central Sahara on the Tropic of Cancer, the sun will reach its greatest culmination north of the equator, and the Northern Hemisphere will switch from spring into summer. It will be the moment of the summer solstice. The word solstice means "sun standstill," where the sun essentially does not move north or south. Sol still continues its easterly motion among the stars by about one degree per day, due to the Earth's yearly circuit around the sun, but it pauses in its north-south movement changing its position by only several seconds of arc during the same 24-hour period. Keep in mind that there are 3,600 seconds of arc in one degree. While the seasons "flip" effortlessly as the sun passes certain "signposts" in the sky, this current journey towards summer holds special significance for me. For the past 55 years I have been involved in the education profession—13 years as a student in the public schools of Allentown, PA, then four years of college at Kutztown (PA) University. For the past 38 years I have taught in the Allentown schools, first as assistant director, then as director of the Allentown School District Planetarium. Now all of this is coming to an end as retirement beckons at the onset of this summer's solstice. I will be calling this the year of the endless summer, but don't think that "old" teachers like soldiers simply fade away. I plan to continue writing about astronomy, observing, and photographing the night sky. I will also continue to teach, but this time on the tertiary level at Moravian College in Bethlehem, PA. No more bells or rigid schedules to adhere to, but I will miss the electrifying enthusiasm of kids seeing the stars for the first time. New roads, new journeys, and a new life... 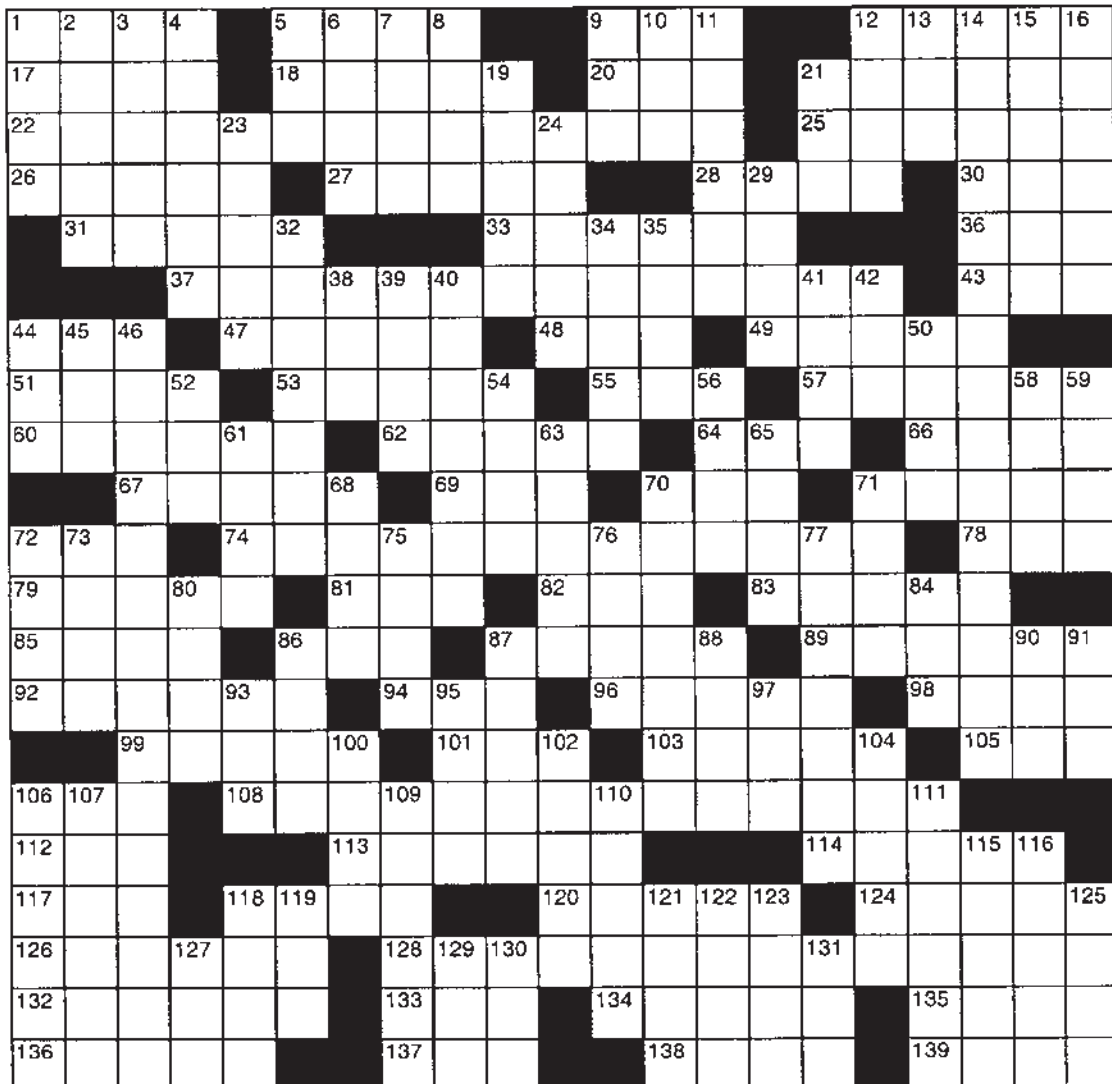

• On June 29, 1613, the Globe Theater, where most of Shakespeare's plays debuted, burns down. The Globe was built in 1599 from the timbers of London's very first permanent theater, Burbage's Theater, built in 1576.

• On July 4, 1776, in Philadelphia, the Continental Congress adopts the Declaration of Independence, which proclaims the independence of the United States of America from Great Britain and its king. The declaration came 442 days after the first volleys of the American Revolution were fired at Lexington and Concord in Massachusetts. The American War for Independence would last for five more years.

• On June 28, 1928, 26-year-old Louis Armstrong walked into a Chicago recording studio and recorded "West End Blues." Armstrong's 15-second trumpet intro to "West End Blues" and his eight-bar solo near the end make it one of the most influential pieces of recorded music in history.

VILLAGE OF LINCOLN MINUTES

The Lincoln Village Council met on Monday June 7 at 7 p.m. at the village hall. The meeting opened with the "Pledge of Allegiance." Those present included President Jordan, treasurer Kossa, clerk Somers and council members: Gauthier, Kennard, Lask, Somers and Stutzman. Council member Naylor and Deputy clerk/treasurer Stutzman were absent. Also present were several guests and village attorney Cook.

The minutes of the May meeting were approved on a motion from Gauthier with support from Kennard. Carried. The treasurer's report was approved subject to audit on a motion from Gauthier with support from Somers. Carried. Fire chief Bob Reynolds introduced new firefighters for the village. They include Mike Serafin, Keith Thompson and Anthony Escareno. Bob also stated that he is putting in for a DNRE grant that would be a 50/50 match. The funds could be taken directly from the fire department's budget. He stated that they have until June 25 to file the necessary paperwork. Bob will be taking care of all the paperwork pertinent to that grant application. President Jordan welcomed the new firefighters and thanked them for their efforts in volunteering on the department. Sue Kennard reported that the Brownlee Lake Association stated that the permit has been secured from the DEQ for beginning work on the aeration system for the lake. She stated that they should have a release of funds for the grant money and hope to begin the project in July. She stated that they have received donations from people and will continue to try to raise funds through their Texas hold-'em parties and solicitations. Troy Somers, zoning administrator stated that he has sent out five letters to property owners asking them to clean up their areas. He stated that there has been movement in three of the areas so far. Kennard stated that some of these are becoming health and safety issues in instances where buildings are up for sale. President Jordan stated that the home on Millen Street has been cleaned up satisfactorily.

In old business, Stutzman stated that the Flights of Imagination Park is looking very good. Dick has done a lot of maintenance and volunteers have cleaned up the flower beds. Jordan stated that the park looks nicer this year than in many previous years. Special thanks to the "bag ladies" for their help in keeping flowers in the community looking good.

President Jordan is still trying to get the trees trimmed along Traverse Bay. Kennard stated the application for the boat launch grant is moving forward. Kennard would like the record to reflect that no bids were received for the boat launch. Kennard commended the homeowner that is restoring the home on Traverse Bay. Kennard stated that he would like to continue working to move forward with addressing fire funding from the four townships that give funding to the village. Somers read an ad for publication for

roadwork. A motion to place the ad for publication for work was made by Somers with support from Kennard. Carried.

In new business, Somers stated that a home on the corner of 1st and Fiske streets is set to be torn down soon. The new owners need to contact the building department. He stated that there is a lot of work needed on the village pickup. He presented estimates for repairs to the council. The repairs that are needed total over \$2,000 and work on the body totals over \$3,700. A discussion followed. President Jordan stated that he believes we need to look around for used and or new vehicles. Kennard asked about the road that leads to the boat launch/ramp. Somers stated that he doesn't believe that it is a dedicated roadway. Attorney Cook stated that it may be considered an access road only. In order to do the grant for the launch area it will need to be measured for inclusion.

President Jordan stated that in regard to ORV closure within the village, things haven't been closed as planned. He stated that he has been questioned about leaving an access point open along South Sleeper Drive. ORV riders would like to have someplace to get into the business areas in town. Currently plans were in place to close Barlow Road from village limit to village limit. A motion to amend the prior motion regarding ORV traffic on Barlow Road from South Sleeper Drive to the southern village limits was made by Kennard with support from Lask. Motion carried.

In order to get the boat launch grant moving forward there is a need for a topographical survey to be done. A motion to have a survey done not to exceed \$650 was made by Stutzman with support from Kennard. President Jordan stated that he would like to close the Flights of Imagination Park from 9 p.m. until 8 a.m. A motion was made by Kennard with support from Somers to close the park from 9 p.m. until 8 a.m. Carried. President Jordan stated that the Memorial Day events in the village were carried out very well this year. He thanked those who participated and especially thanked Dick Sheppard for his work in putting the service together. Also, a special thank you to Ron Kennard for actually putting together the entire program.

Grant funding for demolition of two buildings in the 2nd Street area are well underway. Jordan stated that funds should be able to be released after June 14. The streetscape grant funds will be under environmental review and should be able to be accomplished yet this year. The ICE grant along Traverse Bay Street should be accomplished next year. The final goal is to complete work on Traverse Bay Street to Barlow Road. Jordan stated that there are several stops in Lincoln for bus service through Thunder Bay Transportation Authority. This is on a trial basis currently.

The Alcona County Quilt Trail maps are available for anyone who is interested. More work has been done on the village Web site thanks to Eileen

Oposnow. Jordan stated that he would like to close the Brownlee Lake beach when the aeration process first starts. Jordan has received a request to move the basketball hoops from the village hall area and place them at the tennis court area. Council members agreed that moving them would be a great idea.

Jordan stated that he would like to have a citizen of the year award for outstanding people within the community. Kennard, Gauthier, Lask, Kossa and Jordan will form a committee to address this matter. A bid for work on F-41 was received from the Alcona County Road Commission for shoulder work. Stutzman offered the motion with support from Kennard.

A motion was made by Kennard, with support from Somers, to put the delinquent people that are on the sewer system on the tax roll and pass the following resolution: Be it resolved, upon a request from the village treasurer, received and filed, that these accounts including penalties and interest are unpaid.

In the Lakeshore Development (LS) District and the Residential Lakeshore (RL) District, properties containing seawalls/breakwalls have an artificial Ordinary High Water Mark. As such, the 49 foot front yard requirement begins at the outside edge of the seawall/breakwall. Revision of Section 307, Porches and Projections into Yards. Currently reads -- Changes include deletion of some words and the addition of the last sentence: For the purpose of this ordinance, an open, unenclosed and uncovered porch may project into a yard for a distance not exceeding setback limits from lot lines in the zoning district where the structure is

built (amended September 15, 2004), but this shall not be interpreted to include or permit fixed canopies or roofs. Architectural features, not including vertical projections, may extend or project into a required front or rear yard for not more than three (3) feet. Paved terraces, stamped concrete or wooden decks placed at ground level are allowed within the setback limitations. The next day, after I'd dried the flag, I took it back to the center, and it turned out that the teens responsible for raising and lowering the flag were all in the rec room.

Never one to let a teaching moment pass, I ended up giving the kids a few instructions for the proper care and handling of the flag. To their credit, they took it seriously, working out daily assignments for putting the flag up and taking it down. They practiced folding and clipping the flag to the halyard.

One thing led to another, and those kids developed their own project: Over the next year they're going to hold fundraisers to replace the worn flags on the poles outside the stores along the main drag of our town. Next summer they'll take all those worn flags and participate in the flag-retiring ceremony at the local American Legion. Posts of the American Legion hold flag retirements, called The Ceremony for Disposal of Unserviceable Flags, each year on Flag Day, June 14.

You know where I'm going with this, right? I'm calling on you to do the same thing, either with a kids group or a school class, or even by yourself if necessary. If you start now, by next summer the flags in your area should be in great shape and the worn flags can be retired with dignity.

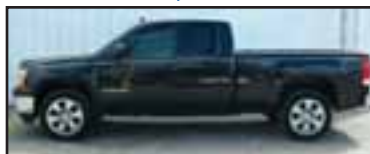

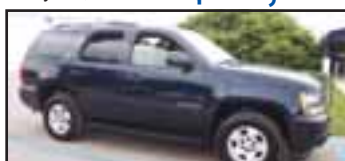

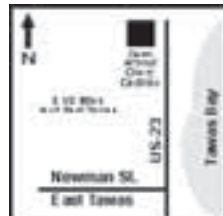
