

## Stimulus funds helps pay for Black River Road project

A section of Black River Road will be under construction starting next week and will be paid for by the federal government and Alcona County residents.

According to the Alcona County Road Commission, funding from the American Recovery and Rehabilitation Act of 2009 (ARRA) will be used to reconstruct Black River Road in Alcona Township.

The segment of Black River Road to be reconstructed is from US-23 east to Lake Shore Drive, and Lake Shore Drive south from Black River Road to the bridge crossing

Black River. Construction is slated to begin June 1 and calls for limited tree removal; drainage improvements; guardrail work; minor hill cuts, just east of US- 23 and just west of Sand Hill Trail; grinding the existing surface; and laying a new asphalt surface. The plan also includes replacement of the culvert crossing at Black River east of Fontaine Road.

The amount of ARRA, or stimulus funding, allocated to Alcona County for road improvement projects is \$331,618 and will be supplemented by \$100,000 from Alcona County's allocation of

Surface Transportation Program funding helping to pay for the project's estimated \$790,000 price tag. Alcona Township will be contributing 50 percent of the project cost from its voter-approved road improvement millage. Work on the project is expected to complete by July 31.

During the construction period, the road will be closed to through traffic for a period of up to three weeks to allow for the stream crossing replacement and the hill cuts. There is not an alternate route nearby, so traffic bound for the community of Black

River will routed to Alcona Road about four miles south of Black River Road on US-23. Alcona Road connects with Lake Shore Drive along Lake Huron and will convey travelers to points on the other side of the construction zone.

Upon hearing of the allocation of funding under the ARRA program last spring, the Black River Road project was chosen because it was considered the best fit for the amount of money expected. Only those roads formally designated as federal-aid routes, generally designated as such by their importance to the road network, are eligible for federal funding.

Originally, the next segment of road up for funding under Alcona County's Surface Transportation Improvement Plan (STIP), or the long-range plan for Alcona County, was F-30 between US-23 and Wice Road in the southeastern part of the county; however, that project is estimated to cost more than the stimulus package funding would provide. It was decided to leave the F-30 project on the list where it had been scheduled for full funding in 2011 and move another project up.

The next project on the list was Hubert Road between Mt. Maria Road and the Thunder Bay River on the

north boundary of Alcona County. The cost of this project was estimated to be below the anticipated income from the stimulus package and would have, therefore, not taken full advantage of the funds earmarked for Alcona County. Including the portion east of the river to connect with the recently reconstructed portion east of Bear Springs Road would

## Alcona joins new athletic league

Alcona Community Schools has been a member of many athletic leagues through its history, but now it seems to have taken a solid step to create one that could be permanent for years to come.

Alcona Community High School Principal/Athletic Director Jim Watts and Athletic Secretary Patti Byce have played a pivotal role in starting a new league - the Huron Shores Conference. Starting next season the Alcona Tigers will join Tawas, Whittemore-Prescott, and Oscoda in the new conference.

Watts said that conversations about a new league began untraditionally. "Last year in the early spring Patti and I were at a meeting in Au Gres, Mich. with several schools (Standish, Pinconning, Tawas, Oscoda, Whittemore-Prescott, and another school or two). At the conclusion of the meeting in the parking lot I mentioned to WP, Oscoda and Tawas that we should stop talking and form our own league calling it

Huron Shores League. They agreed. Serious discussions followed shortly after that."

The league was recently certified by the Michigan High School Athletic Association and a constitution has been developed.

Rich Sedgwick, teacher and former coach for Alcona schools, was encouraged by the new conference, "The logistics make sense. It provides good opportunities for strong rivalries. It surely is an improvement over some of the other experiments."

Alcona has always been in an awkward position when attempting to join athletic conferences. The Tigers have been in many conferences -- Northeast Michigan Conference and Great Northern Conference to name two -- and recently applied to be a member of the Northstar League, but were denied several times. The schools surrounding Alcona are either too big, too small, or too far away geographically to make a new conference logical.

Alcona schools was a mem-

ber of the Straits Area Conference (SAC) a little over five years ago. The conference included teams from northern Michigan and in the Upper Peninsula.

Watts and Alcona had to intervene when the SAC decided to expand. It was decided it no longer would be a good fit for Alcona, "When Sault Ste. Marie (class A) and Cheboygan (class B) joined the Straits Area Conference we decided the size difference would be unfair to our student-athletes. It was a great league that we were proud to be a member of, but ultimately it came down to giving our student-athletes a competitive opportunity each time they set foot on the court/field," Watts said.

The new league seems to be a much better fit, but the Tigers are still the smallest school. The estimated enrollment for each high school is as follows: Tawas 568 students, Oscoda 485, Whittemore-Prescott 314, and Alcona 313. Tawas and Whit-

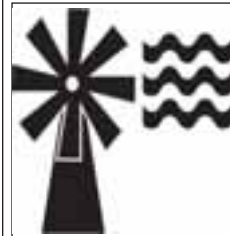

Coach Larry Spare said this is the first time that all

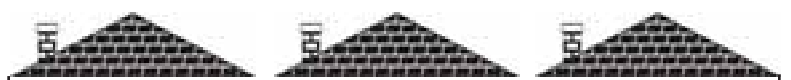
four boys relay teams and all four of the girls relay teams placed in the regional competition since the early 1990s.

# Elementary students win posters awards

### StarWatch By Gary Becker - Colder Winters Ahead?

I am a proponent of global warming, and I believe that the one degree F. increase in the Earth's temperature during the past century has been largely a problem of humanity's love affair with fossil fuels. The analogy of our attitude toward global warming is similar to someone who smokes cigarettes. Cigarettes simply don't kill the smoker fast enough to be of any immediate concern. So why worry? But I am an optimist, and I believe that we will combat this crisis before Earth is diagnosed with terminal "lung cancer." The problem, however, is an extremely complex one because the Earth has gone through many natural cycles of warming and cooling without human input. In fact, about half of the last 600,000 years have been spent in long eras of glaciation with the last ice having retreated just 12,000 years ago. Glaciation may result from cyclic changes in the Earth's orbital eccentricity (ovalness), slight variations in its axial tilt, and the direction that the long axis (major axis) of its orbit points in space. Another factor which intrigues me is the sunspot count. It would seem natural to surmise that when the sun is speckled, less energy should be emitted. Just the opposite is true, for the sun overcompensates when larger numbers of sunspots are visible and is less luminous when there are fewer spots. Between 1645 and 1715, astronomers were observing the sun regularly, but noting few spots—an interval now known as the Maunder Minimum. During this period global temperatures went down. Between 1790 and 1830 another lull in sunspot activity occurred, known as the Dalton Minimum, dropping temperatures 3.6 degrees F. in a 20-year period at one German weather station. Remember how cold and snowy it was in Dickens's Christmas Carol (1843)? Our current solar minimum began in 2004 and continues. Despite global warming, the next few winters could be interesting. - On June 9, 1772, the British vessel Gaspee runs aground off the coast of Rhode Island while pursuing the Hanna, an American smuggling ship. ## GREENBUSH TWP. ORDINANCE

### Township of Greenbush County of Alcona, Michigan

At a regular meeting of the township board of the township of Greenbush, Alcona County, Michigan, held in the township hall located at 5039 Campbell Street within the township, on the 20<sup>th</sup> day of May, 2010 at 7 p.m. it was moved by township board member Olin and supported by township board member Abraham that the following ordinance be adopted:

#### Ordinance No. 97.03

An ordinance to regulate uses and activities which occur at road ends ending or terminating at lakes within the township and related matters and to provide penalties for the violation of such regulations.

The township of Greenbush (the "Township") ordains:

**Article 1. Intent, Purpose and Short Title.**  
**Section 1.1 Intent and Purpose:** The Greenbush Township Board recognizes and concludes that the proper and safe use of land and water resources at and near public and private roads which end at lakes in Greenbush Township ("Township") is desirable in order to retain and maintain the physical, ecological, cultural and aesthetic characteristics of the lakes in such areas within the township, to preserve and protect the quality and safety of the lakes and shorelines and the rights of adjoining riparian owners and users in the vicinity of such road ends at lakes, to promote safe use of such road ends, to minimize conflict, and to promote the public health, safety and welfare of all persons making use of the lakes and lands with the township at or near the road ends involved. Accordingly, it is the intent and purpose of the township board to adopt reasonable regulations for the use of road ends at lakes within the township.

**Section 1.2 Short Title:** This ordinance shall be known and may be cited and referred to as the "Greenbush Township Lake Road End Ordinance," and shall hereinafter be referred to as the "Ordinance."

#### Article 2. Scope and Application.

**Section 2.1 Minimum Standards:** The terms and provisions of the ordinance shall be interpreted and applied as minimum standards and requirements for the promotion and protection of the public health, safety and welfare, and for the public peace and preservation of natural resources and public and private property within the township.

**Section 2.2 Interpretation:** This Ordinance is intended to supplement other laws and ordinances. If this Ordinance imposes more stringent requirements than other ordinances, the provisions of this Ordinance shall govern, except as otherwise herein provided.

#### Article 3. Applicability; Coverage.

**Section 3.1** For purpose of this Ordinance, the phrase "road end" shall mean

and road, street, highway or similar way which ends or terminates at a lake or is more or less perpendicular to the shore of a lake, regardless of whether it is public or private, improved or unimproved, an easement or a right-of-way. This definition shall also include any private access easement (or the equivalent) which ends or terminates at a lake, and which benefits six or more lots, parcels or properties. This definition shall also include any and all shorelines, beaches, and bottomlands attributable to any such road end.

#### Article 4. General Regulations.

**Section 4.1** The following uses and activities shall not occur at, on or from any road end:

- (a) Littering.
- (b) Engaging in any loud or boisterous conduct. Nor shall any person play music at a volume which is audible beyond the boundaries of the road end.
- (c) Trespassing on adjoining or nearby private land.
- (d) Refueling, repairing, or working on or regarding any boat, vessel, vehicle or boat trailer.
- (e) Engaging in any conduct which shall impair, impede or diminish the free use of travel across the road end by others who are utilizing the road end in conformance with the law.
- (f) Camping.
- (g) Disturbing the peace.

**Section 4.2** No automobile, truck, recreational vehicle, trailer, motorcycle or other vehicle shall be parked, stored or kept at or on any road end except as follows:

- (a) For public road ends, automobile and trucks may be parked for short periods of times only in spots specifically designated for parking by the township signage. No such parking allowed by government signage shall occur during the times when a public road end is closed to the public. If no signs are posted at a public road end indicating the times when parking is permitted within the parking spots designated by proper signage, the no parking shall occur within those designated parking spots between the hours of 9 p.m. and 7 a.m.

**Section 4.3** No dock, wharf, pier, shore station, boat cradle, boat launch, boat tether, buoy or similar item shall be installed, stored, kept or utilized at any road end (or the shoreline or the bottomlands thereof) except a dock for public use at a public road end specifically authorized by the Township and installed by the Township.

**Section 4.4** No boat, watercraft, vessel, personal watercraft, jet ski, sail boat or similar vessel or item shall be moored, stored, anchored or kept at any road end (or the shoreline or bottomlands thereof), except as follows:

- (a) For all road ends, a boat may pull up to the shore to pick up or drop off passengers where lawful, but such use shall occur in a reasonably fast fashion. No boat, watercraft, personal watercraft, jet

ski, or other water vessel shall be beached, stored, anchored or kept at any road end (or the shoreline or bottom lands thereof) while the operator is not physically present on the watercraft or for any time period longer than simply picking up or dropping off passengers.

**Section 4.5** No lounge chair, towel, or other personal item shall be kept, stored, or left at or on any road end overnight.

**Section 4.6 Hours of Usage:** Unless different hours are posted by the township on signage at and for a particular public road end, public road ends covered by this Ordinance shall not be utilized between the hours of 9 p.m. and 7 a.m.

#### Article 5. Enforcement

**Section 5.1 Enforcement and Administration:** Any violation of this Ordinance is hereby declared to be a nuisance per se. This Ordinance shall be enforced and administered by the township zoning administrator, or such other Township official as may be designated from time to time by resolution of the township board.

#### Article 6. Exemptions.

**Section 6.1** This Ordinance shall not apply to any structure or improvement installed by a governmental unit or to any uses, activities or vehicle regarding any employee, agent or contractor of a governmental unit (including, but not limited to, Greenbush Township, the Alcona County Road Commission and the state of Michigan) when engaging in a governmental function regarding maintenance or repair to a public road end or any item thereon, or any emergency fire or rescue uses or activities engaged in by any fire fighting, police or ambulatory officials or services.

#### Article 7. Severability.

**Section 7.1 Severability:** In the event that any one or more sections, provisions, phrases or words of this Ordinance shall be found to be invalid by a court of competent jurisdiction, such holding shall not affect the validity or the enforceability of the remaining sections, provisions, phrases or words of this Ordinance.

#### Article 8. Effective Date.

**Section 8.1 Effective Date:** The provisions of this Ordinance shall take effect thirty days from the date of publication of the Ordinance or a summary of its provisions in accordance with law.

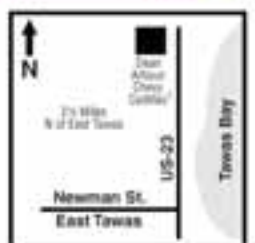

# After 43 years in the classroom, Slayden retires

It's true that some people have to spend a little more time in elementary school than others. Still, when teacher Bev Slayden of Lincoln leaves Sanborn Elementary for the last time this month, she'll be coming to the end of 43 years in the little school building on US-23 in Ossineke.

Slayden came to the Lincoln area in tenth grade with her parents Barry and Mae Weeks and younger siblings Deb and Wayne. Up until that time, the family had followed Mr. Weeks in his construction work, moving almost yearly. "I went to 14 different elementary schools in nine years," Slayden said. In 10th grade, we moved to Lincoln. I was just amazed when 10th grade started and we were still here. Maybe that's why I stayed at Sanborn so long."

After high school, Slayden attended Alpena Community College (ACC) participating in an intern program with Michigan State University. In her senior year of college, she interned at Sanborn Elementary in Ossineke, one of eight elementary schools in the Alpena district, housing 250 students in kindergarten through sixth grade.

After graduating with a Bachelor of Arts degree in education and marrying her husband, Dan, Slayden remained at Sanborn, teaching in third and fourth and fourth and fifth blended classrooms. Over the years, she obtained a master's degree in reading from Central Michigan University (CMU) and 30 credit hours toward a reading specialist degree.

She's served as building representative for the executive board of the Alpena Education Association, was on the Sandborn Parent Forum, belongs to the Alcona Historical Society and was a charter member of the Alcona County Friends of the Library.

Asked what's changed in her almost half a century of teaching, Slayden said, "I feel that things go around in education. You do something and it changes and pretty soon it comes back under a new name. There's a more data-driven emphasis, more emphasis on testing now."

"It almost takes the fun out of teaching," she said, "Before if the kids came in with a cocoon, you could stop and do something on butterflies. Now, you have so much structure, it's hard to do the extra things. We used to say you never knew what the day would bring. Now, everything is so scheduled, you don't have much time for that (sort of thing)."

"I taught fourth grade because they get your jokes," Slayden laughed. "Their sense of humor is wonderful and they still want to please.

There's just something there. They want the teacher to be happy with them."

Slayden obviously was happy with them. Students from many years ago continue to send her e-mails and thank-yous for their time in her classroom. In part, that's undoubtedly because she was a fun teacher. As when she recounts her recent ride in a hot air balloon. The school had the opportunity to bring a ReMax Education Program balloon for students to see, she explained, and one teacher could ride in the tethered balloon. The principal chose Slayden to take the short trip before the entire student body.

"I climbed in the basket," she said, "and up we went. But someone forgot to tie the rope to the truck. As we went higher, one teacher caught a rope and tried to hold it, but the rope burned his hands and he had to let go. I just turned to the operator and said, 'Field trip!'"

Slayden said math and social studies were her favorite subjects to teach. She helped to co-author the school's shipwreck curriculum and served on the School Improvement Committee assisting in writing its mission statement. She's also remained an active member of Delta Kappa Gamma, a sorority for women in education.

As a teacher who arrived at her classroom about an hour before school started each day and stayed late each afternoon, Slayden joked that in her retirement she plans to "ignore the alarm clock."

In reality, she's far too active for that. She and her husband, who have traveled several portions of the United States and as far as Nova Scotia on their motorcycle, plan to tour the western states. "It was always too hot to do it in the summer," she explained.

Slayden also plans to continue the stained glass projects she works on along with her collections of lady's hat pins and flower frogs.

Although she feels the time is right for her retirement, Slayden said she will miss interacting with her students. "It's exciting to see the spark in their eyes when they finally get something," she said. "You'll be working and working on a subject and they'll say 'Oh! Now I see.' It's so much fun to watch."

Her affection and understanding of her students is evident in her various philosophies of education. "I don't believe in homework," she added. "Kids need to be kids. They need that time to relax, they work so hard in the classroom."

She feels a real affection for the school she's gone to for so many years, as well. "Our parents and the com

# Alcona Quilt Trail exceeds goal

## with help from community and grants

When you finish a project called "Stitching Together A Community" any quilter would tell you, you tie the final knots and tidy up the edges.

The Alcona County Quilt Trail Project group has done just that, entering their third season of existence.

The group's original goal was to have two of the eight foot by eight foot wooden quilt blocks mounted on locations in each township in order to include the entire county along the trail. They've exceeded the original goal, placing at least two in each township for a total of 28 quilt blocks.

A map of the trail showing the location of each block has been printed and is avail-

able at Hollyhock Quilt Shoppe and other area businesses.

To bind the edges of Michigan's first and longest quilt trail, the group is in the process of creating replicas of the Alcona County Quilt Block, "Fish, Forests and Fun" to be placed at the county line in each of three directions, making individuals entering the county aware of the trail.

The trail project got its start in 2008, when an economic development class from Michigan State University researched and presented information on quilt trails throughout the country to a group of interested Alcona County residents. Since that time, groups have begun projects in Osceola County, currently with 10

blocks and in the Cadillac, Mich. area, where three blocks went up last fall.

The Alcona group was fortunate, president Cindi VanHurk said, to receive two grants for the project. Those included a \$1,500 grant from the National Quilting Association for materials and a grant of more than 96 colors of paint from Behr Process Corporation of California.

She noted that the group also received yearly donations from the East Shore Art Guild currently operating a gallery in the Harbortown Marketplace on Main Street. "That collaboration has helped so much," she said, adding that one artist from the guild is in the process of producing greeting cards featuring paintings of each of the quilt blocks.

VanHurk is at work on the last of six miniature fabric reproductions of the 28 existing blocks to complete the display at Hollyhock Quilt Shoppe. Kits to recreate each of the blocks are also available, with all proceeds going to the Quilt Trail Project and donations are still being accepted.

Officers of the Quilt Trail Committee include VanHurk, vice president Bill Thompson, secretary Bonnie Wichtner-Zoia and treasurer Denise Hartz.

munity of Ossineke are so supportive of the school," she said. "It's a wonderful place to teach."

During her time in education, Slayden has seen things change from early mimeographed hand-outs to shared on-line visits with students in classrooms across the United States. Still, the most important thing remains bringing that sparkle to the students' eyes in Room 205. "I always tell the kids at the beginning of each year that I unofficially adopt them," she said. "When I tell them the classroom rules, I say 'When they criticize you (for misbehaving) they're looking at me, because you are my kids...' If you can just touch one kid," she said, "It's such a great feeling."

Based on that philosophy, Slayden should walk through the doors of Sanborn School into retirement feeling her time was worthwhile, indeed.

## Smart ways to protect against melanoma

Dear Savvy Senior,  
Is melanoma hereditary? My dad died of it a few years ago at age 71, and I don't want to follow in his footsteps. What can I do to guard against this deadly skin cancer?

Sun Screened Cindy

Dear Cindy,  
While long term sun exposure and sunburns are the biggest risk factors for melanoma, your genes can definitely play a role too.

Each year, about 65,000 Americans develop melanoma - the deadliest form of skin cancer. While anyone can get it, those most often diagnosed are Caucasians, age 50 and older. And those most vulnerable are people with red or blond hair, blue or green eyes, fair skin, freckles, moles, a family history of skin cancer and those who had blistering sunburns in their youth.

The best way you can guard against melanoma and other skin cancers (basal and squamous cell carcinomas), is to protect yourself from the sun, and if you're over age 50, get a full-body skin exam done by a dermatologist each year. Self-examinations done every month or so is also a smart way to detect early problems. Check your entire body, and be on the lookout for new growths, moles that have changed, or sores that don't heal. For self-examination tips and actual pictures of what to look for see [skincheck.org](http://skincheck.org).

Even though you can't change your skin or family history, you can control your sun exposure. Here are some tips and products to help, and remember, it's never too late to start protecting your skin:

- Stay in: Avoid the sun when possible from 10 a.m. to 4 p.m. when the ultraviolet (UV) rays are most intense.

- Use sunscreen: Be sure to choose a "broad-spectrum" product that provides UVA and UVB protection and has a SPF (sun-protection factor) of at least 30. If you don't like the rub-on lotions, try the continuous spray-on sunscreens which are easier to apply and reapply and less messy.

- Sun pills: There's a non-prescription sun-pill on the market called Heliocare that provides additional UV protection. The pills are intended

to supplement sunscreen, and are sold at drugstore chains for about \$60 for a bottle of 60 pills.

- Cover up: Thick or tightly woven cloths can help prevent the sun's rays from reaching your skin or you can purchase a variety of lightweight clothing and hats that offer maximum UV protection in their fabric. Coolibar.com and sunprecautions.com are good places to find such products.

- Wash-in protection: SunGuard laundry additive ([sunguardsunprotection.com](http://sunguardsunprotection.com)) is another option that allows you to wash an invisible shield of sun protection right into your clothes.

- Monitor yourself: Oregon Scientific Inc. ([www2.oregon-scientific.com](http://www2.oregon-scientific.com)) sells a handy UV monitor for \$24 that will warn you when you've had enough sun exposure. Or,

you can check sites like [epa.gov/sunwise](http://epa.gov/sunwise) which provides UV Index ratings where you are.

- Wear sun shades: Sunglasses with UVA and UVB protection can help prevent cataracts and macular degeneration along with melanoma of the eye and skin cancer around the eyelids.

If melanoma is caught and treated early, it's nearly 100 percent curable. But if it's not, the cancer can advance and spread to other parts of the body, where it becomes hard to treat and can be fatal. Standard treatment for melanoma is surgical removal. In advanced cases however, chemotherapy or radiation may also be used.

Savvy Tip: In the spring and summer, there are a variety of places that offer free skin cancer screenings. Check with the American

Academy of Dermatology -- (888) 462-3376, [aad.org/public/exams/screenings](http://aad.org/public/exams/screenings)) which offers free screenings done by hundreds of volunteer dermatologists across the U.S. You can also find free screening through the American Society for Dermatologic Surgery ([asds.net/skincancerscreening.aspx](http://asds.net/skincancerscreening.aspx)), and the Skin Cancer Foundation ([skincancer.org](http://skincancer.org)).

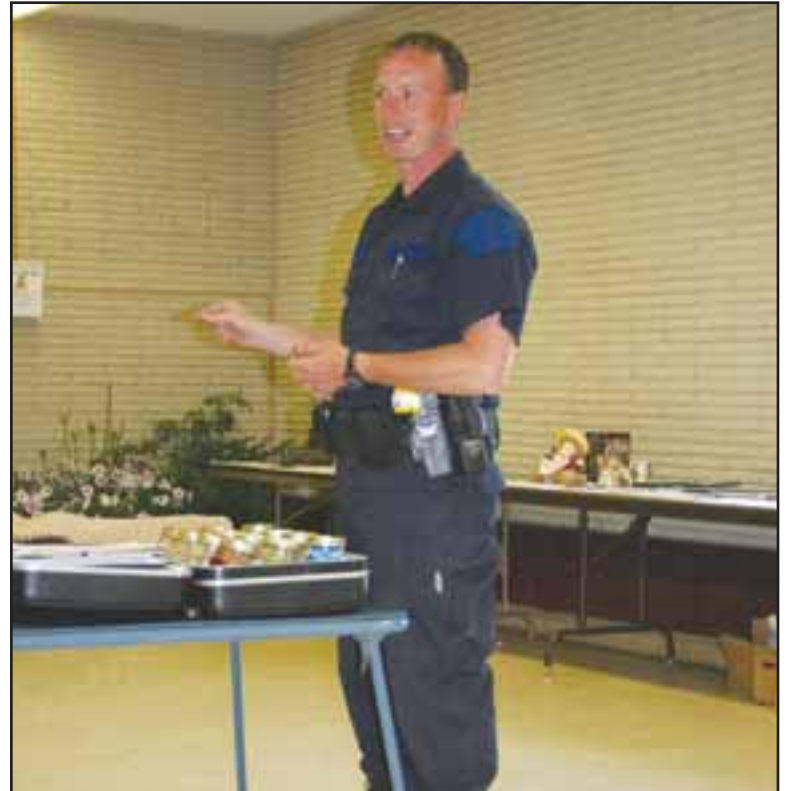



Arizona Bill 1070 -- what is  
it and why has it split this  
great nation of ours into two  
warring camps?

Speaking of war, some  
people are ready to declare it  
on the state of Arizona and  
send their legislature and gov-  
ernor away "in irons." They  
say the law is racist and dis-  
criminates against a Mexican  
minority. Others are saying

only thing it says about the  
"appearance of a person,"  
which is the thing that seems  
to be driving the biggest critics  
crazy, is the very clear state-  
ment that no one shall be  
asked for this proof if the sus-  
picion is based on race or color.  
And that warning appears  
twice -- as if there was a real  
effort to emphasis this point.

It has been suggested that  
the police will bend those two  
words "reasonable suspicion"  
to fit their needs and circum-  
stances. But does that seem  
likely in a society where litiga-  
tion about hot coffee has made  
millionaires out of poor  
people? Let's face it, three  
people walking down the street  
in Tucson, Ariz. does not con-  
stitute "reasonable suspicion"  
and I don't think a cop is going  
to jeopardize his career by ap-  
proaching them.

But if he is stupid enough  
to do it anyway, those three  
guys will become instant mil-  
lionaires no matter what na-  
tionality they are. If, on the  
other hand, those same three  
guys are observed climbing  
up the banks of the Rio Grande  
in soaking wet clothes, I think  
they are in trouble even if their  
skin is purple.

One thing of note is that  
most of the bill pertains not to

the illegal aliens themselves  
but to the procedures and  
punishments for people, who  
harbor, employ or transport  
them and of course these  
people could very well be legal  
citizens of the state. But even  
in prosecuting those people,  
there was a warning about  
race and color profiling.

So all in all I guess I don't  
see what all of the "hullaba-  
loo" is about. Arizona has a  
horrendous problem that's  
resulting in their citizens be-  
ing murdered, kidnapped and  
harassed by a segment of their  
population that is in their state  
illegally and therefore are  
criminals. And it's costing  
them an outrageous amount  
of their money. Nothing has  
been done to help them at the  
federal level either by the  
Republicans and Bush or by  
the Democrats and Obama.

people of Arizona simply felt

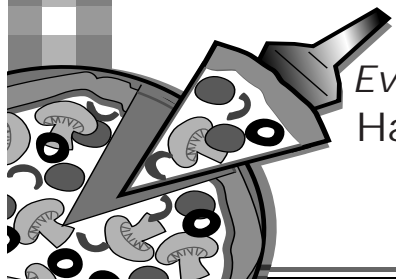

# Fire danger is very high across northern Michigan

The Michigan Department of Natural Resources and Environment (DNRE) warns Michigan citizens and visitors that wildfire danger is expected to be very high across northern Michigan this Memorial Day weekend. The holiday weather forecast is predicted to be warm and dry.

"Southern Michigan has lower fire danger helped by recent rains; however, needle moisture readings that are used to monitor fire danger remain critically low creating concerns for the pine forests of the north," said Lynne Boyd, chief of the DNRE's Forest Management Division. "Low fuel moisture allows crown fires to develop, which is what spread flames rapidly through tree tops on both the 8,500-acre Meridian Boundary fire in Crawford County and 1,039-acre Range 9 fire in Kalkaska County last week."

The result of these two fires was more than just burned trees and a scarred landscape; they destroyed people's homes, cottages, garages and personal property. In the Meridian Boundary Fire, 14 residences were destroyed and 48 outbuildings were either damaged or destroyed.

So far this fire season, the DNRE has responded to 264 wildfires consuming 11,051 acres, where 86 structures

— 18 residences and 68 outbuildings — have been destroyed.

Paul Kollmeyer, DNRE wildfire prevention specialist, confirmed most wildfires can be traced back to people's carelessness when using fire.

Most wildfires are started by careless leaf burning and abandoned campfires. Other negligent reasons include discarding barbecue ashes, torching insect nests and setting off fire works in wooded areas.

"Whenever the weather is dry during holiday weekends we respond to a lot of human caused fires; increased outdoor activity coupled with forest fuels igniting easily is a mixture that elevates the chances a wildfire will get started," Kollmeyer said.

Kollmeyer urges everyone to be extremely careful with any fire.

- Keep campfires small,

and never leave them unattended at any time. It is not enough to wait for a campfire flame to die down and assume it is then okay to leave or go to bed.

- Use plenty of water, stir, and add more water until everything is wet and no steam is produced. Turn over charred logs and wet the underside.

- Be sure barbecues are completely extinguished. Soak unburned pieces of charcoal in a bucket of water before disposing of them.

"Remember that if you don't take adequate precautions and the fire escapes to become a wildfire, it can cost you suppression expenses and any damages resulting from the fire can be billed back to you," Kollmeyer said. 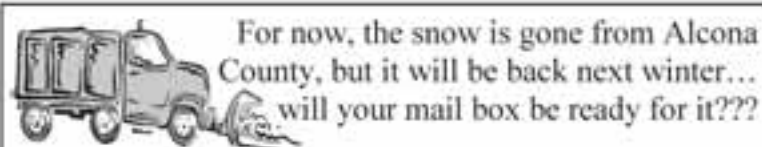
