# Local dancers perform holiday program

Northeast Academy of Dance directors Scott Heinrich and Giuseppe Canale have set about to create an evening of dance that includes the second act from the ballet "Swan Lake"" and "Iphigenia in Tauris," a dance, theater, comedy based on the Greek writer Euri-pides' tragic play by the same name.

The Northeast Academy of Dance will present "At Water's Edge-Two Tales" featuring Act II from "Swan Lake" and "Iphigenia in Tauris" on Saturday, Dec. 10 at 7 p.m., Sunday, Dec. 11 at 3 p.m. at the Oscoda High School auditorium and on Saturday, Jan. 7, 2012 at 3 p.m. at the Standish-Sterling Central High School auditorium.

"Swan Lake" is a timeless ballet fable that centers on a

prince who must find a bride. Feeling no love for the princesses at a party his mother, the queen, throws for him, he ventures out into the woods by a lake with his new bow and arrow. There he meets the Swan Princess, Odette, who has been put under a spell by the evil magician Von Rothbart. The prince falls madly in love with her, and a good thing too, because the only way her spell can be broken, is with true love. But Von Rothbart tricks the prince with his daughter, Odile, who is the black swan, making him think she is the same princess.

Originally performed in 1877, the ballet was later rechoreographed by Marius Petipa and Lev Ivanov with music by the legendary Peter Ilyich Tchaikovsky, into the four act version we know today.

Heading up the cast for this part of the program is Haley Gombos of Harrisville as the Swan Princess, a junior attending Alcona High School. Also in the cast are Kula Batangan of Ann Arbor, Mich. as the Prince, and Cathy Kappius and Margaret Rush, both of Oscoda as the Queen and the Prince's Grandmother. The Corps of White Swans are Cassidy Cooper of Harrisville, Savanna Decker of Standish, Mich., Amanda Denney of Tawas, Emily Freel of Tawas, Grace French (also the Black Swan) of Okemos, Mich., Tahlia Heidt of Tawas, Jessica Holmes of Lansing, Mich., Ginger Neslund of Ann Arbor, Mich., Kali Skodack of Oscoda and Esmeralda Zamorano of Oscoda.

The second part of the program is the dance theater work "Iphigenia in Tauris." Written sometime between 414-412 B.C. by the Greek writer Euripides, this tragic play picks up after the Trojan War. Using as the main music score, Christoph W. Gluck's opera by the same name, dancers and actors revolve around the two main characters, Iphigenia and Orestes, and their journey to an eventual happy end.

As each character laments his or her personal misery, actors Mike Denney and Diane Ray, both of Tawas, narrate the story's complexities, commenting on how the gods love to interfere with and manipulate the lives of humans. Keeping everyone in check, however, is a feisty and dramatic Greek chorus played by Jessica Cummings of Oscoda, Mackenzie Decker of Stand-ish, Mich., Emily Lockenour of Oscoda. Samantha Miller of Oscoda and Megan Pintar of Tawas.

Heading up the cast are Kali Skodack as Iphigenia and Kula Batangan as Orestes. His sidekick, Py-lades, is performed by Heinrich and the evil king of the Scythians (Thoas) is performed by Charles Shuart of Tawas.

Iphigenia's priestesses are Cassidy Cooper, Amanda Denney, Savanna Decker, Haley Gombos, Emily Freel, Grace French, Tahlia Heidt, Jessica Holmes, Ginger Neslund and Esmeralda Zamorano. Greek and Scythian armies will be played by Benjamin Beren-kowski of Oscoda, Kaitlyn Indreica of Tawas, Haley Lingo of Oscoda, Sydney Lopez of Oscoda, Sarah Morton of Tawas, Charleson and Chelewynne Shuart of Tawas and Danielle Velasco of Oscoda.

Admission for the Oscoda performances is \$12 for adults, \$10 for seniors and \$5 for students; admission for the Standish performance is \$10 for adults and seniors

# Snowy owls irrupt to lower 48 states

During the past few weeks numerous sightings of this arctic dweller have been reported in Michigan and all along the northern tier states of the U.S.

The most recent sighting in the area was at Tawas Point on December 2. Peggy Allen took a photograph of a snowy owl in the early morning at the point when she spotted the bird perched in the top of a pine tree.

Often when food sources are scarce, or there is unusual competition for meals, these birds will migrate south enabling them to find additional food habitat. This is known as an "irruption."

There are almost two times as many observed this year already," said Roger Eriksson, a photographer who lives in Iosco County. "I missed the one at the AuSable rivermouth last week by seconds," he said. "I was driving away in my car and was unable to hear the birder next to me pointing it out as it crossed the river and headed north....talk about frustrating moments.

Several other "irruptive" species have also been reported by birders. These include pine siskins, snow buntings and red crossbills.

"I think we're in for a severe winter, as these birds are often indicators of what the weather holds in store for the coming months," said Peggy Ridgway, member of the AuSable Valley Audubon. "Many of these species were

observed unusually early in the season this year and birders are keeping a close eye on the numbers. Our upcoming

# Sturgeon River strain brown trout show promise

Natural Resources (DNR) Fisheries Division electrofishing surveys below Hodenpyl Dam on the Manistee River and on the Au-Sable River below the dam at Mio produced vastly different results, though they did have a couple of common characteristics.

Fisheries crews turned up more than 800 trout during a half-day survey with two shocking boats on the Au-Sable, in a stretch that has come to be dubbed "the trophy water" because of the large trout there.

On the Manistee, two shocking crews turned up just over 100 trout.

But the crews did find some unusually large brown trout in both river stretches and they found something else they were looking for - good survival of Sturgeon River strain brown trout, something biologists hope bodes well for the future of brown trout fisheries in Michigan.

Fisheries Division, discouraged by relatively low return rates from stockings of brown trout in recent years, began stocking a different strain of browns - the Sturgeon River strain - in 2010. The Sturgeon River strain brood stock was collected from wild trout out of the Sturgeon River in the northern Lower Peninsula whereas other strains are raised from brood stock maintained in hatcheries.

Michigan had been using several other strains of brown trout for its stocking programs over the years - most notably wild rose and seeforellen - but the DNR has seen relatively poor recruitment into the fishery in its Great Lakes and inlandlake stocking programs. Biologists wondered if going to a different strain would help.

Research biologist Todd

Recent Department of Wills said Fisheries Division identified the Sturgeon River strain as a potential replacement for the seeforellens in both the Great Lakes and inland lakes. But when fisheries biologist Steve Sendek who works out of Grayling and is responsible for the Au-Sable River - heard about the idea, he suggested that Fisheries Division stock the new strain (along with equal numbers of wild rose browns) in the tailwater fishery below Mio, too.

> Fisheries biologist Mark Tonello, who is responsible for the Manistee River, seconded the motion. So Fisheries Division stocked both strains in the river stretches, marking them with different fin clips.

In the Manistee River, the marked brown trout collected by electro-fishing during the recent survey were all the same strain.

"We only found Sturgeon River fish," Wills said. "We did not see any wild rose fish not a one.

The overall catch of trout was very low," he continued. "It's encouraging to see the Sturgeon River browns - and it leads us to believe that they did better than the wild rose browns - but with the catch as low as it was, it's difficult to make any firm conclusions."

That the catch was low was not entirely surprising as the Manistee River below Hodenpyl is marginal trout water and during the summer of 2011, the area suffered through the hottest July on record. Under those adverse conditions, a low survival rate of stocked trout is not unusual.

Although the catch was much better below Mio, the marked Sturgeon River fish recovered by the shocking

crew far outnumbered the wild rose strain.

"There's no question that below Mio, the Sturgeon River brown trout are doing better than the wild rose strain," Sendek said. "We found about five times as many Sturgeon Rivers as wild roses and not just young-of-the-year fish; it looks like the Sturgeon River fish carry over from year to year better than the wild rose, too."

Sendek said he is encouraged by what he's seen so far.

"Since the Sturgeon River fish are a wild strain, they're a little harder to work with than the wild rose, which is a domesticated strain," Sendek said. "They come out of the hatchery smaller than the wild rose fingerlings, but they catch up.

"I'm looking for the fishery below Mio to not only keep going, but get better," he continued. "With year-round fishing now and new regulations, this could be a win-win situation. This fishery is very special. And we can't count on natural reproduction to sustain that fishery because of the influences of the dam. Stocking is going to be an important part of maintaining that fishery.

"I'm very optimistic about the future with the early results. I'm hoping this will revitalize all of our brown trout fisheries – we just have to learn how to utilize this new tool."

Wills said that the AuSable probably has better ground water resources than the Manistee and therefore would probably provide more cold-water sanctuary areas for trout during a hot summer.

"In addition to warming caused by the dam, the Hodenpyl stretch of the Manistee has a lot of clay soils and that's not good for groundwater movement," he said

And although the survey results are not complete, "it appears from the data we have now that the Sturgeon River strain browns are doing better in the tailwater fisheries – the AuSable and the

Manistee – than the wild rose," Wills said.

As for the lake portion of the study, it's too soon to tell, he said.

"We are not seeing a large return from any of the marked fish in the inland lakes we've stocked," Wills said. "To date we've seen more wild rose fish, so the wild rose strain seems to be doing better. However, some of the lakes that we stock are difficult to sample with our survey gear, so we're working with local fisheries managers to obtain reports from anglers to supplement information we collect in the field.

"We've also stocked Sturgeon River and wild rose strain fish in Lake Michigan, but our creel clerks haven't seen any returns so far. Brown trout returns in Lake Michigan have been pretty low in general, and these fish may still be a little smaller than those typically harvested and reported by anglers," Wills said. "We'll see what happens."

# Assistance dogs can make life easier for seniors in need

Dear Savvy Senior,

Can assistance dogs help seniors with physical limitations? My mother, who's 60, has progressive multiple sclerosis and I'm wondering if an assistance dog could help make her life a little easier. Dog Loving Linda

Dear Linda,

For people with disabilities and certain medical conditions, assistant dogs can be fantastic help, not to mention they provide great companionship and an invaluable sense of security.

While most people are familiar with guide dogs that help people who are blind or visually impaired, there are also a variety of assistance dogs trained to help people with physical disabilities, hearing loss and various medical conditions.

Unlike most pets, assistance dogs are highly trained canine specialists - usually golden and Labrador retrievers, and German shepherds - that know approximately 40 to 50 commands, and are amazingly well-behaved and calm. Here's a breakdown of the different types of assistance dogs and what they can help with.

• Service dogs: These dogs are specially trained to help people with physical disabilities due to multiple sclerosis,

spinal cord injuries, Parkinson's disease, chronic arthritis and many other disabling conditions. They help by performing tasks their owner cannot do or has trouble doing, like carrying or retrieving items, picking up dropped items, opening and closing doors, turning lights on and off, assisting with dressing and undressing, helping with balance, household chores and more.

• Hearing dogs: For those who are deaf or hearing impaired, hearing dogs can alert their owner to specific sounds such as ringing telephones, doorbells, alarm clocks, microwave or oven timers, smoke alarms, approaching sirens, crying babies or when someone calls out their name.

 Seizure alert and response dogs: For people with epilepsy or other seizure disorders, these dogs can recognize the signs that their owner is going to have a seizure, and provide them with advance warning, so he or she can get to a safe place or take medication to prevent the seizure or lessen its severity. They are also trained to retrieve medications and use a pre-programmed phone to call for help. These dogs can also be trained to help people with diabetes, panic attacks and various other conditions.

If you're interested in get-

ting your mom a service dog, contact some assistance dog training agencies. To find them, Assistance Dogs International provides a listing of around 75 U.S. training agencies on their website that you can access at assistancedogsinternational.org. After you locate a few, you'll need to either visit their website or call them to find out the types of training dogs they offer, the areas they serve, if they have a waiting list, and what upfront costs will be involved. Many agencies offer dogs for free, and others may charge several thousand dollars.

To get an assistance dog, your mom will need to show proof of her disability which her physician can provide, and she'll have to complete an application and go through an interview process. She will also need to go and stay at the training facility for a week or two so she can get familiar with her dog and get training on how to handle it.

#### StarWatch By Gary Becker - Dark Days of Winter



Let me get this off my chest. I HATE WINTER! It's not so much the wind and the cold or the fact that I keep my study cooler to save a little on energy. It's all of that darkness, the long winter nights that drive me bonkers. As a positivist who tries to view the glass half full, there is a faint glimmer of hope in the air. The earliest sunset will be occurring this week is on the 8th to be precise. For my earthly location, sundown will be happening at 4:34 p.m. After that date, the sun goes down later, not much later at first, but then picking up speed so that by mid-January people start noticing the effect. This does not mean

that December 8 is the shortest day of the year. That happens two weeks later on the 22nd when the time between sunrise and sunset is at its shortest. This is known as the winter solstice. The latest sunrise happens on January 5 when coincidentally the Earth is closest to the sun. The reason why earliest sunsets and latest sunrises do not take place on the shortest day of the year is because timekeepers follow the motion of a fictitious or mean sun which moves uniformly over Earth's equator. The eastward motion of the real or apparent sun varies from day to day because Earth revolves in an oval shaped orbit. This makes the sun change its position fastest in the winter and slowest during the summertime. In addition, the Earth's axial tilt causes the sun to move northward after the winter solstice and southward beyond the summer solstice. This slows the eastward motion of the sun against the stars which is created by the orbiting Earth. The result is that the real sun gets ahead of or behind the mean sun which is the time kept by the government and our house clocks. Currently, the real sun reaches noontime seven minutes ahead of the mean sun, causing sunsets to occur earlier than expected, with the earliest sunset occurring on Thursday. www.astronomy.org



# Fine-tune finances before year's end

**By David Uffington** 

The quiet week at the end of the year is a good time to review finances and make any needed changes before the New Year.

Tax deductions: The trick is to balance payroll deductions with the taxes you'll owe in April so that you come out with nothing due and no refund. If too much money is taken out, you're essentially giving the government an interest-free loan. Instead make the changes to your W-9 form and put that extra money from each paycheck into a savings account.

The biggest event that should make you review your deductions is buying a house. You'll get a mortgage interest statement (Form 1098) for the interest you paid, which can become a deduction on the Schedule A of your tax forms if you itemize. (You'll also be able to claim the property taxes you've paid.)

If you can, make a 13th mortgage payment in December to add to the amount of the mortgage in-

Better savings interest rate: If your emergency fund is safely in place, likely in a savings account, considering putting further savings into a CD or money market account. You'll get a bit more interest, and the money is still easily accessible in case of an emergency.

Health Savings Account: If have a high deductible on your medical insurance, investigate putting money into a Health Savings AcHSA is tax-preferred, which means that it's not taxable when earned. Balances roll over from year to year, and the only stipulation is that it be used to pay medical expenses. "High deductible" is defined as \$1,200 for yourself or \$2,400 for family coverage for 2011. Go online to irs.gov and look for IRS Publication 969 for more details about how much you can contribute.

If you're self-employed, stock up on the consumables you normally use. Those become a business expense that you can deduct. If you'll likely need a new computer soon, or telephones, consider buying those before the end of the year.

If you've planned to make charitable donations, do it now. It's a deduction on the Schedule A if vou itemize.

Invest in an early copy of the 2011 tax software and run the numbers. This will help you fine tune your year-end strategy.

# Make it easy on your survivors

Do you keep your service files organized? Most of us don't, unless pushed. But here's something to consider: Can your family easily find what it needs to handle your affairs if something happens to you?

Here are a few documents your family will need to lay their hands on quickly:

-Your DD214 or service equivalent. If you don't have your discharge papers, send for them.

-A list that includes Social security number, branch of service, dates of service, date and place of birth. Include all the places you were stationed, and dates.

-Immunization record, birth certificate and will. (You do have one, right? And it's updated, not one you wrote 20 years ago?) Add your government life-insurance policy, copy of all marriage certificates and divorce decrees and copy of children's birth certificates.

Download online (or send away for) the following blank forms, to be kept in the file: Application for United States Flag for Burial Purposes; Claim for One Sum Payment Government Life Insurance; Claim for Monthly Payments National Service Life Insurance; Application for Standard Government Headstone or Marker.

If you have an ongoing claim with the Department of Veterans Affairs, put all related documents in a separate file, newest at the top. Keep several sheets of blank paper in the file so you can note the date, time and whom you spoke with whenever you call the VA so the information is always current.

Go online to www.vba.va.gov, click Veteran Services, then Survivors. Scroll down and look for any additional information that might apply to you. Send for the appropriate forms. Print out the VA Benefits for Survivors pamphlet and put it in the file, or call the VA (1-800-827-1000) and have one sent to you.

You only need to do this once. When you've assembled and organized your information, you just need to keep it updated.
