## Cooke Dam celebrates 100 years with events

Consumers Energy will host centennial activities on Saturday, June 18 to celebrate Cooke Dam's 100 years of service to Michigan's electric customers.

The celebration includes tours of the Cooke Dam, a historical program about Consumers Energy and the AuSable River dams, and a special AuSable River Queen excursion boat ride focusing on the dams.

The Huron-Manistee National Forest Lumberman's Monument Visitor Center of the River Road Scenic Byway will serve as headquarters for the event. Cooke Dam tours will be conducted from 10 a.m. to 2 p.m. and will begin at the visitor center. Tickets for the tour are free and will be issued at the visitor center where participants will board an Iosco Transit bus for the short ride to the dam. The buses will run continuously to transport visitors to and from the dam. Private vehicles cannot be accommodated at Cooke Dam for this event.

At 1 p.m. at the visitor center pavilion, a presentation on the history of the AuSable dams and Consumers Energy will be provided by Jim Bernier. The day's events conclude with the special AuSable River Queen excursion leaving from Footesite

Park on River Road at 3 p.m. "Renewable hydro power remains one of Michigan's most important homegrown energy sources to serve the needs of customers," said Jim Bernier, senior natural resources manager for Consumers Energy's hydro generation unit. "We're proud and pleased that Michigan has been able to count on this reliable, renewable energy for a century and that Cooke Dam and the other AuSable River dams will con-

## Commission lifts deer baiting ban -- except in DMU 487

The Michigan Natural Resources Commission (NRC) voted 4-3 on June 9 to lift the current deer baiting and feeding ban in the state's Lower Peninsula. The ban had been in place since 2008, when Chronic Wasting Disease (CWD) was detected in a deer at a private deer breeding facility in Kent County.

Baiting will still be prohibited in Deer Management Unit (DMU) 487, the six-county Bovine Tuberculosis zone in northeastern Lower Michigan. The counties where baiting will continue to be prohibited are Alcona, Alpena, Iosco, Montmorency, Oscoda and Presque Isle.

The NRC approved a proposal to allow baiting in limited quantities from October 1 to January 1, 2012. Hunters may place any type of bait, no more than two gallons at a time, across a 10-foot by 10-foot area per hunting location.

The NRC also reinstated recreational feeding of deer

in the Lower Peninsula, with the exception of DMU 487. Property owners may place two gallons of bait on their property within 100 yards of their residence year-around.

The NRC also placed a three-year sunset on the regulations, which means it will reconsider the baiting issue again in 2014.

In 2008, the Michigan Department of Natural Resources announced it had detected the state's first case of CWD in a three year-old female deer at a private deer breeding facility in Kent County. At the time, the DNR followed protocol as outlined in the state's emergency response plan for CWD and immediately banned baiting and feeding of white-tailed deer in the Lower Peninsula. The NRC then passed regulations making the ban permanent, but said it would reconsider the ban in three years, giving the DNR adequate time to perform dis-

ease testing and surveillance in the state for CWD.

In the three year period, the DNR tested thousands of white-tailed deer for CWD, but did not detect another case.

The NRC also directed the DNR to work with the legislature to strengthen the penalties for baiting violations. A potential bill sponsor has been identified who supports establishing an escalating scale of penalties for repeat offenders, which would include mandatory hunting license revocation.

If hunters do use bait, the DNR requests they not place bait repeatedly at the same point on the ground, and only place bait out when they are actively hunting. This may minimize the chance of direct and indirect exposure of deer to any unknown disease that may be present.

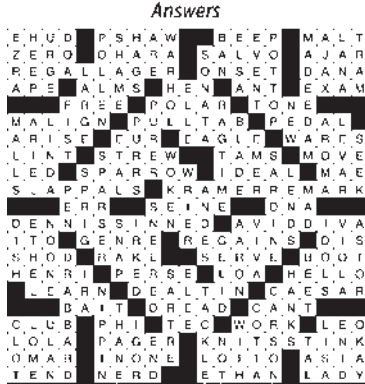

tinue to serve customers in the future."

After the Cooke Dam entered into commercial operation in late 1911, Five Channels Dam came on line in 1912 and Loud Dam followed in 1913.

## How work can affect your Social Security

Dear Savvy Senior,  
I'm looking at retiring sometime this year and starting my Social Security benefits, but would also like to work part time. Will this affect my benefits, and if so, how much?

Social Insecurity

Dear Insecurity,

You can collect Social Security retirement benefits and work at the same time, but depending on how old you are and how much you earn, it can cost you temporarily.

Social Security says that if you're under your full retirement age (which is 66 if you were born between 1943 and 1954; if not, see [ssa.gov/pubs/ageincrease.htm](http://ssa.gov/pubs/ageincrease.htm) to find your full retirement age) and are collecting benefits, then you can earn up to \$14,160 in 2011 without jeopardizing any of your Social Security if you don't reach your full retirement age this year. But if you earn more than the \$14,160 limit, you'll lose \$1 in benefits for every \$2 over that amount.

In the year you reach your full retirement age, a less stringent rule applies. If that happens in 2011, you can earn up to \$37,680 from January to the month of your birthday with no penalty. But if you earn more than \$37,680 during that time, you'll lose \$1 in benefits for

every \$3 over that limit. And once your birthday passes, you can earn any amount by working without your benefits being reduced at all.

Wages, bonuses, commissions, and vacation pay all count toward the income limits, but pensions, annuities, investment income, interest, and government or military retirement benefits do not. To figure out how much your specific earnings will affect your benefits, see the Social Security Retirement Earnings Test Calculator at [ssa.gov/OACT/COLA/RT-effect.html](http://ssa.gov/OACT/COLA/RT-effect.html).

It's also important to know that if you do lose some or all of your Social Security benefits because of the earning limits, they aren't lost forever. When you reach full retirement age, your benefits will be recalculated to a higher amount to make up for what was withheld. For details and examples of how this is calculated, see [ssa.gov/retire2/whileworking3.htm](http://ssa.gov/retire2/whileworking3.htm).

You also need to factor in Uncle Sam. Because working increases your income, it might make your Social Security benefits taxable.

Here's what the IRS says. If the sum of your adjusted gross income, nontaxable interest, and half of your Social Security benefits is between \$25,000 and \$34,000 for individuals (\$32,000 and



\$44,000 for couples), you have to pay tax on up to 50 percent of your benefits. Above \$34,000 (\$44,000 for couples), you could pay on up to 85 percent, which is the highest portion of Social Security that is taxable. About a third of all people who get Social Security have to pay income taxes on their benefits.

## Paying for retirement is major concern

More and more of us are concerned about how we're going to pay for retirement, or whether we can retire at all, especially as the economy has soured. The Society of Actuaries recently issued a report entitled "The Impact of the Economy on Retirement Risks" about how we're handling our fears.

Here are some facts its survey uncovered:

- Nearly half of those polled who have not yet retired are very concerned about retirement finances, much more so than ever before.

- Two-thirds of retirees surveyed say their finances are worse than before the economy took a downturn, with a quarter saying "much worse." For those not yet retired, the figures are even higher. Those who banked on having return from investments have suffered from low interest rates, and those who considered their home a "nest egg" for retirement money are hard hit.

- A quarter of retirees fear they might need to return to work, while two-thirds who haven't retired think they'll need to work longer.

- People who haven't yet retired have more concerns

than those who have already retired. The major concerns are paying for long-term health care, the falling value of investments, running out of money, inability to maintain a standard of living and not having anything to leave to heirs.

- Seniors have more debt than they expected to have at retirement. But if there's a retirement strategy the majority agreed on, it's this: Get rid of consumer and mortgage debt before retirement by paying off credit cards and cutting back on spending for gifts, vacation and restaurants.

# How not to clean a pond

It seemed like a good idea at the time. Several years ago when we first acquired our mosquito farm in the north woods, all my husband, Willy, wanted to do was clean out the backyard pond. I'm not even sure it ever was a pond to begin with, just a small swampy area where cattail had grown so thick barely a pollywog was seen amongst the rooted muck.

With no tractor or bull dozer, Willy's brain was in overtime considering his options. He did have a four wheeler with a small snow plow and a garage full of this and that.

Willy's first wheel in motion was a hasty decision to just plow through the swampy land. He did manage to send mud and ooze flying, but unfortunately with the mud and ooze came two buckets of minnows that were dumped in the pond area after a failed fishing attempt the month before.

With the little minnows gasping and flopping in the mud, my sister and aunt, who were visiting with us that weekend, immediately went into action to save the poor minnows. Wading through the pond muck we began picking up the three inch fish and dumping them into a pail of water. Most revived quickly but several were belly up.

Having her own fish aquarium for many years, my dear sister had become accustomed to treating sick or, as she would call it, "depressed" fish.

I had never acquired the "aquarium" gene; so quite frankly, I didn't have a clue as to what a depressed fish looked like, let alone, how to revive a minnow. My only attempt at having fish for pets was a couple of goldfish I won at my fifth grade carnival. I named them "Ofor" and "Petesake" because that is what my mother told me as I asked her over and over again what to name the fish while she was busy cleaning an oven. Apparently in fifth grade I had no idea that my mother couldn't possibly name goldfish while her head was in an oven smelling noxious fumes.

"Ofor" and "Petesake" lasted about a week and a half. They were pretty traumatized fish. It was actually surprising they lived that long considering they'd been sloshed around for an afternoon in a hot plastic baggy before being dumped into a pan of cold chlorinated water (I lived in the city back then, there was no such thing as today's great well water of Alcona County).

My sister, on the other hand, was a natural at aquarium life. She slaved over parenting each fish, first guppies and angel fish and then graduating to more difficult salt water fish.

Occasionally, Poco (or as I liked to call him "Sushi") would become so depressed and despondent that he would try to end it all by taking one great leap into the air and fling himself across my sister's family room. Poco usually landed in a flopping wet mass, just inches from my sister's grasp. The cats, although desiring a meal of Poco, would have rather jumped through rings of fire than get wet from Poco's escape, fleetingly they exited the room in a screeching hysterical flash usually upsetting a lamp or sending something breakable crashing.

On these occasions, my sister would calmly scoop up the fish and throw it back into the tank where she would console and minister to its every need. Poco would recover and swim quietly until he could devise another attempt to commit suicide.

I'm sure it was during this time of trial that my sister found her unique skill as a fish whisperer.

She really had become quite an expert at depressed fish and at that moment there seemed to be a dozen or so very sick, very depressed minnows lying belly up in a pail. 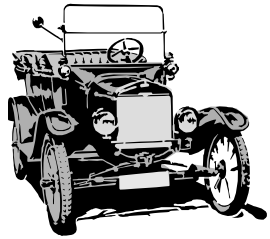
thought for sure he would explode, but he took it in stride - Willy always seems to turn defeat into a stronger urge to conquer.

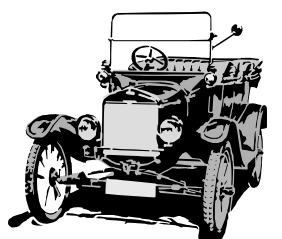
cess riding the can that resulted in dredging some of the muck out. Yippy Yi Ki Yay!

# Summer blood supply low, donors needed at local drives

America's blood supply is an important piece of the country's ability to respond to disasters. By donating blood, people can help prepare for the unexpected and help ensure blood is available when and where it's needed.

"Any disaster, man-made or natural, can result in people being injured and needing blood," said Sharon Jaksa, CEO for the Great Lakes Region of the American Red Cross. "While people often join together to help after a disaster, it's just as important to be organized and

prepared today for when disaster strikes."

Just last month, the American Red Cross responded to devastation in the South and Midwest when Joplin, Mo. was hit with an F5, half-mile wide tornado that leveled a large stretch of the town. An F5 rating on the Fujita Scale is the highest classification for tornado intensity. More than 135 people have been confirmed dead, making it the nation's deadliest single twister since a June 1953 tornado in Flint, Mich.

Couple recent events with typical low donor turnout

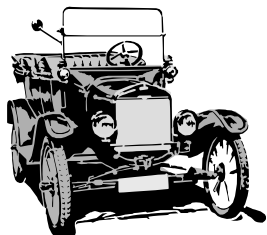

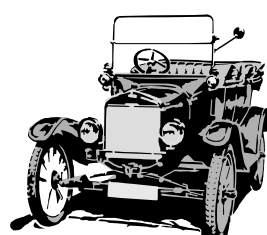

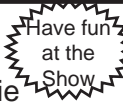

They explained particulars of House Bill 4361, a new law that contains many changes in tax credits and made certain public pensions taxable, including those of most school personnel. Their report emphasized how important it is for citizens to call and express their point of view with their legislators.

Regional director Carol Pratt presented a silver sticker from MARSP recognizing this chapter's participation in various MARSP goals. Acknowledgement was also made of former membership chairperson Lindy

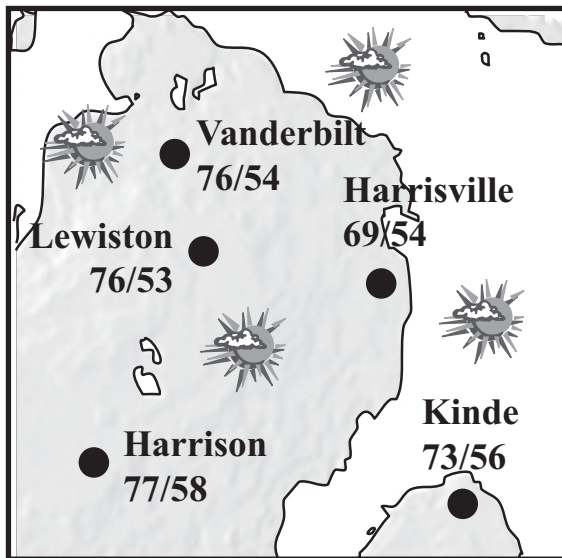

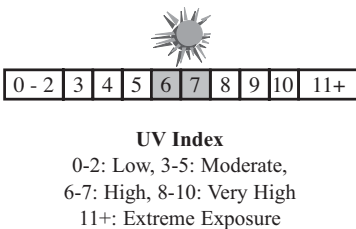

### StarWatch By Gary Becker - Gotcha!

When I was volunteering in Bryce Canyon's Night Sky Team during the summer of 2006, answering questions at the front desk of the Visitor Center was one of my least enjoyed activities. Many queries went like this. "I've only got a few hours to spend in the park. What should I see?" "Well, sir," I often felt like responding, "you've got 90 minutes before sundown, it's going to be raining pretty soon, and several lightning fires have the park closed just up the road. Go down to Zion where it's warmer and sunnier." But then there was the day the French-Canadian hiker came in. When she stood in front of me, I was suddenly 25 again, buff and tan, with a shell choker. She had a rugged, outdoorsy type of beauty, but her eyes told me of another story, one of frustration. There was also a woman in back of her trying to get my attention, but I refused to make eye contact and focused only on her. She needed a backcountry pass. I told her she had arrived too late in the day for one to be issued. Then she pointed to a group of teens lingering near the entrance and told me her story. She was a naturalist from Montreal, bilingual, and hired by an exclusive French touring firm to escort kids, who came from very wealthy families, on a camping trip to the American West. Things were not going particularly well. The teens were not used to material deprivations and her partner spoke no English. My hands went to the forms like a magnet to iron. As we talked, she relaxed and smiled a bit and it became obvious to me that she really was prepared. She asked well-organized questions and knew the camping rules cold. I fantasized about schlepping down the trail that night with my hundred plus pounds of telescope gear to show her the stars, but it really was raining. She departed. I sighed. "Now to that pesky lady," I thought. I looked her straight in the eye and gasped. It was my wild-eyed wife, Susan, that I saw. Gotcha! [www.astronomy.org](http://www.astronomy.org)



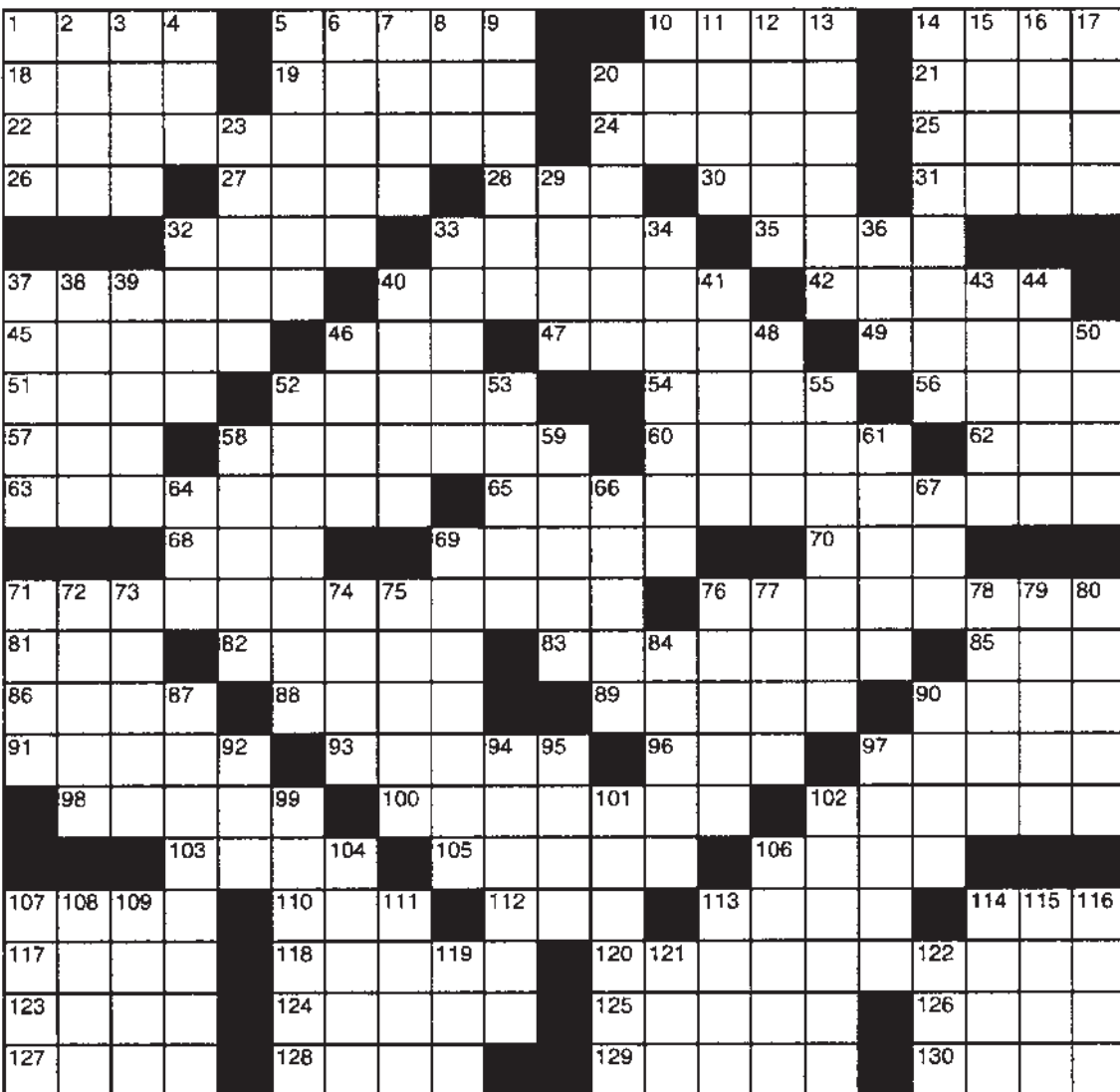

### VILLAGE OF LINCOLN MINUTES

The Lincoln Village Council met on Monday, June 6 at 7 p.m. at the village hall. The meeting opened with the "Pledge of Allegiance." Those present included: President Jordan, treasurer Kossa, clerk Somers, deputy clerk/treasurer Stutzman and council members: Gauthier, Healy, Lask, Naylor, Somers and Stutzman. Also present were several guests and attorney David Cook.

The minutes of the May meeting were approved on a motion from Gauthier, with support from Somers. The treasurer's report was approved, subject to audit, on a motion from Gauthier, with support from Stutzman. Leroy Hall, fire chief, and Scott DuBay attended the meeting to give an overview of activity within the department. Hall stated that the siren has been fixed and is now going off at noon daily. It will also be used for emergency use in case of severe weather et cetera. President Jordan urged the fire department personnel to continue to work on an emergency plan with village residents and members of the Baptist church and senior citizen center to implement the plan.

In public comment time John Vecchione asked about the status of tree cutting along Traverse Bay. Jordan stated that the process is just starting with Consumers Energy and will take about 12 weeks to complete. Ron Kennard spoke about the Memorial Day ceremonies that were held in the village. He thanked those who attended for the nice service. He also stated that a meeting was held for the Brownlee Lake Association on Saturday. A plaque was given to Sue Kennard to express appreciation from the members for her efforts in starting the Brownlee Lake Association.

Kennard stated that the USDA grant funds are no longer available so the group will still need to raise the \$25,000 that the grant funds would have covered. They still need approximately \$17,000 to finish the project. He stated that they are still taking donations from the local community and will welcome any help to reach their goal. Thanks to Ron Kennard for the wonderful flag stand as well as the POW flag. Jordan stated that we will get two new flag poles and a state of Michigan flag. Thanks to Sue Kennard for the frame for the photo of Abraham Lincoln. Sue Kennard stated that there will be a Texas hold-'em tournament to benefit the Brownlee Lake Association.

Evelyn Good, Downtown Development Association (DDA) treasurer, gave a copy of the DDA budget to the council for approval. Jordan thanked Good for her work. A motion was made by Lask, with support from Healy, to adopt the DDA budget for 2011-2012. Carried. Following is the DDA Budget:

Debbie Shaneour stated that a village garage sale will be held over the Labor Day weekend. Donations will be accepted to benefit the Brownlee Lake Association. Persons who are interested in donating to the cause may contact Debbie Shaneour at (989) 736-8346. Jordan thanked members of the community who were at the meeting for the hard work they all are doing. John Klinger, Gustin Township supervisor attended the meeting. He stated that members of his board are looking forward to working with the village on several issues. He said they would be interested in working on ordinances with our planning group. Currently they are working on the Civil War ceremonies to take place in September at the Twin Lakes Cemetery. He is trying to find funding for a sign to honor the soldier. They are hoping to hang the new sign under the current sign at the cemetery. He asked about what is needed to remove lilac bushes around the Gustin Township building. He stated

that they are getting in the way during the winter months with snow removal. Kathy Putsky added that she will be selling tickets for the 50/50 drawing for the lake association in July. She also commented that she thought the Memorial Day service was exceptionally nice.

In old business, Stutzman asked about the status of sidewalk repairs that are needed and have been budgeted for. Jordan suggested waiting until the streetscape work is finished. Stutzman asked about purchasing a tree to use for a village Christmas tree in Railroad Park. He would like to have something that can be decorated every year. Stutzman stated that the Flights of Imagination flower beds are in bad shape. He stated that he is unsure about what to do to get the beds whipped into shape. Jordan stated that two flats of flowers were donated by Harger's Nursery to be planted there. Stutzman offered to spearhead a cleanup there.

Gauthier stated that the dedication for the Everett Schram memorial ball fields is set to be held on July 23 beginning at noon. Further details will be coming soon. She also stated that there are boards that are laying around at the Flights of Imagination. She asked about the status of the pavilion for use for concessions during the summer months. Somers stated that the existing dock at the beach is in bad shape. He will try to get some help to get things fixed in the next few days. Lask stated that she has been in contact with one of the county commissioners regarding the siren and emergency plan for the village. Gauthier asked about the old elevator building and what will be done regarding this. Jordan said that he has asked to have it boarded up and sealed in order to keep people out of it. In its current state it is a hazard.

In new business, Naylor stated that the Masonic Lodge will be hosting an open house to dedicate their new kitchen facility. The event will occur on June 16 between noon and five. Somers will be working on putting up new signs along village streets. He stated that MDOT requirements are that the signs be in place before the end of the year. Stutzman stated that the flyers were delivered to several businesses for the Civil War reenactment that will take place over the weekend of June 18 and 19. Kossa stated that she has concerns about traffic on Barlow Road Park during the event. She asked about blocking one of the drive areas and also about parking vehicles by the Flights of Imaginations area. She asked for direction about how to proceed with blocking things off. Jordan stated that there are several places that could be used for parking vehicles.

Somers will work with Kossa to see what needs to be done to block off the roadways.

A motion to change the Vecchione property from residential to business was made by Lask with support from Healy. Motion carried. Additionally, a recommendation was received that the planning commission be allowed to work with NEMCOG / Denise Cline to write all new ordinances for the village. A motion was made by Healy, with support from Gauthier. Carried. Planning commission chairperson Constance Stutzman brought a recommendation to the council regarding the possibility of having Joan Gonyea rejoin the planning commission. John Vecchione also expressed a desire to join the group. Jordan stated that he felt this would bring the group up to where they need to be. A motion was made by Gauthier, with support from Healy, to accept Joan and John on the planning commission. Carried.

A discussion was held regarding the village's insurance. A three year rate guarantee was received from Lappan Agency along with a 10 percent reduction in premiums. Mr. Lappan was unable to attend the meeting but sent information along to Phil Jordan. A motion was made by Lask to accept the three year insurance guaranteed rate offered by Lappan Insurance to provide insurance for the village. Carried.

Issues regarding the swim area at Brownlee Lake were discussed. Jordan stated that the buoys are going to be put out tomorrow with help from Ron and Sue Kennard. The first dock will be worked on immediately. Jordan stated that he thinks it should be replaced after this swim season. They will see how the new pontoon dock works this year before deciding to purchase another one. John Bernard will be coming yet this week to pull out the poles from the big dock.

Jordan stated that he would also like to have the sign moved from its current location and placed beside the water where it is clearly visible. He said it needs to be located where it can be seen. It is recommended that it be placed in the grassy area just away from the water's edge. Gauthier asked about placing a port-a-john at the beach area for the summer months. Kossa will take care of ordering them. Jordan asked village attorney Cook about what can be done regarding foul language and bad behavior at the beach area. Jordan will speak with Sheriff Doug Atchison about how to enforce the ordinance issues.

Jordan spoke about the Memorial Day ceremonies that took place in the village. He said the wrong dates were published and there was not a lot of participation perhaps due in part to that error. He said next year a committee will take care of

putting together the ceremony. Sarah Healy offered to head up that committee.

President Jordan met with Von Hoffman and Joe James to see about putting in a security system for the Flights of Imagination area. Hoffman has stated that if two poles can be put in place immediately he can work on installing the system. It can be an ongoing process to upgrade it yearly. A motion was made by Gauthier, with support from Lask, to proceed with installing the surveillance system immediately at Barlow Road Park/ bathroom area. Initially there will be four cameras installed. As time goes by it is possible to add on as needed. President Jordan stated that it has been suggested to have the master plan put on the village website. Council members agreed that it would be a good idea to have it accessible for all residents. President Jordan stated that bids need to be advertised for replacing the roof on the village maintenance garage. Dick will put together the specs for advertisement and will put them out for bids to be opened at the next meeting.

Jordan gave an overview of the sewer system and the work that has been done to bring everything up to where it needs to be. He stated that a maintenance schedule is now in place and all tanks are identified and numbered to correspond with the sewer customer's name/number.

A motion was made by Gauthier, with support from Healy, to put the delinquent people that are on the sewer system on the tax roll and pass the following resolution: Be it resolved on a request from the village treasurer received and filed that these accounts including penalties and interest are unpaid.
