

## Michigan one step closer to regaining wolf management

With the announcement last week that wolves in Michigan, Minnesota, and Wisconsin could be off the endangered species list by the end of the year, the Michigan Department of Natural Resources (DNR) moved one step closer to putting the state's Wolf Management Plan into action and managing wolves in a scientifically and socially acceptable way.

According to the U.S. Fish and Wildlife Service (USF&WS), the wolf population in the western Great Lakes states has recovered and should be removed from special management protections provided by the Endangered Species Act.

The announcement opened a 60-day public comment period that will close on July 5. A final decision on the delisting proposal is expected before the end of the year.

"This is great news for the wolf population in Michigan and for the Endangered Species Act," said DNR Endangered Species Coordinator Chris Hoving. "Treating wolves as an endangered species, when they have reached and exceeded federal recovery goals in Michigan for more than a decade, is a disservice to the species."

Doing so has eroded public support for both wolves and the Endangered Species Act in recent years, which isn't fair to other species that are dependent on the Endangered Species Act for survival, he added.

Wolves were first added to the federal endangered species list in 1973 after being extirpated from the Lower Peninsula in the early 1900s and nearly disappearing from the Upper Peninsula by 1960. Natural emigration of wolves from Minnesota and Ontario back to the Upper Peninsula

was first documented in the 1980s and by 1992, when the population numbered an estimated 20 animals, it was clear wolves were starting to successfully rebound in the state.

Although rumors to the contrary persist today, the DNR did not "reintroduce" wolves to Michigan. According to DNR wolf specialist Brian Roell, one failed attempt was made in 1974 to relocate wolves to the Upper Peninsula, but all four animals died within eight months.

The decision was subsequently made to let wolves return without human intervention. Now, in 2011, the minimum winter population of wolves is estimated at 687 animals, an all-time high since the wolf population began to recover.

Michigan's Wolf Management Plan, approved and ready to roll since 2008, was created through a roundtable process that brought stakeholders from all sides of the wolf issue together over a period of months. Their task was to develop guidelines for how wolves should be managed once removed from the endangered species list.

The plan, which has undergone review and approval on the state and federal levels, represents a consensus view that takes into account all concerns.

"The Wolf Management Plan gives us a lot more flexibility for managing wolves in Michigan, including using lethal methods," said Roell. "Currently, when there is a report of a wolf taking livestock or someone's dog, we can investigate it. We can offer tips on how to deter those wolves. We can reimburse farmers for their losses. But even in cases of documented, repeat offenders, we can not actually remove that wolf unless there is a threat to human safety."

"This is understandably difficult for those who are affected by loss of property," Roell said, "and it is starting to negatively affect the social carrying capacity of wolves in the Upper Peninsula. People are frustrated and, in some cases, they are turning to poaching — a federal offense under the Endangered Species Act."

If wolves are removed from the endangered species list later this year, the Wolf Management Plan will allow wildlife officials, such as Roell, to use lethal control against individuals when necessary.

Claytonia perfoliata is a fleshy annual plant native to the western mountain and coastal regions of North America from Alaska and British Columbia south to Central America, but most common in California in the Sacramento and northern San Joaquin valleys. The common name miner's lettuce refers its use by California gold miners who ate it to prevent scurvy. It is eaten raw in salads, but it is not as delicate as other lettuces. Sometimes it is boiled like spinach, which it resembles in taste. It is widely naturalized in western Europe, where it was introduced in 1749.

"We still will start with nonlethal efforts, unless we feel there is a threat to human safety," Roell said. "But when nonlethal control fails, we will have the latitude to kill those wolves that are causing problems. Removing that behavior from the pack is important so bad habits aren't taught to the other animals."

Roell said he thinks helping farmers and pet owners to protect their property will help improve the reputation of wolves in the Upper Peninsula - something that is very important to continuing long-term wolf recovery in Michigan.

However, before Michigan's Wolf Management Plan can be put into action, the federal proposal to de-list the Western Great Lakes wolves must be finalized. A decision won't be made until after the 60-day public comment period is complete and the USF&WS has had a chance to review the newly submitted information.

"We frequently hear from people with very strong opinions about wolf management," Hoving said. "This public comment period is an opportunity for those people to go on record with their concerns. The decision to de-list isn't a done deal. The comments submitted during this time matter."

The deadline to submit comments is Tuesday, July 5.

In addition to submitting written comment, there will be an opportunity to learn more about the proposal to delist the western Great Lakes wolves at a public meeting in Ashland, Wisc., May 18, from 6-9 p.m. at the Northern Great Lakes Center, 29270 County Hwy. G. The DNR has requested that the USF&WS add a public hearing in the Upper Penin-

sula, but it is not yet clear if one will be scheduled.

If the proposed delisting rule is finalized, management of wolves in Michigan, Wisconsin and Minnesota could return to state authority before the end of the year. As a condition of delisting, the DNR will continue to monitor population numbers for five years to ensure recovery is stable.

In accordance with the Wolf Management Plan, wolves in Michigan will be classified as a non-game protected species. Any future decision to reclassify wolves as a game species would be up to the state legislature.

If you're not sure you're getting all the benefits you're entitled to, or if you assist someone who might qualify for more, there is an easy way to find out.

Benefits Checkup is a National Council on Aging website that lets you hunt for information on all kinds of benefits. Whether it's prescription costs, utilities, taxes, meals and more, you could be eligible for help.

The questions might seem a bit intrusive in some areas, but that's to help figure out where you might qualify for assistance. There's no need to give your name, however.

At the website [www-benefitscheckup.org](http://www-benefitscheckup.org), click on Find Benefits, then click Comprehensive. Before you begin, check the Click Here button for a list of things you'll need to have before you start. For example, you'll need to know all your current income and assets for you and anyone else in your home, as well as the amounts of your utilities and medical bills not covered by insurance. If you're on prescription drugs, have those handy as you'll be

entering the names of the medicines you take. If your spouse is a veteran, they want to know that as well, as there may be veterans benefits you're eligible for.

Be patient as you go through the questions, and answer all that apply to you.

At the very end you'll see a results overview with a list of programs you might qualify for. Each link is a description of the program, local contact information and an application form. If you like, you can print out the results or go back and change some of your answers.

Give it a try! You might just qualify for benefits that you never even considered.

# "Some gave all"

The men march out under the trees on the courthouse lawn. Their uniforms don't match one another, and your dad says that's because they come from all different branches of the military. Some of them are old - so old that, as a kid, you think maybe they'd been in the Civil War. But no, your mom says, those gentleman served in the first world war. You can't imagine back that far.

Next to them, carrying the flags and the rifles, are the men from the second World War. Some of them are your friend's grandfathers or their fathers. These are the men who, on other days, stand in parking lots with Buddy Poppy cans or serve the hot dogs after the Fourth of July parade. Their war ended just a few years before you were born, but to you, it's something out of history.

They hold the ceremony every year near the stone on the courthouse lawn and all the kids always go. It's exciting, what with the rifle shots

and the marching and it represents, in this little northern Michigan town, the beginning of summer.

So the men march out under the trees, and the post commander shouts "Parade rest!" and they spread their feet a little further apart and put their hands behind their back which means that the speaker who is making his way to the podium is probably going to go long.

He does, mostly about courage and loyalty and sacrifice. You pass the time looking at the faces of the veterans and the medals on their uniforms and listening in your head to songs from a time gone by. "Mademoiselle from Old Algiers, par-Le-vois" and "There'll be Blue Skies Over The White Cliffs Of Dover." Places you've never seen, only heard of in the songs.

But here's the amazing thing about these men. As you get older, they will get younger. And the men who join them will get younger still. The names of places and the songs will change. "See the pyramids along the Nile, watch the sunset on a tropic isle...", "Gonna take a sentimental journey."

Somewhere along the way,

the men under the trees are joined by a handful of boys you went to high school with. Boys who got on the bus with baby faces and came back with chiseled jawlines and narrowed eyes. More new places have come into your vocabulary. Saigon and Hanoi and Chu Chi. In your head, the songs change once again, "Put silver wings on my son's chest, make him one of America's best..." "Remember Charlie, remember Baker, they left their childhood on every acre..." echo through your head. This war is your war, it seems, and for the first time, those lost and honored have faces, have histories you know.

And then, in what seems like just a few years, you begin to hear other names from other places. Baghdad and Mosul, Kabul and Kandahar. The sons and even the grandsons of friends stand on the

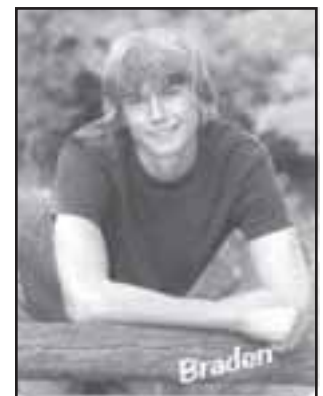

The vets look off at something in the distance and clear their throats before lifting their flags or shouldering their rifles. This is the time when, even for those of us for whom those cities are just names, it all becomes, for just a minute, real. "My buddy, my buddy, your buddy misses you."

And then it's over for another year. The soldiers march away back behind the courthouse, and head back to the post home for some lunch and maybe a beer. The kids rush out to gather the spent shells from the lawn. Some people visit the cem-

etary, others go on picnics, pack to head back downstate, or hit a Memorial Day mattress sale.

The stone stands silent within its sheltering pine trees, the carved names covering five plaques now on its east and west faces. But through the rest of the day, from time to time, a fragment of a song, the flash of a face will run through your mind.

That's the other amazing thing. That in each decade for more than a century now, there have been men and women willing to step up. To risk their lives to protect and defend their country, their family, their home. That some gave all.

That's the sad part, too. That in every decade - ever since this country began - there's been a need for that sacrifice. Thank you isn't enough, but it's what we have to offer.


Thank you and thank you and thank you again.

Every year for so many years the men have marched out, onto the courthouse lawn.

"Imagine there's no countries. It isn't hard to do.. Nothing to kill or die for. And no religion, too. Imagine all the people living life in peace. You may say I'm a dreamer, but I'm not the only one. I hope someday you'll join us. And the world will live as one."

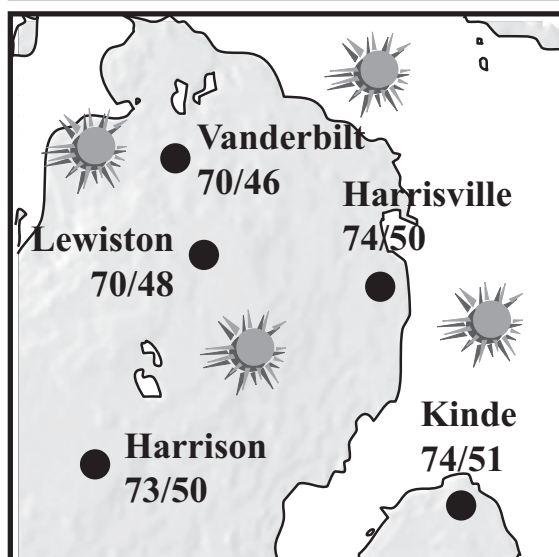

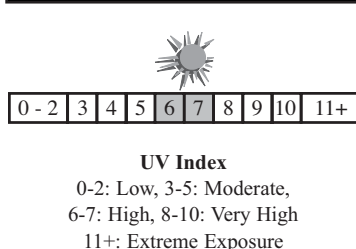

### StarWatch By Gary Becker - Gravity Trains: Jules Verne's Version of Amtrak

Jules Verne's classic science fiction novel, *A Journey to the Center of the Earth*, contains many misconceptions and beliefs that have been proven false since its publication in 1864. However, the idea of going to the center of the Earth has remained a fascinating concept to both scientists and fiction readers alike, and the plausibility of getting there has been debated for years. At the focus of this debate is the theoretical concept of gravity trains. A shaft could be bored from one point on the surface of the Earth straight through the center and out to the surface on the other side of the planet. People in a capsule could freefall through the shaft and continue to accelerate due to gravity until they reached the center of the Earth, where they would begin to decelerate at the same rate due to an opposing gravitational force. At journey's end, they would attain a speed of zero at the surface on the other side of the planet. This would provide a new and efficient mode of transportation, taking only 42.2 minutes to get from any point on the Earth to the point directly opposite it. However, the theory of gravity trains is impossible for several reasons. There is no known material that could line the tunnel walls and withstand the heat and pressure from the mantle or molten rocks of the outer core. Also, air resistance would play a significant role in slowing the train, making it necessary to evacuate all gasses from the tube. Additionally, in the 42.2 minutes that the train would take to get from one side of the Earth to the other, the Earth would continue to rotate, but at continuously changing speeds with depth. The train when released would start its downward journey with its surface velocity intact. In its plummet through the tube, the capsule would be diverted in the direction of Earth's rotation and crash into the walls. All of these complications have relegated the concept of gravity trains to a Jules Verne/mathematical type exercise. 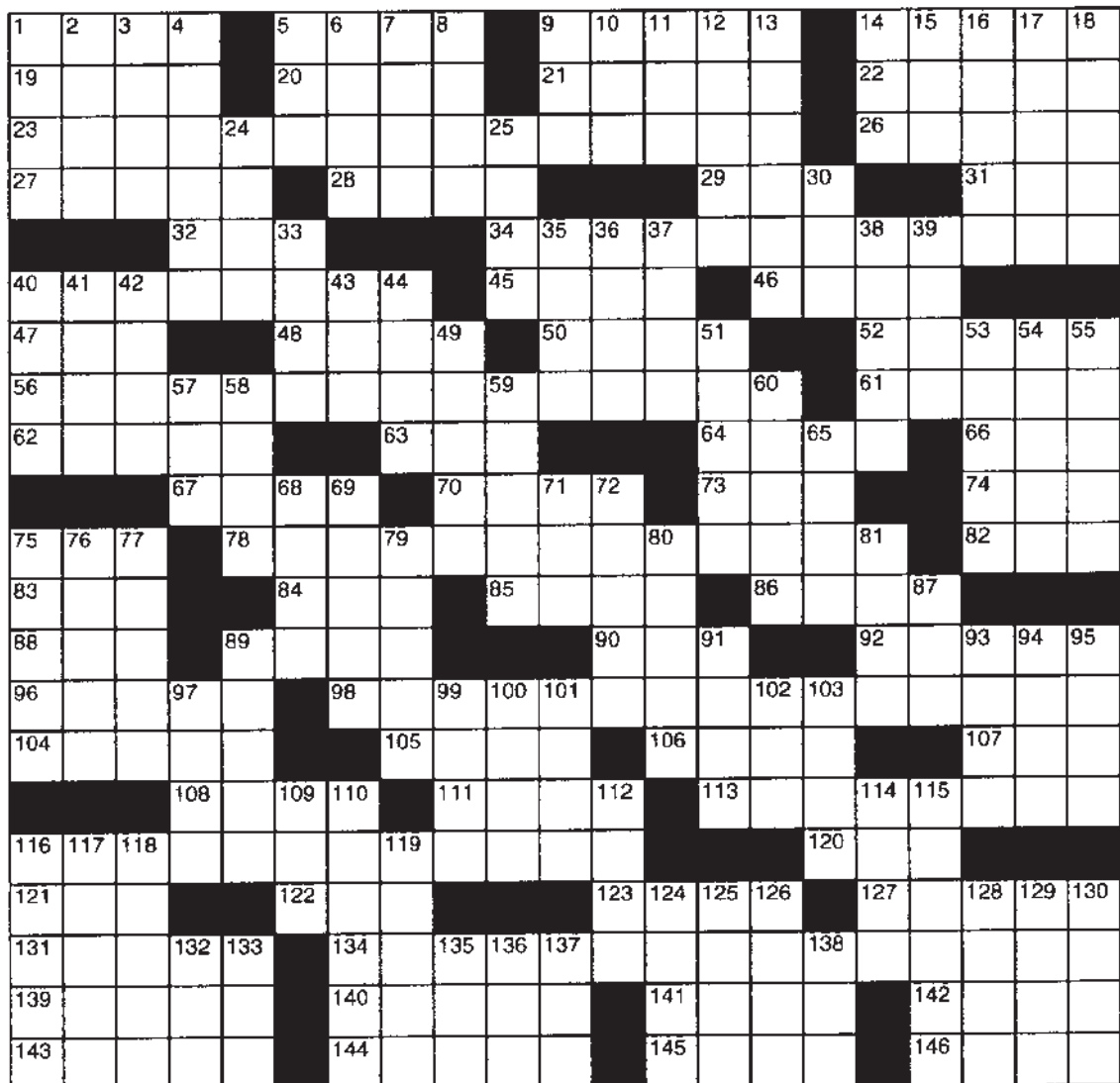

#### The History Channel

• On June 15, 1215, King John puts his royal seal on the Magna Carta, or "Great Charter," a peace treaty between John and his barons, guaranteeing that the king would respect feudal rights and privileges, uphold the freedom of the church and maintain the nation's laws. Four original copies of the Magna Carta of 1215 exist today.

• On June 16, 1738, printer, publisher, postmistress and patriot Mary Katharine Goddard is born in New London, Conn. In 1777, when Congress decided to print the Declaration of Independence, including a complete list of signatures, it chose Mary Goddard as printer.
