## Fire fighters graduate from academy

Seven and a half months is a long time to commit to anything let alone a course of study that spans three seasons, hundreds of miles of travel to and from classes, mental and physical tests and studying around jobs and family life.

All for a volunteer job that puts them in harm's way whenever a fire call goes out.

That's what the students of the 2011 Thunder Bay Fire Fighter Academy managed prior to becoming graduates and certified for Fire Fighter I, Fire Fighter II and Hazardous Materials (HASMAT) Awareness and Operations.

According to Vince Cammack, course manager for the academy and training chairman of the Thunder Bay Fire Fighter Association, classes began on October 4, 2010 and were held every Tuesday and Thursday evenings from 7-10 p.m. at the Air National Guard base (Alpena County Regional Airport) in Alpena. A practical class was also conducted roughly one full Saturday each month.

Cammack explained a fire fighter academy is held every other year and this year's academy had the largest number of students in the last 15 years. The Thunder Bay Fire Fighter's Association encompasses four counties - Alcona, Alpena, Presque Isle and Montmorency counties.

Twenty-eight men and women from northern Michigan completed the course and 24 graduated from the academy on May 7. According to Cammack, fire departments with fire fighters attending the academy pay for the required text book. State allocated funds awarded to each county, pay for fire fighters to attend the academy. Fire departments also make sure that each academy student has the necessary personal protection equipment.

He said each student receives 260 hours of classroom and practical training and must pass written exams and 12 practical stations to receive certification and graduate from the academy.

"Anyone attending the academy must be a member of a fire department according to state requirements," Cammack said. "However, a fire fighter has to become certified within two years of joining a department. There is a limited amount of duties an uncertified volunteer can do without certification."

Several local academy graduates gathered for a group photo and recounted

## Police Report

A Glennie resident remains in critical condition following a one-vehicle roll over on M-72. According to a report from the Alcona County Sheriff's Department, deputies responded to Hubbard Lake Road, south of Proconier Road, at 5:11 a.m. on June 1 for an accident.

A preliminary investigation report states that Deanna Lee Grubaugh, 39, of Glennie was southbound on Hubbard Lake Road when her vehicle "left the main traveled portion of

the roadway. The driver lost control when the vehicle re-entered the roadway and flipped onto its side, rolling over numerous times, left the roadway and struck a tree."

Grubaugh was ejected from the vehicle, according to the report, and sustained injuries to her head and ribs. She was transported to Ta-was St. Joseph Hospital by Alcona County EMS and was transferred to Saginaw St. Mary Hospital.

While speed appears to

have been a factor in the accident, it remains under investigation by the Alcona County Sheriff's Department.

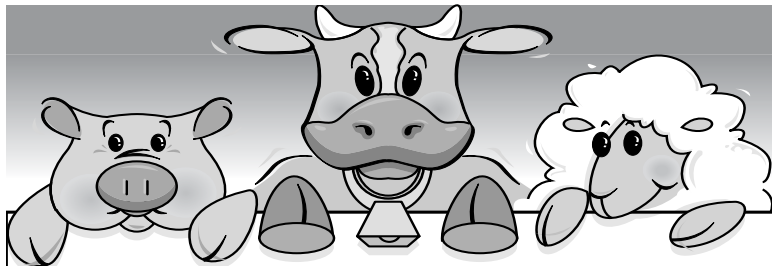

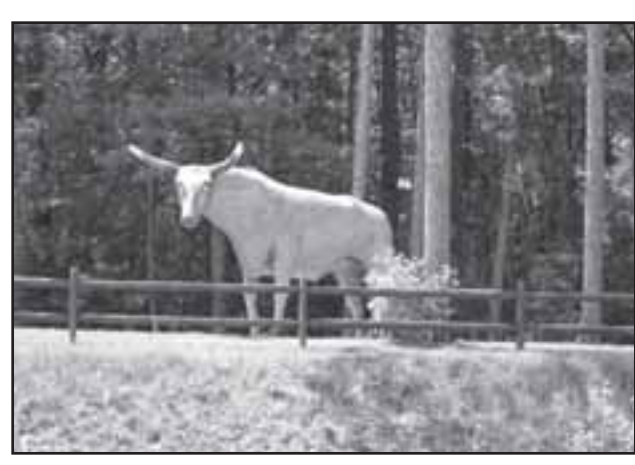

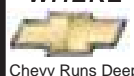

## Assistance programs for seniors

Dear Savvy Senior,

What kinds of programs are available to help low-income seniors with their Medicare costs and other expenses? My 81-year-old mother has gone through her savings and is having a tough time getting by on her Social Security benefits. What can you tell us?

Worried Son

Dear Worried,

There are actually a variety of under-utilized programs that can help lower-income seniors with their Medicare costs, grocery bills, utility expenses and more.

For millions of seniors who are having a tough time paying their out-of-pocket healthcare costs, help is available through Medicare Savings Programs (MSPs). These are Medicaid-administered programs that pay Medicare Part B premiums and depending on your mom's finances may even pick up the tab on her Medicare copayments and deductibles.

To qualify, her income must be under \$1,246 per month (or \$1,675 for a married couple), and her assets must be below \$6,680 (\$10,020 per couple) not including her house, vehicle, burial fund, furniture or other household items. To find out if she qualifies, or to apply, contact her local Medicaid office - call (800) 633-4227 for contact information.

If your mom is eligible for a MSP, she's also eligible for "Extra Help" in paying her

Medicare prescription drug plan costs. If, however, she's not eligible she can still get Extra Help if her annual income is below \$16,335 (\$22,065 for a married couple living together), and her cash assets are under \$12,640 (\$25,260 for married couples) excluding her home and vehicle. For more information, call Social Security at (800) 772-1213 or see [www.ssa.gov/prescriptionhelp](http://www.ssa.gov/prescriptionhelp).

In addition to the Medicare programs, your mom may also be able to get some help with her grocery bills. Food assistance programs like SNAP (Supplemental Nutrition Assistance Program) are available to seniors, age 60 and older, with cash assets under \$3,000, and a "net income" below \$903 per month (\$1,215 for a family of two).

Net income is figured by taking your mom's gross income minus allowable deductions like medical expenses, rent or mortgage payments, utility costs, insurance, taxes and more. The average monthly SNAP benefit is currently around \$101 per person. To find out if your mom qualifies, use the SNAP pre-screening tool at [www.snap-step1.usda.gov](http://www.snap-step1.usda.gov) or contact her local SNAP office - call (800) 221-5689 for contact info.

There are also resources available that can help low-income seniors reduce their utility bills. The Low Income Home Energy Assistance Program, as well as local utility companies and charitable or-

ganization help millions of Americans each year with their home heating and cooling costs. To search for help go to [energynear.org](http://energynear.org), a web portal that provides information on all energy assistance programs in each state, along with qualification details, how to apply and who to contact. You can also call the National Energy Assistance Referral project at (866) 674-6327.

Another program to check into is SSI or Supplemental Security Income. Administered by the Social Security Administration, SSI provides monthly payments to very low income seniors (age 65 and older), as well as to those who are blind and disabled. To learn more or find out if she's eligible, visit [www.ssa.gov/ssi](http://www.ssa.gov/ssi) or call (800) 772-1213.

Savvy Tip: To search for other assistance programs go to [benefitscheckup.org](http://benefitscheckup.org), a comprehensive web service developed by the National Council on Aging, that contains a database of more than 2,000 federal, state and local programs that can help seniors in need. The site will help you locate programs that your mom may be eligible for and will show you how to apply. This service is only available online.

## Social security scams

I got an email offering a service to help with a Social Security disability claim. It sounded promising... as all scams do until you take a closer look.

The email listed all types of services it provides to help get benefits after someone has been turned down. But if you're expecting personal service, it's not likely to happen, and if you want your money back when it doesn't do what it says it will, you'll be out of luck. See, this company wasn't even in the United States. Instead of having a .com at the end of the Internet address, it was a .co - which means Columbia. No wonder the ad said it would make use of videoconferencing for any claim hearings.

That's not the only scam going on. They're all over the country.

In one scam sent out email that looked as though it came from Social Security, offering to send a replacement card or statement of earnings. What the scammers are looking for is your name and Social Security number to start putting to-

gether an identity-theft package.

In areas that have been hit by flooding disasters, scammers are calling people who had applied for food or services and told them that a Social Security number was needed to complete the file.

In another area of the country, seniors received phone calls saying they had received too much money and had to pay some of it back. A "collector" actually showed up at their door.

If you need to deal with Social Security, call it directly at 1-800-772-1213 between 7 a.m. and 7 p.m. Monday through Friday. Don't use the Internet and don't respond to email claiming to be from Social Security.

A while back, I read an interesting article that said that people over 50 rarely text on their cell phones. I text. So when I was lying in bed watching the "Tonight Show" a few nights ago and they announced that Iron and Wine would be the musical guest, I reached for my cell phone and tapped out a message to the Princess. A few seconds later, she texted me her thanks.

I mention this just to illustrate that I'm as addicted to technology as all the rest of us. Because when I sent the text message, from my bed upstairs, the Princess was sitting on the couch in the living room, downstairs. I could have just hopped up, opened the bedroom door, and passed the information on. I never even thought of it.

But lately, in the prime time of the "information age," when everyone has all the toys and then some, I've been observing an interesting trend.

I've long contended that you can spot the first indicators of sociological change by watching television commercials. And lately, I've noted what may be the prelude to a new direction, technologically speaking.

The ad in question features a father. Unobserved, he peeks into the living room, where one of his children is playing a video game, then into the bedroom, where another is surfing the Web and finally into the office, where his wife is working on her laptop computer. The next scene shows him in the basement, throwing the master switch. When his son comes to find him at the barbecue in the backyard, and asks, "What happened?" the father replies, "Power went off. Want a hotdog?" In the final scene, the family is sitting around the picnic table, eating hotdogs (the ad is for Oscar Meyer) and laughing together.

Turning off the power seems a little extreme, but it does underwrite the fact that in most households these days, there are several cell phones, computers, Wiis, Xboxes and Tivos taking up an inordinate amount of our time and, rather ironically, isolating us more and more from the 3-D, living, breathing people around us.

As I said, I use technology as much as anyone - maybe more. There are so many amazing positives associated with it, after all. I can set my laptop on the kitchen counter (at a safe, non-splash distance) and make a recipe shared in a blog written in France. I can take a photo with our aging digital camera and send it off to family and friends in mere minutes.

With my DVR, I can "time shift" zapping television shows out of the air and watching them when it's more convenient. On Facebook, I can keep track of friends, their children and dogs and re-establish a connection with high school classmates. I can text the Princess, whether she's in Chicago, Ill.

or downstairs on the couch. And I don't even have the fancy stuff or particularly high tech skills.

But there's a downside to all this electronic magic, too. A primary element of that downside is the isolation mentioned above. As Robert Putnam told us, a whole generation of young people are "bowling alone," spending their entire lives connected to cyber life while, some contend, failing to develop their social and communication skills.

A second dark side to the world electronic, it seems to me, is what the kids refer to as "TMI" - too much information. As a minor example, technology allows otherwise well-meaning folks to send the equivalent of the chain letter by e-mail in seconds, leaving the recipient to groan as he or she opens yet another "send this to 12 people in 10 minutes or bear the wrath of Khan" message. As a major example, e-mail, cell phones, Twitter and Facebook allow us to propagate inaccurate information worldwide at a fearsome rate (take the President Obama's birth certificate issue as an example).

I'm not a Luddite, but I don't want to see a photo of the dead Osama Bin Laden, or any other dead body, thank you very much. And I certainly don't want an "app" that will alert me to the latest photo of a congressman in various stages of undress, either. I don't need to be beeped the next time a starlet is arrested with coke in her Coke.

I'd grudgingly acknowledge that there are those who could benefit from knowing the state of the market instantly, and I'd welcome an app that let me know a tornado is heading my way. But I'm a little weary of having instant 24/7 access to anyone's life other than my own, no matter what their status might be.

So it was refreshing, recently to read an article about a man who has decided to integrate what he calls "Walden time" into his life. The owner of many pieces of technology, this gentleman was standing in line at a Starbucks one day when he realized that his cell phone was vibrating. That was just before he remembered that he'd left his cell phone at the office.

The vibrations he was experiencing, dubbed "phantom vibration syndrome" is apparently happening more and more to technology users. Again, with reference to television commercials, note how often the background in ads these days features cell phone ring-like noises, placed in the soundtrack to trigger our Pavlovian response. These days, the gentleman has programmed un-plugged time into his schedule, when nothing beeps, rings or vibrates to take his attention from the real world around him.

In "The Winter of Our Disconnect: How Three Totally Wired Teenagers (and a Mother Who Slept with Her

iPhone) Pulled the Plug on Their Technology and Lived to Tell the Tale," Australian journalist Susan Maushart details her family's self-imposed six months "without screens" including television.

While "The Experiment" as she calls it was difficult (hardest, maybe for the author herself, addicted to cell phone communication) it also resulted in some surprising positives - among them her daughter's increased sleep and study and her son's discovery of the saxophone, jazz and reading. And the entire family found themselves eating dinner together and enjoying it.

Maushart concludes that much of the behavior we consider normal for teenagers - untidiness, poor eating habits, disordered sleep, ineffective time management, and mood swings - are due to the multimedia and communications stew in which most adolescents simmer.

She calls this disordered, boundary-less state "blobbiness, the result of greater leisure, more affluence, prolonged schooling and, most important and damning, our lowered expectations that teens will contribute to the family and the community."

And she concludes that this is mostly a product of digital distraction, writing, "The explosion in connectivity (if not always in communication) that has enabled the 24/7 lifestyle to which our digital natives incline has detonated a whole new set of landmines, reducing an already besieged set of personal boundaries to tatters."

I haven't many teenagers in my life these days, but I do have a highly "connected" family who often come late to the dinner table thanks to screen-time of one type or another, toting a dinging, disruptive phone along. I'm not certain many of us could (or necessarily should) survive six months or a year totally unplugged, but I do think some Walden time would be a good thing for most of us.

I could go on, but, ironically, my laptop battery is running out. Hang in there - I'll text, or Tweet, or FB you - as soon as I plug it in again. If you don't hear from me, drop on by. Who knows, we might rediscover the joys of talking face to face.

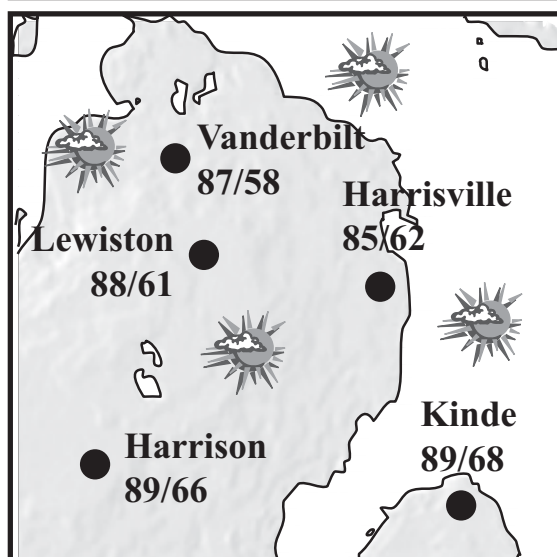

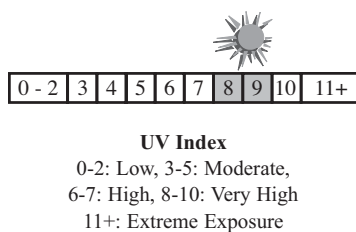

### StarWatch By Gary Becker - One Year to Spectacular Venus Transit

Heads up, because on June 5, 2012 one of the rarest repeatable astronomical events takes place, a transit of the planet Venus across the disk of the sun. The only difference between a transit and an eclipse is the size factor between the two objects. In a transit, the occulting body is much smaller than the object being hidden. Two sets of two transits (four in total) occur in a period of 243 years. Each set is separated by an eight year interval, but the sets themselves can be separated by a time gap of 121.5 years or 105.5 years. The 2012 event is the second of a set separated by eight years. The last transit of Venus across the sun occurred on June 8, 2004. I worked with a group of about 15 students and adults to organize a public event 30 miles west of Allentown, PA which began at sunrise. The East Coast was at the tail end of this worldwide event. Needless to say my efforts to attract print and broadcast interests for this happening were met with tepid responses. Unbeknownst to me was that all day while the transit was being viewed in other parts of the world, media sources were hyping this occurrence in the biggest possible ways. Dawn, June 8, was met with dense fog and drenching dew at our observing location. I told my group to set up and to keep acting positive. About a half hour after sunrise with pockets of mist wafting across the field and our capped telescopes dripping in the damp morning air, I explained to the 250 people assembled that probably the fog would burn off eventually, and maybe we would get a chance to see it. While speaking, someone in the crowd said, "Look, it's there." I turned around to be greeted by a deep, orange sun specked by one dot near its upper right limb. The sky slowly cleared, the transit unfolded on cue, and the media arrived in droves. What a glorious morning! If you miss next year's Venus transit, plan on hanging around until 2117 or 2125 when it happens again. [www.astronomy.org](http://www.astronomy.org)

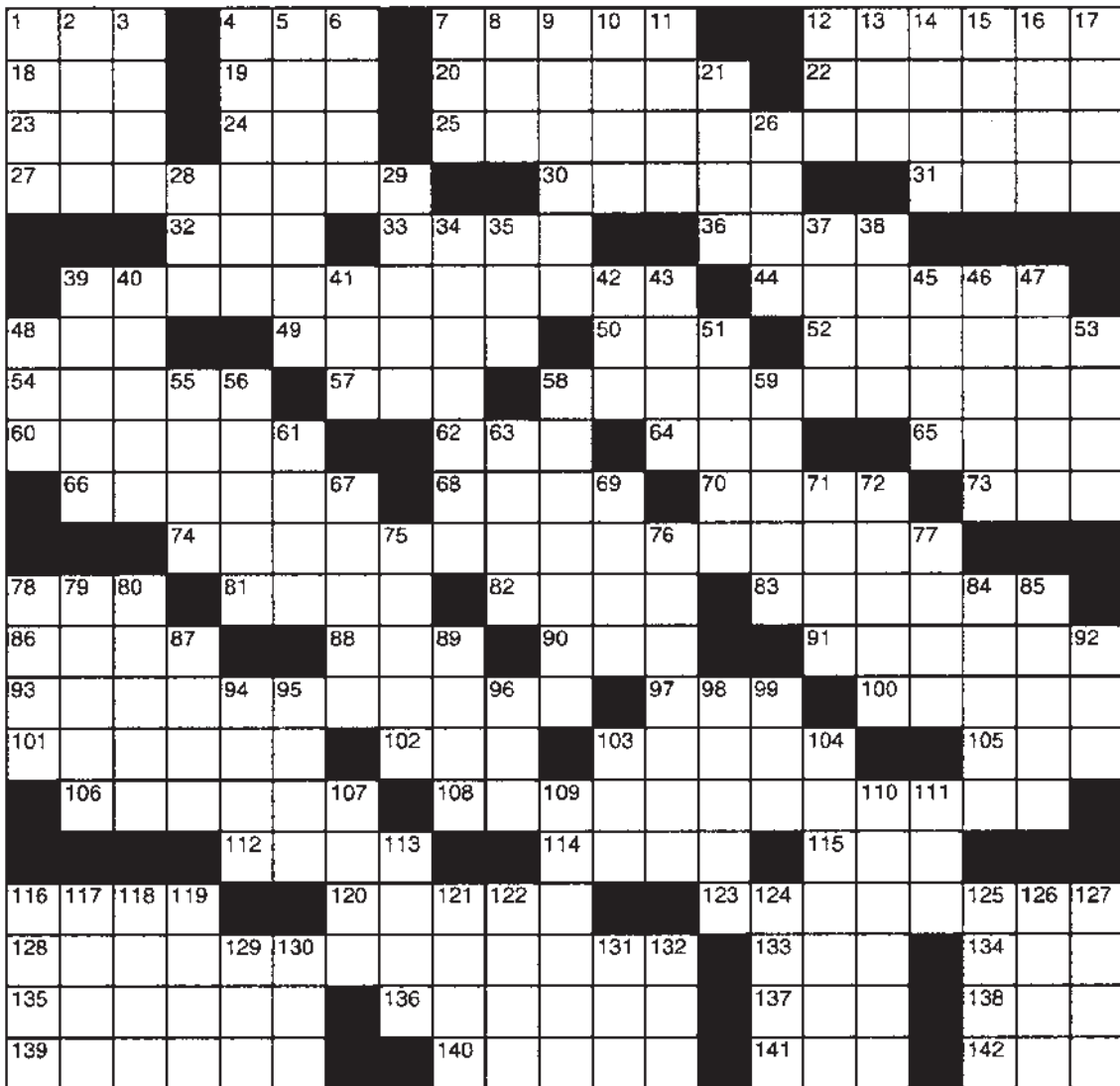
