

## Huron Undercover Narcotics Team gets new commander

The new commander of the Huron Undercover Narcotics Team (HUNT) is working to get to know officials and residents in the four counties the team covers and talks about the many ways the team serves those communities.

Detective Lt. Del Putnam, a native of Lansing, Mich. assumed command of HUNT in late July. "We are in a good situation. This is a well-run team and it has been received well in all four counties," Putnam said.

HUNT is a multijurisdictional drug task force that investigates all levels of drug dealers. The counties serviced by HUNT are: Alcona, Alpena, Montmorency and Presque Isle. Participating law enforcement agencies include the Alcona Sheriff's Department, Alpena City Police Department, Alpena Sheriff's Department, Montmorency County Sheriff's Department, Presque Isle Sheriff's Department, Rogers City Police Department and the Michigan State Police.

Putnam graduated from Everett High School in 1986. He has a bachelor's degree in criminal justice from Ferris State University and more than 20 years of law enforcement experience, including 18 years with the Michigan State Police. He was a trooper for nine years at the post in Monroe, Mich., which included two years with an undercover unit as a detective trooper. In 2002 he was promoted to sergeant to the post in Mt. Pleasant, Mich. where he served as a shift commander.

Before he came to Alpena, Putnam spent a year and a half implementing and then overseeing the 3<sup>rd</sup> District Hometown Security North Team which focused on criminal interdiction on the roadways covering nine counties from Saginaw, Mich. north to Tawas and as far west as the Clare/Mt. Pleasant, Mich. area. "This involved high volume traffic stops where we were looking for criminal activity," Putnam explained.

He is pleased to be in northern Michigan and in com-



Detective Lt. Del Putnam mand of the team. "I've worked narcotics before and always wanted to get back into it and I've always liked northern Michigan and the outdoors - so this is perfect for me."

HUNT, which was formed in October 1990, has six full time and one part time law enforcement officers representing the law enforcement agencies in its jurisdiction.

"It's been going well and

it's been busy," Putnam said referring to several criminal investigations the team is handling - some of which involve alleged violations of the Michigan Medical Marijuana Act and also the time he is taking to introduce himself and talk about HUNT at governmental meetings in Alpena and Montmorency counties. He plans to touch base with officials in Alcona and Presque Isle counties as well.

"I'm going to meetings and trying to get to know people in each county...this is a fiscal time of year and I'm dealing with budget issues," Putnam said. Financial support for HUNT has been one of the topics Putnam brings up at the meetings in Alpena and Montmorency. "I hate meeting people for the first

time and asking for money...I have to bring it up because we have to change the way things are done financially," he said.

Alcona and Presque Isle counties support HUNT with a millage that includes money for operating costs and salary for an officer from that county as a member of the team. "I really appreciate the voters support (in Alcona and Presque Isle) and how it helps HUNT...it's huge," Putnam said.

He explained the need to look at financial support from two counties comes from a cut in funding at the national level. A federal grant that funds multijurisdictional drug teams was cut by 30 percent - which, according to

He was born February 5, 1943 in Detroit, Mich. to Donald and Ruth (Cummings) Johnson.

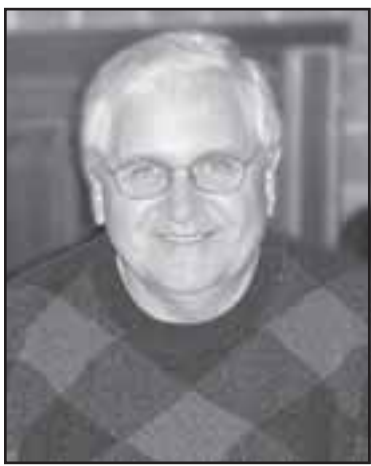
He married Karen Droz on August 27, 1966.

Spruce 48762 postal patrons and area businesses are urged to attend the United States Postal Service (USPO) public meeting at the Caledonia Township Hall, November 16 from 5-6:30 p.m., where we'll be treated to the USPS's scripted justifications for proposed closure. Spruce 48762 postal customers received the standard letter to convince an otherwise uninformed public that closure is

just good business, along with the weighted customer survey designed to provide responses to justify closure.

It's not a business, it's a service, the USPS's only product guaranteed every household, hamlet and city for over 239 years, providing universal service at uniform rates by law. Alleged savings realized by closing Spruce and thousands of rural post offices would be less than one percent of postal costs.

The other side of the issue Spruce P.O. patrons won't hear from the USPS will be presented at the public meeting, and what we as citizens can do about it. It cannot be emphasized too strongly that

the USPS is the only agency that does not receive a dime in federal taxpayer money.

Putnam, is \$38,000 out of HUNT's annual budget.

Another challenge Putnam and the team is facing involves infiltration of methamphetamine (meth) into the area. "People need to understand that meth is here - in all of the counties. I believe this is a major criminal justice and public safety issue that needs to be addressed in the region," he said. "Due to the nature and complexity of

meth, HUNT needs to be at the forefront of addressing the issue and we will be vigilant in that."

"There are drugs that pose a certain public safety threat - meth is at the top of that list," Putnam said. "Heroin, cocaine and prescription drug abuse follow meth on the list."

Putnam would also like to see members of HUNT "out in the community more to talk about HUNT." He said HUNT

is "a huge asset for the area because of the level of cooperation between all of the law enforcement agencies in the four counties and the prosecutors...The level and quality of work present in the region has really contributed to furthering public safety for communities," Putnam said.

He explained the focus of the team is dangerous felons and immediate public safety issues like meth labs, trafficking of drugs, et cetera. The team evaluates and prioritizes each case. "There is plenty of work to do," Putnam said. "We could buy dope every single day, but we have to evaluate what cases we take on," he said.

In addition, Putnam said the team also helps law enforcement agencies in the four counties by sharing experience, equipment, technology and manpower.

Since Putnam has been in command HUNT has made arrests in several Michigan Medical Marijuana Act cases, made arrests in connection with two meth labs, recovered weapons and ammunition connected to the armed robbery of a pharmacy in Alpena last summer, arrested several fugitives, assisted in gathering evidence in a rape case, served as the arresting team for several felons and set up and facilitated a manhunt for a juvenile offender who escaped from custody.

"HUNT is a public safety net that serves the region as a multijurisdictional unit - it's not just about narcotics," Putnam said. "We are capable of pooling manpower and resources to target anything that comes up in the region."

"The personnel from all agencies receive extensive training in a variety of areas...all of this training helps them work very well in a team. It's a benefit that we can respond any time. Our schedule can be as fluid as it needs to be - whatever the issue we work it out. That's a huge benefit and why we are able to do the things we do. We aren't hooked to 911 coverage (like other area law enforcement agencies). We work our cases and other cases to do what needs to be done."

"We are really trying to do what we can for the citizens that we serve. That is the mindset of HUNT and that's what makes us successful here," Putnam said.



### Don't pay extra fees on a VA home loan

If you're considering purchasing a home with a Department of Veterans Affairs loan, or if you've already done so, you need to be aware of the scam potential. A lawsuit has come to light alleging that many banks have been overcharging veterans during refinancing, burying fees they're not allowed to charge. Therefore, it's not much of a stretch to be concerned that overcharges can appear during an original purchase as well.

Know your rights, and know what you can and can't be charged for. Here are a few examples:

—You can be charged only 1 percent of the loan amount as an origination fee.

—You can be charged only the actual amount of incidentals, such as the cost of appraisals, credit report, title insurance and more, not inflated fees.

—You cannot be charged for the cost of an attorney, unless it pertains to title examination. (This is where the lawsuit came in. It alleges that attorney fees were buried in title examination costs.)

—The lender must use

ONE of two forms to disclose fees you pay, and not split those fees between a HUD-1 statement and a new origination statement.

—You cannot be charged fees not listed in Circular 26-10-1. This information sheet outlines all the fees banks are allowed to charge you. Go to [www.benefits.va.gov/homeloans](http://www.benefits.va.gov/homeloans) to find Circular 26-10-1.

If you've already purchased a home, pull out your paperwork. If you have been overcharged you might get your money back, but you have to find the overcharges first.

If you're already a homeowner with a VA loan, look through all the Circulars to see if any apply to you. There are Circulars about problems with drywall, acceptance of condo associations, info on the Servicemembers Civil Relief Act (protections you have while on active duty in regard to your mortgage) and others.

If you have original Medicare (Part A and B), it's important to know that "routine" vision care like eye exams, eye refractions, eyeglasses or contact lenses are generally not covered. But, "medically necessary" eye care usually is. Here's a list of what is covered:

- Eye surgeries: Any surgical procedure that helps repair the function of the eye like cataract removal, cornea transplant, glaucoma surgery, et cetera.
- Eyeglasses or contacts: Only if you've had cataract surgery.
- Medical eye exams: Only if you're having vision problems that indicate a serious eye condition like macular degeneration, retinopathy, glaucoma or dry eye syndrome.
- Glaucoma screenings:

Annual screenings for those at high risk (have diabetes, a family history of glaucoma, are African-American or Hispanic).

- Diabetic eye exams: If you have diabetes, yearly exams for diabetic retinopathy.
- Macular degeneration: Certain treatments are covered.

You also need to be aware that of the eye care services that are covered by Medicare, you're still responsible for 20 percent of the cost - Medicare pays the other 80 percent. To help with this out-of-pocket expense, some Medigap supplemental policies provide gap coverage. Or, if you have Medicare Advantage, some plans provide eye care benefits. Be sure you check with your plan administrator.

If you find your eye care needs aren't covered, or you can't afford the 20 percent out-of-pocket that Medicare doesn't cover, there are other ways to save. For starters, if you need a refractive eye exam or a new pair of eyeglasses, many optometrists and eyeglass dealers offer discounts - usually between 10 and 30 percent - to seniors who request it. Memberships in groups like AAA and AARP can also provide lower rates.

Another way to get low-cost eye care is at an optometry school. Many offer affordable care provided by students that are overseen by their professors. See [opted.org](http://opted.org) for a directory of

schools and their contact information.

Depending on where you live, there may also be some local clinics or charitable organizations that provide free or discounted eye care or eyeglasses. Put in a call to your local Lions Club to see what's available in your area. To reach your local club, visit [lionsclubs.org](http://lionsclubs.org) or call (800) 747-4448 to get the number to your state Lions Club office, which can refer you to your community representative.

Or, if you need medical eye care, check into EyeCare America. This is a national program that provides comprehensive medical eye examinations to seniors age 65 and older, and up to one year of treatment at no cost. They accept Medicare or other insurance as full payment. And if you don't have insurance, care is free. To learn more or to find out if you qualify, visit [eyecare-america.org](http://eyecare-america.org).

If you're under age 65, some other services that can help include Mission Cataract USA ([missioncataract-usa.org](http://missioncataract-usa.org)), which provides free cataract surgery to low-income people who don't have

## Finally, a bump up in Social Security

We're about to receive our first Social Security cost-of-living increase in three years. But don't rush out to buy jewels, furs and vehicles with your new riches: The increase will be 3.6 percent and will take effect in January.

These past two years were the first time since 1975 that there was no adjustment, but the economy changed just enough to trigger the small increase. The Cost of Living Adjustment (COLA) is based on any increase in the Consumer Price Index from one year to the next.

The average Social Security check this year was \$1,177. The 3.6 percent increase of \$42.37 will bring that up to \$1,219 per month in 2012.

Per the Social Security website, the earnings limit for those under age 66 is as follows: For those born in 1943 through 1954, the limit will be \$14,640 with \$1 deducted from benefits for each \$2 earned over that amount. If you'll turn 66 in 2012, you can earn up to \$38,880 without penalty, but will lose \$1 for every \$3

you earn over that amount until the month you reach age 66. These limits are slight increases.

Then, too, there is the possibility of an increase in Medicare Part B premiums. (You should have gotten your Annual Notice of Change in the mail.) Your Social Security increase might be completely eaten up by the increase in Medicare premiums.

If you haven't filed for Social Security, run the AARP Social Security Benefits Calculator [[www.aarp.org](http://www.aarp.org)] to get a better idea of whether it will benefit you to wait, or to keep working and file at the same time.

To save money, the Social Security Administration no longer mails out annual statements.

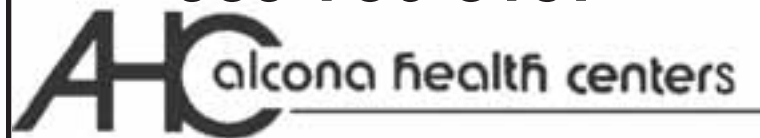

# Christmas shoebox collections happening next week

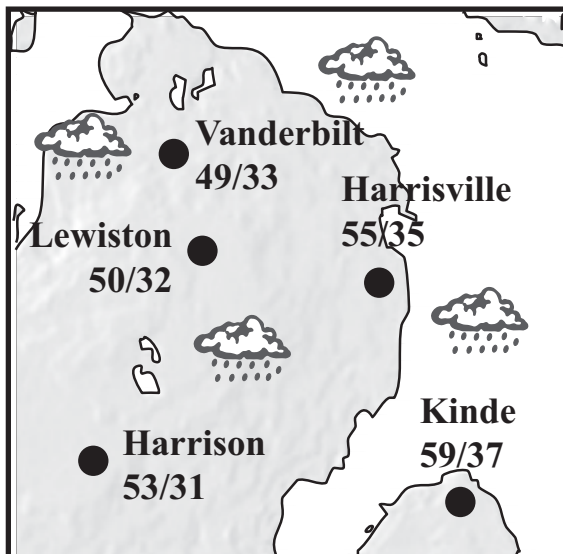

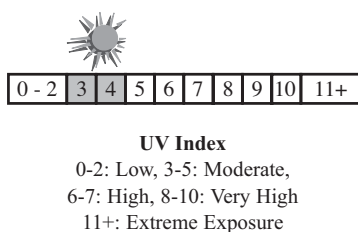

### StarWatch By Gary Becker - Empty Magnification

Last week, I wanted to continue a dialogue on telescopes, since the holidays are fast approaching and scopes have an affinity to find themselves under Christmas trees; but a freak Halloween snowstorm which blanketed the East Coast stole the show. Clean up still continues, but the snow is gone and almost everybody has had their electricity restored. I wanted to say a few words about magnification since it is considered so important to people purchasing their first scopes. It should never be the prime consideration for owning any telescope, but it does have its place in using a telescope properly. Mathematically, magnification equals the focal length of the telescope divided by the focal length of the eyepiece. The focal length is simply the distance that light takes to come to a precise focus. Both the telescope and the eyepiece play a role in how powerful a telescope's magnification can become. Because of the nature of light, images are brought to a focus as a series of dots or diffraction disks similar to a newspaper photograph. Larger aperture scopes produce smaller diffraction disks and can tolerate higher powers. The observer looking at an image in the eyepiece is totally oblivious to this fact, but the analogy is an accurate one. Every time the magnification is doubled, the field of view and the brightness of the image become one quarter of their original value which is a function of inherently larger diffraction disks. If a person looks more closely at a newspaper photo, there comes a point where no new information can be gleaned, and at even closer distances, less detail is perceived. Likewise, simply "jacking up the power" in telescopes produces "empty magnification" where no new detail can be revealed. The upper limits of magnification are about 50-60 power per inch of light gathering aperture. Beyond this point the magnification becomes empty, in other words, useless. 

### MOMENTS IN TIME

#### The History Channel

- On Nov. 25, 1783, nearly three months after the Treaty of Paris was signed ending the American Revolution, the final British soldiers withdraw from New York City, the last British military position in the United States. The city had been in British hands since 1776.

- On Nov. 26, 1898, a powerful winter storm batters New England, killing at least 450 people in New York, Connecticut and Massachusetts. Blizzard conditions caused 20-foot snowdrifts, some 100 ships were blown ashore in Boston and another 40 were sunk. About 100 people died when a steamer sank near Cape Cod, filling the harbors and nearby beaches with bodies and debris.

- On Nov. 23, 1936, the first issue of the pictorial magazine Life is published, and it quickly became an overwhelming success. At its peak, the magazine had a circulation of more than 8 million. Life ceased running as a weekly publication in 1972.

- On Nov. 27, 1942, guitar legend Jimi Hendrix is born in Seattle. Hendrix made his first U.S. appearance at California's Monterey Pop Festival in 1967. He made a splash by burning his guitar and was quickly established as a rock superstar.

- On Nov. 22, 1963, John Fitzgerald Kennedy, the 35th president of the United States, is assassinated while traveling in a motorcade through Dallas. First lady Jacqueline Kennedy was beside him, along with Texas Gov. John Connally and his wife. Lee Harvey Oswald allegedly fired three shots from the sixth floor of the Texas Book Depository.

- On Nov. 24, 1971, a hijacker calling himself D.B. Cooper leaps from a Northwest Orient Airlines 727 over Washington state carrying \$200,000 he extorted from the airline. Wearing only wraparound sunglasses, a thin suit and a raincoat, Cooper parachuted into a thunderstorm with winds in excess of 100 mph.

- On Nov. 21, 1980, 350 million people around the world tune in to television's popular primetime drama "Dallas" to find out who shot J.R. Ewing, the character fans loved to hate. J.R. had been shot on the season-ending episode the previous March.

1. If you haven't had your furnace inspected this year, it's not too late to do so. Consider buying one of the service plans. If your furnace quits in the middle of a cold night, you not only want to know who's going to come fix it, you want to know that some or all of the repair costs are covered.

2. Be sure you're not blocking any air vents with furniture.

3. If you never got around to caulking your windows and are feeling drafts when the wind blows, head to the hardware store and look for Frost King plastic window sheeting. This clear plastic (three large sheets to the box) goes on the inside of windows with the adhesive tape that's supplied. Shrink the plastic tight with a hair dryer and trim off the extra. The trick is to get a few inches of dead air space between the window glass and the plastic. The wider that area, the better the insulation factor.

4. While you're at the hardware store, pick up two or three furnace filters. Plan to change them on the first of every month during the winter, when the furnace is running frequently.

5. If you have ceiling fans, run them in reverse to move the warm ceiling air down into the main part of the rooms.

6. Consider turning down the temperature on your water heater. Generally they're set at 140 degrees F. You can still get a hot shower, and it will save 3 percent to 5 percent of your energy bill with the temperature set at 120 F.

7. If you're home during the day, open the drapes on the sunny side of the house, and close them when the sun moves to the other side.

8. Turn down the temperature on your thermostat 1 degree. In a few days, turn it down another degree. You likely won't feel the difference in temperature, but you'll save between 2 percent and 5 percent on your heating costs. If you can, invest in a programmable thermostat set to lower the temperature when no one is home.

9. Insulate your attic access door, if you have one.

10. Add a warm-air humidifier: Moist air feels warmer.

11. If you're in the market for a new furnace, water heater, doors and windows or attic insulation, remember to check [www.energysavers.gov](http://www.energysavers.gov) for rebates before you buy.
