

Alcona native retires after 36 years in law enforcement

After 36 years in a law enforcement career that has taken him all over the state, an Alcona County native is looking forward to spending more time in the area and finishing a long list of projects that has been piling up.

Friday, March 30 marked the last day of work for Michigan State Police Captain Russell Dennis Smith. After 32 years with the Michigan State Police, Smith retired as captain of the seventh district which is headquartered in Traverse City, Mich. He was the district commander who oversaw four MSP posts in Cadillac, Mich., Houghton Lake, Mich., Gaylord, Mich. and Alpena. He was also responsible for five detachments, five resident trooper concepts and three multijurisdictional task force teams in 19 counties in the northern Lower Peninsula - Huron Undercover Narcotics Team (HUNT), Traverse Area Narcotics Team (TNT) and Straits Area Narcotics Enforcement (SANE).

"It's been a great career. I enjoyed it very much," Smith said. "Certainly for a young man from Alcona County it's been above and beyond what I would have ever expected in a career with the Michigan State Police. I'm blessed to be able to retire from a career in law enforcement."

Smith was raised in Alcona County and graduated from Alcona High School in

1970. He began his career in law enforcement as a dispatcher for the Alcona County Sheriff's Department in February 1976. In May 1976, he became a deputy sheriff assigned to road patrol. In February 1978 he was accepted into the 93rd Recruit School of the Department of Michigan State Police.

He graduated in May 1978 and was assigned to the post in West Branch, Mich. In 1979 he was assigned to the Bay City post until 1980 when he was one of the first laid off troopers in the MSP. During this time he was hired as the chief of police, for the Village of Marlette, Mich.

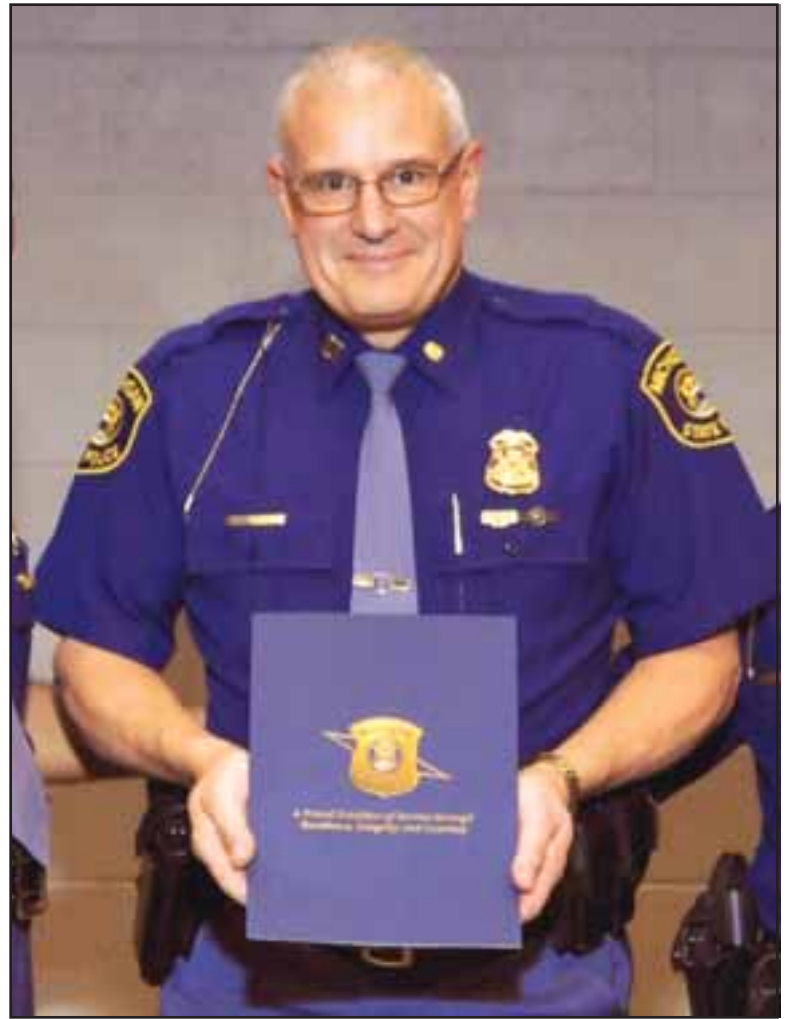
He returned to the state police in the spring of 1981, assigned to the Flint, Mich. post, where he served until 1984 when he was transferred to the Bridgeport, Mich. post. In May of 1987 he was promoted to a uniform sergeant's position at the West Branch post where he served until 1988 when he was transferred to the Bay City, Mich. post.

While assigned to the Bay City post he became a firearms instructor and eventually became the team leader for the Third District 9mm Transition Team converting the agency from the six shot revolvers to the Sig Sauer auto-pistols. "That was a historic time in our agency," Smith said. "From 1917 until then we carried revolvers. It was a large transition for an agency with 1,200 plus officers (at that time). It took 11 months for everyone to complete the complex training

mission. Then we became equal in firepower to some of the predators we encountered."

In 1990 he took a lateral transfer to the East Tawas post filling a vacant detective sergeant position. While assigned as a detective, he was awarded two departmental Professional Excellence awards, the first for his role in the arrest and conviction of a suspect in 27 breaking and entering complaints that included five safe breakings occurring in five counties in northeast Michigan - including Alcona County. The second was for his role in the successful investigation and arrest of three suspects involved in an arson and quadruple homicide that occurred in Gladwin County. During this time, he was also trained as a hostage negotiator for departmental Emergency Services Team.

In 1994 he was promoted to the operations lieutenant position at the Bridgeport, Mich. post. In the spring of 1995 he was promoted to first lieutenant of the Sault Ste. Marie, Mich. post. While at the Sault Ste. Marie post, he had numerous occasions to work with his international partners in Canada. He also assisted Chippewa County in the development of its emergency 911, central dispatch system. In August of 1997 he accepted a transfer to the Gaylord, Mich. post as a post commander. In 2000 he was promoted to the assistant district commanders with the rank of inspector for the seventh district.

In 2007, Michigan hosted the National Governors Association summer meeting held at the Grand Traverse Resort in Acme, Mich. The Michigan State Police was in charge of the security and transportation of the 50 governors for this event. Smith was the assistant incident

commander for this event. In June of 2010 Smith was promoted to captain of the Michigan State Police Seventh District.

Lt. Col. Gary Gorski, commander of the MSP Field Services Bureau and deputy di-

Dying with debt: Will your children inherit your obligations?

Dear Savvy Senior
 What happens to a person's debt after they die? At age 78, I have accumulated quite a bit of credit card and medical debt over the past few years and am concerned about leaving my son and daughter with a big bill after I die. What can you tell me?

Old and Broke

Dear Old,

In most cases when a person with debt dies, it's their estate, not their kids that's legally responsible.

When you die, your estate - which consists of the stuff you own while you're alive (home, car, cash, et cetera) - will be responsible for paying your debts. Whatever is left over is passed along to your heirs as dictated by the terms of your will, if you have one. If you don't have a will, the intestacy laws of the state

you reside in (see mystate-will.com) will determine how his estate will be distributed.

If, however, you die broke, or there isn't enough money left over to pay your unsecured debts - credit cards, medical bills, personal loans - then your estate is declared insolvent, and your creditors (those you owe) will have to eat the loss.

There are, however, a couple of exceptions that would make your kids legally responsible for your unsecured debt after you pass away: If your son or daughter is a joint holder on a credit card account that you owe on, or if they co-signed on a loan with you.

Secured debts - loans attached to an asset such as a house or a car - are another story. If you have a mortgage or car loan when you die, those monthly payments will need to be made by your estate or heirs, or the lender can seize the property.

You also need to be aware that there are some assets,

such as 401(k) and 403(b) accounts, brokerage accounts, and some life insurance policies that creditors cannot get access to. That's because these accounts typically have designated beneficiaries, and the money goes directly to those people without passing through the estate.

If you haven't already done so, you need to inform your kids and the executor of your will of your financial situation so there are no surprises after you die.


If you do indeed die with debt, and you have no assets, settling your estate should be fairly simple. Your executor will need to send out letters to your creditors explaining the situation, including a copy of your death certificate, and that will probably take care of it. But, your kids may still have to deal with aggressive debt collectors who try to guilt them into paying.

If you have some assets, but not enough to pay all



your debts, your state's probate court has a distinct list of what bills get priority. The details vary by state, but generally estate administrating fees, funeral expenses, taxes and last illness medical bills get paid first, followed by secured debts and lastly credit card debts.

If you have questions regarding your specific situation, you should consult with an attorney. If you need help locating one use findlegal-help.org, a consumers guide created by the American Bar Association that offers referrals and links to free and low-cost legal help in your area based on your income level. If you don't have Internet access, call the Eldercare Locator at (800) 677-1116 for referrals.

The Michigan Department of Natural Resources' Northern Lake Huron Management Unit in Fisheries Division has will hold meetings in Alpena, Cheboygan, Mich. and Grayling, Mich. to discuss local and statewide fishing regulation proposals. There will also be a short informational session to describe unit activities.

The meetings will be held on the following dates in the following locations:

- Thursday, April 12 beginning at 7 p.m. at the Cheboygan Sportsman's Club, 13516 Seffren Road, Cheboygan, Mich.

- Monday, April 16, beginning at 7 p.m. at the Thunder Bay National Marine Sanctuary, 500 W. Fletcher Street, Alpena

- Thursday, April 19, beginning at 7 p.m. at the Grayling Nature Park, 100 James Street, Grayling, Mich.

Several local regulation proposals will be discussed at the meetings, including the following:

- Ocqueoc and Black river watersheds pike regulation, including addition of Tomahawk Lake, Ocqueoc Lake and Pug Lakes for no size limit on pike.

- Trout (Carp) Lake pike regulation change (no size limit).

- West Branch River trout stream designation boundary change of downstream limit.

Several statewide regulation proposals will also be discussed, including the following:

- Brook trout daily possession limits for Upper Peninsula streams.

- Northern pike size and possession limits.

- Muskellunge size and possession limits.

- Prohibiting the recreational take of the newly listed special concern species - queen snake and western lesser siren.

The boy walked to the local convenience store to get a bag of Skittles and a can of iced tea. I'm not sure why the media has locked onto that fact so strongly – those purchases are mentioned in almost every report, as they are here. Perhaps because they're just so innocuous.

Likely, they weren't anything he needed. More a chance to get out and away for a few minutes. Away from the eyes of the 'rents, out into the darkness, a chance to stretch his legs and call his girlfriend one more time before the game came on television. A walk to the store and back, more for the going than for anything he purchased. Seventeen's an age that chafes at confinement, especially in boys.

The man was only 28, the local neighborhood watch captain in his gated community. Perhaps, had he carried a candy bar and a cup of coffee, we would not know his name today. But, tucked in his waistband, the man who had called 911 more than 40 times in the previous six months carried a nine millimeter semi-automatic handgun.

Everyone's read the story – everyone knows what happened. Or none of us do. We know that ultimately, the confrontation ended with the boy dead on the ground and the man allowed to go home, with no arrest forthcoming. As to what happened in the rain that night, every story is different, even those of the witnesses coming forth.

What we do know, it would seem, was that there was something else out there with the boy and the man that night. Some people say it was racism, some that it was the result of an angry generation. It seems to me it was fear.

A good portion of Florida's middle-class live in "gated communities," some in places that have a fairly low incidence of crime. In many, given the major inconvenience of getting in and out, the gates are rarely closed, although there's nothing to indicate this was true at the Retreat At Twin Lakes, where the shooting occurred. There had been other break-ins in the community, according to police reports. And all of it happened less than 20 miles from Orlando, Florida, home of Disney World – "the happiest place on earth."

The loss of a boy – of any young person – is a terrible thing. Fear is a terrible thing. And while I expect to get some argument on this, I can't help but comment that if the man had been carrying the candy bar and cup of coffee mentioned above, both characters in the story might be alive today.

But the answer to this particular death lies not just in the issue of whether it was self defense or flat out homicide. To a large extent, it lies further north, in Tallahassee, Florida's state capital where, five years ago, the Stand Your Ground Bill was signed in to law.

Many states have laws that protect the individual's right to use deadly force if he feels his home or property is being threatened and while I'm not sure I agree, I wouldn't argue them. The Florida law goes much further. It contends that if you believe you are being threatened – on the street, in the park, anywhere – you have the right to use deadly force to protect yourself.

That law might have a chance to work, if everyone could be counted on to make accurate evaluations and rational decisions in times of stress. Fear, however, can render those thought processes faulty in the best of us.

We know that in the Trayvon Martin case, George Zimmerman, the shooter, tended to fixate on young African American men as predators. As part of his role as watch captain, he went door to door, specifically warning about the issue. His earlier calls to 911, and their subject matter, tend to back that up.

We know that when advised by the 911 dispatcher to back off and allow the police to take over, Zimmerman did not. He continued to follow the boy, whose girlfriend advised him over his cell phone to run. We don't know if the boy attacked the man – witnesses give conflicting testimony. We don't know how the gun went off, how the fatal shooting occurred.

But we do know, I think, that the entire event was fear driven. And that years earlier, members of the Florida

legislature used that fear to raise support for the Stand Your Ground bill.

Five years ago, because my daughter was living in south Florida, I read the South Florida newspaper on-line on a regular basis. I remember warning her, when the bill became law. "You have to be careful," I told her. "Under this law, mouthing off to someone on the street could give them the right to shoot you."

Young and invincible as she was, I suspect she paid little attention to the warning. And in reality, she – or anyone who isn't overtly committing a crime – shouldn't have to.

Fear is a powerful force. We fear those who are different, those who we think – for whatever reason, rational or otherwise – might do us harm, take what is ours. We fear the unknown figure in the darkness.

Unlike our own small town, people in bigger places tend to avoid eye contact with strangers. If the boy and the man had acknowledged each other, if they'd mentioned the rain, the game that night, they both might have recognized the lack of a need for fear. The fatal incident might never have occurred.

And if it had not been legal for the shooter to "stand his ground" it might have made a difference, too. "Guns don't kill people," the bumper sticker reads, "People kill people." The fact is, it's a lot easier and a lot more likely to kill someone with a gun in your waistband. Laws don't kill people, either. But the fact is, a law to legitimize decriminalizing acting out your fear makes it a lot more likely you will.

All by itself, fear is a terrible thing. There are people, everywhere, forced to face it in their day-to-day lives simply because of the circumstances in which they live. But not in the gated communities of central and south Florida. Not to the extent that the Stand Your Ground law allows.

Guns don't fight fear. Neither do laws. Knowledge fights fear. Comprehension fights fear. Rationality fights fear. We need, as a nation, to strive toward those goals.

Otherwise, we find ourselves more and more a frightened vigilante society, our distinctive colors and personalities and ethnicities bleeding together into a sticky mess, legitimizing fear, not celebration. Like a bag of Skittles, scattered in the rain.

Surveying elk population from the air

In order to responsibly manage the elk population, the DNR needs to know where the elk are located and how many there are. The DNR conducts aerial elk surveys every other year in northern Michigan.

Two fixed-wing Cessna 182 airplanes are used for the elk survey. Three DNR staff are in the plane: A pilot and two observers. Observers look out the window on each side of the plane for elk as the plane is flying about 80 miles per hour and 500 feet in the air.

The planes do not fly around looking for elk just anywhere; instead, to conduct the most effective survey, grids are placed onto a global positioning system (GPS) unit. Each grid is two miles wide and six miles long and the entire elk management area is broken into 86 grids. Several passes will be made within the grid to adequately cover the survey area. This allows for optimal viewing to find herds, or even locate lone elk standing in the snow. When an elk is spotted, the pilot starts circling to allow staff to count the elk.

The aerial survey usually begins in early January, after enough snow has fallen to make it easy to spot elk. The survey allows staff to see where elk are gathering and to get an idea of the number of male elk (bulls), female elk (cows), and young elk (calves). This survey provides the data needed for DNR wildlife biologists to recommend license quotas to the Natural Resources Commission for the 2012 elk hunting seasons.

The goal for elk management in Michigan is to achieve optimal elk viewing and hunting opportunities

with minimal timber browse and agricultural damage impacts. The core of the elk range is an area from Indian River east to Onaway south to Atlanta and back west to Vanderbilt. But elk also live outside that area. Hunting is the best management tool to control the elk population and distribution.

"Our survey was delayed by about two weeks this year, due to low snow accumulations," said wildlife biologist Mark Monroe. "Fortunately we got the snow we needed, and we ended up having a great survey." DNR staff flew the entire elk range from January 18 to February 1. Several days had to be cancelled due to poor visibility but weather conditions improved and those days were

made up in reasonable time.

In the end, a total of 850 individual elk were counted, which provided an estimated population of 1,042 elk. "We know that we do not see every elk because the plane is moving fast and elk are sometimes under heavy cover," said U.P. wildlife biologist Dean Beyer. "Therefore, aerial counts underestimate the number of elk in the population." To provide a more accurate estimate of elk, totals are adjusted with a correction factor that accounts for the elk missed. This correction factor was established by running experimental trials on radio-collared elk. This is now a standard practice among wildlife managers throughout the nation.

Connecting female veterans to VA benefits

Women who performed military service to their state and nation as nurses, cooks, uniform construction and repair clerks, couriers and other roles prior to World War II were not recognized as veterans and were not eligible for VA benefits.

It wasn't until 1948 when President Harry Truman signed the Women's Armed Services Integration Act, that women would be considered an official and permanent part of the regular and reserve U.S. military.

Still today, many female service members do not think of themselves as veterans and thus may be missing out on VA benefits they are eligible to receive. "We have found in our studies of female veterans that they do not relate to the term 'veteran.' Many spent time as administrators and in supply roles to combat troops during their military service. When they leave the service they do not associate themselves with the term and move on with life," said Susy Avery, executive director of the Michigan Women's Commission Female Veteran Initiative.

"They do not take advantage of the benefits they have

earned." The National Center of Veterans Analysis and Statistics estimates that 45,400 female veterans currently live in Michigan. Michigan female veterans have played important roles in the Gulf War, Operation Enduring Freedom, Operation Iraqi Freedom and Operation New Dawn.

Today more than 17 percent of veterans returning from Afghanistan are female and new units like the Female Engagement Team are forging new sociological inroads that vastly expand the effectiveness and cultural sensitivity of all U.S. forces.

"The Veterans Administration has made great strides in serving female veterans, especially at the VA Medical Centers," said Jason Allen, Senior Deputy director, Department of Military and Veterans Affairs. "The more we talk about the resources that are available, the higher the likelihood those veterans will apply when they need assistance."

The VA has established Women Veterans Program Managers (WVPM), stationed full-time at every VA medical center across the nation. Program managers are health

care professionals who serve as advisors and advocates for women veterans in order to help connect them to VA services. A directory of VA centers can be found at www.va.gov/directory or by calling (202) 273-6193 or (202) 461-1070. Additional VA information can be found at www.womenshealth.va.gov.

Volunteers set to begin Michigan's annual frog and toad survey

Odds are, unless you're a 10-year-old boy or a herpetologist, you haven't thought a lot about frogs lately.

Fortunately for the frogs, the Michigan Department of Natural Resources (DNR) has - and sometime around the

end of the month or the beginning of next month, the DNR will launch its 17th annual frog and toad survey across the state.

Designed to serve as a rough indicator of the state of Michigan's frog and toad

populations, the survey involves an army of volunteers driving, stopping and listening for the amphibians calling across the state. The survey covers an average of 200 routes annually - not all routes are covered every year - with volunteers trained to record both the amount of calling they hear as well as the different species.

Volunteers travel along an established 10-stop route, driving for a half-mile, then stopping and listening for five minutes. They record what they hear on a scale from zero (nothing) to three (too noisy to count individual calls) for each species.

Lori Sargent, who coordinates the survey for the DNR's Wildlife Division, said the survey is designed to provide a simple index to give wildlife managers an idea of which direction Michigan's frog and toad populations are heading.

"We know that the common species - the green frog and the American toad - are fairly stable," Sargent said. "The rare species - Blanchard's cricket frog, Fowler's toad and mink frog - are still pretty rare."

Michigan boasts 12 species of frog and two species of toad. Some are widespread

across the state. Others are found in specific areas. The mink frog, for instance, is found only in the Upper Peninsula. The boreal chorus frog is found only on Isle Royale.

"Bullfrogs are around and reported all over the state, but they're not real common," Sargent said. "Spring peepers are probably the most common; they're certainly the loudest."

"Fowler's toads are found only on the west shore, but I've had people say they've heard them on the east side, but that's not confirmed," she said. "Blanchard's cricket frog used to be more widespread

across the southern half of the Lower Peninsula, but now we only hear them in the lower two tiers of counties. Green frogs are very common. Eastern gray tree frogs are common, too."

Sargent explained volunteers for the survey come from a wide pool of amphibian enthusiasts. "I've got teachers doing it with their classes, from elementary school to college," she said. "There are clubs and individuals, too."

Although frog and toad populations have been decreasing in some parts of the

The Sprint Cup season is only five races old, but Clint Bowyer has gone a long way toward eliminating the uncertainty that clouded his career during the off-season.

Bowyer, 32, made his name at Richard Childress Racing, where he won five races since joining the Cup ranks full-time in 2006. Twice he won at New Hampshire Motor Speedway, in 2007 and 2010, and at Talladega Superspeedway, in 2010 and 2011. He also won at Richmond, in 2008.

Late in 2011, Bowyer found that, due to sponsorship issues, there was no place for him at RCR. The Emporia, Kan., native considered several offers and decided to move to Michael Waltrip Racing, where his No. 15 Toyota is sponsored by 5-Hour Energy Drink.

Waltrip's team has won only twice since its inception in 2007. RCR has won 100 Cup races, dating back to 1983.

So far, so good. Bowyer ranks ninth in the Cup standings with one top-five and

two top-10 finishes.

"These MWR cars have been good ever since (teammate Martin) Truex was running good at the end of last year," Bowyer said. "Just real proud of everybody."

"Looking at last year, they showed signs of brilliance, and then, I think, where they lacked was being consistent throughout the year. If we're able to go there, that's one thing that's always been my strong point. If I can continue my consistency... that's what we're missing."

Bowyer never felt the perceived uncertainty regarding his latest career move.

"In this sport anymore, the cars are so much the same that the only real thing you're starting over with is the group of people," he said. "Sometimes change can be good and bad. There's no question that, last year, I didn't have the success that I expected and that I wanted."

"Maybe it was time to make a change, and I'll be able to answer that in a year or so. I really see a lot of potential here, a lot of things coming together at the right time for

me to make a change and ride that wave on into the future."

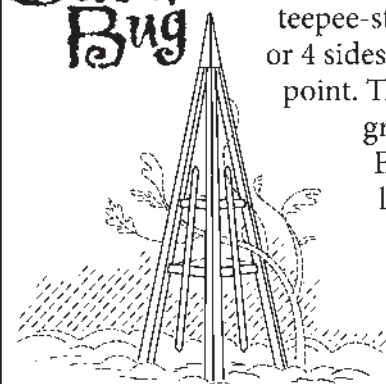


A teepee trellis

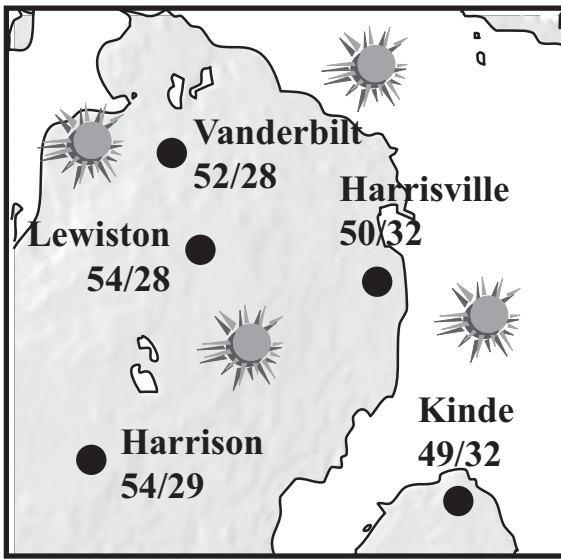

StarWatch By Gary Becker - Journey of an Iceberg



"Iceberg, right ahead...!" Those words were called out by lookout Fredrick Fleet at 11:40 p.m., April 14, 1912, shortly before the Titanic struck the mountain of ice that would send it to the bottom of the North Atlantic three hours later. Where did the iceberg that fated the Titanic originate, and by what journey did it arrive in the Titanic's path? The experts believe that it calved from the Jakobshavn Glacier in western Greenland, perhaps in September of 1910. During the next year and a half it floated into Disko Bay and into the West Greenland Current, where it moved northward, floating past the rugged shores of western Greenland, passed Thule, counterclockwise around Baffin Bay, and then southward along Baffin Island, through the Davis Strait, and into the Labrador Current. As it came close to the craggy coastline of southern Labrador and the southeastern shores of Newfoundland, it may very well have become grounded, not once but several times, as tidal forces waxed and waned. It is the moon that is responsible for the majority of the tidal effects that we experience. In fact, Luna is about 2.2 times more potent in raising the tides than the sun. As the Earth rotates underneath a slower moving moon, the oceans oscillate between high and low tides twice each day. Exceptionally high tides that could strand some icebergs and release others, called spring tides, occur when the moon is either new or full and the tidal forces of the moon pull in the same direction as the sun. Neap tides result when the moon and sun pull at right angles to each other dampening the tidal pull, causing lower high tides and higher low tides. East of St. John's Newfoundland, the iceberg moved slowly but steadily south, then southeast into the North Atlantic and into the path of the doomed ship. 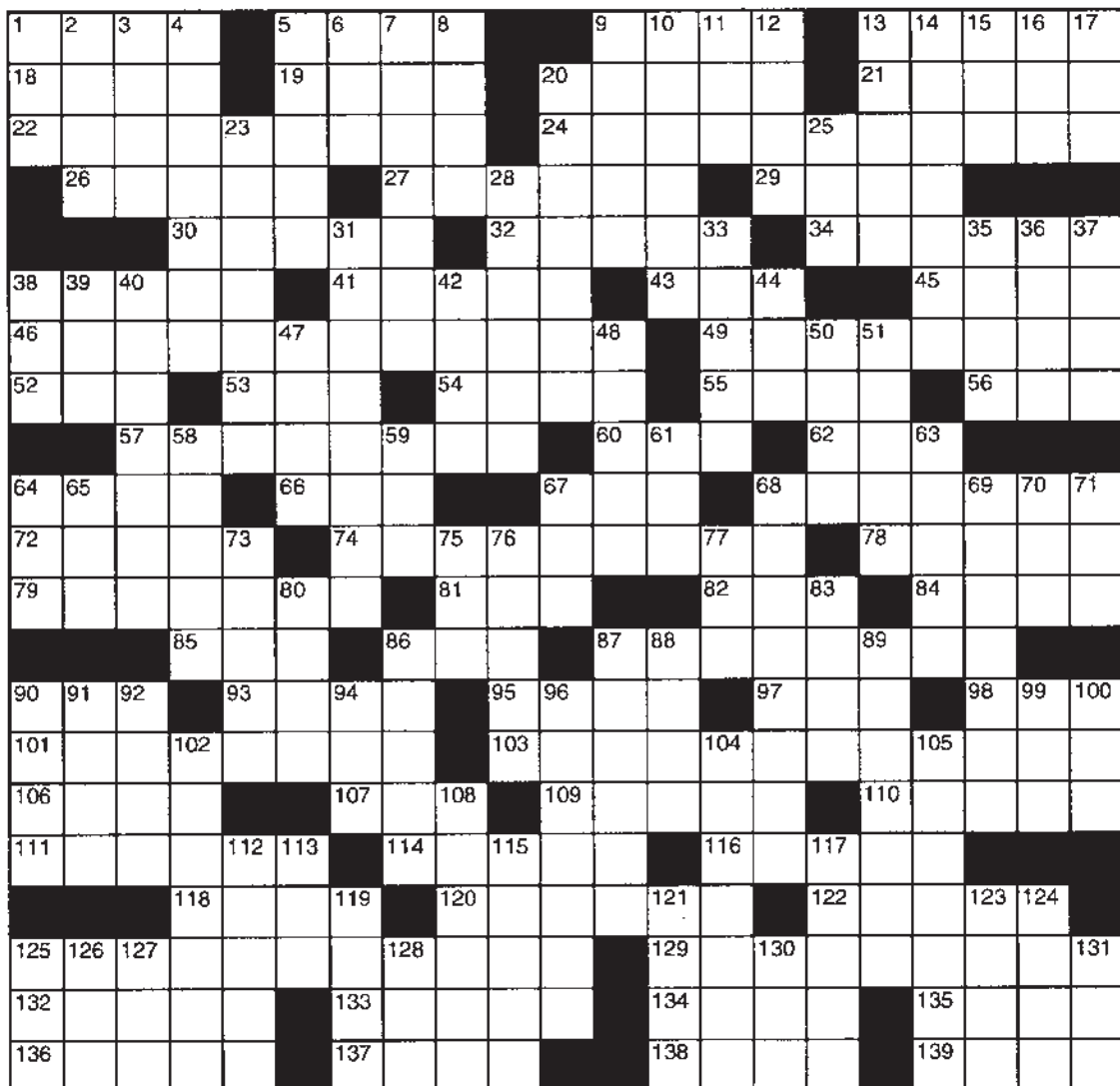

• On April 22, 1889, at precisely high noon, thousands of would-be settlers make a mad dash into the newly opened Oklahoma Territory to claim cheap land. All told, from 50,000 to 60,000 settlers entered the territory that day. Towns like Norman, Oklahoma City, Kingfisher and Guthrie sprang into being almost overnight.

• On April 21, 1918, in the skies over France, Manfred von Richthofen, the notorious German flying ace known as "The Red Baron" with 80 victories under his belt, is killed by Allied fire. He was 25 years old.

• On April 17, 1937, Daffy Duck makes his debut in the Warner Bros. short "Porky's Duck Hunt." In the 1920s, movie houses had started showing a short cartoon before feature presentations, but the form became more popular after sound was introduced in 1928.

• On April 16, 1947, in Texas City's port on Galveston Bay, a fire aboard the French freighter Grandcamp ignites ammonium nitrate, causing a massive blast that destroys much of the city and takes nearly 600 lives. The fire department tried to douse the flames, but the ship was so hot that the water from their fire hoses was instantly vaporized.

• On April 19, 1957, the Brattle Theater in Cambridge, Mass., presents its first showing of "Casablanca," introducing a new generation to Humphrey Bogart, who had died months earlier. Bogart had been wounded aboard a Navy ship during World War 1. His upper lip was scarred and partially paralyzed, giving him the tough-guy poker face and slight lisp that characterized his acting.

• On April 18, 1983, Joan Benoit wins her second Boston Marathon in the women's division with a time of 2:22:43. The inaugural Boston Marathon was run on Apr. 19, 1897, and was a men-only event until 1972, when women were officially allowed to compete.

Don't become a victim of identity theft

The Consumer Federation of America has a new website designed to help reduce identity theft. IDTheftInfo.org is packed with consumer, business and victim resources, as well as the latest news and a section on shopping for identity-theft services.

One section on the website explores how well you guard your personally identifying information (PII), even something as simple as your library card. If you were to lose the card, you might not be too concerned as it's not something connected with your bank account. But if someone checks out and doesn't return (in effect, steals) books or videos under your name, you're responsible for the monetary damages.

ID Theft Info suggests making a "PII Chart" to document the identity relations we have with companies and individuals. Who has our name, address, phone number and email address? A security breach in one area can lead to other areas also being breached, and it need not be associated only with financial transactions. Homeowner associations, frequent-flier clubs and churches can all have pieces of our personal information that can be put together.

Some suggestions:
 Use a Post Office box for

miscellaneous mail such as club newsletters and church bulletins; disable the GPS photo function on your smartphone; and use only one credit card for online purchases. Don't sign up with your real name on public Internet sites. Work to limit the amount of information in each section of your PII Chart.

When you go to the doctor and fill out the forms, leave out your Social Security number. Ask if you can substitute another form of identification.

Don't use public charging stations or anyone else's computer for your cell phone, and don't let anyone else hook their phone to your computer. Data-stealing malware could be transferred from one to the other.

Are you a potential victim of identity theft? Assess your risk with an online test. The higher the score, the bigger your risk. Big point items (indicating a larger risk) are questions about whether you've ordered your credit report in the last two years, posted your outgoing mail at home in an unlocked mailbox or failed to scrutinize your monthly bank and credit-card statements.

Look around the ID Theft Info website. The more you know, the less likely you'll become a victim of identity theft.

Ty Cobb on hitting

A SPORTING VIEW

The old-timers come out of the woodwork every spring, don a practice jersey, put on the hat and offer their 2-cents worth of advice to rookies and veterans alike. Sandy Koufax used to join the Dodgers at Vero Beach, George Brett is a mainstay for the Royals, and old greats like Yogi Berra and Reggie Jackson still visit the Yankees at Legends Field.

But what would, say, Ty Cobb teach you about hitting? Luckily, thanks to a letter he received from a struggling ballplayer, we know the answer.

1. DON'T GRIP YOUR BAT AT THE VERY END; leave, say, an inch or two. ALSO, LEAVE AT LEAST AN INCH OR MORE SPACE BETWEEN YOUR HANDS; that gives you balance and control of bat, and also keeps hands from interfering with each other during swing.

2. Take a position at plate, especially against right-hand pitchers, BACK OF PLATE, and against a man with a real curve, YOU CAN STAY ON BACK LINE OF BATTING BOX. ... Start now practicing to hit your right-handers to the opposite field. An inside ball from a right-hand pitcher you will naturally pull, say, to left-center.

3. DON'T SLUG AT FULL SPEED; LEARN TO MEET THEM FIRMLY, and you will be surprised at the results.

4. Now, to hit as I ask, to right-center or center, STAND AWAY FROM PLATE the distance you can see with mind's eye that you can hit the ball that curves on inside corner,

to center. This ... will allow you to hit the outside ball to right. In other words, you protect the plate both on inside pitches and outside.

5. Remember, THE PLATE IS THE PITCHER'S OBJECTIVE AND HE HAS TO COME TO IT. ... Now, USE A SLIGHTLY CLOSED STANCE, AND KEEP A LITTLE MORE WEIGHT ON YOUR FRONT FOOT THAN BACK. That gives you balance and won't pull you away from curves. You are always in position to give maximum drive.

6. DON'T PULL A CURVE BALL FROM A RIGHTHANDER. The ball is revolving away from you. Hit with the revolution and to right field.

7. KEEP YOUR LEFT ELBOW COCKED ON LEVEL WITH YOUR HANDS OR EVEN HIGHER. Never let the elbows down below the hands, and keep your hands always well away from the body — keep pushing them out, even with your body or

back.
 8. KEEP YOUR BACK LEG STRAIGHT. Of course, if you put your weight more on the front leg, then the back leg will be straight.

9. IF HIGH FAST BALLS INSIDE REALLY BOTHER YOU: crouch over from waist and pass them up. Don't bite, in other words. In crouching, you make the pitcher throw lower, which forces him away from the position that bothers you. But I think with the instructions I have given, you will hit them wherever they pitch.

10. AGAINST A SPEEDY LEFT-HANDER, DON'T PULL. Use same stance I have given you, and when he throws you his curve, knock him down with it. ... BUT AGAINST A LEFT-HANDER OF FAIR SPEED: Move up in the box, also closer to the plate, and PULL THIS STYLE OF PITCHING.

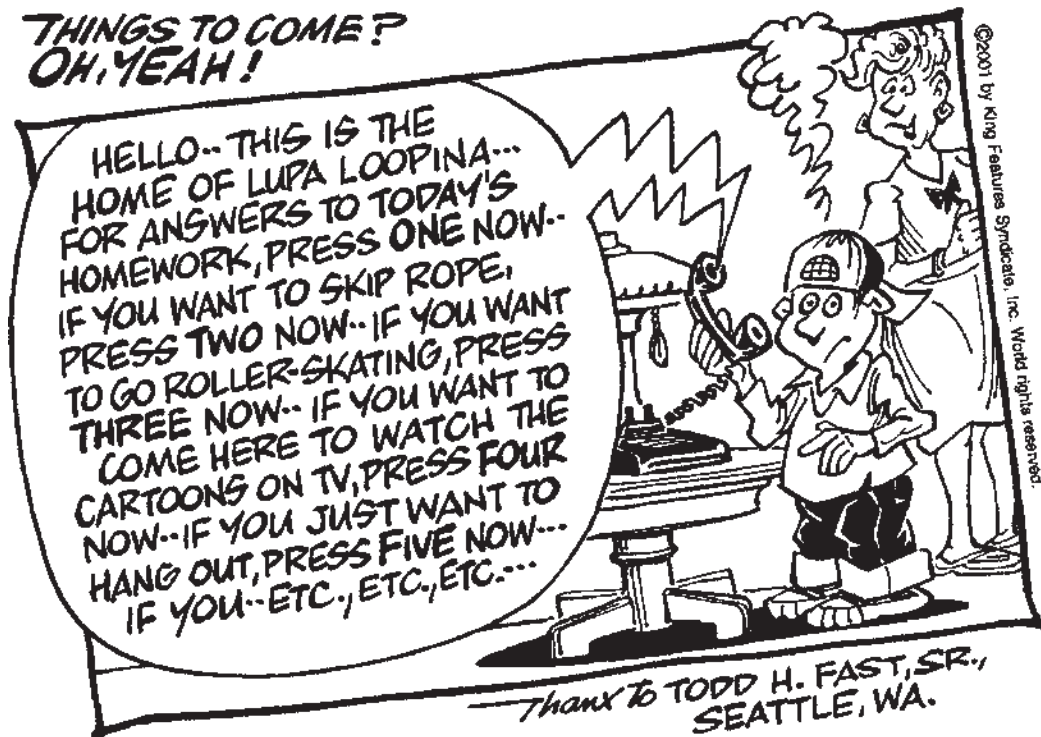

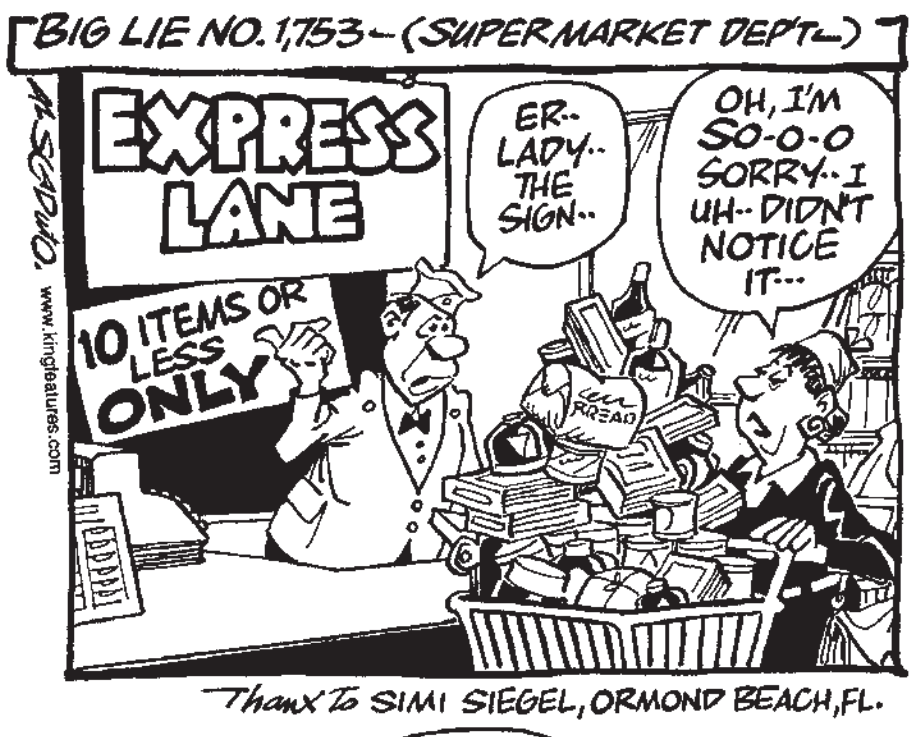

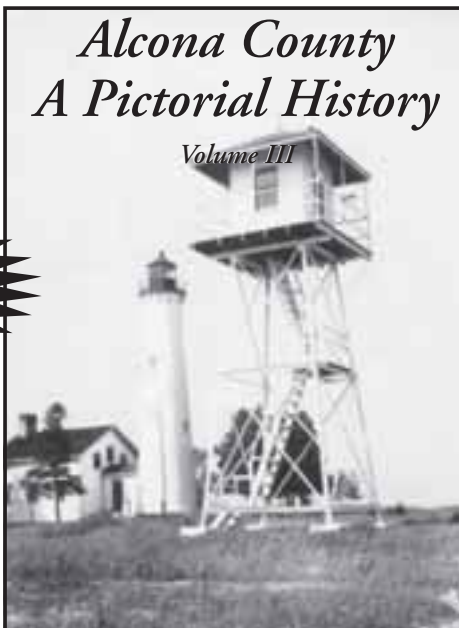

country – notably the West – Michigan’s populations seem to be holding up well, Sargent said. Some species, however, are in decline.

“Relative to how they once were, leopard frogs are less common than they used to be,” she said. “Pickerels, which can be confused with leopards, are even less common.”

Blanchard’s cricket frog is a state-threatened species. The boreal chorus frog is a species of concern. Sargent said she has some professional concern about Fowler’s toads – they were not reported in the 2011 survey – but the information doesn’t justify their listing as such quite yet.

Although frogs and toads

are well down the list of animals most folks are interested in, Sargent said the DNR is very concerned about their well-being.

“These things have been here for millions of years,” she said. “They’re pretty adaptive. But they’re kind of an indicator of environmental health, so if you see them wicking out, you know something’s going on.”

“They’re important wildlife; an important food source for birds, snakes and some mammals; and they also eat their fair share of mosquitoes and other insects – that’s important, too.”

The survey “really monitors the habitat,” Sargent said. “If you see frog populations going down, you know you have a wetlands or water-quality issue.”

The frog and toad survey will continue through early summer, and the results will be compiled and published. The survey is relatively inexpensive to conduct, as it’s mostly conducted by volunteers. It’s funded, in part, by

the folks who buy wildlife conservation license plates. Volunteers are trained to distinguish the various calls and, although the DNR hasn’t held a training session in several years, compact discs are available for volunteers who want to study up on identifying calls.

Amphibians (as well as reptiles) are actually managed by the DNR’s Fisheries Division. Those 17 years of age and older must have a fishing license to take them. The limit is 10 amphibians of all species combined, though Blanchard’s cricket frogs and boreal tree frogs may not be taken.
