

## Local Vietnam veteran receives Quilt of Valor

Veterans walk among us every day going about their lives with little or no recognition of their sacrifice and service. Most are like John Jay Baker, a man proud of his family and proud of his country.

John spends his days in

retirement putzing through a list of honey-dos and tinkering on this or that in his garage. He lives a rather quiet lifestyle with his wife of over 40 years. They often sit together admiring the peaceful view of deer grazing just 20 feet away from their dining room window in Mikado Township.

Not many know the horrors of war John witnessed. Not many know the scars he endured and the debilitating health those years of service waged upon him. Only other veterans who served in similar ways comprehend the nightmare of war put away in memories they would rather not recall.

John would not want any attention for the years he sacrificed for his country. And, would never consider himself a hero. He fought a war in Vietnam -- a war which many to this day still do not understand.

But John is a hero and a decorated hero at that. He was awarded three Purple Heart medals for wounds received in a year's time fighting in rice fields. John's troop also received several presidential citations for jobs well done.

John was not drafted like many that served during Vietnam. He signed up to serve the country he loved, a love that is as strong as ever today. "I wanted to serve, it was the right thing to do," he said.

John went into the U.S. Army on Thanksgiving Day

in 1968. He took his basic training at Fort Knox, Ky. where he was trained in tanks and armored personal carriers (APC). He was deployed to Vietnam in May of 1969 at the age of 18 and was assigned to F Troop 17 Calvary 196 light infantry brigade. He drove an APC lead vehicle for reconnaissance.

"My first (injury) was when I hit a mine. It blew my tank up," John said. His second Purple Heart medal was for wounds received when John was in his APC in a rice patty

and the enemy shot the fuel tank with a rocket propelled grenade.

The third Purple Heart medal was awarded after an ambush. "The infantry was riding with us; I had to ground guide the APC through the woods at night to get us back to the unit. Just as (I) got to a clearing the enemy shot a rocket. It hit the side of the tank and it blew me up on top of it. I was just hanging there. It messed my back up and I suffered another concussion," John said.

After that hospital stay, John still wanted to fight with his unit and defied orders and hopped on a helicopter to get back to his unit. "When I got there the captain told me I was too short on (service) time left to help and sent me back."

He returned to the states in April of 1970 and reported to Fort Hood, Texas where he was a specialist fourth class. He trained other troops how to drive and maintain tanks and APCs. John maintained this position during his military career which he completed in 1971.

John met his beloved Bonnie in Texas a hundred miles from where he was stationed. "I don't know what he saw in me, but he kept driving the 100 miles every weekend to see me," Bonnie said. The couple has three children and six grandchildren, one deceased.



## Strength training tips for seniors

Dear Savvy Senior,  
Can lifting weights help with age-related health problems? At age 70, I have diabetes, arthritis and osteoporosis and recently read that strength training could improve my conditions. What can you tell me?

Looking for Help

Dear Looking,

A growing body of research shows that strength training exercises can have a profound impact on a person's health as they age – and you're never too old to start.

Regular strength training, done at least two nonconsecutive days a week, helps you build muscle strength, increases your bone density and improves your balance, coordination and stamina. It can also help reduce the signs and symptoms of many chronic conditions like arthritis, diabetes, high blood pressure, back pain, depression and obesity. And some studies even show that it

helps improve cognitive function too.

For the most part, strength training exercises – especially if you start conservatively and progress slowly – are safe for most seniors, even those with serious health conditions. But, if you have health concerns or if you are currently inactive, you should talk to your doctor about what may be appropriate for you.

A good self-help resource to help you find an appropriate, safe exercise program is the "Exercise and Screening for You" tool at [easyforyou.info](http://easyforyou.info).

If you've never done strength training exercises before, you may want to work with a personal trainer for a few sessions to help you develop a safe and effective routine you can continue on your own. They cost anywhere from \$20 to \$100 per hour. To find one, ask your health care provider or contact a good health club or fitness facility in your area. You can

also search for one online at reputable sites like [acefitness.org](http://acefitness.org) or [ideafit.com](http://ideafit.com).

If personal training isn't an option, there are lots of great senior strength training videos you can purchase to guide you through a wide variety of exercises that you can do at home. Collage Video ([collagevideo.com](http://collagevideo.com), (800) 819-7111) sells dozens of age and fitness appropriate DVDs at prices usually ranging between \$10 and \$20.

Also see [go4life.nia.nih.gov](http://go4life.nia.nih.gov), a resource created by the National Institute on Aging that offers a free exercise DVD and guide that provides illustrated examples of exercises you can do at home to strengthen your body. You can order your free copies online or by calling (800) 222-2225.

If you don't like exercising alone or need some motivation consider joining a gym, or call your local senior center to see if they offer any strength training exercise

classes. You should also check out SilverSneakers ([silversneakers.com](http://silversneakers.com), (888) 423-4632) or Silver&Fit ([silverandfit.com](http://silverandfit.com), (877) 427-4788). These are fitness programs offered in thousands of fitness centers, gyms and YMCAs throughout the U.S. that offer special classes designed for older adults. These programs are available only to seniors that have certain Medicare supplemental policies or Medicare Advantage plans.

If you work out at home you'll probably need to invest in some equipment. While some strength training can be done using your own body weight (like push-ups, sit-ups and leg squats), hand weights, ankle weights, medicine balls, resistance bands or rubber tubing are all great tools for strength training. You can find all these products at sporting goods stores, or online at [amazon.com](http://amazon.com) for around \$10 or less. Cans of soup, water bottles or plastic



milk containers filled with water or sand could also be used (like small hand weights) for resistance.

Another great strength training tool you should know about is the Resistance Chair (it costs \$280). This is an all-in-one home fitness system that helps seniors maintain and improve their strength from a safe seated position with minimal risk of injury. After they were married, John got a job working for the Chrysler Corporation. He worked there for 30 years and was disability retired due to ischemic heart disease. Ischemic heart disease reduces blood supply to the heart muscle. It affects many veterans as a result of being exposed to Agent Orange herbicide while serving in Vietnam.

John has had at least 30 angioplasties and 17 stints placed due to his ischemia. He also survived triple bypass surgery, but suffered loss of blood to his optic nerve during surgery and is now legally blind. "I can see straight, but I have lost my field vision," he said.

After retirement John and Bonnie moved to Mikado Township, a place John knew well. "I was raised in Warren, Mich., but my folks bought 80 acres up here in 1949 and every summer we came up. It wasn't always fun coming up as a kid because all we had to do was work, work, work, cutting hay, bailing it and getting rid of it. What we did like about it was there were lots of places to hunt.

"My mom still lives up here and I have brothers and sisters up here and even some aunts and uncles. We call this part of Mikado Baker-ville. We love it up here; love the fresh air and no traffic. The grandkids come up and visit and ride the four wheelers and Bonnie's golf cart. They have a great time," John said.

"I'm still kicking. I can still see my kids and grandkids, and my wife. I'm not ready for a dirt blanket yet. I keep busy. I cut the grass and watch it grow back. I have a heated garage and I do a lot of stuff out there. I like plowing in the winter," John said. Bonnie nodded in agreement, "He'd plow the whole county if he could; he's always got to be outside doing something."

Bonnie enjoys quilting and is a member of the Quirky Quilters Quilt Guild of Oscoda. They recently surprised John by presenting him with a Quilt of Valor sewn by guild member, Beverly Rue.

The Quilt of Valor foundation is an organization created by a mother of a soldier who was deployed to Iraq. Her mission was to award members and veterans touched by war with healing quilts. Since its inception, 69,743 quilts have been given to comfort veterans with a token of gratitude for their service.

"I thought I was going to a ceremony to accept a cane

posthumously for my dad (Jacob Baker) who was also a veteran and died last year," John said. "I had no idea they were going to present me with his cane and a quilt for me."

Bonnie explained it was hard to keep the quilt a secret and yet obtain information about John's time in service to tell at the ceremony. "I got our 12 year old granddaughter, Jordyn, to tell Papa she was working on a school assignment about a special person and she wanted to write about John. She ended up writing a two page report about John's time in service which I read at the ceremony," Bonnie said.

"It was quite a humbling experience," John said shaking his head. "There were a lot of other veterans there that should have been honored instead of me, but I was extremely honored. I'm very thankful to the Quirky Quilters and to the Sunrise Side Wood Carvers," John said as he gazed at the massive quilt in red, white and blue and the cane.

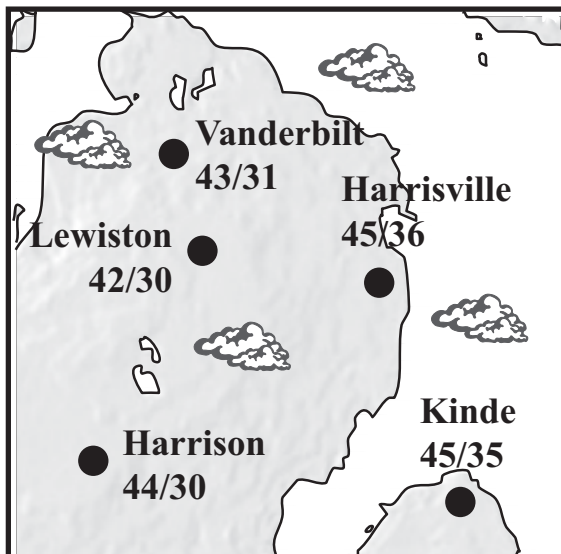

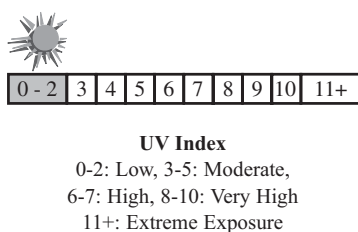

### StarWatch By Gary Becker - From Snow to Blow

"I don't think I have ever seen a day quite like today. There will be no stars shining in Coopersburg this evening, just the silent beat of star-shaped snowflakes falling among semi-skeletal trees." Those words were written on October 29, 2011 during the first hours of a Halloween snowstorm that blanketed the Northeast, and in my particular area, caused thousands of leafed branches to snap. Electrical outages lasted for a week for some of my friends, and cleanup went on for months. I dropped six trees in my backyard this past spring that had been severely weakened by that storm. It is now October 29, 2012 and although it isn't snowing, the winds are beginning to howl with an increasing ferocity as Hurricane Sandy hooks to the west and targets southern New Jersey with 90 mph winds. The tempest is still 200 miles off the coast of Delaware. This scenario is being called "unprecedented in the history of tropical events" because of its size and its odd movements. My lights have already begun to flicker, predicting in no uncertain terms that the electricity will go out soon, and this time, longer than last year; it may affect as many as 10 million people in the path of this monster storm. Make no mistake; this is just the beginning of a swing to wilder and crazier weather and more extreme conditions that will begin to affect greater numbers of people around the world, but particularly in the continental US. Even before the scientific community began to warn us decades ago about the detriments of global warming, the United States was always the battleground for the staging of severe weather. We get more impactful tropical systems, and four out of every five tornadoes occur here in the US. When you go to the polls on Tuesday, remember that one party doesn't even support the belief that global warming exists. That one fact alone is reason enough for me to want to vote for the other guys. www.astronomy.org

### MOMENTS IN TIME The History Channel

- On Nov. 24, 1849, John Froelich, the inventor of the first internal-combustion tractor, is born in Girard, Iowa. Froelich and investors formed the Waterloo Gasoline Traction Engine Company. The Waterloo Tractor Works, owned by John Deere since 1918, remains one of the largest tractor factories in the United States.

- On Nov. 22, 1900, the first car to be produced under the Mercedes name is taken for its inaugural drive in Cannstatt, Germany. The car was specially built for Emil Jellinek, a fan of fast, flashy cars. He bought 36 of them. In exchange, the company agreed to name the car after Jellinek's 11-year-old daughter, Mercedes.

- On Nov. 19, 1915, British airman Richard Bell Davies performs a daring rescue, swooping down in his plane to whisk a downed fellow pilot from behind the Turkish lines. The British government awarded him the Victoria Cross.

- On Nov. 21, 1934, teenager Ella Fitzgerald wins Amateur Night at Harlem's Apollo Theater. Putting her name in the hat on a bet, she'd originally planned a dance number. History was made when she changed her mind and sang "The Object of My Affection."

- On Nov. 20, 1945, a series of trials of accused Nazi war criminals, conducted by a U.S., French and Soviet military tribunal based in Nuremberg, Germany, begins. Twenty-four former Nazi officials were tried, and half would be sentenced to death by hanging.

- On Nov. 23, 1959, Robert Stroud, the famous "Birdman of Alcatraz," is released from solitary confinement for the first time since 1916. For 15 years, Stroud lived among canaries brought to him by visitors, and he became an expert in birds and ornithological diseases. In 1943, Stroud's Digest of the Diseases of Birds, a 500-page text that included his own illustrations, was published to general acclaim.

- On Nov. 25, 1963, President John F. Kennedy, who was assassinated three days earlier, is buried with full military honors at Arlington National Cemetery. An eternal flame was lit by his widow to forever mark the grave.
