Rich has lived in Alcona County since he was two and a half years old when his parents, Dick and Ruth Gillies, purchased a funeral home in Lincoln. He grew up in the house next door to the funeral home.

He had no idea that he would end up following in his father's footsteps, but at the age of 23 Rich graduated from Worsham Mortuary School in Chicago, Ill. -- the same school his father graduated from.

With his wife, Mary, working at his side, they kept the family business going while raising their own family in the same house Rich grew up in. They have two children, a son, Jeffrey who is an environmental journalist and a daughter, Sara.

Sara and her husband, Aaron Healy, also graduated from the Worsham Mortuary School and are raising their

two and a half year old son, Henrik, in the same house. The Gillies Funeral Home is now being operated by Richard, Sara and Aaron. "We've lasted three generations here. My dad bought the funeral home in 1956 and it's still being run by family," he said.

While not sure why other families pass the business down through generations, he thinks it is what they become accustomed to over the years. "The business encompasses so much of your life. It's a 24 hour a day business. My wife, Mary, helped with the business quite a bit. There were times when you'd have a vacation scheduled, but you'd get a call, and the vacation would have to wait. The

business draws you in and just becomes a part of your life.

"Operating a funeral home is a round the clock business in a small town; you never know when you will get a call in the middle of the night and have to go. It's an encompassing job which dictates your schedule. Sometimes when I would attend parent's day at school (being a funeral director) I'd be the only parent wearing a suit and tie," Rich said.

"There were long hours put into the business, but we had a lot of fun being a family here. Living next door to where I worked, I was able to spend a lot of time with my kids when they were growing up. I really got to know my kids. I'd see them mostly during the day, for lunch. I'd have to miss some of the school programs that went on in the evenings though because of business," he said.

Sara, agreed that her dad worked a lot, but he was always around. "He coached my soccer team, umpired baseball and would chaperone on field trips when he could. I always felt very lucky he was so involved," she said.

Now that Sara and Aaron help with the funeral home Rich has been able to scale down his work hours. "When Aaron and Sara moved back,

## Friends of playground fundraise for facelift

Since its paper chain link ribbon cutting ceremony in 2000 the Flight's of Imagination Playground has been the go-to park for Alcona County's younger set. After all, the entire playground was designed with the kids' of Alcona County dreams and wishes in mind.

The children of Alcona County have enjoyed its many amenities for the last 12 years. However, very little has been done since it was built, and the playscape is in need of repairs.

The playground was an idea conceived in 1999 when presented to Teresa Hart and the late Dawn Sherwood to

give the children of Alcona County a recreational outdoor play area.

The team first met with architects from Leather and Associates of Ithaca, N.Y. Mari Mitchell, an architect from the firm, then interviewed 551 students of the elementary school to gather their ideas and design a playground area to meet their desires.

Work began to fundraise the \$100,000 needed to build the project. "We did fundraiser after fundraiser, I don't even remember that year of my life," Hart said. "Lincoln was centrally located in the county and the Village of Lincoln just happened to have room near

the ball fields for the playground and donated the land to us. It would have taken considerably more time and money to build the project if we had to buy the land," Hart said.

The sweat equity began as volunteers donated tools and time to build the structure. Two architects oversaw the construction, but the actual building of the project was all donated time and effort. "We built it in five days, everything -- tools and meals -- were all donated and everything was done by volunteers. We were supposed to have 300 people at each shift, a morning, afternoon and night shift. We were lucky to get 150 people at each shift, but when the job was complete the architects sent me a letter stating they loved our community."

"This company had built playgrounds all over the United States and beyond, but they told us that our small community, even though we didn't have the numbers needed to work every day, the skilled labor in our county was unbelievable and they had never seen anything like it in their life. impressed

Often workers were locked in factories, leading to the death of 146 garment workers, ages 11 to 48 in the 1911 Triangle Shirtwaist Factory fire in New York City.

prison than any other country in the world.

Meanwhile, the level of violence among dealers fighting for "shelf space" has escalated, murdering tens of thousands of people.

In 2011 the Global Commission on Drug Policy published this conclusion: "The global war on drugs has failed, with devastating consequences for individuals and societies around the world." Many countries are now modifying their policies to view drug abuse as a medical issue -- not a criminal one. Three U.S. states will be voting on the legalization of marijuana in November and polls indicate that some will pass.

Only about seven percent of the U.S. population uses

marijuana regularly, but over 50 percent now favor its legalization. Is this because they are tired of wasting tax dollars on failed policy?

A review of HUNT's annual reports shows a steady increase in funding, but no change in annual investigations. This indicates that the amount of drug activity in our area remains unchanged, in spite of HUNT's efforts. This will not surprise anyone who understands that if people with money want to buy a product, somebody is going to sell it to them, regardless of how many you lock up.

In my opinion, any additional funding for HUNT is throwing good money after bad.

Are you as frustrated as I am when viewing the campaign lies about Proposal 2? You know the one that says your child's teacher gets five chances to come to school intoxicated before his employer can reprimand him. The one which says teachers and bus drivers with criminal records could be hired. The one about school bus safety standards could be bargained away under Proposal 2.

All school employees are required to receive background checks by the FBI. Proposal 2 doesn't change that. If an employee of a public school is charged with a crime, disclosure to the superintendent of the district is required under the Pupil Protection Act. Proposal 2 doesn't

change that. If a school employee is convicted of a crime, the due process and legal prosecution is not affected by Proposal 2.

The claim about eliminating safety standards for school bus drivers is also false. Federal and state law make clear that labor organizations cannot bargain about the licensing requirements under federal and state law.

What does this proposal do? It guarantees that workers and management will have the right to sit down and work out agreements covering wages, hours, and working conditions. That is workers are not simply given the authority to single handedly raise their wages or improve their working conditions.

## Direct deposit options for Social Security recipients

Dear Savvy Senior,  
I have received my Social Security check in the mail every month for more than 25 years, and now I'm told I have to switch to direct deposit. Do I have any options?  
Suspicious Senior

Dear Suspicious,  
If you're over age of 90, or live in a remote area you may still have the option of receiving your Social Security checks in the mail if you want. Otherwise, you have until March 1, 2013 to switch from paper benefit checks to direct deposit.

The reason the U.S. Department of Treasury is phasing out paper Social Security checks and replacing them with electronic delivery is because it's cheaper, safer and more reliable. About 93 percent of federal benefit recipients already receive their payments via direct deposit. Switching most of the remaining seven percent to

paper-less payments is expected to save Social Security around \$600 million over the next 10 years in postage, paper and printing costs. The switch will also eliminate the potential problem of checks that get lost in the mail or stolen.

Therefore, anyone who is currently receiving their Social Security, SSI, veterans, railroad retirement or federal civil servant retirement benefits in the mail, will need to switch to direct deposit either into a bank account or credit union of their choice, or a Direct Express Debit MasterCard by March 1, 2013.

The only exceptions are for elderly seniors born before March 1, 1923, mentally impaired people and recipients who live in remote rural areas. They will still have the option of receiving their government benefits via paper check if they wish.

If you don't want your gov-

ernment benefits direct deposited in your bank account, or if you don't have a bank account that your payments can be deposited into, you'll need to get a Direct Express Debit MasterCard. This is a prepaid debit card that was introduced by the Treasury Department back in 2008.

With a Direct Express Debit MasterCard your Social Security and/or other government benefits will automatically be deposited to your card's account on your payment day each month. Your card can then be used to get cash from ATMs, banks or credit unions tellers, pay bills online and over the phone, make purchases at stores or locations that accept Debit MasterCard and get cash back when you make those purchases, and purchase money orders at the U.S. Post Office. The money you spend or withdraw is automatically deducted from your account. And you can

check your balance any time by phone, online or at ATMs.

There's also no cost to sign up for the card, no monthly fees and no overdraft charges. There are, however, a few small fees for optional services you need to be aware of, like multiple ATM withdrawals. Currently, cardholders get one free ATM withdrawal per month, but additional monthly withdrawals cost 90 cents each not including a surcharge if you use a non-network ATM.

Another important feature is security. Your card is PIN-protected, the money in your account is FDIC-insured, and if the card gets lost or stolen it will be replaced with consumer protections if it's reported promptly.

To sign up for direct deposit into a bank or credit union, or to sign up for the Direct Express Debit MasterCard, call Go Direct at (800) 333-1795 or visit [godirect.org](http://godirect.org).

You also need to be aware that if you don't sign up for direct bank deposit or get a Direct Express card by the March 1, 2013 deadline, the government will automatically issue you a Direct Express card and mail it to you, and your benefits will be deposited on your card's account thereafter.

with Alcona County," Hart said.

The playground needs some attention and commitment from the community again. Hart and Naomi Potter are working on getting a committee of Friends of the Playground to help conduct fundraising efforts.

"After 12 years of some tough and rugged weather, as well as tough and rugged play time, the playground is in need of a facelift with special concerns regarding the surface of the ground under the playscape.

Since the playground was built in 2000 a number of new laws have come into effect, the Americans Disability Act (ADA) being one of them. The act requires playgrounds to be accessible to disabled people for any new or renovated playgrounds by March 15, 2012.

The law, however, isn't mandatory for any playgrounds built prior to 2012 that have not been renovated. "The problem is more than just meeting ADA requirements," Hart said.

Naomi Potter noted there was a swing for handicapped children at the park as well as a wide slide. "It's about the safety of all our children playing there," she said.

The architectural firm that designed the playground is recommending the ground surface be covered with a natural safety surface of engineered wood fiber. Fibar is a company that makes an engineered wood product that passes all standards for impact protection and wheelchair access. The engineered wood is controlled as to type and size of the wood fibers.

According to information from the the Fibar Group, LLC, the fibers knit together to provide a surface springy enough to cushion falls, yet firm enough for wheelchairs to navigate on. Another advantage is that rain water passes through the Fibar playground mulch, so kids can play right after it rains.

The company also states, testing is done on the Fibar material, which is made from 100 percent virgin wood fiber. No recycled wood is used because it may contain things such as nails or treated lumber, things you do not want children to play on. Testing is done by the International Play Equipment Manufacturers Association to make sure the product meets with all American Society for Testing and Materials (A.S.T.M.) standards.

"The wood chips that were put in place in 2000 have dwindled down to nothing; there is no protection for the children. Areas where weed barrier was put down under the wood chips are now showing through, causing trip hazards. Weeds are taking over the playground," Hart said. "It's crazy how fast things are deteriorating at the playground and it breaks my heart because we all worked so hard to build it."

Hart and Potter are asking the community to come together again in support of the playground.

"It's not just a Lincoln project, every child in Alcona County uses that playground," Hart said noting that many children have held birthday parties at the site. "We were pleased that Lincoln donated the property for the playground, but it is a county project, built by members of the county and we all need to take part in keeping it up," Hart said.

The resurfacing project will cost approximately \$6,000 for eight inches of Fibar and necessary mats for under swings. The Fibar will go on top of six inches of sand which has already been donated by the Village of Lincoln.

In addition to the surface, Hart and Potter hope to repaint the artwork designs and reseal the lumber. "The lumber should be sealed every year, but it has only been sealed every other year due to budget (constraints). There is a garden at the playground area installed by a family who lost their infant son which

also needs some attention. "More important than just being eye appealing, it's the safety issue we are most concerned about. We will need donations of time and funds to get the project completed. We will be searching for grants and work bees will need to be scheduled. We are hoping to start laying down the new surface by next spring or summer," Hart said.

Wooden picket fence slats that encompass the playground will be sold with families or business names engraved on them, a fundraiser that began when the playground was built in 2000. "We still have about 500 slats to fill with names," Hart said.

The picket fence name slats will be sold for a \$20 donation to the playground. Picket fence forms may be picked up at the Village of Lincoln Trick or Trunk and Chili and Soup Cook-off on Saturday, Oct. 27 from 11 a.m. to 1:30 p.m. on Second Street, or contact Teresa Hart for picket fence forms.

Bake sales are also scheduled fundraisers for the Saturday, Nov. 10 and Saturday, Nov. 17 in front of the Lincoln Outdoor Center. The group is asking for volunteers as well as donations of baked goods for the bake sale.

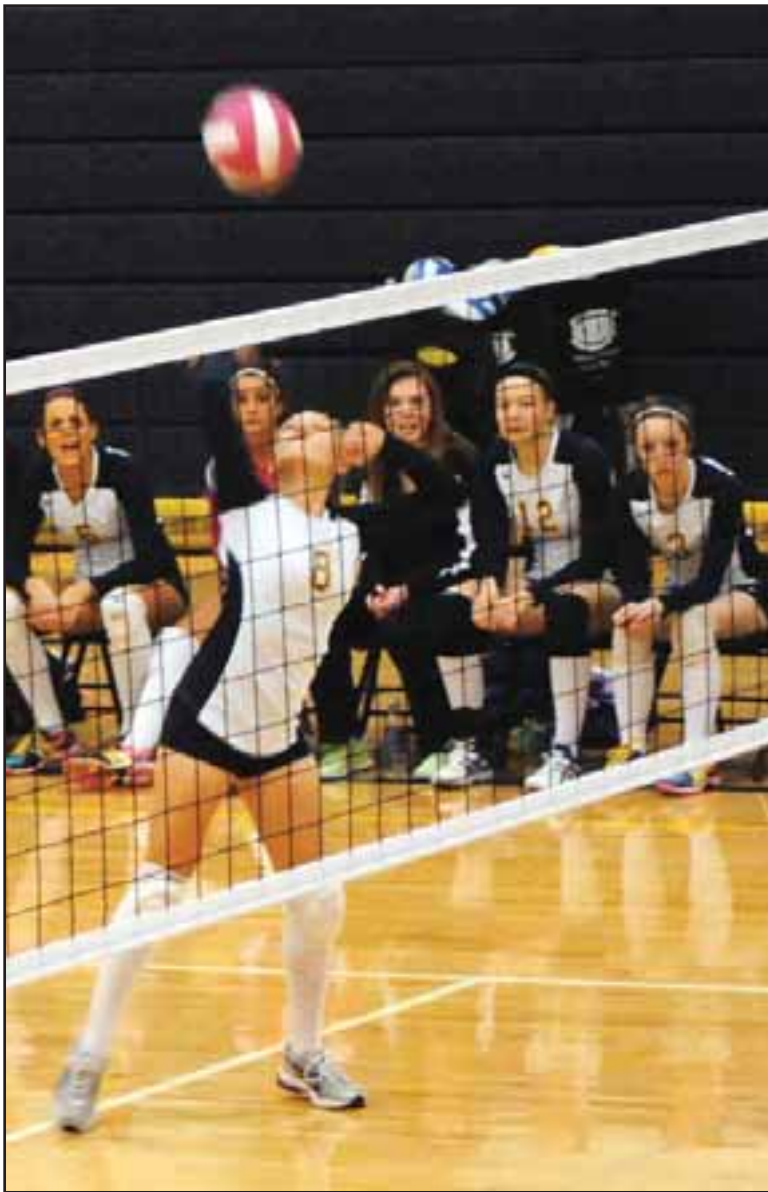

# Harrisville heading in healthy direction

With the presidential race going full tilt, a question that pops up frequently is: "Are you better off now than you were a few years ago?"

Well, let's apply that same tactic when it comes to health. With obesity numbers at epidemic levels, and childhood obesity continuing to climb, there are good reasons to ask how we're doing.

I can recall working as a new dietitian in diabetes education 30 years ago, we often referred to Type Two Diabetes as "adult-onset" because it only affected adults. It was unheard of to have a child with Type 2 diabetes.

Not so any longer. I remember the first time a child was referred to me for Type 2 diabetes. I actually thought there was a misprint on the referral. Now we are seeing kids with high cholesterol, high blood pressure, pre-diabetes and full-blown Type 2 diabetes... and the ramifications are frightening.

Excess weight wreaks havoc on a body, setting us up for serious health problems for life such as diabetes, heart disease, arthritis and some cancers.

So are we better off now than "then"? Ask yourself the following questions and the answers will reveal what has led us to our current health problems:

*How did you get to school?*

- If you walked/biked give yourself one point.
- If you rode in a car, bus give yourself two points.

*Did you have gym class or recess when you were in school?*

- If you had gym or recess at least four days per week give yourself one point.
- If you only had gym or recess two or less days per week give yourself two points

*When out of school (before dinner), what did you do?*

- If you played outside or chores give yourself one point.
- Sat inside and watched TV, used the computer/video games give yourself two points.

*Where did you eat most of your suppers?*

- At home give yourself one point.
- Restaurant/on the road /fast food give yourself two points.

*What did you drink at most*

*of your suppers?*

- Milk or water give yourself one point.
- Pop, Koolaid, energy drink or sports drink give yourself two points.

If you scored closer to 5 than to 10, chances are you probably lived in the "good old days." Remember those days? I do, and they were fun. Hula hoop, jump rope, roller skating, bicycling -- as long as we were moving, we were happy.

Lifestyles have changed for many of us these past 30 years, and not all for the better. Larger portion sizes, more frequent eating out, less home-cooked meals, more time spent doing sedentary activities has led to an explosion of obesity and weight-related health conditions.

As you probably know by now, over the past three decades childhood obesity rates in America have tripled, and today, nearly one in three children in America are overweight or obese.

The good news is that by making a few lifestyle changes, we can create a healthier environment for ourselves and our family.

And that leads me to the City of Harrisville. After being approached by community members about the idea, the Harrisville City Council decided to sign on to become a "Let's Move" city.

According to Joan Crick, Harrisville City council member, "becoming designated as a 'Let's Move' city is a wonderful initiative," and she is "looking forward to seeing what we can accomplish as we move forward."

According to the website [www.letsmove.org](http://www.letsmove.org): Let's Move! is a comprehensive initiative, launched by the First Lady, dedicated to solving the challenge of childhood obesity within a generation, so that children born today will grow up healthier and able to pursue their dreams. Combining comprehensive strategies with common sense, Let's Move! is about putting children on the path to a healthy future during their earliest months and years.

The Let's Move initiative challenges local elected officials to commit to helping parents, child care providers, schools, and others in-

corporate best practices for nutrition and physical activity. Creating an environment that makes it easy to be healthy is what Let's Move is all about. Launching programs that create more access to play spaces for children, or committing all municipal venues that serve food to following the Dietary Guidelines for Americans are examples of what municipalities can do as a Let's Move partner.

Last week, a visionary meeting was held in Harrisville to discuss what a "Healthy Harrisville" could look like: In one month, one year, five years, and 10 years down the road. There's nothing like getting creative minds together and have them dream for a couple hours. Many ideas were discussed, many of them doable, even in a small town like Harrisville.

In the meantime, while we are helping to whip Harrisville into shape, what can you do to make sure you, your child, or your grandchild achieve or stay at a healthy weight?

An interesting study recently published in the journal Pediatrics revealed how making a couple simple changes can reduce the risk of childhood obesity. In fact, this information can be applied to any age.

The study showed that at the end of six months, 10 percent fewer children were obese due to making three simple changes:

1. Try to limit junk foods like cookies to two or less a day.
2. Limit screen time to two hours or less a day.
3. Drink water instead of soda pop.

Let's challenge ourselves to each give this a try and in the meantime, send me your thoughts and ideas on what you think a Healthy Harrisville would look like.

Together we can create a healthier world for ourselves, and for our children.

Dale Earnhardt Jr. has won five races at Talladega Superspeedway. His father won 10. When a NASCAR driver named Earnhardt says "enough is enough," he deserves an airing of his grievances.

The Good Sam Roadside Assistance 500 ended with the track strewn with as many burnt-out vehicles as tanks left smoldering at El Alamein.

This wasn't a battle, though. It only resembled one. Everyone walked away.

In the fourth turn of the final lap — which was one too many, owing to overtime — 25 cars crashed, making Matt Kenseth's victory elementary.

That crash left Earnhardt 20th in the race and, more importantly, 11th among the

12 in the Chase for the Sprint Cup. He is 51 points behind Brad Keselowski, and since Talladega will host no other races this fine autumn, the odds of an Earnhardt championship are as long as the distance from Talladega to El Alamein, which is in Egypt.

The ending was ridiculous, as Earnhardt freely admitted.

to race and nothing is going to change, I think NASCAR should build the cars. It would save us a lot of money."

"Really?" replied Earnhardt. "It's not safe. Wrecking like that is ridiculous. It's bloodthirsty if that's what people want. It's ridiculous.

"I don't even want to go to Daytona or Talladega next year, but I ain't got much choice."

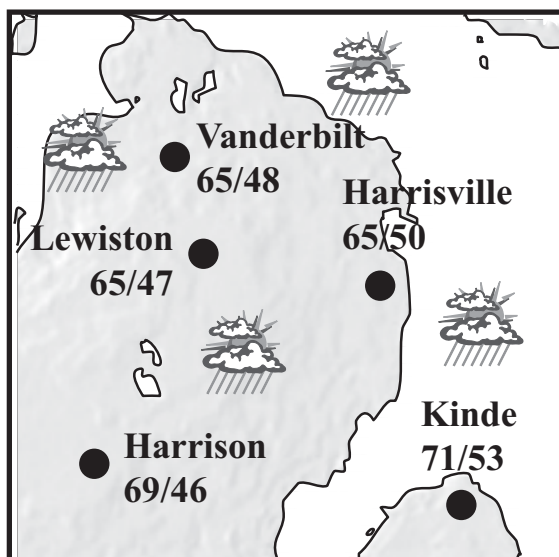

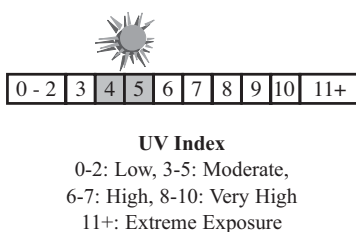

**StarWatch By Gary Becker - It's Showtime for the Orionids**

The meteor season has been underway since the Perseids of mid-August. Now it's time for the big three autumn spectacles to commence, starting first with October's Orionid Meteor Shower, followed by the Leonids of November, and finally, the biggest shooting star event of the year, the December Geminids. Orionid activity peaks on the morning of Sunday, October 21, with meteors radiating from an area above and to the east (left) of Orion's super red giant star, Betelgeuse. Even the crescent moon is cooperating by setting around 11 p.m. local time on the 20th. Orionid meteors begin "to fly" in earnest after midnight when the radiant is about 30 degrees above the eastern horizon. As the hours roll by, Orion and the area from which the meteors are diverging, get higher and higher in the sky. By 5 a.m. this point reaches its maximum altitude, about 65 degrees, allowing observers to see shooting stars streaming from above and below the radiant. This is when events max at about 25 meteors per hour from a rural locale. In addition to the Orionids, there are two other minor showers which bear mentioning. They are the Northern and the Southern Taurids with meteors emanating from the constellation of the bull. Even combined, these streams produce little activity, but when a Taurid flares, often it is in the form of a slow moving, long duration fireball which can be really spectacular. In comparison, the normal Orionid meteor is swift and much fainter. Remember that for mid-latitude observers, October nights are not for the fainthearted. When contemplating your apparel and the equipment you should be bringing, think winter. Although the shower might be "rocking and rolling," you will be lying stationary looking towards the SE. Ground tarps, sleeping bags, headgear, gloves, and thick socks will help keep you comfy so that you can enjoy the show in style. [www.astronomy.org](http://www.astronomy.org)

**STRANGE BUT TRUE**

- It was 20th-century American author and actress Cornelia Otis Skinner who made the following sage observation: "One learns in life to keep silent and draw one's own confusions."
- If you grew up during a certain era in the United States, you are probably familiar with the board game Parcheesi. If you have a particularly good memory, you may recall that the game's subtitle is "The Royal Game of India." You may not realize, though, that the game is so-called because royalty in India used to play a life-size version of the game in gardens specially designed for the pursuit. Centuries ago, rajas would dress members of their harems in brightly colored costumes and use them as game pieces.
- Everyone knows that a sophomore is someone in his or her second year of high school or college. Most people don't realize, though, that the word is derived from the Greek words "sophos," which means "wise," and "moros," which means "stupid."
- It's not unusual for music critics and the artists they critique to butt heads, but they usually do it in print, not in person. In 1978, though, the staff of Rolling Stone magazine and the band the Eagles went head-to-head in a softball match. The writers ended up losing to the rock stars.
- The creator of the ubiquitous smiley face earned a grand total of \$45 for his creative effort.
- Having trouble with your teenager? It's a worldwide problem, it seems — though not always for the same reasons. In 2004, a 13-year-old boy in India ran away from home, declared that he was a Hindu holy man and founded a monastery. His parents arranged for him to be kidnapped and brought back home.

**MOMENTS IN TIME**  
The History Channel

- On Oct. 30, 1893, the World's Columbian Exposition closes in Chicago. Fairgoers were offered a chance to see the first gas-powered motor-car, an alternating-current power plant, a 46-foot-long cannon, a 1,500-pound Venus de Milo made of chocolate, and Juicy Fruit gum.
- On Nov. 4, 1922, British archaeologist Howard Carter and his workmen discover a stone sarcophagus containing three coffins nested within each other. Inside the final coffin, which was made of solid gold, was the mummy of the boy-king Tutankhamen, preserved for more than 3,000 years.
- On Nov. 3, 1930, the Detroit-Windsor Tunnel between the United States and Canada is officially opened to auto traffic. Each end of the tunnel had a 100-foot-tall ventilation tower; each tower held 12 huge fans, six for pumping fresh air into the tunnel and six for exhaust. The tunnel's ventilation system still works just as well today as it did 80 years ago.
- On Oct. 29, 1948, a killer smog continues to hover over Donora, Pa. The town's steel mills and a zinc smelting plant had released excessive amounts of sulfuric acid, carbon monoxide and other pollutants into the atmosphere. Over a five-day period, the smog killed some 20 people and made thousands more seriously ill.
- On Oct. 31, 1950, 21-year-old Earl Lloyd becomes the first black man to play in an NBA game when he takes the court in the season opener for the Washington Capitols. The Capitols had picked him in the ninth round of the draft. After seven games with the Capitols, Lloyd was drafted into the military and sent to Korea for two years.
- On Nov. 1, 1967, "Cool Hand Luke," starring Paul Newman as a tough, anti-authoritarian, poker-playing prisoner, debuts in theaters. The film contained the now-famous line: "What we have here is a failure to communicate."
- On Nov. 2, 1986, Norwegian distance runner Grete Waitz wins her eighth New York City marathon. She finished the 26-mile, 385-yard course in 2:28.6, more than a mile ahead of the second- and third-place women in the race.
