Community service trooper provides safety education

Providing services such as mentoring youth, working with seniors and educating citizens on emerging crime trends is all in a day's work for a community service trooper.

Michigan State Police have troopers assigned to regions across the state to focus on community outreach and help strengthen communities. Trooper Ashley Simpson has been assigned to the Alpena Post since May.

As such, Simpson's area covers Montmorency, Presque Isle, Alpena, Alcona and Oscoda counties. In addition to community service and training, Simpson also works with other police agencies to help strengthen law enforcement.

cause of Simpson's love of hunting and fishing found that law enforcement would be a better fit for her. She is the first law officer in her family. Employed by the Michigan State Police for five years, Simpson's energy and enthusiasm for educating the public about safety suits her as a service trooper.

Along with educating senior citizens, Simpson also gives 20 minute presentations to Rotary, Kiwanis, Lions clubs and other organizations interested in new crime trends and strategies to avoid becoming a victim.

Simpson also worked on an inner city initiative in Flint, Mich. where she taught kindergarten through sixthgraders about gun safety and general safety rules. "I enjoy working with kids and se-

Volunteers breathe life into Alcona Elementary library

Filling a void left by a financially struggling school system, volunteers, comprised mostly of retired teachers, have been working to organize, clean and operate the Alcona Elementary School library (media center).

Since May Deb Kruttlin, Carol Lund, Connie Petrovich and a handful of other retired teachers and concerned citizens have been doing all they can to keep the library operating as an oasis for young

"We didn't know what we were doing at first, we didn't know where to start or what to do, it was overwhelming, but we were able to get some help from Judi Stillion the retired director of the Alpena County Library who helped us get started," Kruttlin said.

Alcona County Library Director Carol Luck has also assisted.

Kruttlin explained in the last two months over 150 volunteer hours have been invested into the library with volunteers doing inventory tasks which involve withdrawing some tattered older books from the library shelves. "Letting go of a book is tough, but we were taught that every book needs to deserve its place on the shelf," Kruttlin said. Lund explained if there is a book on the shelf they didn't want to open or look at because of its condition or age; children would probably feel the same and not want to read it either.

The sun-filled library, which was added on to the elementary school when the middle school was built, has an expansive cathedral style

window facing a western view of a grassy yard, forest and sky. Sturdy, yet comfortable chairs and tables seem to vearn for summer's end so a child can once again take full advantage of their usefulness. Kid-friendly pictures cheerfully claim wall space and stuffed animals gaze happily from their shelves above books. The library also has a puppet-friendly corner as well as a quiet professional area with padded chairs just waiting to accompany teachers in search of a calming spot to work on lesson plans or study media material.

While Kruttlin, Lund and Petrovich took a break from their library inventory, a new student who will begin the school in the fall stopped by accompanied by her grandmother and the new school secretary, Ronnie Miller. Miller explained the kinder gartner wanted to see what her new school would be like so she was showing them around. The library volunteers welcomed the young girl, who shied away from adult attention, but was drawn to the puppet corner and pulled her grandmother's hand to go toward the books near there.

"When we were teachers here, going to the library was special to our students and we want to continue that for them. For years now the school couldn't afford a media specialist. Paraprofessionals were given the assignment and they did their very best, but they had very limited time for the monumental task," Kruttlin said. Lund and Petrovich agreed

"I'm in and out of schools and throughout the community to provide education in all forms of public safety," Simpson said as she was getting ready for a presentation on avoiding elderly scams at the senior center in Lincoln.

Simpson grew up in the Alpena/Posen area and went to college at Lake Superior State University. She began her college studies with conservation courses but be-

There are certain facts we need to be stated in order for the full story to be heard regarding the news article on the front page of last week's (July 31) paper about the car accident in Greenbush. My wife, Melissa Ashford of Harrisville, was a victim of a car accident due to the negligence of one Patricia Lehman, who failed to yield to oncoming traffic while making a U-turn.

My wife was sent to Alpena Regional Medical Center and, upon being seen by a doctor, was told that she suffered from injuries related to the accident with several broken ribs, broken foot, broken ankle and sprained ankle along with severe bruises and other injuries when her air bag deployed.

The article in the paper never stated the fact that she sustained any injuries at all and all of this because of Lehman's negligence.

I am also very disappointed that a picture of the scene in its entirety was not included with the article. Due to the damages sustained from the accident, my wife's car is a total loss. She will have to have at least one, possibly two, surgeries on her ankle to resolve the issue of the broken bone and be off of work for at least two months.

I would like to extend my immense gratitude to the **Greenbush Fire Department** and the medical first responders, station one of the Alcona County EMS and their team and all of the bystanders who assisted my wife and my niece and nephew. As a member of the Harrisville Fire Department, I can truly appreciate the team and professionalism of all the medical and fire department personnel of each station throughout the county. They come together for a common goal.



that over the years the library had not received the full attention that it should have had and had turned into something of a storage spot for unused equipment.

"I didn't understand how bad finances had gotten in the school system until the enhancement millage came to my attention. I went to several meetings and heard about the programs that had been dropped and how the funding from the state had decreased. The day after the millage failed I came in and put in my application to volunteer. I volunteered in the classrooms when they needed me and then after coming to the library saw a need for people to help in this area," Kruttlin said.

Volunteering at the school not only takes a personal commitment of time, but volunteers must fill out an application and have a background check which the volunteer pays a onetime fee, typically \$59 to \$75 out of their own pocket. Something Kruttlin and the other volunteers had no problem doing because it benefitted the children and helped insure their safety.

"A lot of volunteers jumped on board after the millage failed, but more are needed. We're still learning. None of us are media specialists. 

Shingles vaccine protects seniors, covered by Medicare

Dear Savvy Senior,

What can you tell me about the shingles vaccine? I just turned 65 and have been thinking about getting vaccinated, but would like to know how effective it is and how it's covered by Medicare.

Afraid of Needles

Dear Afraid,

Older adults who get the shingles vaccine can actually cut their risk of getting the painful condition in half, and those that do happen to get it are likely to have a milder case if they've been inoculated.

Here's what else you should know about the shingles vaccine, along with how it's covered by Medicare.

Shingles, also known as herpes zoster, is a burning, blistering, often excruciating skin rash that affects about one million Americans each vear. The same virus that causes chickenpox causes it. What happens is the chicken-

pox virus that most people get as kids never leaves the body. It hides in the nerve cells near the spinal cord and, for some people, emerges later in the form of shingles.

In the U.S., one out of every three people will develop shingles during their lifetime. While anyone who's had chickenpox can get shingles, it most commonly occurs in people over age 60, along with people who have weakened immune systems. But you can't catch shingles from someone else.

Early signs of the disease include pain, itching or tingling before a blistering rash appears several days later, and can last up to four weeks. The rash typically occurs on one side of the body, often as a band of blisters that extends from the middle of your back around to the breastbone. It can also appear above an eye or on the side of the face or neck.

In addition to the rash,

more than one-third who get scription drug plan, it will shingles go on to develop severe nerve pain that can last for months or even years.

The Center for Disease Control and Prevention recommends that everyone age 60 and older should get a onetime shingles vaccination - called Zostavax. Even if you've already had shingles, you still need the vaccination because reoccurring cases are possible. See zostavax.-com or call (877) 974-4645 for more information or to locate a vaccine provider in your area.

The vaccine is also very safe. For most people the worst side effect is mild redness or arm soreness.

You also need to know that Medicare covers the shingles vaccine as one of its preventive benefits. But, unlike some other vaccines that are paid through Part B, the shingles vaccination is covered by Part D.

If you have a Part D pre-

pay for the vaccine itself and for your doctor or other health care provider to give you the shot. You are only responsible for paying the plan's approved co-pay at the time you get vaccinated, which usually runs around \$60 to

But, you need to make sure you follow your plan's rules in order to keep your out-ofpocket costs down.

If you're vaccinated at a drugstore, check to make certain it's in your Part D plan pharmacy network. Otherwise, the shot will cost you more than your usual copay.

If you're inoculated in a doctor's office, check to make sure the office can bill your plan or at least can work through a drugstore in your plan's network. Otherwise, you'll have to pay the entire bill upfront and then claim reimbursement from your





I have a little "app" on my computer that tells me the lesser-known holidays in a given month. I use it primarily for the church newsletter, but from time to time, it gives me a column idea.

As an example, did you know that this Thursday (August 8) is National Dump Some Zucchini on Your Neighbor's Porch Day?

So I smiled (appropriately) when I discovered that the second week in August was National Smile Week, the third week was National Friendship Week and the fourth week was Be Kind to Humankind Week. August should be a good month. Briefly, I wondered if there was a column in there somewhere. But no, it seemed. As much as I'd like to write it, it would just be one more of what my family calls my "Mary Sunshine" speeches."

There are times, though, when life just keeps handing me little seemingly unrelated puzzle pieces that eventually form an image. The three week-long holidays were the first piece and shortly thereafter a brief article on the morning news show provided the second.

The majority of people responding to a survey, the anchor said, feel that they are buffeted by rude or uncivil behavior at least twice a day. Oddly, the piece made me feel better. Apparently, I wasn't just a short, sensitive dinosaur, walking through the world and often feeling bruised or battered by the behavior around me.

So I was surprised, as I entered, to find seven or eight people in front of me in the line for the two clerks. I gave a small, involuntary groan and the lady in front of me nodded. "It's moving pretty fast though," she said.

Looking around me, I noted a cute little girl sitting on the bench to one side of the line. She was three or four, blonde, and quietly engaged in a coloring book. A few minutes later, the little girl raised her voice a bit to speak to ner motner, wno was by now at the first win-

She had one of those little Disney-mouse voices that make you smile when you hear it. "Mom," she asked, "Is it okay if I put my book in your purse?" Yes, her mom told her that was fine. A moment later, the little voice piped again. "Thank you, Mom.'

I wish I could describe the sunshine that streamed into that room full of impatient people with that high-pitched little sentence. The lady behind me smiled, "Nice," she commented. "Isn't it?" I agreed. The clerk, still waiting on Mom, mentioned it, too and added a purple lollipop to the pile of materials she was giving Mom.

Art told me that as they

got in their car, the mother asked the little girl, "Did you notice how much people liked your good manners?

They certainly did. And I think it was easily explained by the news article I mentioned earlier. Children these days often operate under the mistaken notion that rude or smart-alec is cute. Adults, in many cases, are worse. We're an unhappy, angry society, by and large, and we take it out on each other, most often on people we don't know well enough to be accountable to.

When we reached the highway, he suddenly swerved around to pass us. honking his horn. As the car went by, the five or six kids packed into it shouted and made obscene gestures.

"Well," I commented to Art as we pulled into the store, "That seemed like an overreaction." We sat there a moment, shaken by the violence of the response to a simple gesture. Drinking? High? Perhaps they thought I had given them an obscene gesture of my own. But what would make them assume that a grey-haired lady they didn't know would do that?

Beyond its seeming unconcern and anger, like the kids mentioned earlier, society seems to have somehow developed the idea that sarcasm and unkindness are amusing. They rarely are. They often add one more stressor to a day that already had its share or more. A favorite quote of mine says, "Always be kind. Everyone you meet is fighting their own battles." Like most great proverbs, it's true.

So at the risk of being Mary Sunshine, I'd like to encourage us all to participate in these upcoming silly, manufactured holidays. Perhaps if we all smile at everyone for a week, appreciate our friends more than usual for a week and spend a week being kind to mankind, we can make a tiny, infinitesimal difference. Perhaps those smiles and little kindnesses will be passed on and grow exponentially as they make their way through the world.

If they have half the impact that that little mousevoiced girl's thank you did in that crowded office, that in itself would make the world a better place.





StarWatch By Gary Becker - Picnic with the Perseids

This is the best weekend of the year for people to gather for a picnic, and then to spend a few quality hours looking at the heavens. It is Perseid party time. and those bright streaks of light created by the dusty dross of Comet Swift-Tuttle sweeping into Earth's atmosphere are sure to bring delight to anyone who cares to look into the night sky. The two best days for viewing occur on the mornings of August 12 and 13, a Monday and a Tuesday, when suburban rates before dawn could top 30 meteors per hour; but there will still be plenty of good observing on the weekend prior to the peak times. Just don't believe the exaggerated hype of the media predicting rates of 100 meteors per hour. In suburban locales, a day or two before maximum, respectable rates are 10 meteors per hour before midnight and a little higher thereafter. One positive aspect of observing the Perseids before maximum is that they tend to appear somewhat brighter. Like all meteors which orbit the sun in an organized pack, they will appear to diverge from a radiant, a specific area of the sky, making their identification a snap. Begin your star party around 10 p.m. with lawn chairs facing towards the NW. Since the sky is normally darkest at the zenith, lay back and look overhead. Perseid meteors will seem to diverge upward from the NE. They will be swift, and some of them will leave luminescent glows that will persist for an instant to many seconds. As the night progresses, face your chairs more to the east, but keep looking overhead. Most of the meteors will still appear to radiate upward, but you'll also begin to catch Perseids glinting below the radiant point which will help to increase numbers. In the predawn hour, weekend rates could top as many as 20 meteors as the radiant reaches skyward toward the zenith. Don't worry about the moon; it sets before midnight through maximum night. Savings bonds still drawing interest

Dollars And Sense By David Uffington

You don't hear much about savings bonds anymore. Low interest rates for certificates of deposit and savings accounts have many consumers assuming that there just isn't anywhere to put money that earns any interest. But savings bonds are still around (since 1935) and still paying interest.

Benefits of bonds include:

· No state or local taxes on the interest. Federal taxes on the interest can be deferred until the bond is mature or vou cash it in. And some bonds are tax-free if used for education.

• Starting small. It costs only \$25 to buy a Series EE bond and \$50 for a Series I bond.

Since 2012 there is only one way to buy bonds (you can't go to your local bank anymore), directly from the Treasury Department in the

form of an electronic bond. Go online to TreasuryDirect at www.treasurydirect.gov, click Individual, and scroll down the left side to the types of bonds that are available.

Study each type of bond to know what you're getting. For example, series EE bonds dated from May 2005 have a fixed interest rate, with the interest added monthly. Series I bonds have an interest rate based on a combination of fixed rate and inflation that changes twice a year.

You'll need to open an online account if you want to buy or redeem Series EE and I savings bonds, buy bonds as a gift or enroll in a payroll savings plan automatic purchase of bonds.

Know what your financial plans are before you purchase bonds. Series I, for example, are for long-term investments, and earn interest for up to 30 years. You can cash them in after one year, but if you cash them up to five years from purchase, you'll lose three months of interest. (If you're cashing in bonds, know when the interest is recalculated and cash them after the new interest is

If you've had the paper version of bonds in the past, you paid half the face value, for example, \$50 for a \$100 bond. The electronic bonds are now sold at face value.

Look for the growth calculator on Treasury Direct to get an idea of the future value of your bonds, especially if you have a long-term financial plan and will buy bonds on a regular basis.

Q: I have a creamer in the shape of a cow. I bought it at a church sale and paid \$35 for it. -- Mark, Hammond,

A: I'm not sure what your question is, but I must tell you that many of the "cow creamers" have been reproduced, and most generally sell for less than \$20. To determine if your creamer is authentic and older, show it to an established antiques dealer in your area for his or her opinion. For current values, I recommend "The Antique Trader Kitchen Collectibles Price" edited by Kyle Husfloen. There are several pages featuring creamers with current values.

Q: I have a collection of cigarette silks that were given away as premiums, probably during the 1920s. Is there someone I can contact about them? The ones I have represent international flags. -- Bill, Flagstaff, Ariz.

A: Robert Forbes is a serious collector of tobacco memorabilia and has written several books on the subject. He might be able to advise you. His address is P.O. Box 62, DuPont, WA 98373. Check out his excellent reference "American Tobacco Silks, Flannels, and Leathers," which can ordered from him.

Q: My parents were married in 1953 and received a set of sterling flatware in the "Bridal Veil" pattern. What

can you tell me about it? --Susan, Westminster, Colo.

A: Your pattern was crafted by the International Silver Company and introduced in 1950. The company was formed in 1898 in Meriden, Conn., by a group of independent silversmiths. The association eventually included several additional companies including Rogers Brothers, Derby Silver, Meriden Britannia, Webstar and Wilcox, and others. Although this isn't one of the more expensive patterns, it is certainly a handsome one.

Q: I have a set of six volumes of "Nation's Heritage" published by B.C. Forbes & Sons in 1949, all in fine condition. Do these books have any value, and where can I offer them for sale? --R.C.R., Albuquerque, N.M.

A: These appear to sell in the \$15 to \$25 range per volume in my area of the country, Phoenix. You live in a fairly large city with several excellent used bookstores. Begin there.

Scanned claims not up to speed

The Department of Veterans Affairs has converted more than 30 percent of disability claims into digital files, according to a recent VA report. So far, 165 million pages have been scanned and uploaded by contractor Systems Made Simple from paper, photos, faxes, DVDs and flash drives.

Those files now are at the fingertips of claims raters, and finishing up claims should move along faster. But results so far are mixed, and success in speeding up the process depends on the region of the country. Here are a few locations compared with a few months ago:

• White River Junction, Vt., had 834 veterans waiting an average of 239 days. Wait time for first claims was at 559 days. Now there are 869 veterans waiting an average of 193 days, with 525 of them over the 125-day mark and 183 waiting over one year. First-time claim average wait is still 559 days.

• Lincoln, Neb., had 2,560 veterans, with 695 over 125 days. Average wait time was 143 days. Now there are 3,002 veterans waiting, 841 of them over 125 days, with an average wait time of 106 days.

• Fargo, N.D., had 1,122 veterans with 375 waiting more than the 125 days. Av-


erage wait time was 131 days. Now Fargo is up to 1,357 veterans with 395 of them waiting over 125 days, but the average wait time is down to 105 days.

• St. Petersburg, Fla., had 50,492 veterans waiting an average of 319 days. Of those, 34,860 were over the 125 days. Now there are 49,928 veterans waiting an average 233 days. Of those, 35,734 are over 125 days and 11,091 veterans have waited over one

To reach its goal of claims being processed in 125 days, the VA has a very long way to



MOMENTS IN TIME The History Channel

- On Aug. 22, 1776, the British arrive at Long Island -- between Gravesend and New Utrecht -- with 24,000 men, and on Sept. 15 captured New York City. It would remain in British hands until the end of the war.
- On Aug. 20, 1862, New York Tribune editor Horace Greeley publishes a blistering editorial, "The Prayer of Twenty Millions," calling on President Abraham Lincoln to declare emancipation for all slaves. Unbeknownst to Greeley, Lincoln was already moving in the direction of emancipation.
- On Aug. 24, 1873, William Henry Jackson becomes the first person to photograph Colorado's elusive Mount of the Holy Cross, providing reliable proof of its existence. Two deep snow-filled ravines at 90-angles form a large cross on the steep northeast face of a 14,000-foot mountain peak.
- On Aug. 19, 1909, the first race is held at the Indianapolis Motor Speedway in Indiana, now the home of the Indianapolis 500. The track's surface of crushed rock and tar proved a disaster, breaking up and causing the deaths of two drivers, two mechanics and two spectators.
- On Aug. 21, 1935, the Swing Era begins with Benny Goodman's triumphant Palomar Ballroom performance in Los Angeles. When his relatively staid arrangements began to lose the young crowd, Goodman pulled out upbeat, syncopated rhythm arrangements -- to the crowd's immense delight -- and swing was born.

The railroad strike lasted for 21 months. He used the same justification for seizing control of steel plants when the United Steel Workers union struck later in the year.



Retailers can help curb underage smoking

Tobacco retailers play a significant role in protecting youth from nicotine addiction and the harmful effects of tobacco use. Federal law prohibits the sale of tobacco products to minors under the age of 18, as enforced by Michigan's Youth Tobacco Act. By complying with the law, retailers can help prevent underage tobacco use.

Each year across the state, undercover inspections take place to determine the number of retailers who would sell cigarettes to youth. In Northeast Michigan, these inspections are performed by District Health Department No. 2 with the assistance of an underage youth and a local law enforcement officer. Anyone who furnishes a tobacco product to a minor is at risk for a misdemeanor and relevant fines.

From 2010-2013, 14 undercover inspections have taken place in Alcona County. There were four consummated sales to minors, resulting in an overall sales rate of 28.5 percent. This is significantly higher than the state's 14.4 percent average.

Prevention efforts include the distribution of retailer education packets, comprised of signs to be displayed, information on the law, sample store policies and tips for training employees. Store clerks are urged to carefully check photo identification and obey the law.
