Rachel's Challenge comes to school, community

Students of Alcona Community Schools and the community were educated by a thought provoking anti-bullying program given by Rachel's Challenge last week.

Rachel's Challenge was developed in memory of Rachel Joy Scott who was the first student killed at Columbine High School in 1999. She dreamed of making a difference in the world by reaching out with kindness. Separate programs struc-

tured toward elementary students exemplified showing kindness towards others, while the programs for middle school, high school students and community explained in more detail about Rachel Scott, the tragedy at Columbine High School and how to make changes in everyday life.

The program presented five challenges to students and community members: 1.) Look for the best in other people...if we do that, we won't have room for prejudice. 2.) Dream big. Set goals. Live your dreams. 3.) Choose positive influences. 4.) Speak with kindness. 5.) Start your own chain reaction of love and kindness.

Separate programs structured toward elementary students exemplified showing kindness towards others, while the programs for middle school, high school students and the community explained in more detail about Rachel Scott, the tragedy at Columbine High School and how to make changes in everyday life.

The one time fee of \$5,400 to bring the program to Alcona schools was achieved through donations and Parent Teacher Organization (PTO) fundraising, according to Michele Wambold, PTO middle and high school secretary. Money donated above and beyond the cost of the program will be used to pay for supplies needed for additional educational material for the Friends of Rachel (FOR) club.

Wambold explained the FOR club will receive education on anti-bullying techniques and meeting Rachel's five challenges. One hundred students have signed up to

"The program was very well received. There were a lot of students impacted and they are looking forward to making a positive difference which is wonderful and is what we were looking to do," Wambold said. "It was definitely something we needed and will give students the materials and courage to make a change. The feedback from those who attended was very positive, even adults said the program touched them in a big way and was a reality check needed for all ages.

Alcona sixth-grader raises funds to help Sandy Hook victims

Like much of the nation, an Alcona Elementary student felt a sense of loss following the tragedy of Sandy Hook Elementary School in Newtown, Conn. Emily Hoffman, a sixthgrader, wanted to do something to help the parents and students there, but wasn't quite sure what she could do.

She decided to make ribbons and sell them to earn

money to help the community. Kristin Hoffman, Emily's mom, looked to the Internet to find help with what color the ribbons should be.

"We saw the Blue Ribbon Campaign which is a ribbon color used to raise awareness of child abuse," Kristin Hoffman said.

The Blue Ribbon Campaign began in 1989 as a woman's tribute to her grandson. She tied a blue ribbon on her car antenna to symbolize his bruises, after he died at the hands of his mother's abusive partner. The Blue Ribbon Campaign focuses on educating individuals and groups on how to better protect children from abuse. Then Emily and Kristin Hoffman decided blue would be the best color to embrace Emily's effort and began making as many blue ribbons as they could. Together they have made nearly 700 ribbons. The 11-year-old has sold many of the ribbons for a donation during school events such as Alcona Elementary School's Christmas program and the Rachel's Challenge program held last week. She hopes to continue the sale of the ribbons until she has sold all of them.

Iretired in northeast Michigan for the relaxed atmosphere, scenic beauty, fine medical facilities and great school systems. Unfortunately, some of the great school systems are physically and financially broken.

The proposed enhanced school millage (February 26) is a death wish for northeastern Michigan. Three mills for 10 years will greatly reduce available funding for 911, library, fire, ambulance, roads, and other renewable or needed millages. We still have the greatest teachers and some of the finest principals in the business. When this millage was conceived (via a loophole) school superintendents, business managers and board members jumped on the band wagon.

Iask taxpayers to call, write, e-mail or look them in the eye and ask: "What were they thinking?" Ensure that their answers are factual. Then ask them what they have done individually or collectively to inform/convince Lansing that public schools need adequate funding. Or is it so much easier to play the doom and gloom card to parents, grandparents and extended school family?

Having a special election at tax payer expense, when many senior citizens are out of town, with bad weather a possibility, would result in a low voter turnout. Governor Snyder is preparing a school funding bill for February. Our school officials should be in Lansing fighting for proper funding, not trying to win over local taxpayers with doom and gloom.

If this millage is passed, there is no turning back. We will be stuck with it for 10 years, to the tune of 56 million additional tax dollars. We will pay for it on our property taxes, plus we will pay for it again and again through the trickledown effect with every dollar we spend. What's going on in Lansing? Where are the excess bottle deposit funds? Why a guilt trip for local tax payers?

Alcona girls net two wins to start 2013

The Alcona girls varsity basketball team is off to a good start in 2013 after capturing the first Huron Shores Conference win on the road against Whittemore-Prescott Thursday, Jan. 10 and a win over Roger City on Monday, January 7 in the regular season.



Getting Social Security help may boost your benefits

Dear Savvy Senior,

Are there any services that you can recommend that help pre-retirees decide when to start drawing their Social Security benefits? My wife and I are still a few years away from retiring but want to carefully weigh all our options to make sure we get the most from our benefits.

Approaching Retirement

Dear Approaching,

Deciding when to begin collecting your Social Security benefits could be one of the most important retirementincome decisions you'll make. The difference between a good decision and a poor one could cost you tens of thousands of dollars over your retirement, so doing your homework and weighing your options now is a very smart move.

What to Consider

As you may already know, you can claim Social Security any time from age 62 to 70, but the longer you wait, the larger your monthly check. However, there are many other factors you need to take into account to help you make a good decision, like your current financial needs, your health and family longevity, whether you plan to work in retirement, whether you have other retirement income sources, and if you're married, your spouse's situation.

You also need to understand the dizzying array of rules that can affect your Social Security benefits, and factor in the various strategies that can increase your benefits if you're married, divorced or widowed.

To help you compare all your options, there are a number of online tools and services that have sprung up in recent years that can help you make an informed decision.

To get started, your first step is to go to the Social Security Statement web page (socialsecurity.gov/ mystatement) and get your personalized statement that estimates what your retirement benefits will be at age 62, full retirement age (currently 66) or when you turn 70. These estimates are based on your yearly earnings that are also listed on your report.

Once you get your estimates for both you and your wife, there are several online tools you can turn to that can crunch hundreds of calculations to compare your benefits under various scenarios and different ages to help you figure out your optimum claiming strategy.

Two free sites are Analyze Now (analyzenow.com) which offers a robust decision-making tool called the "Strategic Social Security Planner," but requires Microsoft Excel to use it. And AARP's Social Security Benefits Calculator (aarp.org/socialsecuritybenefits), which is a less sophisticated tool but very easy to use.

Or, if you don't mind spending a little money, there are higher-level services like Social Security Choices (socialsecuritychoices.com) which provides a comprehensive customized report for only \$30 to help single, married or widowed pre-retirees identify their best claiming strategy. Or Maximize My Social Security (maximizemysocialsecurity.com), which charges \$40 for their report, and takes into account the thousands of different factors and combinations to help you maximize your benefits.

If, however, you want or need more help, there are specialized firms and financial advisors that can advise you for a fee.

One of the best is Social Security Solutions (socialsecuritysolutions.com, (866) 762-7526), which offers several levels of service including their "Premier Plus" plan that runs multiple calculations and comparisons, recommends a best course of action in a detailed report, and gives you a one-on-one session with a Social Security specialist over the phone to discuss the report and ask questions. The fee for this service is \$125.

Premier Social Security Consulting (premiersocial-



securityconsulting.com, (800) 518-0761) is another option that offers several consulting packages, ranging from \$75 to \$295.

Or, you can get help through a fee-only financial adviser who specializes in Social Security analysis and charges on an hourly basis. To find someone use the Garrett Planning Network (garrettplanningnetwork.com, (866) 260-8400), which offers the services of 300 independent advisers nationwide. The cost for a Garrett advisor ranges between \$150 and \$300 per hour.



Hooray for Hollywood

Somehow, I can easily imagine the people in Hollywood and New York using their vast understanding of those of us in fly-over country while doing their scheduling.

"It's February there," says Mr. Hollywood. "The cows have all been herded somewhere. The corn's been threshed or whatever they do. It's really cold, there's snow up to their wazoo and nobody wants to go out. Let's book all the award shows."

Last week brought us the People's Choice Awards. By the time you actually read this, we'll be past this weekend's Golden Globes and heading toward the Grammys and the Academy Awards -- both in February.

After many years of returning un-watched videos and not bothering to rent the movies available for three bucks on my television, what says I'd watch the ones delivered to my door by courier? Although the goody bags would be nice, especially if they included chocolates – or iPads. Or chocolate-covered iPads.

I've always thought it would be fun to host an Oscar Party one year - with fresh strawberries dressed in little chocolate tuxedos, cheese and crackers shaped like stars, champagne and ballots for guests to jot down their predictions in each category. I never have - it's always just Art and I, trying to figure out who's who. These days, very few of our friends make it to the movies either, they can't have cheese due to the cholesterol and champagne triggers their reflux. It would probably be a bit of a bust. Although, in a larger crowd, perhaps someone would know who that blonde was.

Despite all that, when the award show evening rolls around, I still shimmy into my best pajamas, microwave a bowl of popcorn and settle in to watch. I like to see the dresses, hairstyles and jewels the stars choose, their dates, moms and/or spouses, and the occasional wardrobe malfunction. And frankly, given the nature offilms these

days, if a movie is a hit, they'll show enough clips to give me a pretty good synopsis during the show.

Somewhere around the time they introduce the Price-Waterhouse guys, I usually move upstairs and snuggle into bed, trying hard to stay awake for the final best film announcement. As a general rule though, as with this year's presidential election results, I end up finding out in the morning.

Overall, the Oscars are pretty much my favorite, although the Golden Globes (a name that always brings to mind the actresses on the red carpet more than the award itself) are a little more fun. That's because the Oscar people tend to party after the awards, whereas the Foreign Press Association and its honorees do so during, resulting in more frequent wardrobe malfunctions and somewhat more incomprehensible acceptance speeches.



StarWatch By Gary Becker - Skinny Moon Debuts in Evening Sky

have you noticed the sun setting just a tad bit later? December 7 was the earliest sunset, 4:35 p.m., for souls living at 40 degrees north latitude. We still haven't gained that much daylight since the winter solstice, the shortest day of the year, but we are at least making the most progress at the correct time of the day-evening. Sunsets are now about 25 minutes later. Sunrises, on the other hand, are only three minutes earlier in comparison to the latest sunrise which occurred on January 4. The bottom line is that we still have a long way to go before spring, even though I remain optimistic. At the beginning of the week, you'll notice a scimitar-shaped waxing crescent moon hugging the SW horizon about 45 minutes after sundown. The horseshoe shape of the moon always points to the location of the sun below the horizon, while the tilt of the horseshoe gives a good approximation of the tilt of the moon's orbital plane to the horizon. Bring binoculars along to help accent one of the most beautiful aspects of a young moon, earthshine. When the moon is near its new phase, the Earth as viewed from the moon is nearly full. The Earth consumes 16 times the sky area of a full moon and reflects light about five times more efficiently than the moon, making Earth appear about 80 times brighter (5 x 16 = 80) in the moon's sky than a full moon appears in our sky. Light reflected from a nearly full Earth is reflected back to us by the moon, producing sufficient illumination on the dark face of the moon to allow the entire disk to be seen. This ashen light, earthshine, is also referred to as "the old moon in the new moon's arms." Although Sunday through Tuesday will be the best time to catch the ashen light with the unaided eye, binoculars will still reveal its presence right through First Quarter (Friday) if conditions are clear enough. VILLAGE OF LINCOLN MINUTES

The Lincoln Village Council met Monday, Jan. 7, 2012 at 7 p.m. at the village hall. The meeting was opened with the "Pledge of Allegiance." Those in attendance included: President Jordan, treasurer Kossa, clerk Somers, deputy clerk/treasurer Stutzman and council members Gauthier, Healy, Somers and Stutzman. Council member Lask was absent. Also present were attorney Cook and guests.

The minutes of the December 2012 meeting were approved on a motion by Gauthier with support from Stutzman. The treasurer's report was approved, subject to audit, on a motion from Gauthier with support from Stutzman. Kristy Schulze of Johnson & Schulze presented members with a copy of the village's recent audit report. Most importantly, Kristy stated that we received a clean opinion for this audit. Kristy pointed out a few areas that she felt could be improved upon. She said her comments were meant to be constructive and helpful.

President Jordan stated the village and Downtown Development Authority have had a huge task in doing this particular audit because of the grants involved. The village applies for the grants with matching funds coming from the DDA then we work together to get things accomplished. He said this audit will be useful to help us improve in the long run.

In public comment Naomi Potter and Teresa Hart stated two grants were received totaling \$4,586 to be used to lay down mulch for the Flights of Imagination playground. A donation of \$500 was received from Pat Jilbert and \$130 from her shop employees in honor of her husband, Ron Jilbert. To date there is a total of nearly \$8,000 to be used to improve the playground in the spring. Much of the money was also raised in the recent bake sales.

John Klinger, Gustin Township supervisor, addressed the council about a new program that is being offered in Alcona County regarding health and nutrition. Judy MacNeill is presenting a program called Fuel up to 60. She presented statistics about obesity in both Michigan and Alcona County. She gave information to the council to motivate everyone to become healthier through positive lifestyle changes. She challenged the community to join the "Let's Move" campaign. A motion was made by Gauthier, with support from Stutzman, to file an application to allow Lincoln to be designated as a "Let's Move" community and to authorize Sara Healy to act as a liaison on our behalf.

Leroy Hall, fire chief, stated that this has been a very busy year for the department. The total runs for the year is 203 with 141 outside the village and 62 inside the village. Connie Stutzman stated the next planning meeting is set for January 17 at 6 p.m. We are looking forward to completing the process of rewriting our ordinances and getting everything ready for a final approval by the council

Richard Somers gave his sewer and street reports. We are averaging 3,706 gallons per day being pumped into the system. He stated that Barlow will need to be crack sealed this year. President Jordan asked to have the price quote for discussion at the upcoming budget meeting. He anticipates that Main Street and a few other small streets need to be done this year. Bonny will contact someone from MEDC regarding whether or not grant funds are available for street repairs.

Two bids were received for the pickup truck the village has advertised for sale. One was a bid for \$1,062 and another was a bid for \$752. Both bids were well below the bid threshold that was expected. A motion was made by Gauthier, with support from Healy, to accept both bids and to then reject both while pursuing other avenues for selling the truck. Bonny will work with Dick to get things ready to advertise it again

President Jordan stated he has been contacted by someone regarding the movie, "Lincoln" and the possibility of having it shown in the community. President Jordan will contact the proper authorities and see about having details worked out. The showing date would be February 12. A motion was made by Gauthier,

with support from Stutzman, to have president Jordan pursue this venture. Motion carried. The lighting of the village went very well this year. Many positive comments were made by those in attendance. First place went to Ted and Deb Shaneour: second place went to Dick and Norma Somers: third place went to Billy and Edna Somers; and fourth place went to Rod and Cindy Kilbourn. The travelling trophy for the business community went to Alcona Motors. A plaque was delivered to the Linton family for the flag pole donated in their father's memory. President Jordan stated that he recently met Marty Carpenter, son of the late Doc Carpenter, local veterinarian, that passed away several years ago. President Jordan stated that he would like to purchase a plaque to designate the tree that was donated by his family in his honor. Council members agreed that this

should be pursued. There are several things that need to be fixed on the dump truck. There is a bad cylinder and a bad gas tank.
