

Fire destroys road commission garage

During the late hours of Saturday and early hours of Sunday, Alcona County experienced the loss of an iconic building and wounding to its infrastructure when the Alcona County Road Commission garage was destroyed by fire.

The Lincoln Fire Department was the first to be called out to the structure fire at about 10:45 p.m. Saturday, Sept. 28. "The fire was located in the back of the building and flames were shooting 20 to 30 feet through the peak of the roof when we arrived," said Lincoln Fire Chief Leroy Hall.

While fire fighters were arriving and putting on their turnout gear, road commission crew members arrived on the scene and decided to retrieve vehicles from the burning building. According to Alcona County Road Commission Director Jesse Campbell, he, Jim Quick, Mike Escareno and Dennis Scott "started trying to get trucks (outside) along the fence line away from the building... we extinguished one that was on fire... then we proceeded to go inside... we went through the front door with the loader and pulled out two trucks..."

Hall said fire crews "started spraying water immediately" upon arrival. "We held off on gaining entry to make sure the full crew was suited up and ready... we knew our entry would push flames forward (to the front of the building) to where trucks were parked inside. We wanted to keep the heat off of the trucks," Hall said.

Fire departments from across the county - Harrisville, Mikado, Barton City, Alcona Township, South Shore and Greenbush responded to the fire that eventually consumed all 15,000 square feet of the building. Curtis Township Fire Department, Curran Fire Department and Hubbard Lake Fire Department went on standby status and provided assistance.

"The team work of the fire fighters was unified and command among all chiefs was very effective," said DNR Fire Officer Roger MacNeill, who also responded to the fire. "The strategy and tactics among the chiefs impacted all aspects of the fire and the dangers it presented... it was a win-win situation as (the fire) didn't spread to other structures."

MacNeill explained fire fighters responded with offensive tactics in an effort to save the building, however, the response changed to defensive tactics to keep other buildings from being de-

Road commission employees at work Monday

Alcona County Road Commission employees were at work Monday morning despite the loss of the main building that housed the garage, service center, parts center, meeting area and offices for the foremen and superintendent.

The building on Lake Street in Lincoln was destroyed by fire over the weekend with a preliminary estimated loss of more than \$4 million includ-

ing the structure, vehicles, equipment and tools.

Alcona County Road Commission Director Jesse Campbell said that estimate will probably increase as insurance assessments are ongoing. As of Monday the loss included five orange (dump/heavy maintenance) trucks including a new truck, three pickup trucks, one forklift, one main service truck, one one-ton medium duty truck, a coal patch trailer, a leased crack sealing machine

and countless other equipment, tools and parts.

Then there's the loss of the 15,000 square foot building which is the central location and heart of the road commission. The first section of the building was originally constructed in the 1930s and was added on to four different times with the last addition completed in 1956.

Employees, former employees, family members and members of the community have a strong tie to the build-

ing. Campbell said he has heard countless stories about personal experiences throughout the years from a wide variety of people. "There has been a lot of reminiscing and sharing of stories by employees and their families, retirees and their children," Campbell said.

Mingled with the shared memories is the feeling of extreme loss and uncertainty of what is to come. Morale is

Michigan Court of Appeals rules against county in embezzlement auditor case

Six years and five months after former county treasurer Tom Katona entered a plea of guilty to embezzling more than \$1.2 million from Alcona County, the Michigan Court of Appeals has ruled on the last of a series of appeals that grew out of the case.

The appeals court ruling effectively eliminates the \$1 million originally awarded to the county and, in addition allows the auditing firm to "tax costs" - recovering court costs in the appeal.

In an unpublished opinion issued on September 23, written by justices Mark J. Cavanaugh, Kirsten Frank Kelly and Karen M. Fort Hood, the appeals court reversed an order issued in a 2010 23rd Circuit Court jury trial

against Robson Accounting and Rehman Group, a Saginaw, Mich. based firm. The firms were auditors for the county during the years in which the embezzlement occurred.

Originally, two appeals were filed, one from each of the firms, but the court chose to review them as a single case.

The issue on appeal arose from a decision by Circuit Court Judge Ronald M. Bergeron to deny a motion for summary judgment (disposing of the case) based on language within the auditing contract which established a 12-month period of limitations after performance of service during which claims could be filed.

Both the county and the auditing firm agreed that the last day of service by the au-

ditors was June 28, 2006 and that the county's complaint was filed on March 4, 2008. However, attorneys for the county argued that the state's statute of limitations for accounting malpractice overrode the contract language.

In last week's opinion, the appeals court disagreed.

The embezzlement of funds by Katona came in the form of wire transfers in excess of \$1.2 million to what the appeals court called "The Nigerian Advance Fee Fraud Scam."

In 2006, when investigation into county financial irregularities began, the Alcona County Board of Commissioners directed Katona to report, in writing, regarding certain transactions and to provide a bond in the amount of \$7,000,000 to secure his

faithful performance of duties as county treasurer. Upon failure to do so, the county board removed him from office.

low with employees, but they met as usual at 7:30 a.m. Monday to find out what was going to happen next.

"It's devastating," Campbell said. "We have to keep moving, hold our heads high and move forward. We have a great crew. They work great

together. This is a time to start over. There is no sense in crying over spilled milk."

"This didn't just affect the crew of the road commission - but their wives and kids as well. And, it really effects the population of all of Alcona County. It's sad, it really is.

Monday morning also saw an informal road commission meeting where some goals were identified and strategy was put in place.

"Within the next two weeks the goal is to have a repair facility where regular maintenance can be done on the trucks and our maintenance crew can work. We need a location where we can keep our trucks and work out of," Campbell said.

While the assessment of damage regarding the loss of vehicles, equipment, tools and parts is ongoing, the road improvement projects on Trask Lake Road and Barlow Road will continue. "These projects have to get done," Campbell said.

"This is the worst possible time for this to happen with winter right around the corner," Campbell said. "With the cuts we've had in the last year and now this loss, it will be hard to keep up with snow removal this winter," Campbell said. "Our response time is going to suffer and service won't be as it used to be that's for sure. I'm hoping for an easy winter, but I doubt that will happen."

Despite the uncertainty of what will transpire in the days to come Campbell has been pleasantly surprised at the outpouring of support he and the road commission has received since Saturday night. "Everyone has been very supportive - fire crews, law enforcement, our crew... I've been overwhelmed with the support that has come from the community. A lot of counties around us have been wonderful and have let us know that they are willing to help in any way that they can with anything we need."

stroyed. "We lost the building, but we kept the fire from going from the parameters of the building to the road commission office building and several houses nearby," MacNeill said. "It's a tragedy that we lost the building," Hall said. "But, shortly after we got there we knew it wasn't going to be saved."

However, fire fighters returned throughout the day on Sunday to keep an eye on the scene to ensure hot spots didn't flare up. The scene will be continuously watched until the debris is cleared. "If it wasn't for the community - people willing to assist - we couldn't have done what we did," MacNeill said. "We had assistance from all

trucks we pulled out - that we thought that night would be okay - have a lot more damage than anticipated," Campbell said. "No one was hurt or killed - that is a blessing. I think we handled it very well. We made some good decisions on what we could get out, but, at a certain point it's too risky... the fire expanded a lot when we went

Hall explained two brush rigs were assigned to a roving patrol for surrounding structures. MacNeill said some residents were evacuated for safety measures. In addition to a steady south wind, fire fighters faced safety issues in relation to the contents of the building. "Due to the fact that it was in an industrial building and it had industrial materials - fuel tanks, tires... everyone was very conscious of the hazards," MacNeill said. Hall explained the biggest explosion-like instances that erupted from the building were tires rupturing. "That sounds like explosions," he said. Hundreds of bystanders - including almost all of the road commission employees - watched the building turn into rubble throughout the night and into the morning. Hall's crew cleared the scene at around 5:30 a.m.

In January, 2007, Katona was arrested and charged with nine counts of embezzlement by a public officer and two counts of forgery resulting in a \$1.2 million loss to the county. In May Of 2007, he pleaded guilty to the charges and was sentenced to serve 112 (nine years and four months) to 168 months (14 years) in state prison.

At present, he has served almost half of the maximum sentence.

To date, Alcona County has recovered approximately \$450,000 of funds as restitution, largely from Katona's personal holdings.

In March of 2011, the Review reported that, based on documents obtained under the Freedom of Information Act, legal fees paid by the county prior to the most recent appeal had reached more than half a million dollars.

In order to further pursue the case, it would be necessary for the county to bring it before the Michigan Supreme Court.

How to safely dispose of unused medicines

Dear Savvy Senior,
What is the safest way to dispose of unwanted medications? My husband and I have drawers full of unused and expired drugs that we'd like to get rid of, and get them out of sight of our curious grandkids. What can you tell me?

Concerned Grandmother

Dear Concerned,

The safest and most responsible way to dispose of unwanted, unused or expired, medications is to take it to a medicine take-back event. And the next prime opportunity to do this is on National Prescription Drug Take-Back Day, which is slated for Saturday, Oct. 26 from 10 a.m. to 2 p.m.

National Take-Back Day is a free, anonymous program that will have around 6,000 designated sites nationwide - including many fire and police stations, and community centers - where

you can drop off your unwanted medications.

Developed by U.S. Drug Enforcement Administration, the take-back program was created to help address the ongoing problem of prescription drug abuse, as well as improper use of medications and accidental poisonings.

In the three years of semi-annual collections, more than 1,400 tons of prescription meds have been collected and incinerated. To find a collection site near you, visit dea.gov or call (800) 882-9539.

The reasons take-back sites are a better option than tossing the medications yourself are because throwing drugs in the trash gives kids, grandkids and pets the opportunity to get at them, and a wastebasket is a likely place for family drug abusers to check after they've looked in the medicine cabinet.

And flushing them down the toilet - unless instructed

- is generally a bad idea because the Food and Drug Administration (FDA) wants to minimize drug residues in the public water supply.

If you happen to miss take-back day or there's no site available near you, talk to your pharmacist to see if he or she knows of another medicine disposal program in your area, or call your city or county government's household trash and recycling service. Or, if you want to dispose of your pills on your own, here are some tips recommended by the FDA.

- First, remove all personal information and drug names from the label by scratching it off, or marking over it with a permanent marker.

- Then take the medications out of their original bottles and mix them in another container (like a sealable bag or empty margarine tub) with an undesirable substance, such as cooking oil, coffee grounds or cat litter.

Then seal the container and throw it in the trash. This will make the medication less appealing to children, pets and unrecognizable to people who may intentionally go through your trash.

There are, however, a few medicines that may be especially harmful or even fatal if used by someone other than the person for whom the medicine was prescribed. These medicines have specific disposal instructions indicating they should be flushed down the sink or toilet as soon as they're no longer needed, and when they cannot be disposed of through a medicine take-back program. To see an FDA list of medications that should be flushed once expired, go to www.fda.gov, and type "flush drugs" into the search box.

If you have other questions about proper drug disposal, talk to your pharmacist.

And to keep the medications that you and your husband currently use secured and out of reach of your grandchildren and others, lock them up in a drawer, medicine or file cabinet, or consider purchasing a medicine lock box at your local pharmacy or big-box retail store.

Alcona defeats Whittemore-Prescott in double overtime

Gas was \$1.13 a gallon, a dozen eggs cost \$0.93 and George Bush was president the last time the Alcona Tigers beat the Whittemore-Prescott Cardinals in a high

school football game.

The 21-year record of the Cardinals defeating the Tigers was broken Friday night when the Tigers were victorious with a score of 28-26 in a game that went into double overtime.

Cody Franklin started things off for the Tigers with two carries. A Whittemore penalty set Franklin up to throw a pass that was received by Dawson Forsythe for a 44 yard touchdown. Garrette Norling added on two

more points with a successful two point conversion and made the score 8-0 with 8:54 left on the clock.

The Tigers came out strong on defense as well with three good stops and taking over on downs. Josh Mead took advantage and ran the ball 23 yards where Forsythe had a good block. Franklin tried to advance the ball but the Cardinals took the ball back on fourth down. The Cardinals attempted to pass but the receiver was stopped by Alec Neumann.

Tony DuBay took down the quarterback forcing a fumble which was recovered by Whittemore. A Whittemore pass completion lit the fire of the Tiger defense where they stopped the Cardinals, and forced them to punt. Mead received the punt and that ended the first quarter.

"You prepare by working as hard as you absolutely can. We start fast and finish strong," said Coach Dave Schneider.

At the start of the second

quarter, Franklin scored a touchdown off of two good runs by Nathan Fettes and Mead proving that the Tigers do start strong. The score board displayed 14-0 with 9:43 left in the quarter. The Cardinals advanced the ball down the field with two completed passes. At fourth and ten and a stop from Norling and DuBay, Alcona took over on downs. With less than two minutes left in the quarter, Whittemore intercepted a pass to Forsythe. The Cardinals advanced the ball all the way to touchdown making the score 14-6. Fettes stopped the two point conversion.

After half time, the Cardinals struggled with their offense as stops by Neumann, Fettes and Mead kept tight on Tiger defense.

Alcona got the ball to fourth and one when a penalty was called which moved them back and they were forced to punt. On the punt receive, Whittemore dropped the ball and it was recovered by Mead. The Tigers struggled to get the offense going and had to punt once again. Lucas Weichel, Neumann, Mead and Fettes took over on downs. Fettes got a first down which ended the third quarter.

Mead came short of a first down for the Tigers and punted the ball to the Cardinals to start the fourth quarter. The Cardinals got a first down and moved down the field by completing a long pass. Mead stopped them right in front of the goal line. The Cardinals got a touchdown with 8:34 left and the two-point conversion is good making the score tied at 14-14.

Mead returned the ball 37 yards off the kickoff. Two passes from Franklin to Mead and Fettes get a touchdown for Alcona. Fettes got the touchdown and 19 yards on the play. With three good stops by the Tigers, Whittemore still managed to get a first down. Whittemore kept advancing down the field and got a touchdown on a completed pass and a long run. In high school football overtime consists of each team getting a chance to score. A coin toss determines which team gets the ball first and which end of the field they want. The ball is set at the 10 yard line and each team gets four downs to score.

Whittemore won the coin toss and got the ball first. With two good stops by Fettes and two incomplete passes,

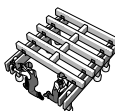



StarWatch By Gary Becker - Opa

I've often wondered what spurred me as a kid to look at the sky. Perhaps it was the bright meteor that I saw on my way to a cub pack meeting or a teacher asking me if the cosmic information that she was conveying to her class was accurate. Then there was my poor father who I bombarded with a gazillion questions until one day he sighed and said, "Son, I just don't know." My response was, "Well, dad, give it your best shot." And on it went... My grandfather, Ewald Marcus (1893-1988), must have also played a role when he regaled me with vivid stories of his life, often using English and German words, interspersed within the same sentences as he spoke. As a student in the gymnasium, he was switched by his teacher when he conjectured about life on distant worlds in our galaxy. When he was 16 in 1910, he and a friend attended a May carnival in his hometown of Solingen-Wald. As the light from late afternoon waned into twilight, and then to darkness, there low in the sky was the bright gossamer tail of Halley's Comet, stretching, as he put it, "from horizon to horizon." The sheer surprise of its appearance always brought awe and wonder to his voice whenever he told me the story. As a German infantry soldier fighting on the Russian Front during WWI, my grandfather volunteered to take over culinary responsibilities when the cook in his regiment was killed. Ewald was an excellent, self-taught chef, and according to him, making a good meal was mostly a function of multiplying the correct ingredients by the number of hungry men who were to be served. My grandfather never received a complaint. At night when his chores were completed, he would often go outside and sit on a chair in the snowpack, reading the German newspaper by just the light of the moon. In the distance, hungry wolves howled at the stars, his "hoowling" sounds sending tingles up my spine. Opa died when I was 38, on my favorite day of the year, the summer solstice. www.astronomy.org

Scam alert trifecta

Dollars And Sense

"Mystery shopper opportunities" are making a resurgence in email boxes. Yes, there are legitimate companies. If you've been working for one for a long time and are happy with them, feel free to continue. But if you want to get started now, don't. Wading through the myriad offers and trying to decide which are on the level is asking for trouble.

When you sign up, you're likely to be asked for your name, address, email address and bank-account information for "instant" receipt of your pay via wire transfer. That's too much information for a company you don't know. You may be asked to pay a fee to sign up as well, or for "certification."

Barring that, chances are that the only "shopping" you'll be asked to do will involve receiving checks in the mail with instructions to take out your fee and send them the balance of the money by MoneyGram. The check will end up being no good, and you'll be out the money you wired to them.

If someone offers to pay a ridiculous amount of money to a stranger for a minimal amount of work, think: scam.

One inventive scam offers to pay people money to put advertising signs on their car and drive around. Amounts offered are up to \$1,000 in advance and then \$500 per week to drive around with a

vinyl sign stuck to your car. You don't have to answer any questions, such as about the number of miles you drive, or where you drive. A legitimate advertiser would want to know where his ads will be seen. Your payment will be in the form of a check, which you are instructed to cash, take out your fee, and send the balance by Western Union back to the company.

Do you see a pattern here? Another scam can reach us right where we live: our homes. Security systems for the homes are designed to make us feel safer. The Federal Trade Commission (FTC) has investigated numerous complaints involving high-pressure sales tactics, shoddy merchandise and more. The warning signs: Someone (likely part of a roving team) comes to your door in a cold call, impersonating a representative of the monitoring company you already use. You're told your old system is deficient in some way, and that the new equipment itself is free if you'll sign a contract.

VA health care for women vets

The American Legion recently released its report on the status of Department of Veterans Affairs health care for women veterans. Members of the System Worth Saving Task Force visited 15 VA facilities in 12 states around the country. Its purpose was to learn what barriers keep women veterans from enrolling in VA health care, understand the challenges women veterans face and make recommendations.

The 2013 Task Force Report on Women Veterans Health Care centered on three points:

1) Women veterans don't identify themselves as veterans and don't know about their benefits.

2) VA medical centers don't use baseline enrollment and marketing and outreach programs to keep women veterans in the health system. Women make up 15 percent of active-duty service members, yet the number of women using VA health care is considerably smaller.

3) Models of care need to be assessed for effectiveness. For example: Women veterans don't receive mammograms results quickly; VA facilities don't all have inpatient or residential mental-health programs for women; and the child-care pilot pro-

gram is about to expire.

Here are some results of the survey, both good and bad:

- Women veterans keep their appointments when childcare is available during appointment times.

- Patient file flags about veterans "at risk" for violent behavior stay in-house, and therefore don't show up on the national records if a patient goes to a different facility.

- Not all facilities are equal. Patients often are required to go to other facilities for care, or even go out of state.

The American Legion program has been in operation for 10 years, visiting VA medical facilities to assess veterans health care and offering information and recommendations to the VA, Congress and government officials.
