Pouring it forward: Local mom gets milk to students in need

An Alcona mom is thrilled to be able to supply milk to elementary students, an idea she got while volunteering to help provide food for families in need.

When Gustin Township resident Katie Dellar and her husband, Jason, visited the Detroit, Mich. area last fall they spent some time volunteering with Forgotten Harvest, a mission to relieve hunger in the Detroit metropolitan area.

The Dellars, who own and operate the Nu-Dream Dairy Farm, were representing the United Dairy Industry of Michigan (UDIM), which had partnered with Kroger Grocery stores in a "Pour it Forward" promotion, a campaign which asked customers of the large grocery chain to donate \$2.50 to go toward a gallon of milk for Forgotten Harvest.

Dellar said the experience of working with other Harvest volunteers touched her deeply. "I didn't realize that many of the people who volunteer with Harvest were also the recipients of their food. They were so appreciative and grateful for this milk," Dellar said noting that one in six people in Michigan were "food insecure."

She explained milk was a scarce item in food bank provisions with many food bank clients only receiving four glasses of milk per year. Just over five percent of items available in food banks come from dairy products. "They began the promotion because if they could guarantee a gallon of milk it was a major draw to get people to come to the food bank for the holidays. They were hoping for 25,000 gallons of milk in the month of November and they got over 34,000 gallons," Dellar said.

Dellar, a mother of four young children, realized how lucky her kids were to be able to have milk anytime they wanted. As a volunteer of the school, she knew not all children attending Alcona Elementary were as lucky as her own and wanted to do something about it.

She took the idea of providing free milk for the weekend to Alcona Elementary secretary Ronnie Miller. Miller agreed it was a great idea and thought at least 24 underprivileged children in the school would benefit from the program.

Dellar received a grant from UDIM near the end of December. The UDIM gives grants of \$1,000 per producer per grant event. "Since every dairy farmer in Michigan pays into UDIM for promotional purposes, this grant is like they all gave a gift to our community. It was very exciting, I told Ronnie I got the grant and she gave me the news the number of kids in need had grown from 24 to 48. I had figured the \$1,000 would last until the end of the year, but with the extra kids I'll need to get some additional community support," Dellar said.

There were still a few hurdles to get the weekend milk home. Dellar had to come up with some kind of way to keep the milk cold during the time it was packed and given to students and stay cold through their journey home. "I was able to get cooler bags from UDIM and Jason and I donated ice packs for each cooler bag," Dellar said. She also secured additional donations from the Barton City Eagles Ladies Auxiliary and from her sister and brother-in-law, Emily and Matt Grams, who also own a dairy farm.

Permission slips were sent home with students, as Dellar wanted to make sure parents were aware the kids were bringing milk home and they had a way to keep it cool once they got it there. They received 38 permission slips back.

Efforts finally paid off last Friday when Dellar and two of her sisters packed insulated bags with chilled ice packs and six half-pints of milk. "This is awesome; this is going to 38 kids who might

Lady Tigers earn ninth straight win

The Alcona girls varsity basketball team had a busy week with three games on the schedule.

On Thursday, Jan. 30 the Lady Tigers hit the snow covered roads to match up against the Fairview Eagles.

Alcona took control of the game with 17-6 lead to end ne first quarter and maintained a comfortable 37-14 lead at halftime. In the second half Alcona outscored Fairview 20-11, extending their lead to 57-25 after the third quarter. Fairview continued to struggle under Alcona's constant defensive pressure. The Lady Tigers secured the 75-34 victory. "It was great to get off to such a good start after having a break again," said coach Brad Cole. "We are all excited for Karina for scoring her 1,268th career point and breaking the school record. It was a team accomplishment. I am so proud of the progress our team is making," Cole said. Alcona's junior varsity team also picked up a 38-25 win against Fairview. The Lady Tigers were led by senior and co-captain

Karina Cole who scored 33 points, grabbed nine rebounds, had five assists and five steals for the night, Megan Quick added 12 points, six assists and had four steals Kendra Cole put in seven points and pulled down seven rebounds. Cassie Carpenter added six points and six rebounds. Nicole Walen had six points, Torie Harmon added four points Maddie Feld had three points and Sydney Pierce and Alissa Terpstra added two points each. On Wednesday, Jan. 29 Alcona played host to the Oscoda Owls. The Lady Tigers dominated the floor offensively in the first quarter to pull ahead 22-4. The second quarter was more of the same as Alcona pushed their lead to 42-14 at the halfway mark. Alcona outscored Oscoda 13-5 to stretch Alcona's lead to 55-19 to end the third period. The Lady Tigers cruised to a 76-29 win over the Owls. "It was nice to have a home game again in front of a great home crowd. Our girls played really well in all aspects tonight," Cole said.

On Monday, Jan. 27, Itook advantage of Peter Pettalia's schedule to meet with constituents in Alcona County. It had been almost three months since his November 1 meetings on fracking and I asked where he now stands on the process.

His fracking meetings did not present many of the concerns being raised about the safety of the new high volume hydraulic fracking. In fact, the panel member who was supposed to be discussing those concerns stated she knew there was no interest in passing a ban or even a moratorium on fracking in Lansing. She certainly wasn't lobbying for either. She was promoting a policy of regulating the industry, when only a ban can protect us.

During the Alcona fracking meeting, someone called for a vote of the attendees. Mr. Pettalia refused to take that vote in Oscoda, Alcona

or Alpena. He didn't include meetings in Presque Isle or Cheboygan, so he didn't hear their opinions either. Last week, he told me he still hadn't made up his mind.

Meanwhile the Michigan Department of Environmental Quality approved 23 high volume wells in 2013, bringing the total of HVHF wells in Michigan to 53. Do we have to wait for a disaster to happen here before we decide that the true cost of energy developed by fracking is more than we can afford? We need to have our representative protect the people and environment of Pure Michigan.

If you still haven't made up your mind about the safety of fracking, I recommend that you take a look at the Facebook page: "Ban Fracking on the Sunrise Side," where the dangers related to fracking are documented in many articles.

not have had any milk for the weekend. This is a huge deal for the community and just fills my heart big time," Dellar said.

It will cost about \$66 per week to provide the students with weekend milk. Dellar said they will continue to send milk home with the students providing they bring back the cooler bags and ice packs.

As Dellar looked at each carton to make sure the expiration date was good, she said, "We will continue until we run out of funds. Unfortunately, once the school year ends, there will still be a need for the kids to have milk during the summer months. We'll have to figure out how to get more funding and how to get milk to the kids during summer break."

The school is accepting donations to continue the weekend milk program. Checks can be made payable to Alcona Elementary School, 181 N. Barlow Road, P.O. Box 249, Lincoln, Mich, 48742. Put the word "Milk" in the memo portion of the check.



How to tell if you have prediabetes

Dear Savvy Senior, My 62-year-old sister was recently diagnosed with type 2 diabetes and was surprised when the doctor told her that she's probably had it or prediabetes for many years. My question is what determines prediabetes and how can you know if you have it?

Surprised Senior

Dear Surprised,

Underlying today's growing epidemic of type 2 diabetes is a much larger epidemic called prediabetes, which is when the blood sugar levels are higher than normal but not high enough to be called diabetes.

The National Institutes of Health estimates that as many as 79 million Americans today have prediabetes. Left untreated, it almost always turns into type 2 diabetes within 10 years. And, if you have prediabetes, the long-term damage it can cause - especially to your

- may already be starting.

But the good news is that prediabetes doesn't mean that you're destined for fullblown diabetes. Prediabetes can actually be reversed, and diabetes prevented, by making some simple lifestyle changes like losing weight, exercising, eating a healthy diet and cutting back on carbohydrates. Or, if you need more help, oral medications may also be an option.

Because prediabetes typically causes no outward symptoms, most people that have it don't realize it. The only way to know for sure is to get a blood test.

Everyone age 45 years or older should consider getting tested for prediabetes, especially if you are overweight with a body mass index (BMI) above 25. See cdc.gov/bmi to calculate your BMI.

If you are younger than 45 but are overweight, or have high blood pressure, a family

heart and circulatory system history of diabetes, or belong to an ethnic group (Latino, Asian, African or Native American) at high risk for diabetes, you too should get checked.

To help you determine your risk of diabetes, the American Diabetes Association has a quick, online quiz you can take for free at diabetes.org/ are-you-at-risk.

There are several tests your doctor can give you to determine whether you have prediabetes like the "fasting blood glucose test "or the "oral glucose tolerance test," that each require an eight-hour fast before you take it. And the "hemoglobin A1C test," that can be taken any time regardless of when you ate.

If you're reluctant to visit your doctor to get tested, an alternative is to test yourself. To do that, you'll need to purchase an A1C home test kit that measures your average blood glucose over the past two to three months.



The ReliOn A1c Test sold at Walmart (or walmart.com) for \$9 is a popular option. With this test kit, you provide a small blood sample (about a drop), and send it to the lab in a postage-paid return mailer for analysis. The results are usually sent back within a week.

A1C tests measure the percentage of glucose in the bloodstream. A reading of 5.7 to 6.4 percent is considered prediabetes, while 6.5 percent or greater is diabetes.

If you find that you are prediabetic or diabetic, you need to see your doctor to develop a plan to get it under control.

The comeback kid

If heaven does have many mansions, you have to hope that the one assigned to Bob Spencer when he arrived, has a bit of fixing up to do. The man who devoted himself to Alcona's Habitat for Humanity program wouldn't be truly happy without a door to level or some new flooring to install.

Bob was a self-described "comeback kid," returning to the county where he was born and raised after his retirement from General Motors where he worked in its research lab and proving grounds. He was a giveback kid, too, serving not just Habitat, but two terms as an Alcona County Commissioner and on the vestry at St. Andrew's-by-the-lake Episcopal Church.

During an interview I conducted with Bob and his wife, Elaine, in 2000, I remember thinking that the visit certainly explained the couple's commitment to helping others find homes of their own. Seated together on a loveseat in their cozy living room, their beagle snoring softly at their feet, they clearly understood the importance of "home."

Bob grew up in the Glennie area and was proud to say his family was the fourth to settle in Curtisville in the 1800s. Asked about his favorite place in Alcona, he said "The AuSable River. Anyplace on it...until I moved back up here, I never realized how much I missed it."

"I love trout fishing," he told me, "but a lot of times, I go down to the river and I don't put my rod together. I just go there and sit and watch an otter float down the river, watch the deer or the turkeys." A lifelong hunter, Bob believed in giving the deer a chance. "We have a policy," he said, "When we hunt, we don't kill a deer from the house. We have to go away from the house before we kill a deer."

He believed in giving people a chance, too. During his years with Habitat, Bob instituted the use of local prisoners to do their community service on Habitat houses and found a cost-effective way to purchase readymade walls built by inmates at Jackson Prison in southern Michigan. He understood that having an affordable home and providing the "sweat equity" required of potential homeowners gave families a base from which to seek further opportunity. As a commissioner, he believed in listening to his constituents, paying close attention and saving his questions until they were finished speaking. He may not have always agreed with what was said, but it was a rare individual who held a conversation with Bob and didn't feel he or she had been heard. Bob and Elaine epitomized a life devoted to family. The two of them were a team. working together to raise two children and several grandchildren. After more than 50 years together, it was obvious to anyone who saw them together that they loved one another and enjoyed each other's company.



My most constant memory of Bob is that each time I saw him, I thought that he had the most honest face I'd ever seen. A good, gentle man with a wonderful sense of humor, he remained philosophical even when diagnosed with Parkinson's disease and dealing with its attendant symptoms.

During the interview mentioned above, he remembered with fondness one of his early teachers, Irene McDougall, who had taught his father in 1918 and later, Bob himself. "She wasn't mean," he told me, "but you didn't goof around. You had to pay attention, because (if you didn't) you either caught an eraser or she tipped your chair over on you."

He remembered another teacher, too, Mrs. Lee, who he rather proudly told me, "used to call us asinine cedar savages. I joke about it now," he said, "Us asinine cedar savages have done pretty well, haven't we? Against the rest of the world, we get by." Bob Spencer did more than "get by." He went out into the world and did well, then he came back home and did good. It occurred to me at his passing that many families, warm and safe within their own homes across Alcona County, held him in their thoughts and prayers.

So when it comes to heavenly mansions, I have to hope that Bob's holds a beagle and a toolbox somewhere in there, that a river runs through the property and a few deer hang out around its edges and that there's maybe a window that needs replacing or a light fixture that requires some fiddling with. I can't help but think that those things would make Bob exactly what he was here on earth – a happy man. I was blessed to know him.

StarWatch By Gary Becker - "Death Star" Rocks Nearby Galaxy

A brilliant supernova has rocked a bright galaxy in Ursa Major (Big Dipper) called M82. The discovery was made on January 21 by an astronomer at University of London Observatory, located within the bright city limits, who was scrambling to image the galaxy for his students as weather conditions rapidly deteriorated. The undergraduates had chosen M82 because it was located in one of the few remaining clear patches of sky. While adjusting the position of the 14-inch, automated telescope, teaching fellow, Dr. Stephen J. Fossey, noticed a new star overlaid on the M82 photo which he did not recognize from previous observations. Checking online pictures of M82 against his new image of the galaxy revealed that the star was indeed a supernova blasting its way into visibility through the dusty lanes of this cigar-shaped galaxy. M82 is really strange. At a close distance of 12 million light years, M82 is interacting with another nearby galaxy, M81. The gravitational disruptions to M82 have caused an enormous amount of star formation in the galaxy's center, about 10 times greater than is occurring in our own Milky Way, giving the irregular galaxy a scruffy appearance as galaxies go. In the central, starburst region, supernovas occur at the rate of about one every decade. Ironically, the new supernova blew far outside this active region. Spectrographic analysis of the exploding star revealed it to be a Type Ia event originating from a carbon-oxygen rich white dwarf, the core of a dead star. In one scenario, hydrogen from a companion star in a contact binary system accretes onto the white dwarf. As the white dwarf gains more mass, temperatures and pressures exerted on its core increase, eventually triggering a runaway thermonuclear event which blows the star apart, creating the supernova. SN 2014J, as it is named, will continue to brighten for about one more week. The fun is just beginning. www.astronomy.org

The Department of Veterans Affairs has printed in the Federal Register its intention to provide a record \$300 million to address veteran homelessness for both fiscal years 2014 and 2015. The money will go to non-profit organizations in the Supportive Services for Veteran Families program that work with homeless veterans and their families.

The list of areas where these groups provide assistance is lengthy: Moving and relocation expenses, child care, rent and utilities for those who are homeless or at risk of becoming homeless, transportation, housing counseling, advocating with property owners, security deposits and emergency expenses. In 2013 alone, SSVF assisted 39,000 veterans and 62,000 veterans with families.

Once the veteran and his or her family are in permanent housing, the program continues, assisting the veteran with medical care, benefits and services, daily living, financial planning, legal services and more.

While veteran homelessness has declined by 24 percent since 2009, in January 2013 there still were 57,849 homeless veterans on the street. More than 7 percent of those veterans were women.

If your non-profit organization wants to qualify to provide support services to homeless or very low-income veterans and their families, start online at www.va.gov/ homeless/ssvf.asp. There is a lengthy process to be accepted into the program.

You also can call (877) 737-0111 or via e-mail at SSVF-@va.gov. Work quickly because your application has to be received by March 14, 2014. Grants are for three years and will begin October 1, 2014.

If you're a veteran who is homeless or at risk to be homeless, call (877) 424-3838 (4AIDVET). Someone will answer 24/7, and many of those who respond are veterans themselves. For information about VA and DOD programs for brain injury, go to www.dvbic.org
