## Pettalia running for re-election as state representative

Representative Peter Pettalia (Rep.) of Presque Isle, Mich. has announced his candidacy for the House of Representatives for the 106<sup>th</sup> District.

Pettalia made his announcement with a series of meetings where he talked about his role in making "Northern Michigan Matter." These stops included visiting Cheboygan Brewing Company, Calcite Port Collaborative in Rogers City, Mich., Scoops of Alpena, the Alcona County Courthouse, the Oscoda Wurtsmith Airport, and finished with a stop at Carroll Broadcasting in Tawas.

Pettalia echoed his message of government removing burdensome regulations to help small business grow, support of private public partnerships helping to create jobs, and examples of entre-

preneurs who continue to grow businesses and provide additional jobs.

Pettalia also highlighted his role in championing tourism throughout the state and supporting the Pure Michigan campaign expansion to advertise into the Canadian market. "I believe that the Toronto market can be to the east side of the state, what

## Two county millages on primary ballot

Voters in Alcona County will see two contested races and several millage requests when they go to the polls for the primary election on August 5.

Most of the local candidates are running unopposed in their bid for election or re-election. However, two county millages are on the ballot and so are several township millages.

The positions local voters will help decide are for a place on the general election ballot in November for the Congressional seat in District 1 and the State House of Representatives seat in the 106<sup>th</sup> District.

Two Republicans - incumbent Dan Benishek of Crystal Falls, Mich. and Alan Arcand of Iron River, Mich. are vying to be on the November ballot for the representative seat in Congress. Whoever is elected in the primary election will be on the ballot across from Democrat Jerry Cannon.

Three Democrats - Rozanne Curley of Oscoda, Robert Kennedy of Harrisville and Scot R. McKenzie of Alpena - are the on ballot for the 106<sup>th</sup> District state representative seat. The candidate that is chosen in August will be on the November ballot with Republican and incumbent Peter Pettalia of Presque Isle, Mich.

The two county millage proposals that will be determined on August 5 are for

the Alcona County Road Commission and the Alcona County Ambulance Service.

The Alcona County Road Commission millage request is for .5 mills for one year "to provide funds for the construction and site improvements of the Alcona County Road Commission facility, which if fully levied, is estimated to raise \$373,671 in the 2014 year."

The Alcona County Ambulance millage is a renewal request of 1 mill for four years (2014-2017) "for the sole purpose of providing funding to operate and maintain the Alcona County Ambulance Service." If the request is approved it is estimated that \$747,342.71 will be raised in the first year.

At the county level voters will see incumbent Harry Harvey (Rep.) of Harrisville on the ballot for a seat on the Alcona County Road Commission.

Kathleen E. Vichunas (Rep.) of Hubbard Lake is seeking re-election for the 1<sup>st</sup> District seat on the Alcona County Board of Commissioners. Joel Blohm (Dem.) of Lincoln is also running for that seat - which will be determined in November.

Four other county commission candidates are running unopposed for a seat on the Alcona County Board of Commissioners - Craig M. Johnston (Rep.) of Harrisville is running for the 2<sup>nd</sup> District seat which was held by Bill Thompson, who is not running for re-election. Carolyn

Brummund (Rep.) of Greenbush is running for re-election.

## How to make an online memorial for a departed loved one

Dear Savvy Senior,  
 What can you tell me about online memorials? My uncle recently passed away, and some of the family thought it would be neat to create an online memorial to pay tribute to him, and accommodate the many family and friends who are scattered around the country who couldn't attend his funeral.  
 Grieving Niece

Dear Grieving,  
 It's a great idea! Online memorials have become increasingly popular over the past decade, as millions of people have created them for their departed loved ones as a way to recognize and remember them.

An online memorial is a website created for a deceased person that provides a central location where their family and friends can visit to share stories, fond memories, photographs, comfort one another and grieve. The memorial can remain online

for life (or a specific period of time) allowing people to visit and contribute any time in the privacy of their own space.

Online memorials started popping up on the Internet in the late 1990s, but were created primarily for people who were well known. But now, these sites are for anyone who wants to pay tribute to their departed family member or friend, and ensure they will be remembered.

Content typically posted on an online memorial includes a biography, pictures, stories from family and friends, timelines of key events in their life, along with favorite music and even videos.

Another common feature is the acceptance of thoughts or candles offered by visitors to the site who want to send their condolences and support to the grieving party.

An online memorial can also direct visitors to the departed person's favorite charity or cause to make a dona-

tion, as an alternative to sending funeral flowers.

To make an online memorial, you can either create an independent website, or use an established memorial site, which is what most people choose to do. Memorial websites are very easy to create and personalize, and can be done in less than 30 minutes.

There are literally dozens of these types of sites on the Internet today. To locate them, do an online search for "Online Memorial Websites." In the meantime, here are a few good sites to check into.

The biggest and most established site in the industry is Legacy.com, which also publishes about 75 percent of the obituaries in North America each year through its newspaper affiliations. Creating an online memorial through this site (see memorialwebsites.legacy.com) will run you \$49 for the first year, plus an annual \$19 sponsorship fee to keep it

visible.

Some other popular sites to check out are Forever-Missed.com, which offers a free barebones option, along with a premium plan that runs \$35 per year or \$75 for life; and iLasting.com, which runs \$49 per year or \$99 for permanent display.

If you're on a tight budget consider LifeStory.com, which is completely free to use, but requires you to log in through Facebook to get to it. And iMorial.com, which is free if you allow ads to be posted on your uncle's page, or it costs \$50 without ads.

Or, if your uncle used Facebook, you can also turn

his profile into a memorial for free when you show proof of death. Once his page is memorialized, his sensitive information will be removed and his birthday notifications will stop, but (depending on his privacy settings) it still enables family and friends to post memories and condolences. In addition, you can also request a Look Back video, which is a short video created by Facebook highlighting your uncle's pictures and most liked status messages.



**Fishing picking up across region**

**Northeast Lower Peninsula**  
As of May 29

• Rogers City: Surface water temperatures were still in the low to mid 40s. Fish the stained water which is warmer. Those targeting lake trout caught fish up near Forty Mile Point, the state park and Adams Point when using cowbells or dodgers with spin glows five to 10 feet off the bottom in waters up to 60 feet deep. Try casting off the breakwalls or trolling around them for Atlantic salmon. Some caught the occasional Chinook on green, orange or blue spoons. The midge hatch is ongoing and should attract fish.

• Alpena: Some are fishing near the mouth of the river and the harbor for walleye, lake trout, Atlantic or the occasional brown trout while others were fishing around Thunder Bay Island. Try spoons or body baits at all depths as the fish are scattered. Cowbells or dodgers with spin glows are taking lake trout. The midge hatch is in full swing. This should

bring some Atlantic salmon closer to the breakwall. Try orange or silver with chartreuse crocodiles.

• Thunder Bay River: Is producing plenty of small-mouth bass and a few walleye. There is also a fair number of steelhead up near the 9th Street Dam. Atlantics are showing up and feeding on steelhead eggs or mayfly larvae. Try drifting spawn under a bobber or artificial baits.

• Harrisville: Had good fishing for steelhead, lake trout, walleye and the occasional salmon. Lake trout are moving towards 80 to 100 feet of water. Fish the lower two thirds of the water column. Steelhead are in the upper third of 60 to 80 feet. Spoons, body baits, flies on lead core, dipseys, planner boards and downriggers are all working. Walleye are in and around the harbor. Shore anglers can fish off the breakwall and the beach. Boats are fishing straight out, north or south of the harbor in 12 to 20 feet with crawler harnesses or body baits.

• Oscoda: Boats are finally heading out and catching a good number of steelhead, salmon, lake trout and walleye. Lake trout are in 90 to 120 feet and hitting on spoons. Salmon and steelhead were in 60 to 80 feet and hitting on spoons and body baits. Good colors were

orange or combinations of black and blue.

• AuSable River: Steelhead are still making their way up to the beds. Anglers have done well with spawn, wax worms and flies. Walleye are being caught off the pier and by those drifting at the mouth. Try crawlers and leeches.

• Houghton Lake: Anglers have caught walleye and crappie but are still waiting for the blue gill bite to get started. Water temperatures are still on the cold side.

• Tawas: Daytime fishing off the pier was kind of slow. A few carp and bass were caught inside the harbor and a couple of salmon were caught on large shiners on the outside. Night fishing off the pier was more productive for walleye by those casting body baits or still-fishing with large shiners. Walleye were caught by those trolling crawler harnesses between the tip of Tawas Point and Buoy No. 2.

• Tawas River: Shore anglers caught mostly small-mouth bass.

• AuGres: A good number of limit catches were reported in 20 to 35 feet between Point Lookout and Pointe AuGres. A few boats heading further south did very well off the Saganing Bar.

• AuGres River: Shore anglers fishing at night caught channel cats.

# Natural disaster awareness workshops for caregivers, community leaders

The morning session, "Natural Disaster Awareness for Community Leaders" will run from 9 a.m. to 1 p.m. The target audience is commu-



Gardening Tips

Container gardening is easy

Planting in a container will help bring the beauty of a garden up close. Local nurseries have a large assortment of plants available now and will be able to help with an appropriate selection of plant materials for any location -- in the sun or shade, on a porch or deck.

All plants must be placed in containers that have drainage holes. The soil in containers from the previous season can be reused. Pour water through the soil-filled pot until you can see it running out of the bottom. This will leach out the salts from last year's fertilizers.

After rinsing the soil, place it in a wheelbarrow or large tub, add slow release fertilizer and a bit of new potting soil. Wash the pot in warm, soapy water and rinse well. Cover the holes with a coffee filter or paper towel to prevent the soil from washing out.

Fill the pot with the cleaned or new potting soil until the plastic containers the plants

come in are about an inch from the top of the pot. Play around with the arranging of the plants and when satisfied, remove them from their grower pots, set them in the container and fill in the spaces with additional soil pressing it down to firm up the plants.

If the container is to be viewed from one side, place the tall plants in the back. Arrangements that can be viewed from all sides should have the tallest plants in the center.

Annuals can be fertilized

lightly every time they are watered. They only live for a year, so this will optimize the flower production during the growing season they are on display.

Perennials will become leggy if over fertilized.

Vegetables such as tomatoes, potatoes, green peppers and lettuce can easily be grown in containers eliminating the backbreaking work of weeding a large garden.

# Salmon program hooks kids on learning about the natural world

Every year more than 15,000 Michigan youngsters are involved in hatching Chinook salmon eggs (supplied by Michigan Department of Natural Resources' (DNR) fish hatcheries) and feeding and caring for the fry until they are old enough, in the spring, to be released into local rivers – hopefully to return in four years to spawn.

Salmon in the Classroom is the DNR's most popular education program. "Our research shows that students engaged in this program show significant gains in a variety of subjects," said Kevin Frailey, the education services manager at the DNR.

"Rather than someone coming into the classroom and talking for an hour, these kids are involved with live

egg to the smolt," said science teacher Matt Carter, who had the school's entire student body (34 students, K-12) on hand for the release. "One of the goals is to stress conservation, the importance of keeping our fish population healthy for the environment and recreation.

"The students worked every day to take care of the salmon. They checked the water quality – looked at the amounts of nitrates and chlorine and ammonia in the water – they checked the pH and scrubbed the tank to make sure there wasn't too much algae. As long as this program is available, we'll continue to do this."

The salmon release, from the bus ride to the park to letting the smolts go, took

10 to 20 at a time, in five-gallon buckets – down the steps to the river.

The DNR has stocked trout in the river since the 1950s, said Cory Kovacs, the DNR fisheries biologist at Newberry. "It offers fly fishermen something unique in the Upper Peninsula," Kovacs said. "It's remote – there's not a lot of access – and it's pretty comparable to the fishing out West in terms of the aesthetics."

The fishery is becoming increasingly popular with kayakers and canoeists, Kovacs said, and a postcard survey of anglers showed a high rate of satisfaction with the angling experience.

"We don't get a lot of reports, but the reports we get are positive," he said.

creatures from the fall until the spring," Frailey said. "The kids learn about biology, chemistry, ecology and stewardship. Tests show they know a lot more about fish and the Great Lakes after the program than they did before.

"The two biggest motivating factors are a dedicated teacher and a committed community," Frailey said. "The equipment – a tank and a chiller – costs about \$1,000 to \$1,500 and many of the programs are sponsored by local conservation clubs or other community groups."

The program, begun by a DNR fisheries biologist as something of a lark in the mid-1990s, is now in some 230 schools, engaging students from upper elementary through high school. Some schools have hundreds of students involved in the program, others a mere handful.

The students at Whitefish Township Community School in Paradise, Mich. recently released the 88 salmon they raised (from about 200 eggs) this year into the Tahquamenon River at Tahquamenon Falls State Park in Chippewa County.

"The program teaches the life cycle of salmon, from the

only a couple of hours, but it turned into a daylong field trip when park interpreter Theresa Neal gave the youngsters an extra job – helping stock trout in the Tahquamenon River below the upper falls.

The river is accessible by a 116-step staircase from the walking path to the water. And there's only one way to get the 4,000 brown trout from the fish truck to the river – by buckets. So the youngsters formed a bucket brigade, passing the trout –

The idea of enlisting the youngsters' help came to Neal in a flash when she saw how difficult it was for the DNR crew – including Fisheries Division personnel and park staffers – to get the job done.

"We're always trying to do new things with the school and we thought this would be a good excuse for a field trip," said Neal, who started the student bucket brigade in 2008. "They learn a little

Those of us who live on the arid Great Plains love to hear rain on the roof. Not hail, but rain. William Jolliff, a poet from Oregon, where it rains all the time, has done a fine job here of capturing that sound.

### Rain on a Barn South of Tawas

It may be as close as an old man in Michigan comes to the sound of the sea. Call it thunder if you want, but it's not thunder, not at all. It's more like the rush of semis on a freeway

somewhere between Bay City and Flint, the road a son will take when he learns, sometime around the last taste of a strap, that the life he was born to is nothing

at all like a life he'd ever bother to live. There's an anger in it, a tin-edged constancy that has no rhythm, quite, something more like white noise that still won't let you sleep.

Think of some man, needing to get a crop in, but the fields are sop, so he's trying to find something to fix, something to keep his hands working, something to weld, something to pound,

something to wrap his calloused palms around that might do less damage than a lead-rope knotted and tossed over the limb of a tree. If you ever decide to lose your years

by working this land, you might think again, about the barn you build, or roofing it with tin.

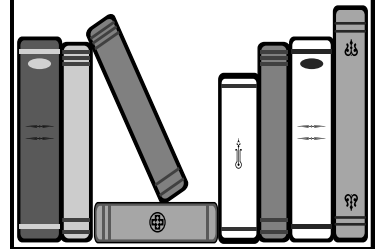

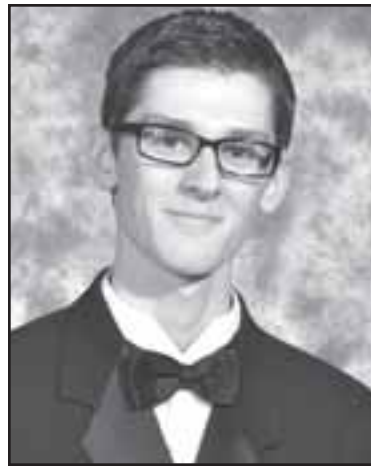

### StarWatch By Gary Becker - No Show Camelopardalids

It was just one of those events that you couldn't pass up. Five orbital theoreticians had predicted that the Earth would pass through the dust strands of Comet 209P/LINEAR's tail on the morning of May 24 between the East Coast hours of 2-4 a.m. The promise of hundreds of bright, slow moving meteors radiating from the obscure star pattern of Camelopardalis the Giraffe, located near the North Star, signified a major event. It was cloudy throughout most of PA on the 24th, so Boyertown Planetarium director, Peter K. Detterline, his son Michael, and I decided to search for clear skies along Virginia's Skyline Drive in Shenandoah National Park. It was a five hour drive for me, but the site we found was truly spectacular, with a subdued light dome from the Capitol about 70 miles to the east and virgin skies in the direction from where the meteors would be streaming. We were in full operation by 1 a.m. Pete faced south, and I looked north in the direction of the radiant. For nearly four hours we watched intently and saw almost nothing, in total, four faint Camelopardalids (Cams) and nine nonmembers for me. Ironically, I imaged a Cam which I don't remember observing. Pete fared better with five faint Cams seen and seven sporadic meteors spotted. Perhaps Michael was the luckiest. He fell asleep almost as soon as we started viewing. The brilliant fireballs predicted by the experts did not materialize, and as the blue dawn invaded the darkness with Venus and a thin crescent moon hanging over DC, we contemplated another five hour journey home. I went a total of 27 hours without sleep, but there was definitely a sense of satisfaction about being a participant in the verification of this event. In meteor astronomy, these types of forecasts are still in their infancy. The lack of confirmation of a meteor show was every bit as valid from a scientific standpoint, but it is back to the drawing boards for the theoreticians. ### Home freezers

A home freezer can be a good bargain over the long term, but buying a freezer also can be a major expense. Here are some things to consider in deciding whether having a freezer is the right move for you.

**Capacity:** How much do you need? The rule of thumb is to multiply the number of family members by 1.5 cubic feet, adding more to the calculation if you'll be adding large quantities of meat from hunting or bulk buys, or if you'll be freezing vegetables from a large garden.

**Energy Use:** Read the EnergyStar rating labels to determine how much energy the freezer will use, and multiply by the kilowatt hour cost (you'll find that on your electric bill) to determine your costs to run the freezer.

**Upright vs. Chest:** Consider the pros and cons for both.

Upright freezers are shaped like a refrigerator and therefore take up less floor space. Since they open from the front, it's easier to find what you want, but bulky items can be hard to store. Uprights usually cost a bit more than the chest style, but most are self-defrosting. When you open the door of an upright freezer, your cold air spills out onto the floor, which adds to your energy cost.

Chest freezers are more

energy efficient because the cold air doesn't escape when you open the top. Most are manual defrost, which saves energy, but can be an unwanted chore. It can be difficult to find items that are at the bottom.

**Options:** Here are some you'll want to consider:

- A lock with key for safety around children
- Self-defrost
- Magnetic door seal
- Interior light
- A defrost drain for manual defrost
- Adjustable temperature control
- Warranty and on-site service

Don't buy more freezer than you need -- due to the operating costs. Freezers work best if filled most of the way. With a too-big freezer, you'll pay extra for the freezer and then again every month when your electric bill comes due.

A freezer can be a money saver if it means fewer trips to the store -- less gas, less impulse buying -- or that you won't eat out as often. But consider your actual usage to determine if it will be worth your while to own one.

## Veterans Post By Greddy Groves

### New VA health program draws praise from vets

The spotlight on delayed medical care at a number of Department of Veterans Affairs medical centers has overshadowed some recent good news about the VA's PACT program, its method of providing personalized primary care.

PACT (Patient Aligned Care Teams) was started in 2010 as a team approach to the wellness of individual veterans by using health plans with care provided at clinics and online via eHealth. Teams are made up of nurse care managers, clinical associates, providers and administrative associates, in tandem with nutritionists, social workers and pharmacists. Appointments with specialists are easily arranged.

Sounds pretty good, doesn't it ... individualized medical attention. The veterans who receive these services like it, too, according to a VA news release. Here are some of the stats:

- Using secure electronics such as telehealth video conferencing, email messaging, home-based monitoring, phone calls and group meetings, the number of interactions with veterans increased 50 percent.

- Of veterans asking for a same-day appointment with their personal provider, 65 percent got it. Of those who asked for a specific appointment date, 78 percent were accommodated. In the past year, care during non-business hours increased 75 percent.

- More than 70 percent of veterans who are discharged from the hospital are contacted within two days to make sure they understand their instructions and to see how they're doing.

- Mental-health care services, also a component of PACT, increased 18 percent.

- As a result of PACT, there's been a 33 percent decrease in the number of veterans needing urgent care, and hospital admissions decreased 12 percent for acute conditions.

The bottom line? In a PACT satisfaction survey, over 90 percent of veterans had

positive assessments of both inpatient and outpatient care.

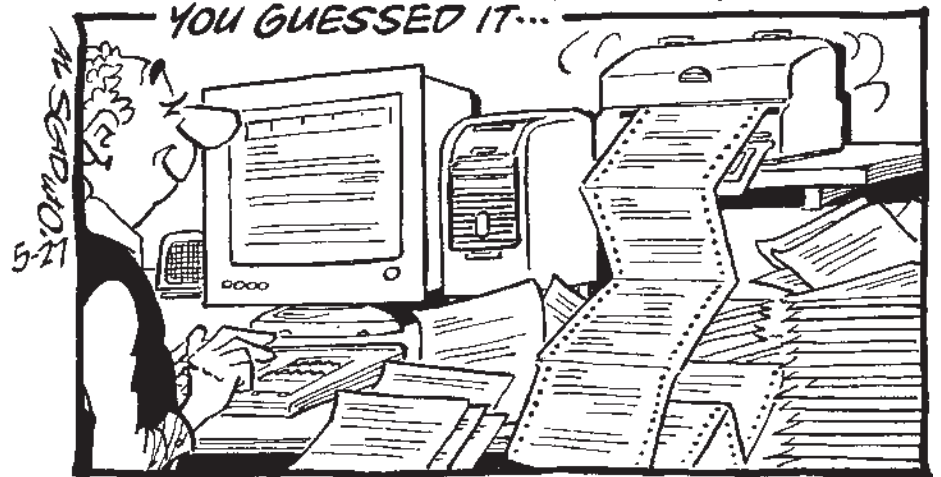

- On June 22, 1611, after spending a winter trapped by ice in present-day Hudson Bay in Canada, the starving crew of the Discovery mutinies against its captain, English navigator Henry Hudson, and sets him, his teenage son, and seven supporters adrift in a small, open boat. Hudson and the others were never seen again.
  - On June 20, 1782, Congress adopts the Great Seal of the United States. The front of the seal depicts a bald eagle clutching an olive branch in its right talon and arrows in its left. The eagle's beak clutches a banner inscribed, E pluribus unum, a Latin phrase meaning "Out of Many One."
  - On June 17, 1885, The Statue of Liberty, a gift of friendship from the people of France to the people of the United States, arrives in New York City in more than 200 packing cases. The last rivet of the disassembled monument was fitted on Oct. 28, 1886.
  - On June 19, 1917, during World War I, Britain's King George V orders the British royal family to dispense with the use of German titles and surnames due to strong anti-German feeling within Britain. He changed the surname of his own family from Saxe-Coburg-Gotha, to Windsor.
  - On June 21, 1947, after an interim of seven years during World War II, the first post-war Mille Miglia ("Thousand Miles") auto race is held in Brescia, Italy with 155 starters. The race on public roads had been delayed two years as Italy's infrastructure had to be rebuilt.

bit about the DNR, our hatcheries and the fish.

"It's a good community event, too," she continued. "We always like to get the community involved whenever we can. It has been a big hit; we get a dozen or so people from the community who don't necessarily have kids in school. A lot of retired folks come to Paradise to live, so it's a good way to introduce them to the park and what we do."

Leo Culbert, a retiree from Hillsdale County, said he heard about the fish planting at the senior center, came to see it, and wound up in the bucket brigade. "I think it's neat," he said. "I'll fish for them. I think it's real nice for the school to come out and help."

Between the salmon release and the bucket brigade, John Prescott, the principal/superintendent of the school, grilled hot dogs and brats for the students and staff.

"This is a fun, highly educational experience," he said. "They get to see the ecosystem. But it's a riot to get them out here to release the trout and then, later on, one of them might catch one."

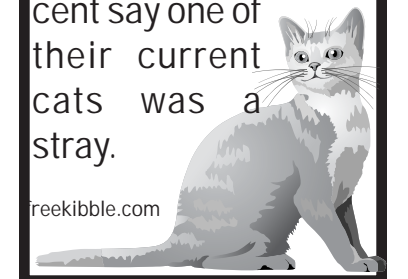
Zachary Ferguson, a ninth-grader who took on a leadership role in the bucket brigade, said he thoroughly enjoys the experience. "I like it," he said. "I know a lot of people catch brown trout out of this river. I'm planning on coming back and fishing for them this summer."
