## Employees offer science and nutrition education

Alcona County residents have access to science and nutrition education thanks to the addition of two new employees with the Michigan State University Extension (MSUE) office in Harrisville.

Tracy D'Augustino and Jessica St. George now work from the Alcona County office. St. George is the new nutrition program associate who took over after Beth Noffze retired and D'Augustino, an MSUE educator, is part of the MSUE science literacy work group.

St. George was born and raised in Tawas and attended Tulane University in Louisiana for two years. Although nutrition wasn't on her radar while attending school, she

was heavily involved with dance and keeping fit which included healthy eating habits. As a nutrition associate, her time will be split between Iosco and Alcona counties.

She became involved in the nutrition program by working as a temporary employee for MSUE in Iosco and Arenac counties. St. George said she is still getting acquainted with the resources available in Alcona County and learning as much as she can about her job and the community.

Her main focus is to improve the knowledge, skills, attitudes and behavior of how individuals view nutrition. She said the MSUE nutrition program is partnered with Supplemental Nutrition As-

## Road commission new building plans still in adjustment process

With winter set to arrive any day, the Alcona County Road Commission is going to spend another snow season without a maintenance/storage building and central base of operations.

The original maintenance building located on Lake Street in Lincoln was destroyed by fire on September 28, 2013. The 17,430 square foot building served as the main base of operations for the department for roughly 80 years. It housed a majority of trucks, equipment and tools.

Since the fire last fall, equipment has been stored outside which caused mechanical difficulties last winter. However, the experience gained last winter has made employees more prepared for this winter and the construction of a new, smaller storage building (pole barn) that was planned roughly three years ago, should help improve response time to get maintenance trucks onto the roads sooner.

Construction began last week and, according to Alcona County Road Commission Manager Jesse Campbell, it will be 7,000 square feet in size. It is located behind the site of the main building and replaces a smaller storage building that was torn down earlier in the year due to an ingress and egress problem with construction of the new main building.

"This is something we planned on doing before the fire because several of the out buildings were crumbling because of age and poor construction. Maintenance cost to repair those buildings exceeded the cost to construct a new one," Campbell said. "We kept them for as long as we could."

Funding for this building will come from an insurance reimbursement of roughly \$150,000. Campbell explained the insurance company agreed to pay for this permanent structure because "they were supposed to supply us with a temporary storage facility (this summer) and there was no place adequate for our needs," Campbell said. "They are giving us the money that would have been used to pay for a temporary structure, and more, so this way we have been taken care of this year.

They are doing everything in their power to make sure we are accommodated this winter."

Campbell said this winter the building - which does not have heat or running water - will house eight (maintenance) trucks and some other equipment. "With these trucks not sitting outside we will be able to respond quicker to icy and snow conditions," he said.

He explained it will be used for cold storage of seasonal equipment and other items that should be stored inside after the new building is completed. "We tore down another storage building five to seven years ago. With this one gone we have actually lost storage space," Campbell said. "We hope to have this basic storage barn done by

December 15 - at least by the end of the year," Campbell said.

Plans for the new 17,550 square foot maintenance building to house all of the maintenance trucks, tools and equipment and office areas for supervisors are still on the drawing board, but getting closer to the construction phase slowly, but steadily, Campbell said.

The latest delay in getting the building plans approved came from the Michigan Department of Health and Michigan Department of Environmental Quality (DEQ) regarding disposal of runoff from the maintenance trucks.

Campbell explained in the winter, when maintenance trucks are applying the "salt"

## Building millage levy on winter tax bill

Construction of the new Alcona County Road Commission garage/facility will be paid for by reimbursement from the insurance company and from a one-time millage approved by residents last summer.

In the August primary Alcona County voters approved a one year millage of .5 mills to help pay for the extra expense in rebuilding the garage/facility that was destroyed by fire last September.

Since plans have yet to be finalized (see related story on page 1), the total cost of the 17,550 square foot maintenance building that will be the base of operations in Lincoln for the road commission, has yet to be determined.

Construction of any kind completed by the road commission - at the site in Lincoln, in the administration office or on the roadways - is not paid for by millage funds.

The millage voters approved is earmarked strictly for the new storage/main building and the funds have not yet been levied on property owners. The levy will come on the winter tax bill in which property owners receive in early December.

According to Alcona

County Treasurer Cheryl Franks, the levy process begins when each governmental entity (township, village or city) sends property owners a tax bill. Property owners pay their taxes to the entity that issued the bill. As tax money is collected, each entity pays the county every two weeks until February 28.

When taxes are sent to the county they are "allocated to the proper line item and the money is put into our bank," Franks said. "(It) stays in our bank until the deadline set by the state."

After the February deadline, Franks explained, the county begins the settlement process where it compares receipts with each entity to determine outstanding payments. This takes roughly six to eight weeks. The county pays all of the tax levies that are outstanding.

"At the end of the settlement process all tax levies are paid in full," Franks said. This means the county pays the total funds levied to each organization that has a millage - library, school, ambulance, road commission, et cetera. "Ideally, we have everyone settled before May 1 which is the completion for determination of what is delinquent," Franks said.

mixture to roadways, ice and snow and a trace amount of the salt mixture collects on the trucks. When they are stored in the heated building, the ice and snow melts and this runoff has to be collected and disposed of according to standards set by the DEQ.

"Initially our plans had this run off going into the leech field of our septic system," Campbell said. "The DEQ wanted 100 percent of it contained in two 10,000 gallon underground storage tanks... We don't have that much room and the cost for disposing of the waste in those tanks was to be \$10,000 to \$18,000 a year.

"They (DEQ) thought this building would store the salt mixture... which it will not.

And, the trace amount of the salt mixture (from the trucks) is so small it isn't even an issue. We had our contamination engineer study the situation. We gave the DEQ his report. Now, we are right back where we were before — only this time the run off will be in a separate leech field near the septic system," he said.

Campbell said this modification is being incorporated into the plans and when the plans are complete and approved by the road commission board, they will be presented to the Alcona County Building Department for review by the building, mechanical and electrical inspectors and to the Michigan Department of Health again for further review.

"Once everything is approved, we can then put it up for bids and advertise it," Campbell said. "My goal is to have it up for bids for spring construction. We are certain there will be no construction this winter because costs are so elevated in the winter and, because we are behind in the process."

**DNR Seeks Dened Bears**

While out in the field, hunters and trappers might come upon a dened black bear. The Michigan Department of Natural Resources (DNR) is looking for those northern Lower Peninsula locations where dened bear are spotted, in order to fit them with radio collars for an ongoing bear research program.

“Information gathered from bears assists in managing the black bear population,” said Mark Boersen, DNR wildlife biologist at the Roscommon Customer Service Center. “Currently, we have three female bears being monitored from both air and ground using radio tracking equipment.”

After locating a dened bear, DNR biologists will determine if the animal is a good candidate for radio-collaring. Bears that are selected will be sedated by a wildlife biologist and fitted with a radio-tracking collar and ear tags. Hair samples will be taken for DNA analysis, and a small, nonfunctional tooth will be collected to determine the bear’s age. Upon completion of the short procedure, biologists will return the bear to its den, where it will sleep through the remainder of the winter months.

People who encounter bear dens are asked to record the location, with a GPS unit, if possible, and contact Dan Moran at (989) 422-6572 or Katie Keen at (231) 775-9727 with the specific location information.

The DNR reminds the public that it is illegal to disturb a bear den or disturb, harm or molest a bear in its den.

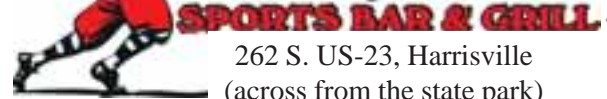

## Northeast Michigan Fishing Report



### Northeast Lower Peninsula October 30

• Rogers City: Fishing has come to a standstill as the weather has made it virtually impossible. A couple of anglers did make it out, but the only thing they caught was a lake trout and that season is closed.

• Alpena: If the weather ever improves, anglers should start catching whitefish around the shoals and islands.

• Thunder Bay River: Anglers are fishing for steelhead, which are starting to show but in very low numbers. Most are floating spawn under a bobber or drifting close to the bottom. Artificial flies that look like an egg pattern were also productive. Anglers are casting fire-tiger body baits and rattle traps. A few perch were caught but most were small.

• Harrisville: Salmon are pretty much done but a light number of steelhead were reported outside the harbor. Those casting outside the wall caught a couple of walleye or steelhead. Walleye seem to be in the area between

Oscoda and the Black River. Anglers were casting or trolling small spoons and body baits. Hot colors were blue, orange, black, silver or fire-tiger.

• AuSable River: Walleye were still coming into the river and catch rates were consistent over the last week. Most are casting blue and silver, fire-tiger or black body baits. Walleye were hitting on spoons intended for salmon and steelhead. Only a few salmon are up in the river and they were in pretty bad shape. Some steelhead were hitting on spawn, flies and spinners between the mouth and the dam. Pier anglers were still fishing with spawn.

• Tawas: Walleye continue to be caught at night off the pier, near the state police post and out of the Tawas River. A few limit catches were taken which is good fishing for pier and shore anglers. Perch fishing off the pier was slow.

• Au Gres: Fishing was slow with almost no boats getting out. Down at Eagle Bay Marina, which is at the end of Sagatoo Road, a fair number of perch were caught inside the marina basin.

## How to improve your balance as you age

Dear Savvy Senior,  
I've always been a walker, but when I fell last month my doctor suggested I start doing some balance exercises. Is this really something I need to practice? What can you tell me?

Avid Walker

Dear Walker,  
Most people don't think much about practicing their balance, but you should, the same way that you walk to strengthen your heart, lungs and overall health, or you stretch to keep your body limber.

As we age, our balance declines - if it isn't practiced - and can cause falls. Every year more than one in three people age 65 years or older fall, and the risk increases with age. A simple fall can cause a serious fracture of the hip, pelvis, spine, arm, hand or ankle, which can lead to hospital stays, disability, loss of independence and even death.

Balance is the ability to distribute your weight in a way

that enables you to hold a steady position or move at will without falling. It's determined by a complex combination of muscle strength, visual inputs, the inner ear and the work of specialized receptors in the nerves of your joints, muscles, ligaments and tendons that orient you in relation to other objects.

It's all sorted out in the sensory cortex of your brain, which takes in the information from those sources to give you balance. But aging dulls our balance senses, and causes most seniors to gradually become less stable on their feet over time.

Poor balance can also lead to a vicious cycle of inactivity. You feel a little unsteady, so you curtail certain activities. If you're inactive, you're not challenging your balance systems or using your muscles. As a result, both balance and strength suffer. Simple acts like strolling through a grocery store or getting up from a chair become trickier. That shakes your confidence, so

you become even less active.

If you have a balance problem that is not tied to illness, medication or some other specific cause, simple exercises can help preserve and improve your balance. Some basic exercises you can do anytime include:

- One-legged stands: Stand on one foot for 30 seconds, or longer, then switch to the other foot. You can do this while brushing your teeth or waiting around somewhere. In the beginning, you might want to have a wall or chair to hold on to.

- Heel rises: While standing, rise up on your toes as far as you can. Then drop back to the starting position and repeat the process 10 to 20 times. You can make this more difficult by holding light hand weights.

- Heel-toe walk: Take 20 steps while looking straight ahead. Think of a field sobriety test.

- Sit-to-stand: Without using your hands, get up from a straight-backed chair and sit

back down 10 to 20 times. This improves balance and leg strength.

For additional balance exercises visit [go4life.nia.nih.gov](http://go4life.nia.nih.gov), a resource created by the National Institute on Aging that offers free booklets and a DVD that provides illustrated examples of many appropriate exercises. You can order your free copies online or by calling (800) 222-2225.

Some other exercises that can help improve your balance and flexibility is through tai chi and yoga. To locate a beginner's class in your area that teaches either of these disciplines, call your local senior center, health club or

wellness center, check your yellow pages or try online directory sites like [american-taichi.net](http://american-taichi.net) and [yogafinder.com](http://yogafinder.com).

If nothing is available near you, there are DVDs and videos that offer tai chi and yoga instructions and routines for seniors that you can do at home. Some good resources for finding them are [amazon.com](http://amazon.com), [collagevideo.com](http://collagevideo.com) and [iefit.com](http://iefit.com), or check with your local public library.

sistance Program (SNAP) through the Michigan Department of Human Services. It will be her job to help bring free nutrition education programs to communities to reduce hunger and food insecurity and promote healthy eating habits.

"I'm providing nutrition education to the people of Alcona and Iosco (counties) of all ages with a focus on the food aspect and also the affordability. We talk about nutrition fact labels and unit prices. How to eat healthy on a budget," St. George said.

Although lately most of her public contact is with elementary school children, St. George plans to also work with teenagers, adults and seniors

She and D'Augustino are just beginning to work on plans to launch science exploration and nutrition education programs which they are hoping to do at the Alcona County Library in Harrisville.

"Lately I've been working closely with the Whittemore-Prescott school system where I meet with students one hour a week for six weeks. We read books and talk about how it applies to their everyday nutrition. I use hands on projects to make the lesson more applicable to life," St. George said. She explained by letting the kid's measure out how much sugar is in a product it gives them a better understanding of what they are consuming.

D'Augustino is working full time as an MSUE educator assigned to science literacy. MSUE has many educators working across Michigan but, according to D'Augustino, only a handful of them are science educators. Although she is based in Alcona County, D'Augustino is the only MSUE educator involved -- 100 percent -- with science literacy in northern Michigan and her service area covers all of northern Michigan and beyond.

A self-proclaimed science geek, she always dreamed of doing this type of work. "It was really exciting to be chosen for this position. I graduated from Alcona High School and my children graduated from there. Home is where the heart is and this is definitely where my family's heart is. To be able to work here and have the opportunity to make a difference in science in Alcona County is pretty special," she said.

D'Augustino explained her position in Alcona County allowed Bonnie Wichtner-Zoia, a MSUE educator previously in Alcona County, to move to West Branch, which is closer to her home in Rose City, Mich. "Bonnie is still doing the same job as an educator for northern Michigan. I'm the new educator for science literacy; I'm not a new Bonnie. We still have Bonnie and she will still serve as an educator like she has before for northern Michigan," D'Augustino said.

D'Augustino has a bachelor's degree in secondary education in biology with

minors in physics and mathematics from Mayville State University in North Dakota. She has a master's degree in biological science interdisciplinary from Michigan State University.

In addition, D'Augustino taught chemistry for 10 years at Alpena Community College and has trained teachers to understand science requirements through the Michigan Department of Education.

D'Augustino said everyone uses the process of science every day but they don't think about how important it is. "I'll be focusing on science education for adults and children, mostly targeting fami-

lies with the purpose of helping parents to support their kids in science education, but anyone is welcome to attend classes. There will be a lot of hands on stuff, building mini catapults, rockets or platforms to suspend bridges. I have all kinds of things we can do," D'Augustino said.

Her enthusiasm for science can be addictive and she hopes to spread her addiction by working closely with MSUE 4-H program coordinators and others who support science programs with students. As part of her position she will be available to work with teachers, youth groups, churches and other organizations interested in

science and stewardship.

To engage kids in science over the summer, she has already begun working on a forestry camp program and is partnering with conservation district forester, Andrew Beebe. She will also be working with Les Thomas, 4-H program coordinator, on statewide and regional summer camps.





### StarWatch By Gary Becker - Taurids Tantalize

My Moravian College astronomy students were recently on a field experience to Shooting Star Farm, east of Hellertown, PA. There were six high-end telescopes on the field supported by friends and members of the Lehigh Valley Amateur Astronomical Society, and about 30 students in small clusters enthusiastically waiting their turns at the various eyepieces to glimpse their real-time views of the universe. At 6:45 p.m. a supply launch to the International Space Station from Wallops Island, VA, visible from PA, was scrubbed, but students were treated to a beautiful and bright five minute flyover of the ISS during twilight. Incidentally, that same supply rocket exploded after liftoff the following evening, October 28. When all was said and done, some very cold but happy students left about 8:50 p.m. Five minutes later, those still present on the field were treated to a beautiful, bright, slow moving and flickering shooting star coming up from the east. It was undoubtedly a member of the Taurid stream. Most meteors observed are faster and fainter, but the Taurids have uniquely brighter and "lazier" characteristics. If you are going to spend a few hours viewing the Taurids, avoid the bright moon. Dress warmly, protecting head, hands, and feet. Once any of these extremities become cold, you are doomed. Observers should view east before midnight, and overhead after that time. The entire month of November is good for Taurids, but these meteors are far and few between, so you may be watching for a half-hour or more before catching your first event. However, seeing a piece of space dust catch frictional heat from Earth's atmosphere, and set a tube of air glowing brightly, which is the meteor phenomenon, can be a mind-blowing experience. I have no problem reliving my most recent Taurid experience or a Taurid that I saw over 40 years ago looking like a distant Roman candle sputtering and sparking to its brilliant death. www.astronomy.org

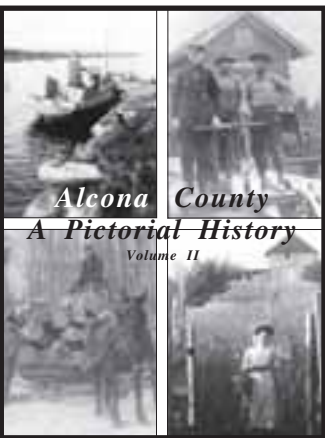

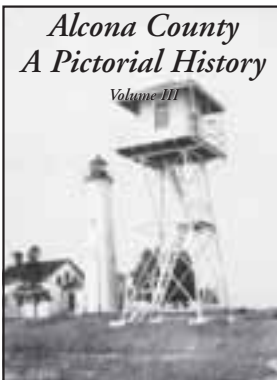
