# Fire destroys Hubbard Lake home

Fire fighters not only had to battle extreme heat in a structure fire last Friday, but also subzero temperatures as well.

According to Hubbard Lake Fire Chief Wes Thiem, fire fighters from Hubbard Lake, Alcona Township, Sanborn Township and Wilson Township responded to a house on fire on Stout Road in Hubbard Lake at 4:30 a.m. on February 13.

The house was full of smoke when we got there," Thiem said. "It was so hot inside we couldn't get in (to fight it)."

He explained one person was in the home, which is owned by Ty Schultz, when

the fire started but smoke alarms alerted him and he was able to get out without incident.

Thiem said weather reports show fire fighters were working in -18 degrees Fahrenheit that morning, which posed its own set of challenges, however the fire was extinguished and the scene was cleared around 9:30 a.m. with no injuries reported. The cause of the fire remains under investigation.

In addition to mutual aid response from surrounding fire departments, Alcona and Alpena EMS personnel were on the scene as well as representatives from the American Red

# Safety improvements set for Bamfield Road

Commission, in cooperation with Curtis Township, and with funding from the High Risk Rural Road (HRRR) program, safety improvements will be made to a portion of Bamfield Road west of Glennie in Curtis Township.

With a projected start date of April 1, weather permitting, about three quarters of a mile of Bamfield Road from AuSable Road west will be reconstructed to meet current design criteria. The work will include crushing the existing asphalt surface, then recycling the material into the road bed to augment reshaping the alignment and curves to better serve modern vehicles and usage.

"The existing lay of the road is basically the same as it has been for decades," said Alcona County Road Commission Managing Director Jesse Campbell. "Simply put, it was designed for slower, fewer, and smaller vehicles, and it is obsolete.'

Campbell explained the crash data showing the number and types of reported vehicle incidents in that section qualified the road for special funding. HRRR funds are a set aside within the federal road funding mechanism specifically to correct these types of safety issues on America's rural road net-

In addition to reshaping

The Alcona County Road the alignment to effectively guide vehicles -- updated signage and installation of guardrail and rumble strips along the road is hoped to raise awareness and alert drivers to the curvy nature of the road.

The work will be done by D. J. McQuestion & Sons, Inc., of LeRoy, Mich. McQuestion was low bidder at a bid letting in December of 2014. The work is expected to be complete by the first part of July. The project cost is approximately \$536,521, with \$118,000 being contributed by Curtis Township, and the remaining costs being covered by the road commission and the HRRR grant funds. Traffic is expected to be maintained during the work, but motorists should expect delays and lane closures, if traveling there at the time of construction.



Unexplained death

## Child pornography arrest

An investigation by the U.S. Department of Homeland Security and officers from the Alcona County Sheriff's Department led to the arrest of a Barton City man for five felony counts involving child pornographic material.

Dale Ruby, 67, was arraigned in 81st District Court on February 11 on three counts of possession of child sexually abusive material, one count of using a computer to commit a crime and one count of felon in possession of a firearm.

According to Alcona County Sheriff Douglas Atchison, Ruby's arrest was the result of an investigation initiated by agents from Homeland Security, who turned the investigation over to officers at the sheriff's department roughly two weeks prior to the arrest. "We went with Homeland Security on the initial search warrant; then our officers compiled the results of the search into an investigation report and presented it to the prosecutor who issued an arrest warrant," Atchison said.

Ruby's bond was set at \$100,000 cash/surety/or 10 percent. He was released on bond. A status conference is scheduled for February 18 in district court and a preliminary examination is set for February 25 at 11 a.m.

# Many brick-and-mortar businesses welcome upcoming online sales tax

Many businesses across northern Michigan could benefit from a new law that subjects online retailers such as Amazon and Overstock.com to the same six percent sales tax that "brick-and-mortar" businesses collect from consumers

The Main Street Fairness Act will affect any online retailer that has a physical presence in the state of Michigan, or has subsidiaries that have a physical presence in the state. The legislation specifically notes businesses that have warehouses and distribution centers in the state, in what is seen as an attempt to target large online retailers such as Amazon.

When the law goes into effect on October 15, it will make Michigan the 23rd state to enact legislation subjecting online retailers to what is more commonly known as the "Amazon tax."

The Senate Fiscal Agency

projects the law will bring in \$50 million in new revenue for the state each year. In May, Michigan residents will vote on a ballot proposal to raise the sales tax from six to seven percent. If the ballot measure is approved, an additional \$8 million in revenue will be raised from the online sales tax.

Under current law, consumers are responsible for reporting any online purchases on their tax returns and paying the six percent sales tax. According to a survey performed by the Minnesota House of Representatives, only 1.6 percent of individuals actually report their online purchases on their tax returns. The Main Street Fairness Act puts the burden on the online retailers, rather than individual consumers, to pay the sales tax.

Rep. Bruce Rendon, R-Lake City, explained that while this may seem like a new tax on businesses, that's not actually the case. "It's

just a reestablishment of the law to make sure that those taxes are collected," Rendon said. "It's not really, in my estimation, a new tax law. The taxes are already supposed to be paid."

Leon Drolet, chairman of the Michigan Taxpayers Alliance and a former state representative, opposes this legislation. In an op-ed for the Detroit Free Press, he argued that while brick-and-mortar businesses are required to collect the sales tax, they benefit more than online retailers from the government services this revenue funds such as police, fire and local roads

Bill Golden, owner of Golden Shoes in Traverse City, Mich. and a board member for the Michigan Retailers Association, said the law will level the playing field between brick-and-mortar and online retailers.

"I had a lady return three pairs of boots," said Golden, whose business does no online sales. "She bought them, then came and returned them the next day. She pulled her phone out and ordered the same thing online at the same exact price because she could save the sales tax."

Requiring online retailers to collect sales tax is especially important for higher-priced items such as jewelry, said Keith Terwilliger, an administrator at Wexford Jewelers in Cadillac, Mich., which does about 20 or 30 percent of its business online.

While online retailers may still be able to offer a better price, this legislation enables traditional businesses to compete better, Terwilliger said. On higher priced items, "six percent can make a huge, huge difference," Terwilliger said. "You could be looking at hundreds of dollars."

Golden Both Terwilliger agreed that the \$50 million in anticipated sales tax revenue for the state is needed. "Sales tax money goes to education and government," Golden said. "Part of that comes back to your local government to run your city. You want roads done, you want police and fire protection. Well, that's how this money is coming back to your town. It's a pretty important thing that people forget."

"If your child had surgery, or has mono (infectious) or is in traction for a broken leg, clearly that student can't be here. In a case where something is going to be prolonged we may even be able to arrange services to make sure that child's education is being taken care of. We don't expect those students to be in school. I'm a mom myself and understand. It's hard to juggle things when you have a sick child," Kurowski said.

Davis emphasized how important it is to keep the lines of communication open so the success liaison can help when necessary. "A student should want to come to school, but sometimes a child may avoid school because of anxiety or other issues. It's our job to try to find out what the underlying problem might be and offer intervention assistance," Davis said.

They explained many things other than illness can keep a child from attending school such as anxiety or frustration over grades, bullying, and things which happen at home may interfere with wanting to go to school.

According to Kurowski, quite often students who are missing class just don't feel a strong connection or have anything fulfilling they do at school. Kurowski said she tries to get those students involved in either an afterschool activity or something during the school day which they can hang on to as a positive part of being at school.

Davis said in some instances he supports incentives, such as a special activity or award for grade school students struggling with attendance issues.

Kurowski and Davis said the policy changes have not come without a few hiccups along the way and they want parents to know they are not out to get them in trouble. They are there to support their child's education success. In some instances, however, it is necessary to remind students and parents that state cash assistance may be withdrawn, or for secondary students, work permits revoked, if a child has too many absences.

Kurowski explained that a student's first job should always be attending school.

"It all comes back to value in education. When a family values education, it's the number one priority for their children. Part of our role is to add value to the kids being in school every day.

"One of the things I talk about with students of Alcona is many of them have two or three years of college waiting for them based on socioeconomics. We talk about goal setting for that and how they are going to accomplish the goals if they don't attend school every day. I develop action plans with the students and the first step is always that they will come to school daily, on time and ready to learn. The bare minimum to anything is just to show up," Kurowski said.

Dan O'Connor, principal of Alcona High School, said Davis and Kurowski were doing amazing work at the school for students and families which need some additional bridging between school and home with personal communication. He said their service is just another step the school district is trying to make an individual approach to each student.

# Do you need to file a tax return in 2015?

Dear Savvy Senior,

What are the IRS income tax filing requirements for retirees this tax season? I didn't have to file last year, but I picked up a little income from a part-time job in 2014, and I'm wondering I need to file this year.

Part-Time Retiree

Dear Retiree,

Whether or not you are required to file a federal income tax return this year will depend on how much you earned (gross income) - and the source of that income - as well as your filing status and

your age. Your gross income includes all the income you receive that is not exempt from tax, not counting your Social Security benefits, unless you are married and filing separately.

Here's a rundown of the IRS filing requirements for this tax season. If your 2014 gross income was below the threshold for your age and filing status, you probably won't have to file. But if it's over, you will.

• Single: \$10,150 (\$11,700 if you're 65 or older by January 1, 2015).

Married filing jointly:

\$20,300 (\$21,500 if you or your spouse is 65 or older; or \$22,700 if you're both over

- Married filing separately: \$3,950 at any age.
- Head of household: \$13,050 (\$14,600 if age 65 or

 Qualifying widow(er) with dependent child: \$16,350 (\$17,550 if age 65 or older).

To get a detailed breakdown on federal filing requirements, along with information on taxable and nontaxable income, call the IRS at (800) 829-3676 and ask them to mail you a free copy of the "Tax Guide for Seniors" (publication 554), or see irs.gov/ pub/irs-pdf/p554.pdf.

There are, however, some other financial situations that will require you to file a tax return, even if your gross income falls below the IRS filing requirement. For example, if you had earnings from self-employment in 2014 of \$400 or more, or if you owe any special taxes to the IRS such as alternative

To figure this out, the IRS offers a tool on their website that asks a series of questions that will help you determine if you're required to file, or if you should file because you're due a refund.

You can access this page at irs.gov/filing - click on "Do you need to file a return?" Or, you can get assistance over the phone by calling the IRS helpline at (800) 829-1040. You can also get face-to-face help at a Taxpayer Assistance Center. See irs.gov/localcontacts or call (800) 829-1040 to locate a center near you.

Even if you're not required to file a federal tax return this year, don't assume that you're also excused from filing state income taxes. The rules for your state might be very different. Check with your state tax agency before concluding that you're entirely in the clear. For links to state and local tax agencies see taxadmin.org-click on "State Agencies/Links" on the menu

If you find that you do need to file a tax return this year, you can get help through the Tax Counseling for the Elderly (or TCE) program. Spon-


The junior varsity team

# Volunteers work to improve

# wildlife habitat in northern Michigan

Volunteers with Michigan United Conservation Clubs (MUCC) and local Michigan Department of Natural Resources (DNR) staff members recently spent a day together giving "hare cuts" on public land in the Grayling Forest Management Unit as part of an effort to improve wildlife habitat.

"Snowshoe hares are a type of rabbit here in the northern areas of Michigan, and a lot of folks have great memories hunting them," said DNR wildlife biologist Brian Piccolo. "Unfortunately, snowshoe hare populations have steadily declined over the past few decades, and research suggests that this decline is due partially to shorter winters and less snow cover due to climate change."

Snowshoe hares differ from the more common eastern cottontail rabbit in several ways – they have longer ears and bigger hind feet than the cottontail, and one other unique trait. "Snowshoe hares have the ultimate adaptation for survival by being able to completely change the color of their fur to adapt to their surroundings," Piccolo said.

He explained that snow-shoes are a brownish-cinnamon color in the summer and will molt, or grow new white fur, in the winter. While many animals molt, most do not change their color so drastically. The white fur gives snowshoe hares great camouflage when snow is on the ground. If there is little or no snow cover during the winter months, having white fur against a brown background can lead to increased detection by predators.

To create prime hiding cover for snowshoe hares and help them stay hidden during not-so-snowy winters, the group hinge-cut conifers within lowland conifer swamps, the preferred habitat of snowshoe hares. Hinge-cutting involves cutting partially through a tree and leaving a portion of the tree still attached to keep the tree alive, and then pushing it over so it's horizontal and lying just above the ground.

According to Piccolo, this horizontal cover not only helps hares escape from predators – such as coyote, fox, bobcat and birds of prey like hawks and owls – but also provides shelter to raise their young, which can lead to an increase in survival rates. In addition to hares, white-tailed deer and ruffed grouse also benefit from low-lying cover and the easy-to-reach browse created by hinge-cutting.

"We had a great volunteer crew," said Drew Younge-Dyke of MUCC. "They drove all the way from the Detroit, Jackson and Lansing areas, as well as local hunters, to give up their Saturday to improve habitat for the game they hunt. Special thanks, too, to Extreme Powersports of Gaylord for lending us a Yamaha ORV for the project."

Around 200 conifers were hinge-cut in Oscoda County's Greenwood Township. A large, mixed-conifer swamp with spruce, fir and cedar on public land was chosen because this area provides ideal cover and is surrounded by aspen trees, which are a preferred food source for hares.

"When we think of doing habitat work in an area, we make sure we are covering multiple needs for that species, specifically making sure food and cover are available. These mixed-conifer swamps with nearby aspen are where most snowshoe hares concentrate and where we can have the biggest positive impact on the species," said Piccolo.

The DNR has identified snowshoe hares as a featured species, an animal that is highly valued but is limited by habitat. Although habitat is just one of a number of different factors that affect survival, the lack of habitat is the primary cause of wildlife declines worldwide, according to Piccolo.

As part of Michigan's recent license restructuring, the need to expand small game hunting opportunities was identified, and the DNR has made an investment to increase habitat work specifically benefiting squirrel,

rabbit and snowshoe hare.

MUCC's YoungeDyke coordinates On the Ground volunteer days all over the state to give hunters and anglers a chance to make a difference outdoors to benefit both fish and wildlife.

# Report All Poaching hotline helps connect conservation officers with public

The sign - Law Enforcement Communications Section - is as nondescript as the standard office door on an unadorned white wall deep within the recesses of Constitution Hall in the state government building complex in Lansing, Mich. But inside that secured door is a nonstop center of activity: The RAP Room.

The RAP (Report All Poaching) Room is staffed 24/7 by as many as seven personnel at a time. It is the main link between the public and the Michigan Department of Natural Resources' (DNR) Law Enforcement Division.

The Report All Poaching hotline was created in 1980 when the state Legislature designated a small percentage of the money raised by hunting and fishing license sales toward developing an easy method for citizens to report illegal hunting and fishing activity to the DNR. It has grown into a 1,000-

square-foot room, outfitted with the kind of high-tech equipment one often finds at county or state regional dispatch centers.

At each of the workstations, six computer screens give dispatchers as much information as they could possibly need to direct the state's conservation officers (CO) to the scene of a complaint – and what the COs need to know once they get there.

Computer screens display information on the current location of COs (through the GPS monitoring equipment on their patrol vehicles), as well as access to the state's Law Enforcement Information Network (LEIN), the state's licensing records, the radio system, the Internet, and even the criminal history of those whom the COs contact.

"Our dispatchers try to gather the best information they can and send it to the officer as quickly as possible," said Lt. Steven Burton, who runs the RAP Room as part of his duties.

Each of the roughly 6,500 criminal complaints that come in by phone call or the Internet into the RAP Room each year is recorded. Some of them are so vague or untimely that nothing can be done to resolve them, but the DNR's success rate in responding to these complaints is considered outstanding. So far, nearly 30 percent of the complaints (5,665 through the beginning of deer sea-

square-foot room, outfitted son) this year have resulted with the kind of high-tech in an arrest.

"Recently, we've made quite a few illegal deer cases," Burton said. "We are well upwards of \$50,000 in reimbursement to the state and many of those cases haven't been completed, as they are still under investigation."

As many as 50 percent of the calls that come into the RAP Room do not involve a criminal complaint, Burton explained. "We get a lot of calls about general rules or policy or people just seeking information," he said. "When people want information they often call the RAP line. We encourage these types of callers to try their local offices first, as this frees up phone lines for ongoing criminal complaints."

"Our dispatchers are required to know all of our laws, rules and regulations hunting and fishing, ORV, marine safety, land use - even environmental laws," Burton said. "Lots of laws." According to Burton, the RAP Room is busiest from October through December, during hunting season, with seasonal bumps during other periods of high outdoors activity - fish migration seasons, holiday weekends, snowmobile season, etc. Calls tend to come in most often during early-morning hours or the first hour or so after dark, he said, though they filter in all day long.

# Lower Peninsula wolf survey underway

From Monday, Feb. 16 through Friday, March 13 the next wolf track survey will be conducted to detect the presence of gray wolves in the northern Lower Peninsula.

"The probability of observing an actual wolf or its tracks in the Lower Peninsula is low," said Michigan Department of Natural Resources (DNR) wildlife biologist Jennifer Kleitch. "It's helpful to have as many eyes as possible looking, so public reports are important for this

She explained wolves began naturally returning to Michigan's Upper Peninsula through Canada and Wisconsin in the early 1990s. Since that time, populations have increased and their range continues to expand. Evidence of range expansion into

the Lower Peninsula came when a gray wolf was accidentally killed in Presque Isle County in 2004.

reason. For Dominique Clemente,

a RAP Room emergency dispatch supervisor and an 18year DNR veteran who has spent 16 years working at the hotline, it is an interesting job. "It's never the same day twice," Clemente said. "The line receives a wide variety of complaints, including an occasional supposed Sasquatch sighting."

Sometimes it takes some coaxing to get the information they need out of callers, Clemente explained. Callers are reminded to stay patient during the call as dispatchers ask very pertinent questions related to the specific crime being reported. "They want us to know about something illegal that's going on but they don't want to be a snitch," she said. "I just remind them the violator is stealing from you and me."

Rewards also are offered by the Report All Poaching program. Information leading to an arrest for a hunting or fishing violation reported through the hotline can net a caller up to \$1,500 or even more depending on the case.

Clemente said the staff's main concern is giving the conservation officers the best information they can to help them do their job effectively and safely, though they do their best to satisfy the customer, too. In many cases, that involves answering broad questions - such as where's a good place to fish or advising some callers that their reported complaints are, in fact, not crimes. "The best we can do is point someone in the right direction," she said.

As with any other office, the RAP Room is constantly changing, taking advantage of new and emerging technology. Right now, Burton explained, the staff is figuring out how best to take com-

# What to do after a data breach compromises your identity

Tens of millions of Americans could be victims of the latest corporate data breach, this one at Anthem Insurance. Unknown hackers apparently stole personal identifying information (PII) from current and former Anthem customers, including names, addresses, Social Security numbers, dates of birth and other information that can be used for identity theft.

Anthem has set up a separate website with information on the breach, but according to the Better Business Bureau (BBB) consumers should always go to a company's main website first and follow links from there. Scammers often take advantage of data breaches and subsequent confusion to set up spoof websites and send phishing e-mails.

The BBB offered the following suggestions for consumers concerned that their PII has been stolen (also available at bbb.org/breach):

- Do not take a "wait and see" approach as you may have done with breaches involving credit card data. You must act quickly. Breaches involving Social Security numbers have the potential to be far more detrimental to victims, and the damage can be difficult to repair.
- Consider taking a preemptive strike by freezing your credit reports. This will

not impact existing credit cards and financial accounts, but will create a roadblock for thieves seeking to create fraudulent accounts using your personal information.

- At a minimum, if you know your Social Security number has been compromised, place a fraud alert on your credit reports. While less effective than a freeze, this will provide an extra layer of protection.
- Take advantage of the free credit monitoring services Anthem will be offering to breach victims. While this is not a preventative measure, this will alert you to new accounts or inquiries using your Social Security number so that you can act quickly to repair the damage
- Vigilance is key. Regularly check your credit reports at annual credit reports at annual credit report. com for unauthorized charges or other signs of fraud. Note: This is the only free credit report option authorized by the Federal Trade Commission (FTC).
- For more information and complete step-by-step guidance on repairing the damage caused by identity theft, visit the FTC's identity theft resources.
- Expect that scammers will take advantage of this data breach to send out phishing e-mails and other messages that appear to be from Anthem, a credit bureau or other legitimate companies. Do not click on links from any e-mail, text or social media messages about this or any other data breach.

For all businesses that collect customer information:

- Make sure you protect your customers' data. If a data breach can happen to a major corporation with significant data security measures in place, it can happen to any business.
- Check out BBB's updated online guide Data Security –



# February brings focus of good oral hygiene for children

Children's Dental Health Month, which brings an increased focus on the importance of regular dental checkups and a balanced diet. The theme of this year's campaign, Defeat Monster Mouth, urges children to defeat Plaqster the Monster by brushing, flossing, rinsing, and eating healthy snacks.

"Children's teeth are meant to last a lifetime, and a healthy

February is National smile is important to a child's self esteem" said Denise Bryan, health officer at District Health Department No. 2. "Good health habits should begin with an introductory visit to the dentist after their first tooth erupts or before your child's first birthday. This will help to make sure your child has a super smile. A balanced diet, limited snacks, daily brushing and flossing and regular check-

ups are the keys to healthy teeth and gums."

Additionally, bottles and pacifiers also impact a child's oral health. Here are some tips from the American Dental Association to keep a young child's mouth healthy:

• Place only formula, milk or breast milk in bottles. Avoid filling the bottle with liquids such as sugar water, juice or soft drinks.

• Infants should finish their

bedtime and naptime bottles before going to bed.

• If a child uses a pacifier, provide one that is cleandon't dip it in sugar or honey, or put it in your mouth before giving it to the child.

 Encourage children to drink from a cup by their first birthday and discourage frequent or prolonged use of sippy cups.

 Serve nutritious snacks and limit sweets to mealtimes.

According to Bryan, older children should follow the same rules of regular brushing, flossing, dental visits and eating a balanced diet, and avoiding surgary beverages like juice and soft drinks. Sugars and starches encourage the production of plaque which can attack tooth enamel. Also, it's not just the sugar in soft drinks that decays teeth; it's the acid too, making this double trouble.





# First bats die off from white nose syndrome this winter

The first reports this winter of bats dying from whitenose syndrome have come in to the Michigan Department of Natural Resources (DNR). Members of the public found dead bats outside the opening of an abandoned copper mine near Mohawk, Mich. in Keweenaw County and reported it to DNR field staff.

White-nose syndrome was first discovered in Michigan in late winter 2014 in Alpena, Dickinson, Keweenaw, Mackinac and Ontonagon counties. Widespread die-offs of hibernating bats are expected in all of these counties, and potentially others, this winter. Experience with whitenose syndrome in northeastern states suggests that most dead bats will be found within 100 yards of the openings to the mines, caves or other places in which they hibernate (called hibernacula), but some bats may travel a mile or more before dying.

Because most of the major bat hibernacula in these counties are in relatively remote areas, most people will probably not see the bat dieoffs. However, in towns like Iron Mountain, Hancock and Norway, where large numbers of bats hibernate in mines within the city limits, area residents may see dead

and dying bats. These bats may be on the ground, or roost on trees, buildings or other structures close to humans and domestic animals.

While there is no connection between white-nose syndrome and rabies, bats can carry rabies, a virus that infects the central nervous system of mammals, including people, and causes death if not properly treated. Rabies is most commonly spread by the bite (or contact with the saliva) of an infected animal. Bats are the animals most commonly found infected with rabies in Michigan, although the disease is relatively rare even in bats.

'We understand the public will be concerned, and we share their concern for the plight of these bats," said DNR wildlife veterinarian Dan O'Brien. "Unfortunately, there is nothing that the public can do to help the bats that are now dying. There is currently no practical way to treat the large number of bats affected by white-nose syndrome.

"For public health reasons, it is very important that people not touch bats with bare hands, and to keep children, pets and livestock away from bats. Pets and livestock

can also be protected by making sure they have a current rabies vaccination," he said.

Bat die-offs this winter should be reported on the DNR website or by calling (517) 336-5030.

According to O'Brien, the DNR will not be collecting and disposing of bat carcasses where die-offs have occurred. The public can safely dispose of dead bats by picking them up with a shovel or heavy gloves and placing them in plastic trash bags for routine garbage disposal.

Rehabilitation of bats is prohibited in Michigan because of the potential for ex-

posure of humans and domestic animals to rabies.

O'Brien explained that long-term, the public can best help bat populations recover from the effects of white-nose syndrome by staying out of mines and caves where bats hibernate (unless proper biosecurity precautions are taken), becoming educated about the critical ecological roles bats play, and supporting bat research and conservation.

## StarWatch By Gary Becker - Riding Light

· There was a T-shirt that was popular several years ago. It showed a drawing of Albert Einstein holding up a stop sign. The shirt's slogan read, "186,000 miles per second. It's the law." That's the speed of light, and it represents the ultimate constant of the universe. Electromagnetic radiation, which includes the light that our eyes see, travels at this enormously fast pace in a vacuum, but is the speed of light really that fast? It all depends upon your perspective. The radio waves that were used to communicate with the Apollo astronauts on the moon took about 2.5 seconds for their round-trip of nearly a half million miles. NASA could easily chat with Neil and Buzz with just a slight bit of hesitation due to the light time lag; however, when we start to consider even the meager distances in our own solar system, the speed of light becomes a real drag. A real-time animation of what it would be like to travel at light speed from the sun to Jupiter has been released by

Alphonse Swinehart and can be viewed at https://www.youtube.com/watch?v=PBwnF4ZGs4s. This video is certainly not great entertainment, but the presentation makes an excellent point of demonstrating just how slow light travel really is, even among the planets. Just in case you're not into watching a mostly black screen with a sun dot in the middle and listening to repetitive spacey music for 45 minutes, here is a recap of the times of the light flybys: Mercury—3 minutes, 13 seconds (3:13), Venus—6:00, Earth—8:20, Mars—12:39; the asteroids Vesta, Ceres, Pallas and Hygiea, 19:39, 22:58, 23:04, and 26:07 respectively; and finally, Jupiter and its four planet-sized moons at 43:16. So why does the video not illustrate all eight planets? That's because it would be 1 hour, 19 minutes, 21 seconds to Saturn (1:19:21), 2:39:50 to Uranus, and 4:10:00 to Neptune. By that time, I truly think the viewer would go nuts. Ad astra (to the stars)! First stop, 4.22 years from now... www.astronomy.org



• On March 3, 1865, President Abraham Lincoln signs a bill creating the Bureau of Refugees, Freedmen and Abandoned Lands. Known as the Freedmen's Bureau, this federal agency oversaw the transition of blacks from slavery to freedom.

• On March 4, 1888, Knute Rockne is born in Voss, Norway. He would go on to become one of the most successful coaches in the history of college football, leading Notre Dame during its golden era in the 1920s. Rockne won three undisputed national championships with the Fighting Irish.

• On March 7, 1938, Janet Guthrie, the first woman to compete in the Indianapolis 500 and Daytona 500 races, is born in Iowa. In 1976, she was the first woman to compete in a NASCAR Winston Cup superspeedway race.

• On March 6, 1945, members of the Dutch resistance attempting to hijack a food truck unwittingly ambush German Lt. Gen. Hanns Rauter, head of the Nazi SS in Holland. In retaliation, the SS put to death 263 Dutch. Rauter later was executed for war crimes.

• On March 2, 1978, in a famous case of body-snatching, two men steal the corpse of film actor Sir Charles Chaplin from a cemetery in Switzerland. After a five-week investigation, police arrested two auto mechanics, who led them to ChaplinÕs body.

• On March 8, 1982, the United States issues a public statement accusing the Soviet Union of using poison gas and chemical weapons against rebel forces in Afghanistan. Evidence to support these charges was largely anecdotal. Some critics charged that the accusations were a smokescreen behind which the United States could go forward in upgrading its own chemical weapons arsenal.
