## Fire destroys residence

Fire fighters from six volunteer departments were called to a structure fire during the early morning hours of Friday, July 3 in Lost Lake Woods Club.

The Alcona Township Fire Department was dispatched to a home on North Chipmunk Trail at 12:22 a.m. where the structure was fully engulfed. The owners, Don and Barbara Proulx, were home when the fire broke out, but did escape without injury.

According to Alcona Township Fire Chief Ralph Klotz, the fire truck stationed in the

club was on the scene within minutes, but the fire had already taken over the structure. Mutual aid was provided by Sanborn Township, Lincoln, South Shore, Mikado and Lincoln DNR fire departments. "We used about 40 gallons of foam and roughly 20,000 gallons of water," Klotz said. "We used the pond at the end of Fox Street to get water."

"Everyone did an excellent job. We just can't thank them enough for their help," Klotz said. "Everyone worked hard to contain the fire... that was our goal - containment - because the house was fully involved. We didn't want the

fire to spread to the woods."

He explained that because of the number of spectators at the fire scene, law enforcement officers from the Alcona County Sheriff's Department and the Michigan Department of Natural Resources were called in for crowd containment. Alcona EMS and The Salvation Army also assisted at the fire scene.

Klotz said the last fire fighter cleared the scene at 4 a.m. No one was injured during the incident. Alcona Township fire investigator Greg Oke said the cause of the fire is still under investigation and that "it appears to be accidental."

## Jewel Lake Campground scene of weapons, drug arrests

Two local men were charged with drug and weapons charges Saturday evening in Barton City.

Law enforcement officers were assisting volunteers with the Barton City Improvement Association with traffic control near the Jewel Lake Campground in Barton City prior to the fireworks display when they stopped a vehicle driven by Alexander Hunter, 21, of Lincoln.

According to Sgt. Scott Stephenson, a loaded .22 cali-

ber pistol was allegedly in the front seat of the vehicle. Stephenson and Justin Repine, a U.S. Forest Service law enforcement officer, searched the vehicle. They allegedly found an undisclosed amount of marijuana and alcohol.

Hunter was charged with carrying a concealed weapon, possession of marijuana, operating while intoxicated and furnishing alcohol to minors. He remains lodged in the Alcona County Jail on a \$50,000, 10 percent cash surety bond.

Matthew Griffith, 20, of Harrisville was a passenger in the vehicle. He was charged with carrying a concealed weapon, resisting/obstructing a police officer, improper transport of medical marijuana and transport of open intoxicants in a motor vehicle. He was released from jail on a \$5,000 personal recognizance bond.

A 14-year-old male was the third passenger in the vehicle. He was cited for alcohol violations and released to

# New high school fishing club sends local students to state championship

There is a wide variety of high school sports available for youth to engage their athletic qualities, but not many which require a boat, fishing rods, reels and lures.

One which does is the Bass Club at Alcona High School. The Bass Club was started by senior Jake Gombos, last April. Although the club is still in its infancy with only six members, Gombos and his teammate Tristan Gordy qualified for and entered the Michigan High School Bass Fishing Championship.

Gombos said another member of the club, Keegan Smith, was also eligible to enter the championship, but was unable to attend because the competition fell on the same weekend as his graduation party. Gombos explained one of the downfalls of high school sport fishing is many of the activities run longer than the school year.

The state championship was held on Lake St. Clair in Detroit, Mich. during the weekend of June 20-21 with 17 teams comprised of high school bass club members throughout the state all vying for first place with the heaviest weight of fish caught.

Gombos and Gordy had never fished in the lake before and although they did pretty well on their first day out, multiple problems including boat issues and a wicked storm which barreled across the lake, put them in 13<sup>th</sup> place.

"My dad (Mike Gombos) had just got a new boat which had not been set up correctly so we tried to stay shallow. We found the bass the day before, but a bad storm during the night pushed the bass out. It was still a great experience. Not bad for our first year at the competition, especially since we didn't know the lake. We'll do better next year and I'm hoping everyone in the club can qualify to go," Gombos said.

He talked about the different lures he used to fish small mouth and large mouth bass depending on water clarity and what color the crawfish are. Gombos said Hubbard Lake is a clear lake, but in murky water, such as Lake St. Clair due to the amount

and size of boat activity, a brighter and "louder" lure -- something that rattles and carries a scent so the fish can see and smell it -- is required. He said the lures he used during the state competition were cappuccino scented.

Gombos explained getting the club together was a lot of work, but it helped him become more organized. "It's not just about catching fish. Our club will be doing some lake clean ups. Keeping the fish population up is a huge concern for any angler. It's important no bass less than 14 inches should ever be kept," he said.

According to Gombos, competition fish are brought in live to be weighed and then released back into the waters; dead fish can still be weighed but there is a penalty. In order to compete in the state competition the six members of the club -- Trevor Scherdor, Luke Loyer, and John Hudgins along with Gombos, Gordy and Smith -- scrambled to host a fishing tournament on Hubbard Lake. Because of strong community support that tournament gave the club enough money to purchase jerseys and paid for some of the three-day hotel room expenses while at the competition in Detroit, Mich.

Gombos said he was always interested in sports and fishing. His mom, Gail, said he was fishing by the time he could walk. The Gombos family lived close to Hubbard Lake and when his sisters, Grace and Haley, would go swimming, he'd go with them to fish.

Gombos played football until a knee injury put him on the sidelines permanently. "I was interested in fishing but it was my football coach at the time, Dave Schnieder, who was a huge bass fisherman which inspired me to focus on bass," Gombos said. He got the idea to start a bass club after watching the high school national championships on television.

Bass Club advisor and teacher, Erich Carlson, said high school bass clubs are relatively new, but are really picking up a lot of momentum and interest. The educational aspect of belonging to the bass club encourages members to develop and use organizational skills, be able to market themselves and the club and hold fund raising events. Carlson explained there are also opportunities for kids to go to national competitions to win boats, cash and even product endorsement opportunities.

"Jake has done a really good job this year getting the club started. We are just a small school and he was crunched on deadlines in order to qualify for the state competition, but he did well, Carlson said. "Fishing is a kind of a lost art among teenagers; most just want to play with their gadgets and gaming. It's really great to see kids get outside on the water fishing and I hope interest continues to grow like it has."

Gombos explained it was through Alcona High School Principal Dan O'Connor and Carlson that the club was able to get the support and help needed to get underway. He hopes more members join next year. Any student interested should have their own fishing equipment and access to a boat and an adult driver for the boat. Members must also pay membership fees to B.A.S.S. Nation and other registration fees.

Gombos' largest bass was caught just a few weeks ago and weighed five pounds, eight ounces and took just 15 minutes to convince the fish to bite. He said the secret to bass fishing is consistency and time. "You have to be dedicated to finding the fish," Gombos said.

## When and how Social Security checks are delivered

Dear Savvy Senior,  
I plan to apply for my Social Security benefits in September. When can I expect my first check? And, is direct deposit my only option for receiving my monthly payment?

Almost Eligible

Dear Almost,

Generally, Social Security retirement benefits (as well as disability and survivor benefits) are paid in the month after the month they are due. So, if you apply for your Social Security benefits in September, you will receive your September benefits in October.

The day of the month you receive your benefit payment, however, will depend on either your birthdate, or the birthdate of the person whose work record you're receiving benefits on.

If you're applying for benefits as a retired worker, your benefit payment day will be determined by your own

birthdate. But if you're applying for spousal or survivors benefits based on your spouse's or (if you were married at least 10 years) ex-spouse's work record, your benefit payment date will be determined by his or her birthdate.

Here's the schedule of when you can expect to receive your monthly check:

- Birthdate is first through 10th of month: Payment day is second Wednesday of each month.

- Birthdate is 11th through 20th of month: Payment day is third Wednesday of each month.

- Birthdate is after the 20th of the month: Payment day is fourth Wednesday of each month.

There are, however, a few exceptions to this schedule. For example, if the day your Social Security check is supposed to be deposited happens to be a holiday, your check will be deposited the previous day. And, if you are

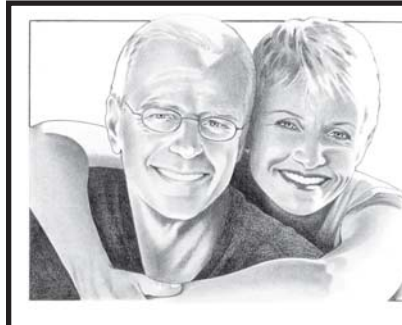
receiving both Social Security benefits and SSI payments, your Social Security check will be deposited on the third day of the month.

You should also know that Social Security beneficiaries who started receiving benefits before 1997, their Social Security checks are paid on the third day of the month.

There are two ways you can receive your Social Security benefits today. Most beneficiaries choose direct deposit into their bank or credit union account because it's simple, safe and secure. But, if you don't like this option or if you don't have a bank account that your payments can be deposited into, you can get a Direct Express Debit MasterCard and have your benefits deposited into your card's account.

This card can then be used to get cash from ATMs, banks

or credit union tellers, pay bills online and over the phone, make purchases at stores or locations that accept Debit MasterCard and get cash back when you make those purchases, and purchase money orders at the U.S. Post Office. The money you spend or withdraw is automatically deducted from your account. And you can check your balance any time by phone, online or at ATMs.

There's also no cost to sign up for the card, no monthly fees and no overdraft charges. There are, however, a few small fees for optional services you need to be aware

of, like multiple ATM withdrawals. Currently, cardholders get one free ATM withdrawal per month, but additional monthly withdrawals cost 85 cents each not including a surcharge if you use a non-network ATM.  Michigan's forests are experiencing ever increasing numbers of insects, disease, and overall decline. The reasons for these issues are many, and often multiple factors are to blame for any given tree health issue.

Protecting the forests longevity is the role of every forester, but anyone with a passion for the outdoors can help protect the forest they love.

The average citizen in Alcona County may not have a four-year forestry degree, they may not be able to define basal area and may even think a French thinning is a weight loss program. However, just because the average citizen isn't a forester by training, doesn't mean that they can't greatly assist local, state and federal foresters in the effort to keep area timberlands healthy.

With so many different forest pests threatening the woods, it is imperative that there are as many trained pairs of eyes as possible searching for signs of these invaders. Forestry professionals are really just beginning to map out invasive species populations and get a grasp on what methods will be most effective at controlling them. There are, however, only so many trained professionals employed by any number of natural resource entities, and the majority of the forested land in Michigan is privately owned.

Because Michigan has so much private land there is a great opportunity for issues like invasive species to go unaddressed, often because the landowner simply doesn't have the expertise to identify an invasive plant.

While it is possible to have

an expert take a look at individual forested properties and evaluate their overall forest health, it would be ideal if individual landowners also had the skills to effectively monitor their properties on a yearly basis. As the old adage goes "weed a man's garden and he eats for a week, teach a man to weed and he eats for a lifetime."

Maybe that's not exactly how that saying goes but the underlying message is the same. Property owners need to take the time to educate themselves and become more aware to the threats that face individual properties.

Identifying plants isn't always easy. Botany is a seemingly endless discipline with a language all to itself. Rest assure, there is help out there for even the most novice among the crowd. The Midwest Invasive Species Network (MISIN) is probably the best place to start if invasive species are a new concept. In truth, MISIN may be helpful even for those who feel quite comfortable with identifying and managing invasive species.

MISIN provides multiple user interfaces that allow users to become more comfortable identifying invasive species as well as allowing them to assist in the fight against invasives in real time.

MISIN contains species information sheets for over 300 invasive plants, animals, insects, and fungi. These information sheets allow users to become familiar with the basics of each species.

MISIN has a tool called training modules that allow users interactively learn the specifics about each species and then test themselves to determine if the information is really sticking with them. Once the user is feeling comfortable with identification, they can then use MISIN to map out real life invasive species populations which will be reviewed by the pros and added to database for later use.

Mapping out invasive species populations is incredibly important work. When natural resource managers have a good idea of where all the problems are then they are able to assist private landowners in stemming the tide of invasive species. At the end of the day, mapping these populations is a way to gather population data for use in the future when money, technology, or innovation allows for more broad management of invasive species.

There are more resources available than a website, however great of a site it may be. The local conservation district or Natural Resource Conservation Service office is always available for species specific information and to

see if it's possible to have a free onsite consultation.

Even better yet, the Alcona Conservation District will be holding several invasive species education workshops over the next few years so watch for upcoming free educational events in this publication.

The fact is, all plants are not created equal. This is a concept that isn't always easily understood by everyone. In this highly mobile and international trade oriented world there are countless opportunities to introduce new species into local forests and other ecosystems. These new species have not adapted over time with our native species and, at times, they are able to vastly outcompete native species because the pressures that keep native plants in check are not yet the same for invasive species.

The forest currently sits at a crossroads. Invasive species have begun to alter the woods, but we haven't lost the battle quite yet. In certain areas invasive plants blanket the understory and prevent new growth while other areas just need a little tending to clean up the weeds. Whether an individual property just needs a little work to keep the situation from getting bad, or it needs a lot of work to establish a state of control, action needs to be taken.

It is likely that today's children will grow up to become adults in a world where ash trees are few and far between and autumn olive still covers fallow fields. It is only possible to move forward and work to ensure that more problems are not created for a forest already in peril. To move forward, landowners need to get serious about invasive species control, monitoring and prevention.

Landowners need to have a management plan of some type to guide individual properties into the future and to mitigate future impacts. Being a steward of the land is a complex task to undertake, but owning land is as much a responsibility as it is a pleasure.

If landowners remain complacent on the issue of invasive species our children's children may find that grandpa's favorite hunting blind is now shrouded in Japanese barberry so thick a mouse can't even move through it.

# Public has opportunity to comment on state forest planning in Alpena, Cheboygan, Montmorency, Presque Isle counties

The Michigan Department of Natural Resources (DNR) will host an open house to talk about proposed forest management plans for 2017 in the Atlanta management unit.

The open house – an opportunity for interested residents to ask questions – is set for Tuesday, Aug. 4 from 2 to 6 p.m. at the DNR Field Office, 13501 M-33 North, Atlanta, Mich.

Each year, DNR personnel evaluate one-tenth of the state forest. The inventory provides decision-making information for foresters and wildlife, fisheries and other resource managers. Staff also assess the age, health, quality and quantity of trees and other vegetation, carefully considering timber management, wildlife and fisheries habitat, minerals, archeological sites, recreational use, wildfire potential, social concerns and other topics.

Because each forest inventory is completed approximately two years in advance (to properly prepare for treatments), a “year of entry” is assigned to indicate when treatments will begin.

“Proposed treatments, which may include timber harvesting, replanting and other management activities, are designed to ensure the sustainability of all forest resources,” said Bill O’Neill, chief of the DNR Forest Resources Division. “We hold these open houses in advance to give folks an opportunity to comment on the science-based decisions we have made for the well-being of our forest resources now and in the future.”

To more easily and efficiently oversee the forest resources, the DNR divides each management unit into smaller units or “compartments.” This year, the compartments under review are in Alpena, Maple Ridge and Wilson townships in Alpena County; Benton Township in Cheboygan County; Albert, Hillman, Montmorency and Vienna townships in Montmorency County; and Allis, Bearinger, Bismark, Moltke, Ocqueoc and Pulawski townships in Presque Isle County.

Maps and information regarding proposed treatments will be available at the open house. The information can also be found at [www.michigan.gov/forestry](http://www.michigan.gov/forestry). Compartment review packets for the 2017 year of entry can be found by selecting the “Find a Forest” button and clicking the “Atlanta” button on the map.

On August 20, the DNR will complete its formal compartment review to decide on final treatment plans for these areas. That review will take place on Thursday, Aug. 20 at 9 a.m. at the Atlanta DNR Field Office.

Those with disabilities who need accommodations for either meeting should contact Cody Stevens at (989) 785-4251, at least five business days before each meeting.

Those unable to attend either meeting are encouraged to submit comments via e-mail to Cody Stevens using

the subject line “Atlanta state forest open house comment.” All comments must be received at least three business days before each meeting.

“Michigan’s state forests truly belong to the people of Michigan,” O’Neill said. “As caretakers of those forests, we genuinely are interested in

hearing – either in person or through e-mail – the public’s ideas about the future use and enjoyment of these vital natural resources.”

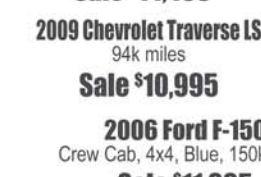

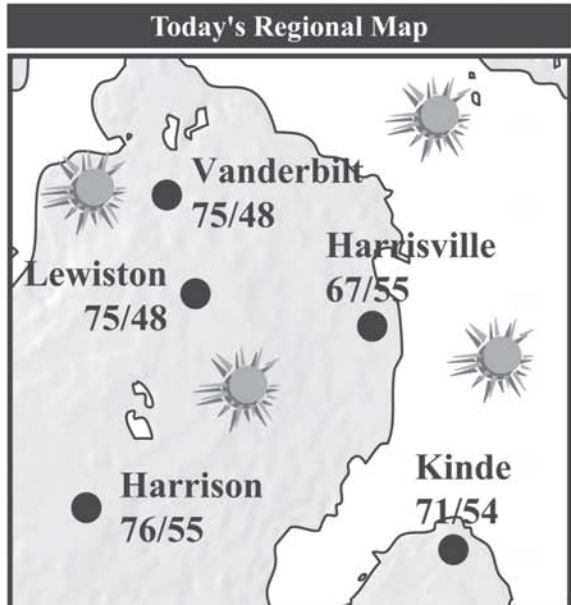

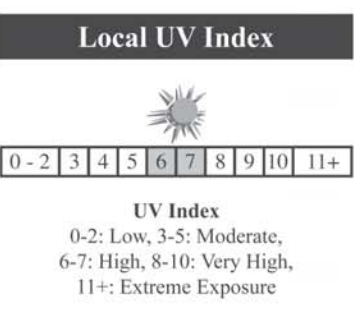

**StarWatch By Gary Becker - New Horizons for Pluto and Clyde**

When New Horizons was launched in 2005, headed towards a July 14, 2015 rendezvous with enigmatic Pluto, the God of the Underworld was still a planet. A year later, Pluto was demoted by the International Astronomical Union when it formally defined that a planet had to be round, orbit the sun, not be a moon of another planet, and clear its own space. Pluto, which is 1470 miles in diameter, was dropped to dwarf planet status because its small size and its mass did not give it enough gravity to clear its orbital path of debris. Still, it was not all bad news for Pluto, which was elevated to the most prestigious of a new grouping of cold, outer solar system objects which danced beyond Neptune, known as Plutoids or more commonly, Trans-Neptunian Objects (TNOs). Four of these, Eris (most massive), Pluto, Makemake, and Haumea are also recognized as dwarf planets, but over 1500 other TNOs have been discovered to date. Evidenced in images being returned as New Horizons approaches Pluto is a varying landscape of blobs and blotches, but it is still too early to decipher specifics. Charon, Pluto's largest of five moons, about 750 miles in diameter, has an unexpectedly dark north pole. Will Pluto have nitrogen geysers like Neptune's largest active moon, Triton, thought to be a captured TNO, or will Pluto's yet unseen craters and topography be worn down by eons of tenuous winds created by the sublimation (ice to gas without a liquid interface) and refreezing of methane, nitrogen, and carbon dioxide gases during Pluto's 248-year orbital period and seasonal cycle. One thing is certain, Clyde Tombaugh, Pluto's discoverer (1930), will have the ride of his afterlife as New Horizons swings past his planet. Stored in this piano-sized spacecraft is a small urn containing some of Clyde's cremated remains. It is a wonderful tribute to the man with unparalleled perseverance who discovered the wanna-be planet that couldn't. [www.astronomy.org](http://www.astronomy.org)

## Large Attendance Fine Program

Fourth celebration was one of the most successful yet held in Harrisville

Harrisville has had many splendid Fourth-of-July celebrations in years gone by, but it is doubtful if there ever was a time when the weather man was more gracious, the crowd larger or better natured or when a better program provided than was the case this year.

It was the aim of the committee to provide a program with something for everybody, from the youngsters to the adults and they certainly are to be congratulated on the success of their efforts.

The program was carried out in full as advertised with the exception of the motorcycle race which through no fault of the committee, failed to materialize. Riders from Alpena had promised to come, but for some unknown cause could not get here. No accidents or other unpleasant incidents marred the pleasure of the day.

The day opened at 5:30 a.m. when the salute committee touched off sixteen sticks of dynamite and fairly

jarred the people out of bed. Several other explosions were given for good measure and when the noise was over everybody was thoroughly convinced that the glorious Fourth had really and truly arrived.

The parade started promptly in charge of Marshal J. E. Yockey and his aids and led by the band. Next came a string of decorated autos headed by Mayor Miler, president of the day, the Calithumpians, fire engines, hose cart, floats, wagons carriages, etc.

The calithumpians were headed by Lloyd Carriveau in a wonderfully constructed auto labelled "Cadillac 1916."

It was a one-horse power machine and all that was visible of the power was the legs. It was certainly some machine and was justly awarded first prize. Second prize was won by Johnson Ritchie and David Oliver, who as Samantha Ann and her "eugenic baby" were very funny. Leslie Spalding cap-

tured the third prize he being cleverly made up as a clown on a bicycle.

There were some very good floats, among them a decorated wagon occupied by ladies of the Civic Improvement League. They wore white uniforms and made a nice appearance.

The line of march was once around the main square and return to starting point. An hour was taken up with games and sports, mostly for the children, on the court house grounds.

The prize winners in these contests were:

Foot race for boys under 16, Russel Potts 1st, Randolph Pyne 2nd. - Under 12, Gene Hayden, Willie McGregor 2nd.

Foot race for girls (under 12) Geneya Swales 1st, Arlene Downer 2nd.

Boys' peanut contest won by Donald Curley.

Girls' peanut contest won by Florence McClatchey.

The hundred yard dash was won by Hugh Beede 1st,

and John Haley 2nd and Harrisville township pulled Haynes across the line in the tug-of-war.

The last thing on the morning program was the exhibition of log rolling given by three Indians, former AuSable rivermen. They were clever and amused the crowd for an hour. Joe Moran gave variety to this feature by diving into the pond and attempting to roll the Indians in. All the performers were very damp when the stunt was over.

Tables and benches were scattered on the court house green and many made use of them during the noon hour.

At the fair grounds in the afternoon Alpena and Harrisville played a stiff game of ball that pleased the crowd immensely.

Following the ball game two horse races were put on, a trotting and a running race. This held the crowd until just the right time to permit many of those from out of town to go home, do the chores and

return for the fireworks and dance.

The trotting race was won by Alex McRae's horse driven by R. Hastings, Dan Byce took second and Fred Byce third money.

Lyle Fowler won first money in the running race, Geo. Haley rode W. H. Robinson's horse for second place and Horatio Pyne on Joe Miller's horse took third.

A big crowd assembled at the foot of Church Street to witness the fireworks.

A preliminary to this was climbing the greased pole, which was accomplished after many trials furnishing much amusement to the crowd, by Hughie Anderson. By this time it was dark enough and the fireworks were sent up. It was a very pretty sixty minutes display and was viewed by hundreds of people.

Dancing at Agricultural Hall brought a successful day to a pleasant close.

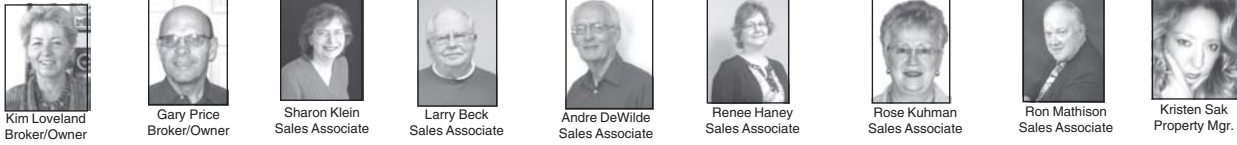
