The discovery and subsequent confiscation of debris from a "one pot" metham-phetamine production found in Curtis Township recently has law enforcement officials encouraging caution on the part of residents and visitors alike when it comes to cleaning up trash.

This incident, which is under investigation by the Alcona County Sheriff's Department, began as a suspicious litter complaint on Aug. 12. According to the Alcona County Sheriff's Department, a citizen found a plastic bag "with what appeared to be batteries cut in half and an empty box of Sudafedrine on the side of the road." Deputy Leonard Franklin identified the batteries as being lithium

tive sergeant and detective lieutenant from the Michigan State Police. All of those detectives have been specifically trained in narcotics and special investigations, undercover operations, surveillance and meth lab response."

"The HUNT guys are specialized in this - we aren't," Stephenson said. "They get the special training (for handling the potentially dangerous material) we get minimal training... It's like going to your family doctor versus going to a specialist when you have cancer. We can do the evaluation and say there is meth (production) but we don't have the skills to clean it up and conduct a longer, in depth investigation. "We handle the possession cases - it's the investigation into criminal enterprise and dis-

and, coupled with the empty box of Sudafederine, determined the items were evidence of methamphetamine production.

According to Alcona County Sheriff Sgt. Scott Stephenson, the citizens who found this debris recognized it as a potential hazard and evidence of a crime. They did the best thing possible - they called the sheriff's department. "Anyone who finds these kinds of things - they need to call us. It can be dangerous from an explosion to being caustic to skin. We can come out and evaluate the situation. If we can take care of it, we will. But, if we can't we will call in the Huron Undercover Narcotics Team (HUNT) to do it," Stephenson said. "HUNT is a multi-jurisdictional task force dedicated to the reduction of narcotics and narcotics related crimes, as well as providing general detective support to other law enforcement agencies," said Lt. Stuart Sharp, team commander. "HUNT provides these services primarily to the counties of Alpena, Alcona, Montmorency and Presque Isle. The team is comprised of undercover officers/ detectives from local police agencies as well as a detectribution cases that we need help with."

The type of debris found in Curtis Township is indicative of a trend in methamphetamine production that is going from large labs to one pot methods. According to Stephenson, this kind of meth production tends to create debris that is easily discarded on roadsides and remote areas - which are where the public needs to be aware of potentially dangerous situations if they encounter (see photos for examples). He explained that two liter plastic bottles, plastic tubing, coffee filters, lithium batteries. fertilizer and Sudafedrine (a chemical found in allergy medication) are household items and can be used to manufacture methamphetamine. "These are used by the average smalltime meth user who produces himself," and uses Stephenson said. According to an April 1, 2015 report from the Michigan State Police to the Michigan Legislature, "a continuing trend in methamphetamine manufacture in Michigan is the use of the 'one-pot' cooking method, in which ammonia is extracted from

Artesian flow cause of damage to Bamfield Road bridge approach

Residents and visitors who travel Bamfield Road in Curtis Township have had a frustrating summer due to a problem at the bridge which necessitated the road being

"The road commission worry was that it was creating a cavity under the road and our fear was that it would collapse - it was a really potentially dangerous situation. So, we closed the road." Traffic was diverted approximately 16 miles in a detour along Brody Road and a U.S. Forest Service trail. "We opened the road two weeks ago to traffic without weight restrictions. Consumers is investigating and monitoring the situation several times a day. So are we. It's hard for us; we want to repair it, but we don't know enough

closed for several weeks.

"It's open – for now," said Jesse Campbell, managing director of the Alcona County Road Commission. He explained the west end approach to the bridge (which crosses the AuSable River) began to slowly sink and cause a recession in the road right around the first part of July. A slight recession at that location didn't cause concern - until it dropped 10-12 inches in several days.

That's when the engineering department of Consumers Energy, owner and operator of the Alcona Dam, got in touch with Campbell and explained there was an "artesian flow" that was being monitored and it appeared to be coming from under the road way.

According to Encyclopedia

the water rises, pushes up the overlying material, which explained the heavy distribution of sediment that Consumers engineers were seeing in the AuSable River.

Consumers had been monitoring the situation for three or four months and around the first of July they noticed a lot of sediment was being extinguished into the river bottom," Campbell said. "The sediment was measuring at 15 yards a day on some days. That is significant... "Their biggest worry was the dam and reservoir... the question is where is it coming from and how will it affect the dam and reservoir?" Because of the location, we weren't allowed to do any boring (to determine how it was affecting the road and bridge). After three attempts Con-



Help prevent the spread of oak wilt; don't move firewood

Now that the season has shifted to August – well past the "no pruning of oak" time of year (April 15 to July 15) – there still are steps residents can take to minimize the spread of the deadly oak wilt disease.

Notably, Michigan Department of Natural Resources forest health experts say not moving firewood is critical to limiting oak wilt. Wood from oak wilt-killed trees can produce spores, which can infect healthy oaks if they're wounded in spring the following year.

According to Bob Heyd, DNR forest health specialist, oak wilt is a serious disease of oak trees. It mainly affects red oaks, including northern red oak, black oak and pin oak. Red oaks often die within a few weeks after becoming infected. Because white oaks are more resistant, the disease progresses more slowly.

"The spread of oak wilt occurs overland to new areas from April through July as beetles move spores from trees killed this year by oak wilt to wounds on healthy oaks next year," Heyd said.

"We need to stop that cycle, and that's why it's important for people not to move firewood for the rest of the summer and fall seasons," he said. "With the transport of firewood and other tree-related activities, you have to assume the risk is present, whether you live in metro Detroit or in the Upper Peninsula."

Oak wilt has been detected in Dickinson, Iron and Menominee counties in the Upper Peninsula and in Alcona, Allegan, Alpena, Antrim, Barry, Benzie, Berrien, Calhoun, Cass, Cheboygan, Clinton, Crawford, Genesee, Gladwin, Grand Traverse, Kalamazoo, Kalkaska, Kent, Lake, Leelanau, Lenawee, Livingston, Macomb, Manistee, Mason, Midland, Missaukee, Monroe, Montcalm, Montmorency, Muskegon,

Newaygo, Oceana, Oakland, Ogemaw, Oscoda, Ottawa, Roscommon, Saginaw, Shiawassee, St. Joseph, Van Buren, Washtenaw, Wayne and Wexford counties in the Lower Peninsula.

Although oak wilt hasn't been confirmed in each of Michigan's 83 counties, the need for vigilance is present statewide.

Once an oak is infected, the fungus moves to neighboring red oaks through root grafts. Oaks within approximately 100 feet of each other – depending on the size of the trees – have connected or grafted root systems. Left untreated, oak wilt will continue to move from tree to tree, progressively killing more red oak over an increasingly larger area.

"There are other oak problems that can easily be confused with oak wilt," Heyd said. "Unlike most other problems, oak wilt causes the tree to suddenly drop its leaves in July or August. In fact, an oak wilt-infected tree dropping its leaves can happen all the way up to fall."

Heyd advises residents who suspect their trees have oak wilt to first confirm their suspicion. "Once confirmed," he said, "you'll be given infor-

Trees that have died from oak wilt should be properly treated to prevent development of spore mats. These treatments include debarking, chipping or splitting, and drying the wood. How to track down things you routinely misplace

Dear Savvy Senior,

Can you recommend any products or devices to help seniors track down lost or misplaced items, like car keys, wallet, cell phone, et cetera? My husband has become forgetful in his old age, so we spend a lot of wasted time looking for things.

Frustrated Spouse

Dear Frustrated,

There are actually a wide variety of tracking devices that can help you and your husband find items that are commonly misplaced or lost. Here are some top options to consider depending on how tech savvy you are.

If you or your husband uses a smartphone or tablet, you can easily track down lost or misplaced items like keys, a purse, wallet, remote control, smartphone, tablet or laptop with a Bluetooth tracker like TrackR (thetrackr.com, \$25 or \$30 per tag) or Tile (the-tileapp.com, \$25 per tag). Both of these products pair with an Apple or Android smartphone or tablet app, which will help you locate the missing item.

All you do is attach a small TrackerR or Tile tag to the items you want to keep track of with an adhesive sticker, a key ring or you can just slip it inside the item.

Then, when a tagged item goes missing, you simply access the app on your smartphone or tablet to see how far away you are from the item or last known location on the map. If you're within 100 feet, you can make the tracking device ring so you can follow the sound.

Or, if you or your husband loses your phone or tablet, both TrackR and Tile work in reverse, allowing you to press a button on the device to make your phone or tablet ring (even if it's on silent) as long as it's nearby. And to help you avoid leaving items behind, TrackR can be set to sound an alarm when there's too much distance between your phone and device.

If, however, you or your husband don't have a smartphone or tablet, there are radio frequency devices like Click 'N Dig (clickndig.com) that can help you find lost/ misplaced items.

This device comes with one finder fob/remote and four or six tags for \$26 or \$39 respectively. Attach a tag to the items you want to keep track of with adhesive or a key ring. Each tag is color-coded and corresponds to a colored button on the finder.

When an item goes missing, you simply press the colored button on the finder fob and the tag will flash and beep. The signal will go through walls and cushions, but you'll need to be within at least 60 feet of your lost item. Make sure you keep



the finder fob in a safe spot, because if you misplace it, you won't be able to find the tagged items.

Another good option, and one that doesn't require a finder fob, is Find One Find All or FOFA (findonefindall.com). This device can manage up to six items. It comes in a key-fob finder and/or a flat, credit card sized finder for your wallet, remote, phone, tablet, et cetera.

These finders can be attached to items you wish to keep track of, and because each finder is also a transmitter, as long as you can find one FOFA tagged item, you can locate the rest.

FOFA finders sound an alarm when signaled so you can follow the sound to locate the missing item, but the range for this device is only 30 feet. Cost: \$25 for two finders.

StarWatch By Gary Becker - Venus and Jupiter in Close Encounter

🗶 When I was in my late teens and in college, I remember observing meteors on an especially dark night. My friend, Mark Adams, who became a professional astronomer, was intrigued with splitting Epsilon Lyrae, a double star with just his unaided eye. Their separation was 3 minutes, 29 seconds (209 seconds) of arc, difficult but not impossible. There are 360 degrees in a circle. Each degree can be broken apart into 60 minutes of arc, and each minute divided into 60 seconds, creating 1.296 million seconds of arc in a circle. Lyra the Harp was close to the zenith when we started observing, and within a few minutes, Mark spilt them. With less acute vision and glasses, I struggled. Every hour or so, I'd return to Epsilon to retry the experiment. Somewhere around 3 a.m., I either did it or hallucinated. I repeated the observation several more times to my enjoyment, but never again was I able to split those two stars. My best guess now is that the time of night was simply taking a toll on my rational brain. On Saturday, August 27, just after sundown this experiment can be repeated, with the third and fourth brightest objects in the sky, Venus and Jupiter. They will be just a little farther apart, under 6 minutes of arc in separation 30 minutes after sunset. Unfortunately, they will be only 4.5 degrees above the western horizon by that time, and binoculars will probably be necessary to separate them. If you want to try it, I'd start scanning the west about 15 minutes after sundown. My best guess is that Venus and Jupiter will be easy to spot with binoculars, but not yet visible to the unaided eye. Practice all this week as the two planets march closer together. On Sunday, August 21, Venus (brighter) and Jupiter are 6 degrees apart and a little higher in the sky 30 minutes after sunset. Mercury is below and to the left. By Thursday this distance has narrowed to 2 degrees, and less than 1 degree by Friday. On Saturday when they are closest, all of Jove's four bright moons will be visible on the Venus side of Jupiter. Much success! www.astronomy.org

Terrorists from Black September had stormed the Israeli quarters in the Olympic Village in Munich early the previous morning.

• On Sept. 8, 1986, Nissan's first European manufacturing plant opens in Sunderland, Britain, an area hit hard by plant closings. Some 25,000 people applied for the first 450 jobs advertised.

either ammonium sulfate or ammonium nitrate during the manufacturing process. The ease of manufacture has replaced the prevalence of other production methods and is responsible for the apparent decrease in other types of lab seizures. The one-pot method poses additional dangers due to the increased possibility of explosion or fire from volatile precursor materials combined in one container.

"Most methamphetamine laboratories in Michigan are considered 'personal-use' labs, based on the limited production capacity of the labs and the method of manufacture. Subjects involved with such labs produce methamphetamine for their own consumption or for limited distribution among close associates.

"Some methamphetamine is smuggled into the state for sale from large-scale methamphetamine distribution operations in the western United States and Mexico. This methamphetamine is a highly pure form known as 'crystal methamphetamine' or 'ice.' Crystal methamphetamine is considered more pure and has a higher potency than methamphetamine produced in small methamphetamine operations."

The report also included statistics in the growing use of methamphetamine. "In calendar year 2014, there were 494 methamphetamine laboratories seized, an increase of 143 labs when compared to 2013. Methamphetamine-related complaints, including laboratories, dump sites, and glassware seizures, totaled 553 in 2012, 641 in 2013, and 861 in 2014. This is a 34 percent increase over 2013 and easily surpassed Michigan's previous record of 760 in 2010. The most common method used in 2014 was the "one-pot' method of manufacture.

Anyone who finds suspicious debris in Alcona County that may be related to meth production should leave it alone and call the Alcona County Sheriff's Department at (989) 724-6384.
