Charges pending in multiple property damage complaints

December was not a good month for mailboxes in several areas of the county or school bus tires; the rest of the winter may not be good for three teenagers who may be charged.

According to Sgt. Scott Stephenson, during December 2015, 27 complaints were made to the Alcona County Sheriff's Department regarding the malicious destruction of property to 30 mailboxes and 10 tires on school buses parked at the bus garage during the school's holiday break.

He explained the damaged mailboxes - which appeared to be damaged with a baseball bat - were located in the Lincoln, Black River and north Harrisville areas and spread over the course of several weeks.

Damage to four tires on two buses was reported on December 28. However, damage to six tires on two other buses was found once employees returned to work after the break.

The total amount of damage for all of the mailboxes has yet to be determined, according to Stephenson, but

the damage to the school bus tires came to approximately \$3,600. Additionally, a break in to a garage on Coville Road in Harrisville Township where two snowmobiles were taken, has been added to the list of "charges" three teenage males will face in Alcona County Juvenile Court.

Stephenson said the investigation into the property damage complaints was conducted by Deputy Nate Leeseberg, and the investigation showed that one of the teenagers was allegedly present during all of the incidents and two were allegedly involved in some of the incidents.

The investigation has been concluded and, as of press time, is in the hands of the county prosecutor who will determine applicable charges for two 16-year-olds and one 15-year-old.

Stephenson explained individuals aged 16 and under, who are charged with a crime, appear in juvenile court where a petition is issued (instead of a warrant which is issued for adults) authorizing charges. The process will then proceed through juvenile court similar to when adults go through the court system.

State police to hold presentations on human trafficking across region

Human trafficking is an issue people often associate with other countries; however, within the United States, including Michigan, men, women, and children are forced into prostitution, domestic servitude, and other labor for little or no pay.

Human trafficking is a modern-day form of slavery, and it is the second-largest and fastest-growing criminal industry in the world.

According to the U.S. Department of Homeland Security, human trafficking involves the use of force, fraud, or coercion to obtain some type of labor or commercial sex act. Children are especially at risk, as 40 percent of human trafficking cases involve the sexual exploitation of a child.

In an effort to raise awareness and combat this emerging crime, the Michigan State Police is stepping up its enforcement and awareness efforts. Presentations will be made throughout northern Michigan during the month of January.

Hepatitis C; a silent killer

A Hubbard Lake man is celebrating 60 years of life and feeling pretty good, despite fighting a serious disease that bewildered doctors and remained undiagnosed for decades.

Greg Indish started having symptoms of Hepatitis C nearly 30 years ago. Despite almost dying and having to go through a full liver transplant and a drug trial, Indish is considered clear and cured of the disease and living on what he calls "bonus time."

Hepatitis C, known as HCV or Hep C, is a viral disease transmitted when the blood of an infected person passes into the blood of an uninfected person. It is a slow progressing, silent disease with symptoms that do not appear for years -- if at all. It is serious; Hep C is the number one cause of liver cancer and liver transplants.

Indish moved to the Hubbard Lake area in the 1970s to run a grinding shop with his dad. It was during this time when he noticed his energy dropping. The former softball player and coach said he looked healthy and strong, but his energy levels would plummet.

He went to doctors and they found nothing wrong with him, but Indish got sicker and sicker. The disease was taking a toll on his liver; he developed ascites which also went undetected by doctors.

Ascites is the excess build up of fluid, typically in the abdomen, causing the stomach and abdominal area to take on a swollen, balloon-like appearance. It is normally a complication of advanced cirrhosis of the liver.

In Indish's case, the swelling was under his diaphragm below his lungs. He was literally drowning in fluids

which doctors couldn't see.

Indish's nails, a condition when the normal pinkish color of the nail plates turns mostly opaque white is also a symptom of liver failure, but again, Indish's symptoms were different. His fingertips became larger. He developed clubbed fingers and his nail beds became distorted. Clubbed fingers is often a symptom of heart and lungs disease caused by low blood levels of oxygen. This was most likely due to the ascites below his lungs. This was also overlooked by doctors.

As he got sicker his work took a toll, "Most people's lungs can tolerate working in a metal shop, but mine couldn't. I'd work for one day and be sick for two," Indish said.

"I got depressed. My wife left and took the kids. I couldn't work anymore and had to sell the business. The depression just set in worse.

I'd sleep more and more. I had diarrhea and no energy. My house was a mess. Things were piling up and I didn't know why. People thought I was lazy," Indish said.

Doctors were baffled. His blood work, according to doctors, did not indicate Hep C. Eventually, Indish got so sick and depressed he didn't care if he lived or died. That was when a family member and friend intervened.

He was going in and out of consciousness when his sister and a friend took him to Traverse City, Mich. because the doctors in Alpena didn't seem to have answers for his illness. "I was almost in comatose state, I recall very little, but I did hear a doctor say he wasn't sure if he would be able to keep me alive through the night. That was when I started fighting back," Indish said.

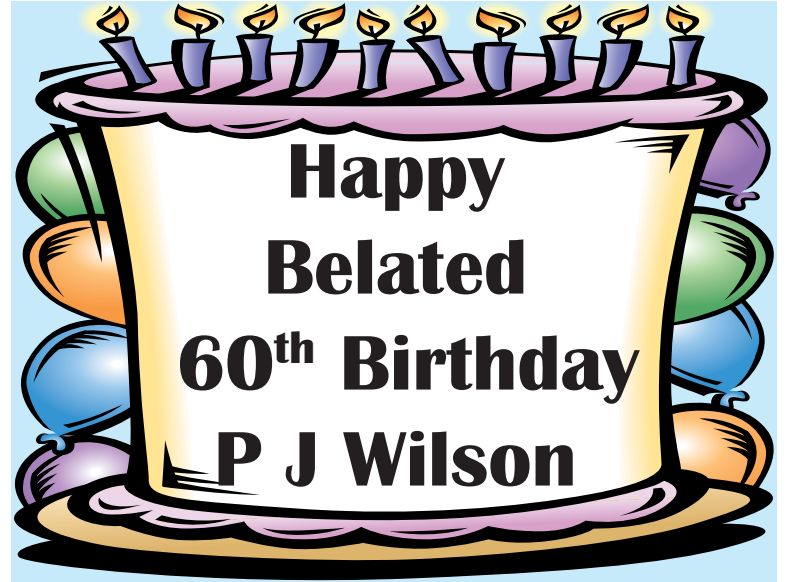

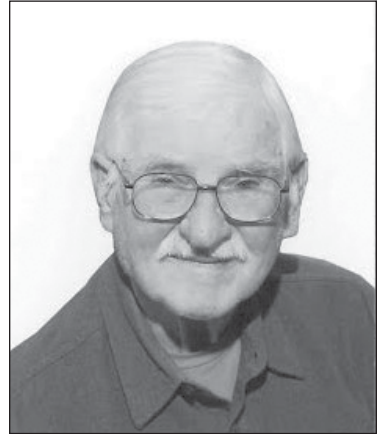

- Someone who shows signs of physical and/or sexual abuse, physical restraint, confinement, or torture.

- High security measures present in the work and/or living locations -- boarded up windows, barbed wire, and security cameras.

How to keep tabs on an elderly parent with video monitoring

Dear Savvy Senior,
Can you recommend some good home video monitoring devices that can help my sister and me keep an eye on our elderly mother? Over the holidays, we noticed that her health has slipped a bit, and would like to keep a closer eye on her.

Worried Daughters

Dear Worried,

There are lot's of great video monitoring cameras that can help families keep a watchful eye on an elderly parent from afar, but make sure it's okay with your mom first. Many seniors find this type of "I'm watching you" technology to be an invasion of privacy, while others don't mind and even welcome the idea.

With that said, here are some top monitoring devices for keeping tabs on your mom.

As the technology has improved and the costs have

come down, video monitoring/surveillance cameras have become very popular for keeping an eye on your home, business, child or pet (via smartphone, tablet or computer), but they also work well for monitoring an elder loved one who lives alone.

Most home video monitoring cameras today are sleek, small and easy to set up, but do require home Wi-Fi.

Although camera capabilities will vary, the best devices all provide wide-view angles, HD quality video, night vision, built-in motion and sound detection that can notify you when something is happening, and two-way audio that let's you talk and listen.

And, they also offer a video recording option (for an extra fee) that saves past video to a cloud, so you can rewind and review what you missed.

One of the best products available today that does all this and more is the Nest

Cam (nest.com), which costs \$199, but if you want their video recording option, it's an extra \$100 per year for a 10-day video history, or \$300/year for 30 days.

Also check out the Piper NV (getpiper.com), which – at \$279 – is more expensive than the Nest Cam but allows free Internet cloud storage. And the SimpliCam (simpliCam.com), which is the cheapest of the three but the video quality isn't quite as good. They charge \$150 for the camera, or \$200 for the camera plus 24-hour video storage for one year.

If your mom is uncomfortable with video monitoring, and doesn't want you to be able to peek in on her whenever you want, another less invasive option to consider is a "sensor" monitoring system.

These systems use small wireless sensors (not cameras) placed in key areas of your mom's home that can

detect changes in her activity patterns, and will notify you via text message, e-mail or phone call if something out of the ordinary is happening.

A great company that offers this technology is Silver Mother (sen.se/silvermother), which provides small sensors that attach to commonly used household objects like her pillbox, refrigerator door, TV remote, front door, etc.

So, for example, if your mom didn't pick up her pillbox to get her medicine or

didn't open the refrigerator door to make breakfast like she usually does, or if she left the house at a peculiar time you would be notified and could check on her. You can also check up on her anytime you want online or through their mobile app. Silver Mother costs \$299 for four sensors, with no ongoing monthly service fees.

Alcona boys top Rogers City, Fairview

The new year started the same way the old one ended for the Alcona boys varsity basketball team -- with a loss to Tawas.

This time the Tigers hosted the Braves, suffering a 54-29 non-conference setback on Tuesday, Jan. 5.

"I just thought we didn't give our best effort and we didn't rebound from our first game against them very well at all," head coach Toby Suttle said. "It was a tough night for everybody, but definitely a learning experience."

The two teams opened with a low-scoring first quarter. Tawas scored the first basket of the game to take a 2-0 lead. Tim Hutchinson hit a three-pointer to give the Tigers a 3-2 lead, though that was Alcona's only points in the first quarter; Tawas led 4-3 at the buzzer.

Hutchinson hit two more threes in the second quarter to take the Tigers to a 12-8 edge. The Braves scored seven straight points to pull ahead 15-12, though a Hunter Sullivan three-ball tied things up at 15-all moments later.

Tawas got the final basket of the half to take a slim 17-15 lead into the break.

"I don't like to use that (long holiday layoff) as an excuse, we just didn't know how to focus on our process I think. What we did in practice didn't translate into the game. After this game we re-

ally have to look in the mirror," Suttle said.

Tawas guard Cougar Wallace erupted for five threes in the third quarter, while the Tigers could only get field goals from Nate Swinson and Devon Mills. Three more points on free throws, and the Braves took a daunting 38-22 lead into the fourth.

Wallace hit another three in the fourth quarter but cooled down after that. The Tigers never quite got back into the game. Highlights in the fourth quarter for Alcona included a three by Swinson and two point buckets from Sullivan and Mills.

"We did some things to try and slow him (Wallace) down but the kid just got hot and that was the difference in the game," Suttle said. "Despite the adjustments we made, he continued to knock them down."

Hutchinson hit three shots from behind the long line and finished with a team high 11 points. Swinson had nine points and two three-balls; Sullivan had five points; and Mills netted four.

On Thursday the Tigers played at Rogers City in a North Star League contest, picking up a narrow 49-47 victory.

"We looked in the mirror on Wednesday and said what was going on and why things were working in practice but weren't transferring in games," Suttle said. "It's a tough place to play but we fought the whole night and focused on executing and managed to pull a close one out," Suttle said.

The Hurons actually led 11-8 after the first quarter and clung to a 25-23 lead at the half. By the end of the third the Tigers tied things up at 39-39, and got a late Isaac Dubuque bucket to

help get the dramatic victory.

"Dubuque made a huge post move for two points that was huge," Suttle said. "Also, throughout the game I thought Jeff Schram really stepped up. He really showed that he understood some concepts and made some key defensive plays. It was just really great to see him succeed."

Alec Link led the Tigers with 13 points. Swinson netted 12 points; Sullivan had 10; and Hutchinson had seven.

The Tigers wrapped up their busy week on Friday with another NSL win, topping host Fairview, 67-45.

Alcona led 16-13 after the first quarter and 32-23 at the half. The Eagles trimmed that lead to 45-39 entering the fourth quarter. The Tigers had their best frame in the fourth, scoring 22 points to pull away for the win.

"We made some real progress in the last few days," Suttle said. "We still have a long way to go, but we definitely took a jump."

Hutchinson led the Tigers with 18 points; Swinson had 14; Alex Stephenson scored 12 points; Jordan Steiner had 11; and Devon Mills scored five.

Alcona (4-3 overall, 4-1 NSL) hosts Whittemore-Prescott on Thursday, Jan. 14 in another NSL contest and hosts Standish-Sterling on Wednesday, Jan. 20 in a non-conference contest.

"Whittemore is a good team and they'll do what they do well, we just need to focus on what we do," Suttle said. "Honestly, I am just focused on our process and I think the kids are too. For every second we think about somebody else, that's the second we are not going to get better."

The Alcona girls varsity basketball team had the home court advantage on Friday, Jan. 8 when they played the Rogers City Hurons for a North Star League contest.

The Lady Tigers wasted little time working both ends of the court to secure a 19-12 lead by the end of the first quarter.

Alcona's early lead was fueled by Lady Tiger Kendra LaFave, but Rogers City rallied back to tie the game twice at 10-10 and again at 12-12 with 1:55 left on the clock.

In the second quarter, the Lady Tigers continued to pressure the Hurons which forced them to either lose control of the ball or turn it over entirely. Alcona's offensive line up pounced at the opportunity to snatch the ball away and extend their lead to 32-20 by the halfway mark.

In the second half, both teams battled to keep possession but Alcona remained focused on offense to increase the 44-31 lead by the sound of the third buzzer. The Lady Tigers remained focused in the fourth quarter and outscored the Hurons 22-13, to take home the 62-44 victory.

"It was an awesome team effort for us tonight. The early outside shooting attack by Kendra opened up the floor and gave us a lot of inside looks," said coach Brad Cole.

Torie Harmon was unstoppable; she scored 10 points, made seven assists, snatched five steals and made three blocks. Kendra LaFave was high scorer with 21 points and grabbed six steals. On January 4 Alcona traveled to Tawas for the second game this season against the Braves. The Lady Tigers were hoping to avenge their earlier loss against the Braves back in December.

Unfortunately, the last few minutes of the game made all the difference in this contest. Alcona pulled together in the first quarter to keep a narrow 14-12 lead but Tawas battled back on offense in the second quarter to tie game 26-26 going into half-time. After the break Alcona stayed within striking distance, but the Braves proved they weren't going away easily -- they tied the game at 38-38 heading into the final period.

The Lady Tigers came up short offensively as they were outscored 25-14 in the final period and Tawas came away with a 63-52 win.

"We played great basket-

ball for the whole game except for one minute and 32 seconds. We were tied and had just a little lapse in our defense that allowed them a 10 point lead. My team played very hard tonight," Cole said.

LaFave led Alcona with 13 points. Decker had a double-

double with 11 points and 10 rebounds. Harmon stepped up with 11 points, 12 assists, six rebounds and three blocks. Sydney Pierce added six points, Livingston had four points and five rebounds. Alissa Terpstra made three points and grabbed five rebounds.

The junior varsity team had a 25-20 win over Tawas.

Alcona traveled to Hillman Tuesday, Jan. 12 to take on the Tigers and will head to Whittemore-Prescott on Friday, Jan. 15 to go up against the Cardinals. The Lady Tigers will play at home against Oscoda on January 21.

He said three doctors conferred and finally figured out what was going on and diagnosed him with Hep C. Indish said they pulled two and a half liters of substance from under his lungs, which, with the aid of oxygen, helped him to breathe and saved his life.

After he started to recover, Indish began the process to qualify for a liver transplant.

After two months, Indish qualified to be put on the list. Diagnosed with type 1A Hep C, the most dangerous and hardest to treat type of Hep C, Indish began therapy treatment with Interferon and Ribavirin. "The treatment causes most people to get incredibly sick, but my liver was so far gone it could have been just water they gave me and it had about the same affect," Indish said.

For the next year Indish went through a hell he said no one should have to go through. He suffered severe diarrhea and had to wear an adult diaper. "Your liver doesn't hurt, but everything else does. The liver doesn't feel pain but as it gets cerotic it hardens and expands squeezing all the rest of the organs. I had flu like symptoms of extreme achenes all over all the time. I was a 50 year old man wearing Depends," Indish said. He also became diabetic because of the affects his liver had on his pancreas.

Toward the end of the year doctors informed him he had only about another month left before he would be too weak to survive a transplant. The demand for transplantable livers is very high as there are very few donors. Five weeks later they found a liver for Indish and, luckily, he was still in acceptable condition to get the transplant.

"I'm a very fortunate man. Someone died and their family grieved so I could live and my family could rejoice. It was a blind transplant, but I'd like to know who my donor was, I'd like to thank that family," Indish said. Doctors found three spots of cancer on his diseased liver when they did the transplant.

Indish takes 23 pills a day so his body doesn't reject his new liver. The best was yet to come, however. Through Henry Ford Hospital, where Indish received his transplant, he was able to get on a drug trial for a possible cure for Hep C.

They put him on a regimen of Harvoni, a pill Indish took once a day for 24 weeks, to clear his Hep C. Although the hospital said Indish is cured of Hep C he is still not sure if the disease will come back or not.

To this day, Indish is not sure how he got Hep C. He explained anyone can get it through a variety of ways as the virus stays alive for seven days outside the body. He is still very careful to put away things like razors, nail clippers, his toothbrush and even his hair brush so no one else could possibly be infected with the disease.

"I lost my wife, my kids, my business. Now I'm dis-

abled. I can't work. The depression was strong, people don't understand depression. It is utterly impossible to pick yourself up by the bootstraps, you don't have any bootstraps," Indish said. He is getting better but there is no way he could work for a full week not knowing how he'll feel one day to the next and being prone for infection.

"People thought I was lazy, they didn't understand. Take a look around. We have to get off our high horse and show compassion to all. This disease shouldn't happen to anyone. People have no concept of what Hep C patients go through. I don't want any-

one feeling sorry for me; I'm not talking about it because I want a pat on the back. I'm talking because I want others to know about the disease and that help is available," Indish said.

Indish declined having his picture taken because he feels the disease is faceless and can affect anyone.

Hep C affects about 3.5 million people in the United States, many of which, like Indish, are baby boomers, born between 1945 and 1965.

With these he pried open the till and made good his escape. As yet there is no clue to the perpetrator of the deed. Detective Wyman has the matter in hand and will give the criminal a lively chase.

Seek work on Alcona shore road link south Ask 5 miles south of Harrisville on priority list

January 16, 1936 - State Rep. Henry Douville was in Harrisville today in conference with the Alcona County Road Commission on a plan for presentation to the State Highway Department asking that the construction of the pavement from Harrisville south to be placed on the priority list for completion early in the summer. The project is approximately five miles in length.

Under the plan of Mr. Douville, which calls for early completion of this stretch of pavement, will mean that there will be only 12 miles of gravel highway between Alpena and Detroit. People going to Detroit will travel on pavement from Alpena to a five miles south of Harrisville, where they will take the present highway M-72 to US-23 just north of Oscoda.

Should the project be completed by July 1 it will mean that all of the highway north of Harrisville to Roe's Comer can be utilized during the early summer when tourist traffic is at its height.

If the project is delayed until late summer it will mean that the pavement from Harrisville north, will be used only by local residents and the bulk of the tourists will traverse the present route on US-23.

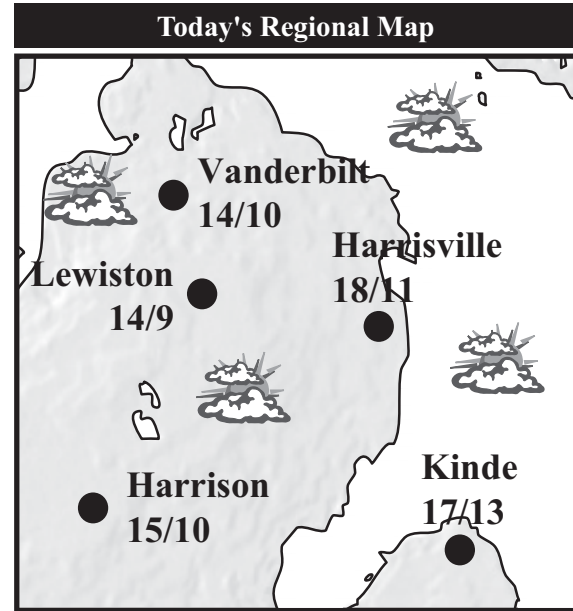

StarWatch By Gary Becker - Sisters All Aglow in the Frosty Night

We had several clear, chilly nights last week, and on the coldest evening, January 4, I had a telescope in the front yard to view the early winter scenery. One of the hallmarks of late fall and winter is the Pleiades or Seven Sisters, a wispy, gossamer cluster of stars that looks like a small exhalation of breath against the frosty night. If you trace the three belt stars of Orion up and to the right, you'll pass orangey Aldebaran (last week's StarWatch), and continue in the same direction to intersect the Seven Sisters. Looking at them with averted vision, the glow will seem to pop, and you'll probably be able to observe half a dozen stars or so. That's because you're looking at the cluster with the rods of your eyes which are more sensitive to light, but less to color and visual acuity. The Pleiades are similar to the Orion Nebula, only 100 million years into the future, a grouping still in its infancy compared to the sun. There are over 1000 members, but it's the 14 young, hot blue stars that cause the Sisters to be visible against the velvety night. Because the cluster is close to us, it appears huge, about three lunar diameters across. That makes it difficult to view in its entirety through most telescopes, but the Sisters become one of the most cherished targets to observe through binoculars. If you view them, know that the photons of light entering your eyes departed from the Pleiades about the same time that Hans Lippershey (1608) invented the telescope, and Galileo Galilei first observed and sketched them (1609-10). To the left of the Pleiades is Auriga the Charioteer, with white Capella about 42 light years in distance, the sixth brightest luminary of the night. Stars, like Capella and our own sun, were born in clusters like the Orion Nebula and the Pleiades eons ago. Most clusters dissipate with the Pleiades being no exception. In about 250 million years they will have evaporated, their members orbiting solo around the Milky Way just like our sun. www.astronomy.org

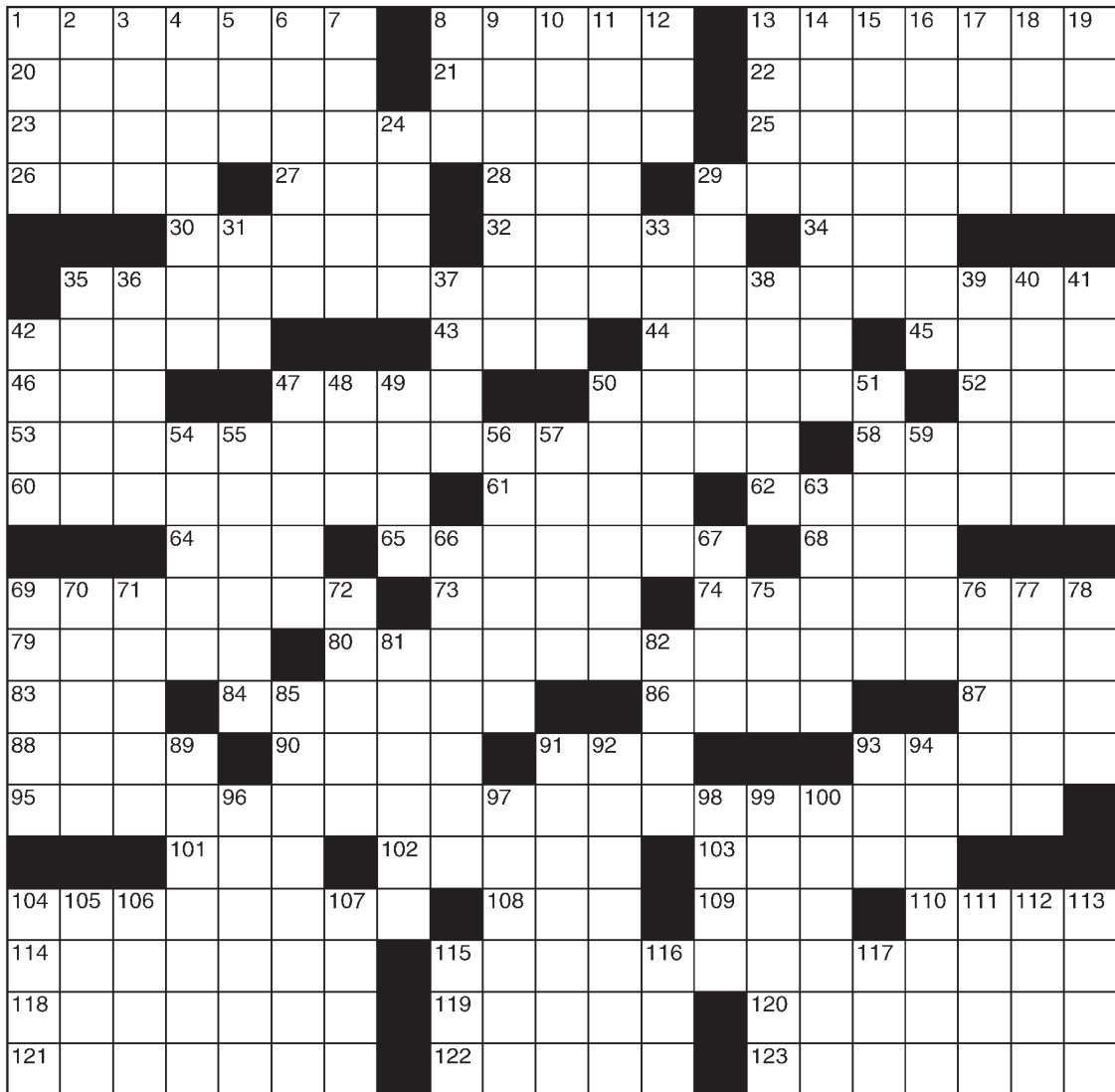
