## Necessary classroom supplies funded by online donations

Having enough school supplies to last the whole year is a dilemma for many teachers. There is help available though and a few creative teachers at Alcona Elementary School found a way to get exactly what they need for their students, without having to beg parents or foot the bill themselves.

Three teachers, Brooke Green, Valerie Haneckow and Lorrie Mongeau are bringing over \$2,700 worth of new supplies into their Alcona Elementary classrooms. The items were funded through DonorChoose.org a website which helps public school teachers across America get necessary supplies by matching them with donors wanting to give.

The site reaches out to donors ranging from those who wish to be anonymous, parents, retired teachers who know the struggle of not having enough supplies, businesses wishing to donate to worthy causes and successful entrepreneurs who want to share their wealth. Some of the donors are people the teachers know personally, some are parents of the students, but many are people the teachers do not know at all. They are just people who want to help a teacher in need.

Donors can peruse the site in search of a teacher or cause which strikes their heart or put out an announcement they are willing to give for a certain cause, such as helping art students, music students or handicapped students and list whatever restrictions there might be with the donation such as amount, age of students or time constraints.

Green, who teaches 28 first-graders, said she first entered a request on DonorsChoose.org for two bean bag chairs so her students could have the option to read in a comfortable place. After that request was filled she asked for eight educational games for her class, explaining on her request page that educational games grow knowledge and community.

Green said she prefers the DonorsChoose.org site rather than asking parents. "I found when you ask parents, it's the same parents who are always giving. The others are doing everything they can just to make ends meet.

"Teachers are in constant need of items. All teachers need folders, pencils, paper, mailboxes, labels, Sharpies, dry erase markers, high lighters, tape and paperclips. I will continue to put (request) items on DonorsChoose.org.

A barn on Bean Hill Road is consumed by fire despite the efforts of local fire departments last Thursday. Barton City Fire Department, with the assistance of Mikado and Lincoln fire departments, was dispatched at 3:45 p.m. on March 10 to a barn owned by Tom and Sandy Labeau that was fully engulfed by the time fire fighters arrived. ## Lincoln man faces charges of stalking

A Lincoln man has been charged with stalking three individuals in the last month. According to the Michigan

State Police, Daniel Arnold Hale, 26 has been arraigned on three counts of aggravated stalking.

The charges were brought against Hale after three individuals contacted the state police in Alpena. The first incident came in early February when a trooper received a report that an unknown male was repeatedly calling a 14-year-old Alpena girl. According to the state police, the male allegedly made inappropriate statements to the girl and stated that he wanted to meet with her. Despite being told to stop making the calls the unknown male continued to call her.

Later in February the investigating trooper received a complaint from a female employee of an Alpena salon who had received multiple unwanted calls from a male wanting a makeup consultation. The male allegedly attempted to obtain her personal phone number and wanted to set an appointment for a time when she was alone.

On March 2 another Al-

pena woman reported receiving multiple unwanted calls from an unknown male subject who made comments similar to those made to the original victims. She told the male to stop calling her, however, he allegedly continued to call her.

According to the state police, on March 4 the male suspect allegedly appeared at the salon where the second victim works. The investigating trooper contacted the suspect and determined he was involved in all of the mentioned incidents.

Hale was arrested and interviewed. He allegedly admitted to repeatedly calling the victims despite being told to stop. He had no connection to the victims and apparently called them randomly.

# Sunshine is important now more than ever

As we face one of the worst government-created problems in Michigan's history, the Flint water crisis, and hear stories of legislators using state dollars to cover up their sordid behavior, the need for more openness in government is stronger than ever.

The Freedom of Information Act (FOIA) in Michigan begins with the following: It is the public policy of this state that all persons, except those persons incarcerated in state or local correctional facilities, are entitled to full and complete information regarding the affairs of government and the official acts of those who represent them as public officials and public employees, consistent with this act. The people shall be informed so that they may fully participate in the democratic process.

The last sentence of this statement is vitally important. We've made some progress over the last several years. The last session of our legislature passed a law to improve the process of FOIA by lowering costs and demanding timelines be adhered to or there would be consequences.

But as events have unfolded in the last year, it's become evident we have a long way to go.

Michigan is one of only two states that completely exempt the governor's office from FOIA. We are one of a handful that exempt the legislature. It's time to make a change. The citizens of Michigan should have access to information about every level of government.

In a study by the Center for Public Integrity and Global Integrity toward the end of last year, Michigan ranked last nationally in ethics and transparency laws and safeguards, in part because of our weak public records law and an absence of laws requiring personal financial disclosures by lawmakers and top state officials.

The Michigan Press Association is hoping to change that ranking. We feel amendments to current law would remove the veil of secrecy in our legislature and the governor's office and would be a big improvement. We expect to see a proposal soon and hope Michigan's citizens will urge support from our lawmakers and governor.

Sunshine Week, March 13 to 19, celebrates the public's right to know. We can do much better. We ask you to join us and encourage our government to see the advantages of transparency and the importance of checks and balances.

**Fruit Tree Grafting**

The Alcona Conservation District, and the Harrisville Institute for Cultural Learning will be hosting two fruit tree grafting workshops this spring. The first workshop will be held Saturday, April 9 at the Harrisville branch of the Alcona County Library, 312 West Main, Harrisville. The second will be held Saturday, April 16 at the Oscoda Public Library, 6010 North Skeel Avenue, Oscoda (on the former Wurtsmith Air Force Base). Both sessions run from 10 a.m. to 2 p.m.

Grafting is a centuries-old method of plant cloning in which a branch or bud from a parent tree or shrub is placed on the rootstock base or trunk of a similar species. The grafted branch or bud when mature, then carries forward the same characteristics, such as fruit variety, as the parent tree.

The workshop includes lecture and demonstration by Greenbush resident Joe Lukasiewicz, plus hands-on experience using different grafting and budding techniques. Each participant will graft three dwarf apple trees to keep, and will be given guidance on their post-grafting care. # Tigers come up short to Tawas in district final despite late-game rally

If the game had just been a bit longer, it might have been the Alcona boys basketball team celebrating a district championship. The Tigers' rally just ran out of time however, as Class C tournament host Tawas handed Alcona a 60-54 season-ending loss.

"No question, if you put another minute on the clock and I think it's a different outcome," Alcona head coach Toby Suttle said. "It is really hard to win a district championship when you only play well for a half though."

The Tigers trailed the entire night, and despite playing much better in the second half, were still behind 57-46 with just over two minutes left to play.

Alcona wasn't about to go down without a fight though. Jordan Steiner started a flurry of Tiger points with a free throw that made it 57-47, then after a jump-ball went Alcona's way Steiner buried a three-pointer from the right side of the court to make it 57-50.

The Braves tried to run some time off the clock after that but Nate Swinson made a heady play to grab a steal, then Swinson heaved a pass to Steiner who laid the ball in for an easy two points to make it 57-52.

The Braves had a chance to put the game away at the free throw line with 40 seconds left but they missed the front-end-of a one-and-one, which Alec Link chased down for a rebound and on the ensuing possession Alex Stephenson drove through the lane rather easily to bring the score to 57-54 with just under 30 seconds to go.

"I never thought we didn't have a chance," Suttle said. "I know our kids. I know they had a ton of heart and they were capable of winning this game."

Tawas split a pair of free throws on the other end though, giving it a bit of breathing room at 58-54 with 24.5 seconds left.

Then, after a missed Alcona three on the other end the Braves grabbed a tough rebound, then padded the final with a pair of free throws in the game's final moments.

"Tawas is a good team this year, they're senior laden and they were really battle tested with a tough schedule," Suttle said.

The Braves started the game on a roll. After an early Isaac Dubuque lay-up that made it 2-2, the Tigers suffered through a scoreless streak of over six minutes before Mitchel Havercroft grabbed an offensive rebound and sent the ball back in for two points. The Havercroft bucket made it a 14-4 Tawas lead, with the Braves also netting the final bucket of the frame to lead 16-4 after one.

In the second, Tawas used a tough man-defense on the Alcona guards, creating several steals and fast-break opportunities the other way for the Braves. This led to

Tawas taking leads of 23-11, 28-13 and finally 32-15 at the half.

"We had careless turnovers," Suttle said. "You can't win tough high school basketball games against good teams when you turn the ball over like that. Their guards were good, they gave us fits. Our guards did the same thing to them in the second half, but we just didn't learn from what they were doing to us quickly enough."

The Tigers stormed out of the locker room and netted five quick points, with Link getting a drive through the lane and a three-pointer. Later Link added a put-back basket to make it 36-24.

Steiner drilled a three-pointer and right after that he stole the ball from a Tawas player, which led to an easy lay-up for himself and trimmed the Tawas lead to 36-29.

The Braves survived that Tiger surge to push its lead to double digits again, though another three by Steiner helped Alcona stay within striking distance, 47-36 entering the fourth.

There, the Braves jumped to a 55-40 lead with 5:05 to play and still led 57-46 before the Alcona rally hit full throttle.

Link finished with 16 points. Steiner had 14, Dubuque had eight and Swinson netted six. Havercroft and Stephenson had four points each and Tim Hutchinson had two.

The Tigers reached the championship game with a hard-fought 61-55 win over Whittemore-Prescott in the semifinal.

"We had a good idea of what they were going to do coming in," Suttle said. "I thought if we could just win the battle of the boards and really put pressure on their point guard, we'd be in a good position."

The Tigers trailed the game 8-6 after the first quarter and fell behind 19-12 midway through the second, but Alcona got big time threes by Swinson and Hunter Sullivan to help tie the game at 27-all by the half.

Link opened the second half with a bucket to put Alcona ahead 29-27, a three by

Swinson kept them up 36-33 and a mid-range pull-up jumper by Steiner late in the period gave them a 44-41 lead entering the fourth.

The Tigers continued to hold on to the lead, up 57-53 late, then got Swinson to make three-of-four free throws from the line to help ice the game at 61-55.

Swinson paced the Tigers with 27 points, including hitting four three-pointers. Link netted 15 points, Dubuque had six, and Sullivan was good for five, Stephenson had

## How retirees can save on prescription eyeglasses

Dear Savvy Senior,  
What tips can you recommend for finding affordable prescription eyeglasses? I used to have vision insurance through my work, but lost it when I turned 65, retired, and signed up for Medicare.

### Looking For Eyeglasses

Dear Looking,  
Prescription eyeglasses today aren't cheap. You can easily spend \$200 for a basic pair, but if you want designer frames or need bifocal or progressive lenses the price can more than double. Here are a few different options that can help you save.

If you are a Medicare beneficiary, you already know that original Medicare (Part A and B) and Medigap supplemental policies do not cover routine eye exams or eyeglasses (unless you've just had cataract surgery), but there are some Medicare Advantage (Part C) plans that do.

Many of these plans, which

are sold through private insurance companies, cover vision as well as dental, hearing and prescription drugs, in addition to all of your hospital and medical insurance. To locate Advantage plans in your area that provides vision coverage, visit Medicare.gov/find-a-plan or call (800) 633-4227. But before enrolling in a plan, check the benefit details to ensure the plan's vision coverage includes routine eye exams, eyeglass frames and lenses.

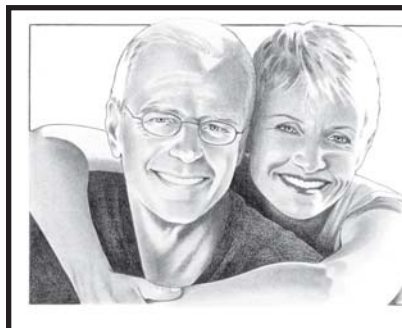
You can switch from original Medicare to a Medicare Advantage plan each year during the open enrollment period, which is between October 15 and December 7.

If, however, you don't want a Medicare Advantage plan, you can still get coverage by purchasing an inexpensive vision insurance policy - see eHealthInsurance.com. Policy costs vary depending on where you live, but they usually start at around \$6 to \$9 per month for an individual. Before signing up,

make sure your savings potential is worth the cost of the premiums and copays.

Purchasing eyeglasses from discount retailers is another way to save. Costco is one of the best discount stores for good eyewear and low prices. Eyeglasses cost an average of around \$150, but to shop there you have to pay a \$55 annual membership fee. Some other good retail options for low prices include For Eyes Optical, BJ's Optical, Sam's Club and Walmart.

You also need to find out if you are eligible for any discounts. Many retailers provide discounts to membership groups like AARP and AAA. AARP members, for example, can get 30 percent off a pair of prescription eyeglasses as well as discounts on eye exams at any LensCrafters, most participating Pearle Vision, Sears Optical, Target Optical, JCPenney Optical and thousands of private optometrist offices.



Savvy Senior

Buying eyeglasses online can also offer huge savings. Some online stores like ZenniOptical.com, Goggles4u.com and EyeBuyDirect.com sell prescription eyeglasses for as little as \$7 plus shipping. These sites let you upload a photo of your face, so you can see what you'd look like in different frames.

Or, for a fancier choice of frames see WarbyParker.com, which offers single-vision glasses for \$95. They even offer a free program where you can request up to five pairs to try on at home for five days.

To purchase glasses on-

line, you'll need your eyeglass prescription from a local eye doctor, plus your pupillary distance number, which is the distance, measured in millimeters, between the centers of your pupils in each eye.

If your income is low, depending on where you live, there may be some local clinics that provide free or discounted eye exams and eyeglasses. Put in a call to your local Lions Club to see what's available in your area. See directory.lionsclubs.org for contact information.

They get funded quickly; my first post was fully funded within the first 24 hours," Green said.

Mongeau recently asked for paper, pencils, crayons and clear wipe-off plastic sheets that she can put worksheets into so her 26 kindergartners could practice writing their letters and math. The plastic can easily be wiped clean for another assignment, which cuts down on paper and copies.

"We are allotted only so many copies during the school year and we are conscientious about how many we make. With the plastic sheets the students can work on anything that I don't have to keep," Mongeau said. Some projects such as tests and other assignments she does need to keep and send home use up a lot of paper.

Mongeau explained students had a lot more supplies to pick from in September. "Items like paper, pencils and crayons need constant re-

plenishing. Pencils need sharpening and erasers wear down. Glue sticks run out or dry out, crayons break, by January and February supplies diminish. The kids like working with new supplies and they take good care of their things. There isn't anybody who doesn't appreciate new supplies to work with," she said.

Mongeau was nervous putting her first request on DonorsChoose.org but when the request was filled in just one day she said she would do it again soon with a request for art supplies -- paper, paint and glue sticks.

Haneckow asked for 60 white boards and markers for her 27 first-graders. When that request was filled within days she asked for five Chromebooks and 30 earbuds. She explained each student in the class needed their own set of earbuds because they are personal items put into the ear and sharing such an item could transfer lice and bacteria.

The five additional Chromebooks would allow a group of students to work on reading at their own level on educational sites and applications. "I love teaching first grade and I love teaching in a rural school district," Haneckow wrote on her DonorsChoose request page, "Students usually come to me eager to learn. This year's group is a little different. They are very active, very inattentive and very challenging to teach. I find myself needing to think outside of the box regularly to be able to help them do their best at being first grade learners.

"We are working hard on being responsible, on task, always safe and respectful. We are making progress each day but it takes a lot of focus and effort on everyone's part to make strides towards being ready for second grade by the end of the year. Chromebooks would make a valuable addition to our class."

Although this request took a little longer to meet the \$2,064 needed, Haneckow announced last week after several donors sent small donations that Elsa Brule, a donor from New York, funded projects in North Dakota, South Dakota, Alabama, Wisconsin and her home state of Michigan. One of Brule's Michigan donations went to complete Haneckow's request.

Haneckow said she was giddy with excitement that her students would be able to take advantage of the Chromebooks soon.

DonorsChoose.org was created in 2000 by Charles Best, a teacher at a Bronx public high school who wanted his students to read "Little House on the Prairie." As he was making photocopies of the one book he could procure, he thought about all the money he and his colleagues were spending on books, art supplies and other materials. He figured there were probably people who wanted to help if they could see their money was going to a worthy cause.

According to the DonorsChoose.org, the site was developed so teachers could post requests and donors could choose the ones they wanted to support. His colleagues were the first to post 11 requests and it spread from there.

Today over 600,000 classroom project requests which range from butterfly cocoons to robotic kits to books like "Little House on the Prairie" are being filled daily. The site has over 80 employees which vet all requests. When the request is completed DonorsChoose.org purchases the items at the best possible price and then ships the items directly to the school.

After the students receive the items, the teacher sends a few pictures of the items being used by the class to the website. Thank you notes, along with the pictures, are sent to the donors so they know exactly how much their donation was appreciated and can see the faces of the students they helped.

# New elk tracking research project begins in northern Lower Peninsula

An elk lies in the snow, covered by a net that just fell from the sky. A "mugger" jumps out of a helicopter, while a ground team moves in.

This is net-gunning - a process the Michigan Department of Natural Resources (DNR) used recently in the northern Lower Peninsula to fit 40 elk with GPS collars.

The DNR and Michigan State University (MSU) are jointly funding this new tracking project, which is being researched by an MSU graduate student.

northeast of Gaylord, Mich. in Otsego and Cheboygan counties.

This tracking research project had been in the works since 2006 and was identified by the DNR's Elk Management Advisory Team as a subject to be analyzed.

"In the early 1980s, our research looked at the effects of oil and gas development. In the late 1980s, we looked at how hunting affected elk behavior within the elk range," said DNR wildlife research biologist Dean Beyer. "Now as time has passed, we

needed. Also, the elk would not be tranquilized, making this collaring effort unique.

"Not tranquilizing an animal changes the ground game in this collaring. We are handling large animals, fully aware and capable of moving, so we need to move quickly," Beyer said. "The elk can then be back on their way and return to their natural setting. Fortunately, we have highly qualified and experienced staff to make this happen."

An adult Michigan elk can stand up to five feet tall at its

Across the country, wildlife research biologists are interested in the combination of wild animals and human activities. "One of the goals of this project is to look specifically at the effects of recreation in the core elk range by tracking elk movements over the next three years," said Brian Mastenbrook, DNR wildlife field operations manager.

Michigan's core elk range includes the Pigeon River Country State Forest, which encompasses more than 100,000 acres of public land

face new issues. This research is designed to look at elk habitat and how elk move in relation to human activities, specifically horseback and mountain bike riding."

The net-gunning capture effort began February 14 with a safety meeting of DNR staff, Michigan State University researchers and a helicopter flight crew from Texas. In all, about two dozen people were involved with the process.

With multiple aircraft, ground crews and live animals involved, clear and reliable communication was

shoulder and weigh up to 900 pounds. The male, or bull, elk hadn't dropped their antlers at the time of collaring, adding sharp-polished bone, weighing up to 40 pounds, into the safety equation.

Crews in two DNR airplanes, looking down from low altitude, had no problem locating groups of the large elk against the white, snowy backdrop.

"It's like hunting for morel mushrooms," said DNR wild-

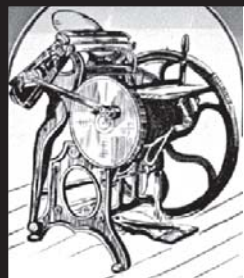

life technician Mark Monroe. "Just like mores, if one elk is spotted, typically others can be found - because elk are a social animal."

Monroe was leading the ground team of multiple snowmobiles that were in constant radio communication with the two airplanes and the helicopter.

"The plane would alert us to the number of elk they'd spotted, their location and if they were males or females," Monroe said. "The best reports were multiple elk near a clearing - which is great, because we need the room to work."

The helicopter crew and the ground team would develop their plan - the route, number of elk and which team would go where. Ground teams would then head in on snowmobiles. Timing was important. They couldn't go in before the elk were netted or they would risk scaring away the big animals.

Guided by crew in the two DNR airplanes, the helicopter flew low to herd the elk into a safe position for capture. The net-gun was then fired from the helicopter to capture the elk. The "mugger" is the first person to get out of the helicopter once the elk is netted. Muggers hold the net until others arrive.

Experienced handlers immediately placed a blindfold on the captured elk and secured the legs with hobbles, which are small belt-like straps. Meanwhile, other members of the team start to remove the tangled bright orange net from the captured elk.

The next step is for the crew to fit the elk with a GPS

tracking collar. The collar sends signals to satellites, providing researchers with information about the elk's movements and location at any given time. The collar is designed to fall off after three years, eliminating the need for researchers to handle the elk again. If elk movement isn't observed, a distress signal will be sent.

The entire collaring process can take a three-person ground team about 10 to 15 minutes. When the team's work is complete, the elk is released by first removing the hobbles and then the blindfold, allowing the elk to immediately run off on its own.

During the February outing, the collaring team worked out of the DNR's Atlanta field office. The team met its goal in just two days - 20 male and 20 female elk fitted with GPS tracking collars. "We are very excited about how quickly we were able to complete this collaring mission," Mastenbrook said. "Although the project development itself was years in the making."

Recently, elk population estimates were made during an airplane survey. DNR staff flew over the Michigan elk core area for nine days and observed 1,002 elk situated within 88 transects they flew. This aerial survey not only provided population estimates, but also showed the location of elk and the proportion of males to females.

"As responsible managers of natural resources, we need to understand what, if any, effects recreation has on our elk," Mastenbrook said. "We are managing wildlife for all of the people of the state of

Michigan. This type of research gives us information that helps us make the right management decisions."

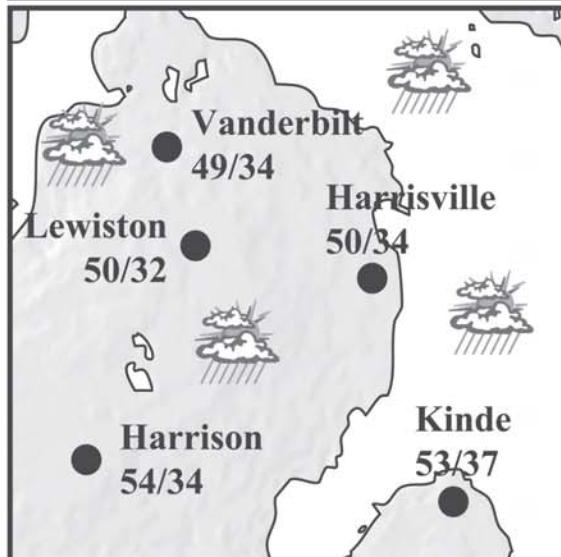

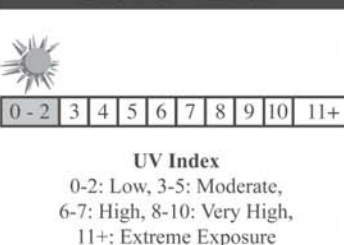

### StarWatch By Gary Becker - Wobbling Earth

Astronomers are confronted with the daunting task of tracking the movements of Earth, as well as the independent motions of the moon, planets, and stars, along with everything else that orbits or oscillates. It's a complicated task, but if we are to send a spacecraft to target a location on the moon or a distant planet, or pinpoint a telescope's position to image a faint galaxy, astronomers must know its location against a frame of reference to a high degree of accuracy. One Earth motion which affects the position of stars is called precession. If a force is applied to the axis of a rotating top, the axis will move in a plane that is perpendicular to the applied force. The Earth is a tilted, rotating top with its equatorial regions bulging outward due to its spinning motion. The sun's net gravitational effect on all parts of this swelling pulls harder on the region of the bulge closest to the sun, trying to right Earth's axis and bring Earth's equator into alignment with its orbital plane, called the ecliptic. The moon also contributes to Earth's precessional cycle because it orbits in a plane which is near to the ecliptic. The resulting action, just like the top spinning on a desk, is to cause the Earth's axis to wobble. Unlike the earthbound top which increases in the magnitude of its wobble, the amplitude of Earth's 26,000-year wobble is very stable. In other words, Earth's axial tilt changes very little. Precession causes the civil year, marked by our calendars to be a shorter duration than the actual time it takes the Earth to orbit the sun. As the Earth's axis slowly pivots, the seasonal constellations regress against the fixed dates of the calendar. New pole stars will replace Polaris. By 14,000 AD the fifth brightest star of the night, Vega will be the new "Polaris" and the Northern Hemisphere will be closer to the sun in the summer. Holy Hannah! There goes 10,000 years of lesson plans except for the ones dealing with the seasons. They still will be the result of Earth's axial tilt and not its distance from the sun. - On April 1, 1700, English pranksters begin popularizing the annual tradition of April Fools' Day by playing practical jokes on each other. It's thought that when the start of the new year moved to Jan. 1 with the adoption of the Gregorian calendar, some people unwittingly continued to celebrate it in late March through April 1, and they became the butt of jokes and hoaxes.
- On March 30, 1867, U.S. Secretary of State William H. Seward signs a treaty with Russia for the purchase of Alaska for \$7 million. The deal was ridiculed in Congress and in the press as "Seward's folly," "Seward's icebox," and President Andrew Johnson's "polar bear garden."
- On March 31, 1889, the Eiffel Tower is dedicated in Paris. The Tower was almost demolished when the lease on the land expired in 1909, but its value as an antenna for radio transmission saved it.
