ark sky preserves could boost tourism in region

A new law designating dark sky preserves in Michigan is expected to pull visitors from all over the world.

"It was a natural fit," said 106th District State Rep. Peter Pettalia, R-Presque Isle. Pettalia was behind the law meant to protect northern Michigan state parks from artificial light pollution. Pettalia is the vice-chairman of the advisory board for the state parks.

"It's such a neat experience to witness celestial happenings all around you," Pettalia said.

The law specifies Rockport State Recreation Area in Alpena and Presque Isle counties; Negwegon State Park in Alpena and Alcona counties; and Thompson's Harbor State Park in Presque Isle County.

The law also includes Wilderness State Park and nearby state forestland in **Emmet County and Port** Crescent State Park in Huron County, as well as Lenawee County's Lake Hudson that was designated a dark sky preserve in 1993 by the Michigan Department of Natural Resources (DNR).

The designation promotes stargazing and night photog-

raphy in the parks. Pettalia said the designations give an edge to Michigan's tourism.

The Headlands in Emmet County, west of Mackinaw City, is Michigan's only international dark sky park. Statedesignated parks must regulate outdoor lighting, but don't have the same requirements as the Headlands, said Mary Stewart Adams, the program coordinator for the county-run Headlands.

noted an uptick in guests that are drawn to the area specifically to visit the site and participate in programs. Thousands of visitors that chose this area specifically because of our designation through the International Dark Sky Association have made their way here from around the region, the country and the globe. It's really quite exciting," Adams said.

State's largest tree award given in Alcona County

Alcona County is home to the largest tree of any living species in Michigan. The certified eastern cottonwood tree has a circumference measuring 311 inches and is probably well over 200 years old.

The tree, located on the

farm of Dale Dellar on Clemens Road in Harrisville, was issued a certificate by the Big Tree Hunt of ReLeaf Michigan, an organization which has contests every few years for the largest trees in the state.

Dellar learned about the big tree hunt when an article appeared in the Alcona County Review in 2012 after Carl Buchner won an award for his big tree -- another eastern cottonwood on Springport Road in Harrisville. The Springport Road tree measured 256 inches. Dellar's 311 inch tree was measured four feet above ground level.

"I saw that article and I called Carl and told him you drove right by the biggest tree in the county to get to the second biggest," Dellar said. Dellar submitted the tree measurements to ReLeaf Michigan in 2013 but the tree wasn't verified until late last fall when he spotted a stranger out measuring it.

The tree has a long history. Dellar said his grandmother, who was born in 1898, remembers the tree as being very large when she was a girl when she traveled past it with a horse and buggy. "That's pretty neat

that my grandmother remembered the tree and remarked about it when we bought the property from Joe and Ida Specht in 1978," Dellar said.

According to Dellar, the tree has weathered many wild storms, some of which took every leaf off of it, but the big cottonwood always came back a few weeks later.

Eastern cottonwoods belong to the willow family and go by other names such as held in Midland, Mich. last the southern cottonwood, Carolina poplar, eastern poplar and necklace poplar. It is the state tree of Kansas and Nebraska and can survive temperatures ranging from 115 degrees Fahrenheit to as low as -50 degrees Fahrenheit.

The tree can either be male or female but it's only the female trees that drop fluffy, white seeds which look like puffs of cotton during early summer, and gives the tree its name, according to the Great Plains Nature Center in Wichita, Kan.

Dellar said his tree drops a lot of fluffy seeds every summer and if a car is parked under it at that time year it's completely covered in fluff in just a few hours.

Since 1993, ReLeaf Michi-

gan, a statewide, non profit tree organization, has challenged the public every few years to find Michigan's largest living trees through its big tree contest. The hunt was created to take over the efforts of Paul Thompson, a botanist, who searched for Michigan's big trees and kept records of them since the early 1940s.

Dellar received two certificates at an award luncheon month. One is for the largest reported tree of any species in Michigan and the other for the largest tree in Alcona County.

The tree is located near the driveway of the farm at 4105 Clemens Road, between Poor Farm and McGregor Roads. For more information about ReLeaf Michigan visit info-@releafmichigan.org or call (800) 642-7353.

tip of Michigan is an important staging area for migrating birds, especially raptors, and protecting the natural darkness means protecting their habitat," she said.

Most of the parks included in the new law are pretty far off the beaten path, making them great for stargazing, but also for conservation, Adams explained. For example, Negwegon State Park boasts four backwoods camping sites accessible only by foot.

"Even getting to the parking lot can be an adventure," said Mara Koenig, a public affairs specialist for the Midwest region of the U.S. Fish

and Wildlife Service.

Negwegon's supervisor, Eric Ostrander, and Koenig agree the backwoods vibe is valuable for conservation efforts. "Huron has a lot of dune and swale habitat," Koenig said. "Dune and swale is primary habitat for whitefish, especially for spawning and nurseries. There are also quite a few endangered or close-to-it species in the area, such as the Hine's emerald dragonfly."

A \$900,000 U.S. Fish and Wildlife Service grant will be put toward a land purchase that will connect the two halves of Negwegon State

Park. The two sites have been separate since the formation of the park 54 years ago. Private landowners had kept their beachfront property, hindering management and stewardship programs from taking full effect, Ostrander said

The state park had been eyeing the land parcel for quite some time and the opportunity finally came to make the purchase when the family who owned the parcel felt it was time to sell. Koenig said the National Coastal Wetlands Conservation Grant Program allocated the funds. The program "came about through wanting to preserve coastal areas in the Great Lakes."

"If we link the parcels, it will be better for our ongoing stewardship programs, searching for invasive species and managing endangered species. You don't have a lot of protected publically owned water fringe habitat," Ostrander said.

Along with the grant, Adams said that Negwegon's dark sky designation may result in community-building and support from partners, as it has for the Headlands. "The list of partners that our international dark sky park designation has resulted in includes the Michigan DNR and state parks system, as well as the National Park Service's Natural Sounds and Night Skies Division," Adams said. "All of this brings increased attention to the natural beauty of our environment, which has a great, positive consequence for all of us."





How to avoid Medicare mistakes while still working

Dear Savvy Senior,

Should I enroll in Medicare at age 65 if I'm still working and have coverage through my employer?

Almost 65

Dear Almost,

The rules for enrolling in Medicare can be very confusing with all the different choices available today. But when you postpone retirement past age 65, as many people are doing, it becomes even more complicated.

First, let's review the basics. Remember that original Medicare has two parts: Part A, which provides hospital coverage and is free for most people. And Part B, which covers doctor's bills, lab tests and outpatient care. Part B also has a monthly premium of \$104.90 in 2016 (though it's higher for individuals earning \$85,000 or more a year).

If you are receiving Social Security, you will be enrolled automatically in parts A and B when you turn 65. If you

aren't yet receiving Social Security, you will have to apply, which you can do online at SSA.gov/medicare, over the phone at (800) 772-1213 or through your local Social Security office.

If you plan to continue working past the age of 65 and have health insurance from your job, your first step is to ask your benefits manager or human resources department how your employer insurance works with Medicare. In most cases, you should at least take Medicare Part A because it's free. But to decide whether to take Part B or not will depend on the size of your employer.

If your current employer (or spouse's employer if it's providing your coverage) has fewer than 20 employees, Medicare will be your primary insurer and you should enroll in Medicare Part B during your initial enrollment period.

This is a seven-month period that includes the three months before, the month of, and the three months after your 65th birthday.

If you miss the seven-month sign-up window, you'll have to wait until the next general enrollment period, which runs from January 1 to March 31 with benefits beginning the following July 1. You'll also incur a 10 percent penalty for each year you wait beyond your initial enrollment period, which will be tacked on to your monthly Part B premium.

If your employer has 20 or more employees, your employer's group health plan will be your primary insurer as long as you (or your spouse if the coverage is from his/her employer) remain an active employee. If this is the case. you don't need to enroll in Part B when you turn 65 if you're satisfied with the coverage you are getting through your job. But if you do decide to enroll in Medicare, it will supplement your employer insurance by paying secondary on all of your claims.

Once your employment (or group health coverage) ends,

you will then have eight months to sign up for Part B without a penalty. This is known as the Special Enrollment Period.

You also need to verify your prescription drug coverage. Call your benefits manager or insurance company to find out if your employer's prescription drug coverage is considered "creditable." (Creditable prescription drug coverage is one that is considered to be as good as or better than the Medicare prescription drug benefit.) If it is, you don't need to enroll in a Medicare Part D prescription drug plan. If it isn't, you should purchase a plan (see medicare.gov/finda-plan) during your initial enrollment period or you'll incur a premium penalty (one percent of the average national premium for every month you don't have coverage) if you enroll later.

onds left on the clock. Torie Harmon's two steals helped fuel Alcona's offense. Brittany Decker, Taylor Livingston, Alissa Tersptra and Jordan Joyce stepped up with crucial buckets to give Alcona the 30-25 advantage at the half.

Early in the third quarter the Lady Tigers extended their lead to 10 points but it was short lived. The Lady Tigers struggled to slow down the Lady Braves outside shooting attack. Tawas went on a 25-8 run and captured the 50-38 lead by the end of the period. Although Alcona was able to match Tawas bucket for bucket in the final quarter, the deficit on the score-

On March 2 Alcona traveled to AuGres Sims High School to take on the Lady Panthers in the second round of girls Class C District basketball action.

Harmon helped set the tempo with eight points, eight steals, and five assists. Livingston netted six points. Decker got the job done with six points, seven rebounds and four steals. Madison Lane scored four points. Pierce added four points, six assists and six blocks. Rachel Warner and Terpstra each made four

StarWatch By Gary Becker - Seeing the Young Moon

One aspect of the evening sky in the spring is that the ecliptic, the Earth's orbital plane projected into space, is tilted at a steep angle (about 70 degrees) to the western horizon. Since the moon orbits near to the ecliptic, this affords an opportunity for the fast moving moon to be seen as a razor thin crescent a day or so after tits new phase. The conditions are right for a series of these types of observations this week if weather conditions cooperate. The moon is new, passing the sun at * 8:54 p.m. on Tuesday, March 8. By sundown on the 9th, the moon will have moved to a position nearly 9.5 degrees above the horizon. Sunset is essentially at 6 p.m., and moonset will be an hour later. Between 30-40 minutes after sundown, an ultra thin, one percent lit crescent moon will be seen (probably using binoculars) about three degrees above the horizon just to the south of west. A flawless western horizon is necessary. A much less difficult observation of a 5 percent lit crescent moon will be visible the following evening, March 10. By 45 minutes after sundown, the sky will be dark enough to see the moon easily, and Luna will be still 14 degrees above the western horizon. That will be an easy observation that can be made without binoculars, but will be greatly enhanced with their use. Look for earthshine, light from a nearly full Earth being reflected back to us from the unlit portions of the moon. If the air is clear, you should be able to see the earthshine by looking at the moon directly; but its effect will be enhanced if you look away from the moon, and use averted vision to see it. The rods, which are in the peripheral area of the eyes, are more sensitive to low light than the cones found in the central vision. This will also work when using binoculars. Earthshine should also be seen under clear conditions on March 11 and 12. Don't forget to set your clocks ahead by one hour before bedtime on March 13 as we jump ahead to Daylight Saving Time, causing Sol to rise and set later, better syncing it with our time awake. www.astronomy.org

Great Backyard Bird Count brings local surprises

Bird watchers from around the globe contributed significant data during the 2016 annual Great Backyard Bird Count (GBBC) held February 12-15.

The event is sponsored by Cornell Lab of Ornithology, The Audubon Society, and Bird Studies Canada. As of February 18, results showed 5,270 species recorded, with 16,572,293 individuals sighted.

Michigan observers tallied 128 species with Wayne County leading, contributing 74 of the total. "Many downstate participants reported unusually high numbers of American robins and eastern bluebirds," said Peggy Ridgway, local ambassador for the event. Additional state rarities included one eastern towhee, one northern flicker, one yellow –bellied sapsucker and four turkey vultures.

"Some of our Iosco County participants also had the state high counts for certain species," Ridgway said. Those counts included; four pileated woodpeckers, 350 pine siskins and 71 wild turkeys all spotted by Gisela Vito of Oscoda. Mary Williams of Oscoda led the tally of brown creepers sighting three. Larry VanWagoner of National City, Mich. located 18 redheaded woodpeckers in the Indian Lake area.

Ridgway and Ed Cole of

Oscoda recorded 200 trumpeter swans at Iargo Springs. "There was much open water at the springs and shortly after Ed and I arrived, the winged beauties began taking to the air and headed downriver toward Cooke Dam. I've never witnessed 150 in flight at one time. That phenomenal scene is etched in my mind forever," Ridgway said.

The evening grosbeak is a northern species that has been totally absent from the list for the past several years. However, Dave Kalush of Hale, had 32 visit his feeders. "This was great news," Ridg-way said.

Other Iosco County participants with rare sightings or unusual counts included Jane Ruster of East Tawas with a single turkey vulture. "I could hardly believe my eyes and nearly fell off my chair as it swished in," said Ruster.

Roger Eriksson of East Tawas spotted one red-winged blackbird and 16 bohemian waxwings at Tawas Point. Also observed by Eriksson were cedar waxwings in East Tawas along US-23. Along the Tawas River near Nunn Road, VanWag-oner located a lone American coot.

A few common redpolls were mixed in with pine siskins, but did not top the 50-150 siskins counted at

many local feeders. Other single hawk reports in Iosco County included red-shouldered, American kestrel, coopers, and sharp-shinned.

Overall, 51 species were recorded in Iosco County along with 25 in Alcona County.

"We still topped the state with the tremendous amount of pine siskins reported. Many thanks to all the folkswho responded to my request for local feeder numbers," Ridgway said.
