County clerk to retire after 42 years of service

Learning and growing is part of life and one Alcona County employee has been consistent, dedicated and hard working for most of her adult life.

With the different positions held in the last 42 years, she has weathered a lot of change, taken on more responsibility and has served the people of the county.

That's about to change for Patricia (Patti) Truman, Alcona County Clerk, when she retires on August 31.

"It will be different after retirement. I won't have that daily commitment. There hasn't been anything I really hated about the job. Sometimes there is stress during election times, but it wasn't anything I hated. I guess that's why I've continued working so long. I've enjoyed it," Patti said.

Patti has been county clerk since she first ran for the position following the retire-

ment of Gayle Simmons in 2004. She has won three consecutive elections since then.

Patti explained the Alcona County Clerk's office is a busy place and she and her staff, deputy clerk Stephany Eller and Lori Achtabowski, handle a variety of responsibilities that keep the county and the court system running without interruption.

"We are the clerk for the board of commissioners and attend all their meetings, take notes and prepare minutes. We take in all circuit court filing, prepare judgements attend all circuit court sessions, oversee elections and accumulate totals, process and maintain vital records such as birth, death, and marriage certificates and things like CPLs (concealed pistol licenses).

"We handle payroll and human resource for all Alcona County employees and do all the account payables for the county," she said. "There are a lot of things we do for the court system too. We do all

the jury notices and send out questionnaires. Some things we do only once or twice a year, but it all has to be done. A lot of people don't realize the volume of work the clerk's office does," Patti said.

Patti grew up in the Black River area. Her parents are Oliver and Kathleen De-Rocher. She graduated from Alcona High School in 1975, a year after her high school sweetheart, Harold, graduated.

Just after being hired at the courthouse, she and Harold married. Patti began working for the county just six weeks after her 18th birthday. She worked two and a half days in the clerk's office and two and a half days in the probate court office.

Although she never went to college, Patti was educated on the job and said the education was on-going for nearly all the 43 years she has worked for the county.

The biggest change over

High flying motocross stunts coming to the fair

High energy, high excitement and dangerous high-flying motocross stunts are coming to the Alcona County Fair this week.

Sick Air, a motocross bike stunt show, which has been performing for audiences of all ages for more than 16 years will be putting on a show on Friday, Aug. 17 at 7 p.m. at the fairgrounds track in Lincoln.

Sick Air owner, Scott Murray, said he and two other performers, Ed Rossie and Kal Werner, are planning to be at the Alcona County show. They do, however, have a full summer line-up of shows and what they do is very dangerous, so should one of them become injured, a backup performer will attend in their place. "It's a very physical sport and a daring thing to do. A stunt driver has to be precise and on point," Murray said.

The Sick Air team will perform stunts 30 feet in the air which include Superman stunt riding, which Murray explained as basically flying through the air looking like Superman on a dirt bike, Superman seat grabs which is the same only with the stunt driver grabbing the seat of the bike while airborne and their most dangerous stunt, back flips on dirt bikes.

"Back flips are the most

dangerous. The other stunts we call upright tricks, because the bike is beneath us. If we feel something isn't right during an upright trick we can just continue on the jump without performing the trick. With a back flip we are fully committed to the trick, the stunt driver is in it to win it because the bike is on top of us. It has to be precise, there is no changing your mind. Hopefully, we execute the trick and land safely with wheels down and ride away clean. That's the way it usually happens, but as you can imagine, flying 30 feet in the air with a dirt bike can be hazardous to one's health," Murray said.

Murray, who is 41, said he has been hurt many times while doing motocross stunts. "I have a metal rod in my left femur held by screws. I've had broken bones, suffered concussions, had multiple bruised ribs, torn ligaments and damaged tendons. Overall though, I've been very fortunate in my personal career," Murray said.

Murray explained when he was young all he ever wanted to do was to be a fighter pilot and fly jets, unfortunately

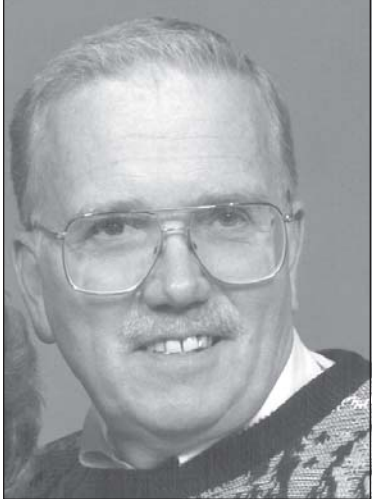
Harvey J. Hanner

The Alcona County Library Board would like to express its sincere thanks to the voters of Alcona County. In the August 7, 2018 election the library millage renewal was passed by a close to two to one margin.

We would like to note some of the services we provide to the entire county:

- Branch libraries in four locations -- Hubbard Lake, Lincoln, Mikado and Harrisville;
- Books, magazines, and reference materials;
- Twenty-four hour/seven days a week Wi-Fi access at all branches (at the community center in Hubbard Lake);

- Summer reading programs for all ages;

- Digitally circulated eBooks, audiobooks, music, and videos from the UPNorth Digital Collection (Overdrive) and Hoopla;

- Searchable digital copies of the Alcona County Review from 1877 to present;

vision problems excluded him from following his dreams. "It was devastating to me when I was told by military recruiting officers that because of my vision issues, my dreams were not something I could pursue. It was all I ever wanted to do," Murray said.

Murray found work after high school driving a logging truck, a common job where he lived and grew up in Helps, Mich., located in the middle of the upper peninsula. But not being able to fulfill his dream gnawed at him. He ended up getting in trouble with the law and lost his driver's license.

"Here I was in the middle of nowhere, the closest town being Iron Mountain, (Mich.) which was a 45-minute drive from Helps. I couldn't work without a license. I had to figure out something to do with my time. I always liked motocross racing and thought maybe I could be a professional racer. I began practicing and racing locally, but it's young man's sport. I found myself racing in my mid-20s against very young racers and my talent and skill level wasn't enough to compete with them," Murray said. Instead, Murray began doing tricks with his motocross bike which thrilled the race audience.

He practiced doing higher and longer jumps. A Monster Truck show came to Escanaba, Mich., and brought with them a team of motocross stunt drivers. After watching the show, Murray approached the stunt drivers and showed them pictures of his jumps and the track he built on his property which was a much

longer jump than most other tracks available. They invited him to jump with them the next day. One thing led to another and before long Murray was performing stunts for pay.

Murray cleaned up his life and got his driver's license back but continued making a living doing motocross stunt riding for quite a few years. Murray said he made a lot of mistakes when he was a young man, but he found his drug of choice to be adrenaline and he is a confirmed adrenalin junkie.

Today, Murray splits his year between stunt riding with his Sick Air company in the

spring and summer and owning a logging truck company which keeps him busy during the fall and winter.

He said the adrenalin junkie in him puts on an action-packed show which is very high energy, but Murray is also a family man with a seven-year-old son and four-year-old daughter, so making his show family friendly is very important to him.

"The four, five and six-year old kids really enjoy our show because to them we are like superhero's flying through the air. It is a high energy show, but we keep it clean for the little's (kids). We enjoy having them watch us, they have a lot of excitement for what we do, but so do the adults. We have fun performing. We are professionals and put on a great show that no one in Alcona County is going to want to miss," Murray said.

The Sick Air show is free with paid \$5 per person admission fee at the gate. Free parking and handicap parking is available. The Alcona County Fair runs from August 14 through August 18.

Fair time: It's all in the family

Families come in all shapes and sizes. Often its a nucleus of two parents and their children, but sometimes there is only one parent with children or a mixture of multiple parenting figures such as step mothers and step fathers including their children from previous relationships that make up the family.

month starting in April. The focus is to teach and help youth become comfortable in handling rabbits and swine and demonstrate different showing techniques. This group also discusses real life situations in the world and in the community and what they can do to help and strengthen community bonds.

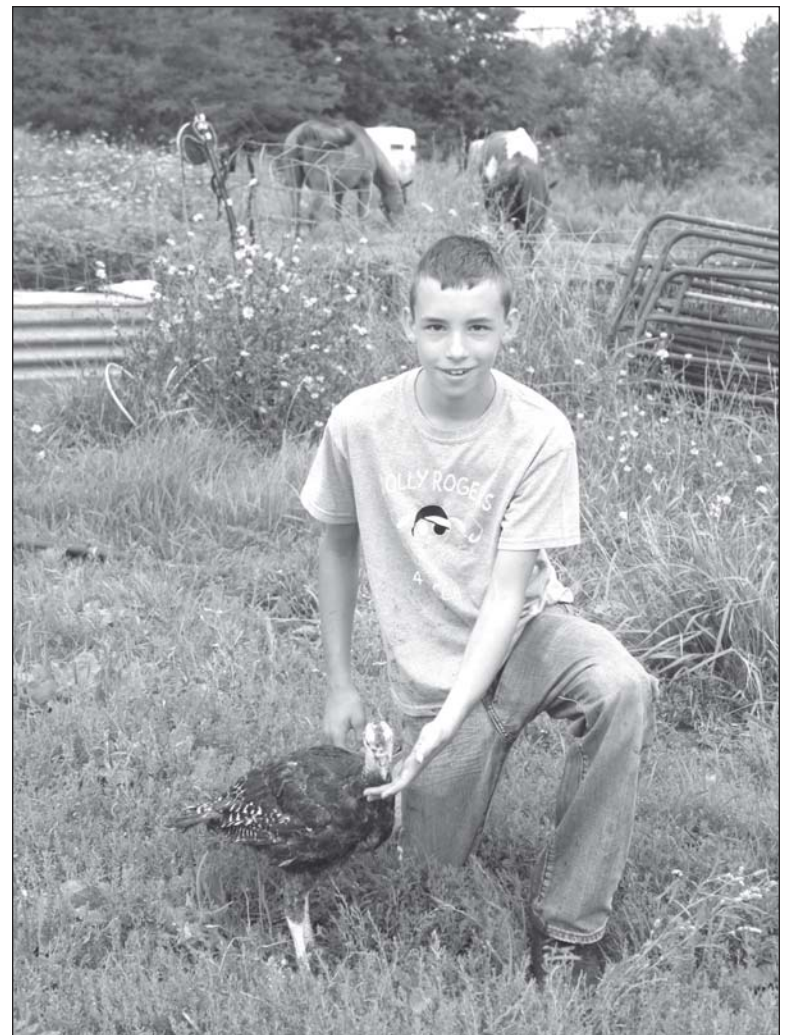

Retirement planning tips for single women

Dear Savvy Senior,
What retirement planning tips can you recommend to single women? I'm 54 and divorced with a teenage daughter and very little saved for retirement.

Financially Behind

Dear Financially,

It's an unfortunate reality, but most single women - whether they're divorced, widowed or never married - face much greater financial challenges in retirement than men. Why?

Because women earn less money - about 80 cents for every dollar that men make, on average, and they have shorter working careers than men due to raising children and/or caring for aging parents. And less money earned usually translates into less money saved and a lower Social Security benefit when you retire.

In addition, women live an average of five years longer than men, which requires their retirement income to

stretch farther for living expenses and healthcare costs. And, according to some studies, women tend to be less knowledgeable and more intimidated about financial issues than men, which means they don't always handle their money as well as they should.

Because of these issues, it's very important that women educate themselves on financial matters and learn how to save more effectively. Listed below are some tips and resources that may help.

- If your employer offers a retirement plan, such as a 401K, you should contribute enough to at least capitalize on a company match, if available. And if you can swing it, contribute even more. By law, you can save as much as \$18,500 in a 401(k) in 2018, or \$24,500 to those 50 and older, due to the catchup rule.

If you don't have a workplace plan, consider opening a Traditional or Roth IRA. Both are powerful tax-advantaged retirement savings accounts that let you

contribute up to \$5,500 annually, or \$6,500 when you're over 50. And if you're self-employed, consider a SEP-IRA, SIMPLE-IRA and/or a solo 401(k), all of which can help reduce your taxable income while putting money away for retirement.

Also, if you have a high-deductible health insurance policy, you should consider opening a health savings account (see HSAsearch.com). This is an excellent tool that can be used to sock away funds pre-tax and use them before or after retirement to pay for medical expenses.

- It's also important to get a handle on how much you need to save for a comfortable retirement. You can do this through a number of free online calculators like ChooseToSave.org or FinancialMentor.com/calculator.

- If you have debt, you need to get it under control. If you need some help with this, consider a nonprofit credit-counseling agency that

provides free or low cost advice and solutions, and can help you set up a debt management plan. To locate an agency, use the National Foundation for Credit Counseling website at NFCC.org or call (800) 388-2227.

- To help you educate yourself on financial matters like retirement planning, saving and investing, health care, annuities and more, a top resource is the Women's Institute for a Secure Retirement at WiserWomen.org.

And to help you get up to speed on Social Security, visit SSA.gov/people/women. This web page, dedicated to women, provides helpful pub-

lications like "What Every Women Should Know," along with links to benefit calculators and your personal Social Security account to help you figure out your future earnings at different retirement ages.

- You should also consider getting a financial assessment with a fee-only financial advisor. Costs for these services will vary from around \$150 to \$300 per hour, but this can be very beneficial to help you set-up a retirement plan you can follow. See NAPFA.org or GarrettPlanningNetwork.com to locate an advisor in your area.

Raising and showing fair animals, especially animals as big as a horse, can be difficult for youth. Sometimes there are difficult calls to make when raising an animal, sometimes it's not the call that's difficult, but the fall.

Things happen, animals get sick, get spooked, feel anxious or perhaps they are just not quite ready to get in the ring and be judged. Other times the animal may be too old to be judged. Youth learn a lot by getting to know their animals and, sometimes, by just getting back up and trying again.

Sydney Petty, 14, has lived in Alcona County all her life on her parent's farm with horses, steer, dogs, birds and more. She has had to make a difficult call this year regarding her horses and has decided not to enter them into this year's fair competition. "It's not that I don't want to, I do, but my younger horse, Duke, is four and he isn't ready yet and hasn't had enough experience. My older horse, Josie, is retired. She's 22. Sometimes you have to listen to your horse and let them decide. They will tell you when they are ready and when it's time to stop," Sydney said. She could show her horse for pleasure, but really does not enjoy that as much as speed competitions.

Sydney has also suffered a difficult fall from riding horses and sustained some fairly

serious injuries, but it hasn't dulled her love for the animals.

The fall happened four years ago when Sydney was 10. She was riding her horse, Chloe, bareback down a dirt road. "I had a helmet on but no saddle. My sister and her friend galloped past me on their horses and Chloe got antsy. I think she wanted to go with them but knew I was riding her bareback so she held back and just bucked. I flew up in the air and when I was on my way down, she bucked again and her hoof just got me in the face. When it happened, I remember knowing my name and my family, but I didn't know what happened," Sydney said.

Her sister had her cell phone with her and immediately called 911 and then called their mother, Jennifer Petty. "I knew something was wrong even before the phone rang, I just had a gut feeling. I didn't know where the girls were and the phone connection was very broken. I just grabbed my keys and drove watching the hoof prints until I found them.

"I knew the ambulance was called, but I didn't pass them and wasn't sure they would find her. I just threw her in the back seat of my car and drove as fast as I could to

Tawas. She wasn't even supposed to be on that road bareback, but I'm glad she had her helmet on or things could have been much worse," Jennifer said.

Sydney suffered a crushed nose, broken cheek bones and broke the orbital floor of her eye. From Tawas she was taken by ambulance to Hurley Medical Center in Flint, Mich. She spent a few days there and had two surgeries to repair her nose, the other bones healed on their own.

"I learned a few things from the experience. I learned to always tell your mom where you are going and to always ride with a helmet," Sydney said.

From time to time she still rides bareback, but only around the farm where her mom can see her.

Instead of bringing her horses to the fair, Sydney is concentrating on her market animals -- a finished beef steer she calls Carl and a pig. This is her first year marketing a steer. Last year Sydney marketed a young beef project and won reserve champion over all and earned about \$1,100 at market for him. Last year's pig brought in another \$1,000. Like most market kids, Sydney put some away for college and invested some in her animals for this year.

Today, Carl follows Sydney around like a puppy dog and seems to love being the center of attention, but it wasn't always that way. "You have to be brave to get in the pen with them. Carl was really wild when I first got him, but after a day or two he was fine. I would just go in and talk to him about random things. I'd tell him it was going to be okay and that I was his mom now.

"I'm very excited to show and sell him. It's hard work every day and I've been working with him since December. It's important to halter break the steer and get them to walk next to you without running you over. He's pretty big, he weighs about 1,300 pounds now and should finish out at over 1,400. I take him for walks over our bridge and I spend a lot of time with him. He's a good boy," she said.

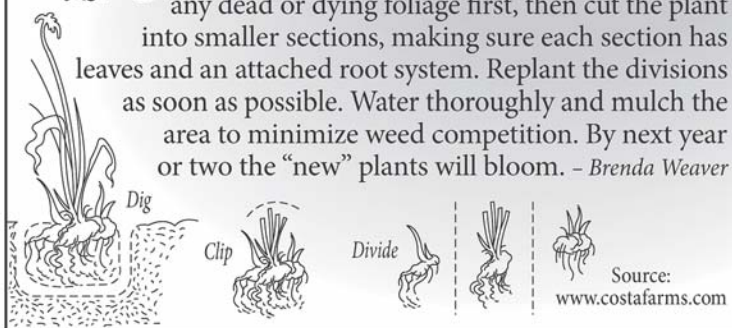

Dividing perennials

Dig around the plant, leaving some soil around the roots. Gently lift out the entire plant, and place it on the ground. Clip away any dead or dying foliage first, then cut the plant into smaller sections, making sure each section has leaves and an attached root system. Replant the divisions as soon as possible. Water thoroughly and mulch the area to minimize weed competition. By next year or two the "new" plants will bloom. - Brenda Weaver

being part of a large family and being in the club meant, "The biggest thing with the Jolly Rogers group is when we work, we work together. We have campouts to get posters and things done for the fair. It's a group effort, everybody comes and we all work together. We are one big family. Some of us really are family but the others in the group are our family too."

They talked about what the Alcona County Fair meant to them, what they liked and

disliked about it and showing and marketing animals.

Joe said he enjoys showing the animals because he gains experience each time. Isaiah, the youngest in the family, is looking forward to showing his first rabbit, but has lofty goals to show a pig sometime soon. He also said the rides at the fair were a lot of fun too.

Matt said answering the question the judges ask during showing can be difficult. "They ask random questions about the animal, so you need

to be prepared to answer anything about it without hesitation," Cassady said.

According to Cassady, there is never specific questions the judge will ask but questions are based on the age and ability of the person showing the animal. "Beginner questions will be easier than questions asked of someone older with more experience showing an animal. One judge asked me what the most expensive cut of meat was. That's something a lot of people don't know. It's the pork belly. Think about it, bacon has gotten pretty expensive," Cassady said.

Sometimes it is difficult to sell an animal. Cassady said she has gotten quite attached to her steer this year who she named Alice because he reminds her of Alice Cooper. "Alice is a really nice steer. He's very sweet and it will be hard to sell him for beef," she said.

Cayden questioned why market kids name their animals. He feels that as soon as an animal is named a bond is formed. "It's too easy to get attached," he said. Cayden will be marketing two unnamed turkeys and a pig at the market sale. His brothers, Dylan, Matt and Joe will each be marketing a young beef project and a pig.

The family visits their animals often to care for them and work with them and help each other build confidence answering questions and showing their animals.

While working with the family's pigs, Cassady explained that pigs don't sweat, which is why they wallow in the mud to keep them cool. "They are actually really clean animals even though they don't look like it today. We've had a lot of rain," she said as she sank into the mud nearly up to her knee and reached into their food trough to make sure they all got their fair share to eat. A little bit of mud is nothing to a farm kid.

The barns at the Alcona County Fair will be open from 10 a.m. to 10 p.m. August 14 through August 18. There will be 4-H or Alcona Junior Livestock Market Club youth available in each barn to answer questions.

Show judging of the animals happen throughout fair week, consult fair program for times. The auction for the Alcona Junior Livestock Club Market Sale begins at 5:30 p.m. Thursday, Aug. 16 in the Joslin Arena.

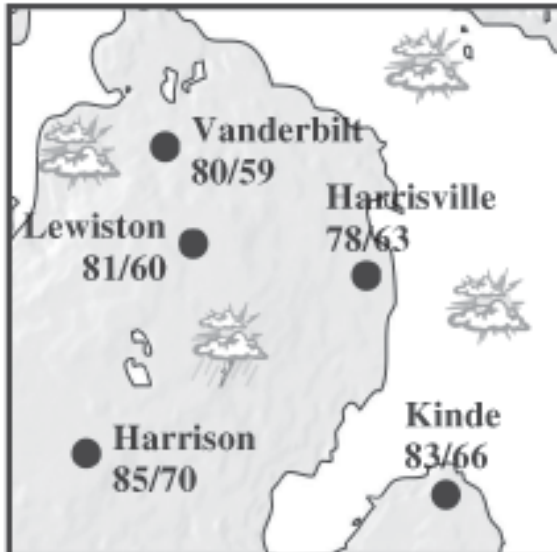

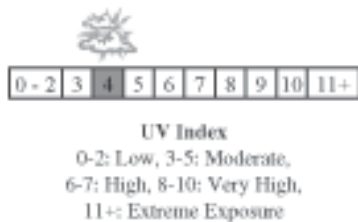

StarWatch By Gary Becker - Mass: A Weighty Concept

"So you want to become rich?" I query my class in this thought experiment. I have become so famous as an astronomy celebrity (I'm fascinated by Neil de Grasse Tyson) that Madame Tussauds in NYC wants to make two wax "dummies" of ME and showcase them in an upcoming exhibit that will be featured in space. One dummy will be constructed in a normal fashion while the other one will be a wax coating of me under solid gold. Both will look exactly like me and be encased in a genuine NASA spacesuit. You, as the 50 millionth visitor to a Madame Tussauds museum, will be trained and flown to the International Space Station, and learn how to spacewalk so that you can choose a "Gary A. Becker" to take home with you. Obviously, you want the gold GAB and so do your 237,000 new Facebook friends. The moment has finally arrived. You're outside the ISS in your spacesuit, and the two GABs are side-by-side in tandem with the ISS. What experiment will you perform to insure that the gold GAB, worth 3.5 million dollars, is chosen? There's silence in my classroom. Thirty seconds, a minute flashes by... A hand slowly rises amidst a sea of students with downward looking stares. I recognize her. "Push them equally," she says. "The gold dummy will move away more slowly than the wax dummy." That is exactly the experiment I would perform too. 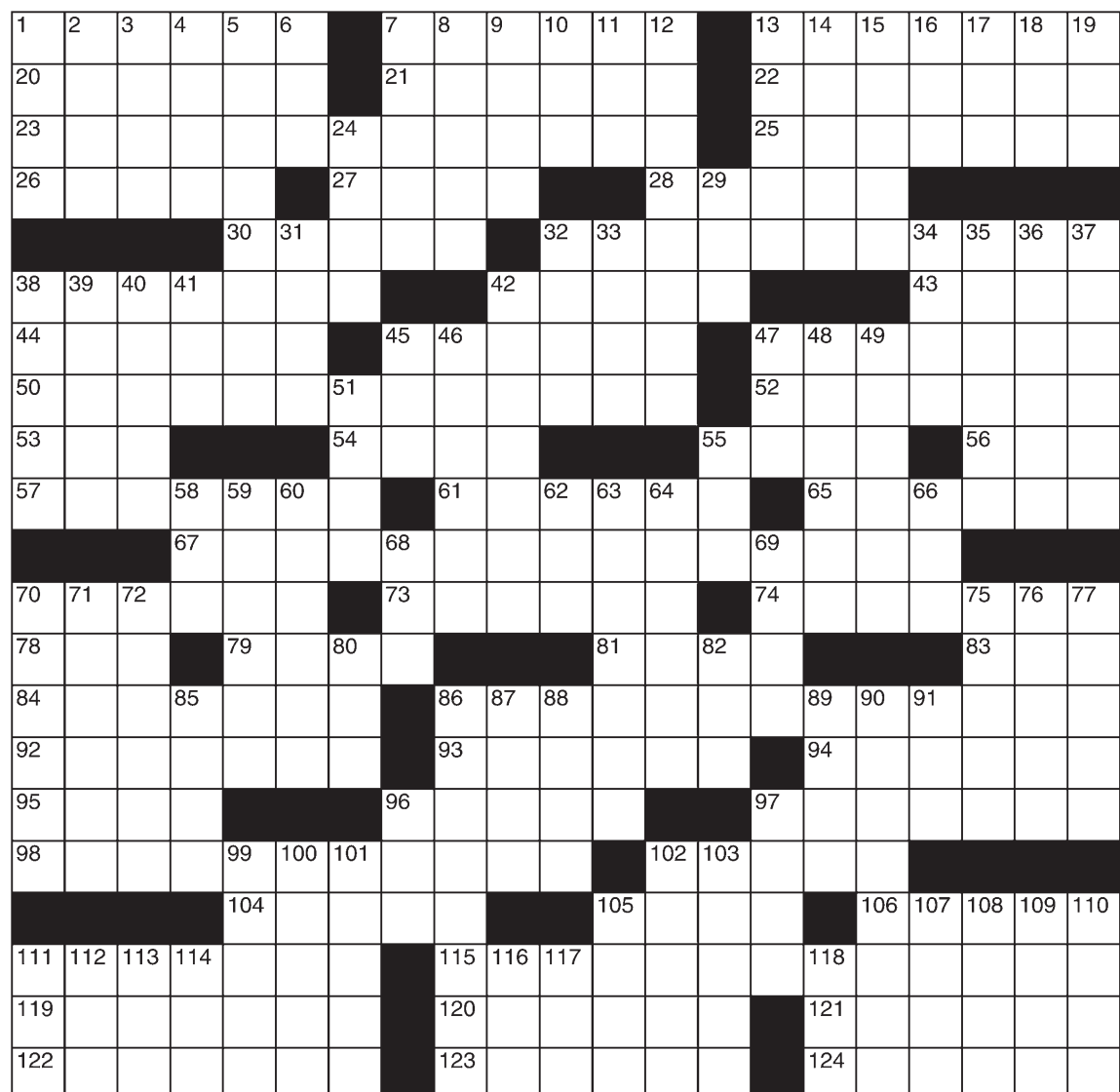

 - On Aug. 21, 1987, "Dirty Dancing," starring Patrick Swayze, opens in theaters. The film was a surprise box-office hit and turned Swayze into a Hollywood star.
 - On Aug. 22, 1992, in the second day of a standoff at Randy Weaver's remote Idaho cabin atop Ruby Ridge, an FBI sharpshooter wounds Weaver and Kevin Harris, and then kills Weaver's wife, Vicki, who was in a doorway holding her infant daughter.
