My wife and I met our 34-year-old son and his family for dinner one night last week. He ordered a soft drink. It was delivered with a paper straw. Headlee Override will not fix mismanagement. Alcona County's negative approach to financial crisis should not scare voters into passing Headlee Override. Threats of job loss, reducing this and that should be replaced with a "Positive \$800,000 Plan."

Voters need to be informed of what is/is not happening within Alcona County government. Published agendas, board minutes, and criminal activities will inform and promote transparency. Plans to reduce patrols should not be a problem as we have an active Michigan State Police field office in Lincoln, two state police officers residing in county, plus DNR officers, all being fully mobile and equipped for emergency response, plus HUNT.

Patrol duties need reviewing for frivolous responsibility; or those mandated to other agencies. Recent Resource Officer plan was to hire a full time officer with school funding two thirds - now we have none. "Scare!" "Scare!"

Reduction of services at Veterans Affairs Office: If you reduce nothing, do you have minus nothing? County commissioners made their feelings toward veterans known when they relocated the VA Office to a remote annex building. Alcona has a large population of veterans. Support them and they will support you.

Building cleanliness should be performed by court ordered community service. "Special Perks," unearned health insurance, etc. should

be reviewed and abolished. What happens to profits from tax foreclosure sales? How many tax-exempt properties are legitimate? Booming real estate sales and values increase property tax revenue. Patrol car mileage limits should be increased before liquidation. Sheriff and undersheriff should return their personal police cars to fleet and they drive "excessive mileage" vehicles. Encourage public participation in government meetings, reporting crimes, accidents, and/or potential county problems. Then say, "thanks," appreciation goes two ways, they may be your next "yes" vote.

Government transparency and credibility must be improved before next millage request.

Alcona was forced into a three-and-out on its first two possessions of the third quarter, allowing the Braves to take leads of 34-18 and 41-18.


Howe finished off the Alcona scoring with his third score of the night, as he ran from 10 yards out to make it 41-24 early in the fourth quarter.

## Glow lures are popular with Great Lakes salmon

Salmon fishing on the Great Lakes is really hitting its stride as many species are getting ready to begin their upstream migration.

One tactic that can be particularly useful when targeting Chinook is fishing with glow lures. This species can often be caught near the surface in low-light conditions and glow lures make that opportunity even more appealing.

In particular, glow lures work well in the early morning hours before the sun comes up or at night. Many believe this type of lure attracts salmon because it can be seen in the dark from longer distances and encourages them to strike.

### Northeast Lower Peninsula August 22

• **Rogers City:** Reports from this area were mixed with anglers catching Chinook, lake trout, steelhead, Atlantics, walleye and the occasional coho. The best depths seemed to be anywhere from 50 to 100 feet of water with anglers deploying lines throughout the water column using downriggers, dipseys, lead cores and copper.

Spoons worked better with the cold water while flashers with flies, cut bait and j-plugs worked better when the water was warm. Good spoon colors included bloody nose, black and white, purple,

blues, greens, oranges and glow stuff early or late.

• **Alpena:** The humps produced for lake trout and anglers did well fishing the Nordmeer Wreck. The best depths were 80 to 130 feet and fishing near the bottom. A couple of steelhead were also caught on higher lines. Walleye did well at Rockport and Presque Isle with anglers fishing them suspended with crank baits or crawler harnesses in 30 to 80 feet of water while fishing the top 30 feet.

• **Thunder Bay River:** Shore anglers used live bait and caught lots of smaller rock bass, smallmouth bass, freshwater drum and the occasional walleye. Overall, fishing was slow.

• **Black River:** Northern pike were caught while casting cranks at the river mouth and channel catfish were caught while still fishing night crawlers in the late evening and early morning. Those trolling stick baits found walleye around structure between Black River and South Point in the dawn and

dusk hours.

• **Harrisville:** Those targeting salmon and trout found lake trout near bottom or 40 to 60 feet down in 85 to 150 feet of water between the Harrisville Harbor and Sturgeon Point. Spoons and spin-gloves worked best. The occasional Atlantic was caught in the early morning hours by anglers trolling spoons on lead core 30 to 50 feet down. Walleye were caught while suspending in 60 to 120 feet or in 20 to 35 feet during low-light hours.

• **Oscoda:** Lake trout were caught while trolling spoons, spin-gloves and meat rigs near bottom or 50 to 70 feet down in 85 to 12 feet, or as far out as 140 feet. Steelhead and the odd Atlantic were taken on spoons 30 to 70 feet down. Walleye were caught on spoons while suspended over 60 to 120 feet.

Pier anglers fishing late at night and early in the morning had a few channel catfish catches while still fishing stink baits or night crawlers.

## Financial aid for family caregivers

Dear Savvy Senior,  
Do you know of any resources that help family caregivers monetarily? I have to miss a lot of work to take care of my elderly mother and it's financially stressing me.

Stretched Thin

Dear Stretched,  
Caring for an elder parent can be challenging in many ways, but it can be especially difficult financially if you have to miss work or quit your job to provide care. Fortunately, there are a number of government programs, tax breaks, and other tips that may be able to help you monetarily while you care for your mother.

• **State assistance:** Most states have programs that help low-income seniors pay for in-home care services, including paying family members for care. These programs – which go by various names like “cash and counseling” or “consumer-directed” – vary greatly depending on where you live and, in some states, on whether your mom is on Medicaid.

To find out what's available in your state, contact your local Medicaid office.

• **Veterans benefits:** Veterans who need assistance with daily living activities can enroll in the Veteran-Directed Care program. This program, available through VA Medical Centers in 40 states, as well as in Washington, D.C., and Puerto Rico, provides as much as \$2,000 a month, which can be used to pay family members for home care.

Visit the “Home and Community Based Services” section at [VA.gov/geriatrics](http://VA.gov/geriatrics) for information.

• Also available to wartime veterans and their surviving spouses is a benefit called Aid and Attendance, which helps pay for in-home care, as well as assisted living and nursing home care. This benefit can also be used to pay family caregivers.

To be eligible your mother must need assistance with daily living activities like bathing, dressing or going to the bathroom. And, her annual

income must be under \$14,133 as a surviving spouse or \$21,962 for a single veteran, after medical expenses. Her assets must also be less than \$80,000 excluding her home and car. To learn more, go to [Vets.gov/pension](http://Vets.gov/pension).

• **Tax breaks:** If you pay at least half of your mom's yearly expenses, and her gross income is below \$4,050 (in 2017) not counting her Social Security or disability, you can claim her as a dependent on your taxes and get a \$500 tax credit. For more information, go to [IRS.gov/help/ita](http://IRS.gov/help/ita) and click on “Whom May I Claim as a Dependent?”

If you can't claim her as a dependent, you may still be able to get a tax break if you're paying more than half her living expenses including medical and long-term care costs, and they exceed 7.5 percent of your adjusted gross income. You can include your own medical expenses in calculating the total. See IRS publication 502, Medical and Dental Expenses ([IRS.gov/pub/irs-pdf/p502.pdf](http://IRS.gov/pub/irs-pdf/p502.pdf)) for details.

• **Long-term care insurance:** If your mother has long-term care insurance, check whether it covers in-home care. Some policies permit family members to be paid, although they may exclude people who live in the same household.

• **Paid caregiver leave:** A small but growing number of companies offer paid caregiver leave as a way to recruit and retain their workforce. Additionally, some states provide caregiver benefits or paid leave to take care of ailing family members. Check with your employer to see what, if any, benefits are available to you.

• **Family funds:** If your mother has some savings or

other assets, discuss the possibility of her paying you for the care you provide. If she agrees, consult with an elder law attorney about drafting a short-written contract that details the terms of the work and payment arrangements, so everyone involved knows what to expect.

• You should also check [BenefitsCheckup.org](http://BenefitsCheckup.org), a free, confidential Web tool that can help you search for financial assistance programs that your mom or you may be eligible for.

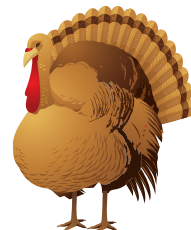

Freshwater drum, small-mouth bass and rock bass were also caught.

• Au Sable River: Channel catfish, smallmouth bass, freshwater drum, rock bass, bowfin, sunfish, yellow perch and undersize walleye were all caught by anglers while still fishing night crawlers and minnows. Northern pike were found by anglers casting spoons in the weedy still waters.

• Houghton Lake: Fishing slowed down but anglers were still finding some walleye, bass and bluegill. Popular timeframes have been early morning and late afternoon/early evening. Walleye were found in the deeper parts of most drop-offs with crawlers, leeches or crank baits in greens, chartreuse or fire tiger. Bluegill were liking wax worms or leeches in eight to 10 feet and bass were active in six to 10 feet with anglers

casting worm rigs or spinners.

• Tawas: Walleye anglers fishing around the weed beds up in the "armpit" of Tawas Bay took a few walleye near buoys 4 and 6. Those targeting perch found a few small ones but nothing big enough to keep. Outside of the bay trollers caught walleye on harnesses beyond buoy 2 and down by the Bell Buoy in 35 to 50 feet of water. Some steelhead were taken from 70 feet around Tawas Point and up to Au Sable Point

• Au Gres: Walleye trollers were fishing in 30 to 40 feet of water with some success, as well as going north to the vicinity of the Bell Buoy off Whitestone Point. Off Eagle Bay Marina, some walleye were taken in 15 to 20 feet of water on harnesses and some yellow perch were caught on minnows off the Saganing and Pinconning bars.

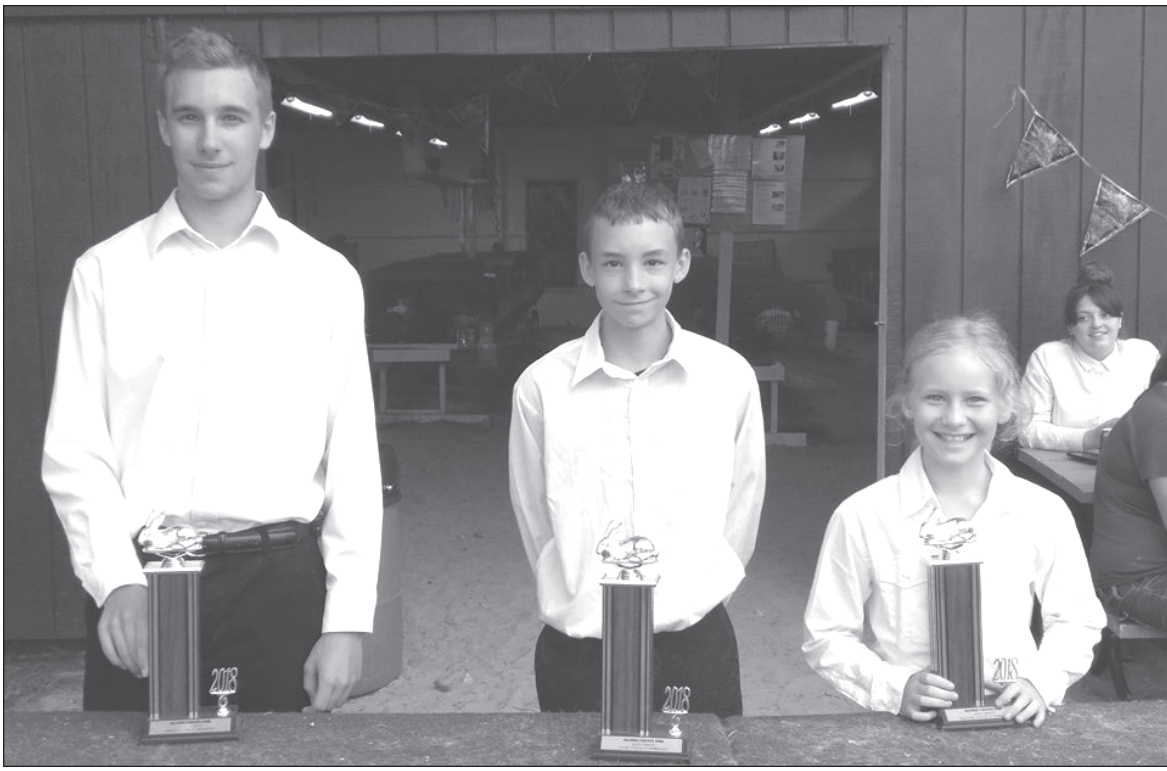

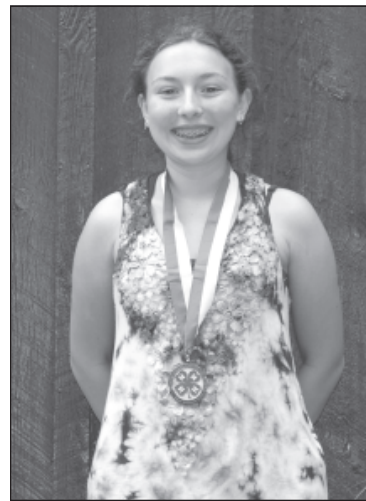

## More Gold Stars in Alcona's Flag

Corp. John E. Armstrong and Albert A. Lange Killed in Action Aug. 5.

**August 28, 1918** ~ William Armstrong of Haynes Friday received a telegram from Washington announcing the death of his son John in France. "Officially reported killed in action August 5", the message read.

John was born in Haynes township on August 22, 1894, and would have been 24 years of age had he lived a few days longer. He enlisted on July 26, 1917, at Fort Brady in Co. D, 33rd Michigan Infantry. Co. D was known as the Alpena company and several other Alcona boys joined that company about the same date. Later the company went into the national army as Co. F, 125th Infantry and has been in France several months.

Young Armstrong was known and respected for his sterling worth and was held in high esteem throughout Haynes township. He wrote regularly from the front to his father and sisters and always his letters were in a cheerful vein, encouraging the folks at home and urging them not to worry about him. He was proud of his life as a soldier and of the work his government had undertaken. He was a corporal at the time of his death. "I hope he took his toll and wish he had lived to get more of them", was the father's comment upon his son's death.

Besides the father he leaves three sisters and four brothers—William of Co. B 135th M. G. Br., Franc; Mrs. Arthur McIntyre of Harrisville, Robert, Mark, Elizabeth, Celina and James at home.

A letter from Washington followed the telegram, stating details of the soldier's death would be sent from the commanding general as soon as it was possible.

The last letter received from John was dated July 30th. Extracts from this and another dated July 7 follow:

July 30:—Dear Father. Have you heard from brother Will yet? I hope he is well and having a good time.

Well, here is where the big noise is that you have no doubt read about by this date and a little while before.

Well, pa, I wish that I could tell you more about this but it wouldn't do any good so I won't. Suppose you are all done harvesting; how are the crops? did you have much hay? In some sections here the wheat is fine and lots of it and in others there is nothing left and never will be anything—I don't think it can ever be leveled down enough to work well.

Well, Pa: give my best regards to all the folks. As ever Your loving son,  
Corp. John E. Armstrong.

"Dear Father:—Just a few lines to let you know I am well and hope you are the same. We are having very warm weather and I hope it will stay nice, as you know it is not

very nice when it rains. Well, I will have my liberty bonds paid for this month, so it won't be long until you get the money—that is if you want to cash them. I have three of them and if you don't need the money yourself you can buy some young cattle for me, or colts, or anything that will bring in a good income—or put it in the bank, as you think best. I also am sending two big shells, engraved, which are fine and will make good vases.

"Well, Pa, whatever you do take good care of yourself and be good to Celina and Lizzie. Good bye, with love to all — John."

On Saturday August Lange and Greenbush township re-

ceived a message stating his son Albert had been reported killed in action on August 5, the same date that John Armstrong was killed.

The message did not give the name quite right, using "A Lang" instead of Albert A. Lange, and the father has not lost hope that there may be some error and that his boy is still alive.

Private Lange was born May 20, 1890, in Saginaw and had lived in Alcona county several years. He went to training camp with the quota of selected men leaving Harrisville on September 21st, 1917, and later was placed in Co. F 125th Inf., the same company that John Armstrong was in.

He and Armstrong were

friends and in his letters home Lange mentioned John on several occasions.

Besides the parents, several brothers and sisters survive.

The following letter was received by the parents a short time ago; it was date July 26 and postmarked August 5th, the day of their son's death:

France, July 26, 1918.

Dear Father and Mother:—

Just a few lines to let you know I am in the best of health and getting along fine, and hope to hear the same of you all. I wrote you a letter a week ago and intend to write home at least once a week and I hope you will do likewise. I sent you some gifts the same day I sent the letter, so when you write let me know if you

received them.

We have just moved to another place and I had the pleasure of seeing the city of Paris. It sure is a fine city, but not as pretty as New York.

We are having very hot weather here at times, so hot we can hardly stand it—and I saw some very hot times while in the trenches—Ha! Ha!

Well, I presume the farmers are busy threshing grain by this time. I certainly saw some fine grain fields on our trip; all crops are fine, and by the reports the crops are good in the U. S. A.

Well I must close now. Will write more next time. Hoping for an early reply and with best wishes for your future, I remain as ever, Your son, Albert A. Lange.

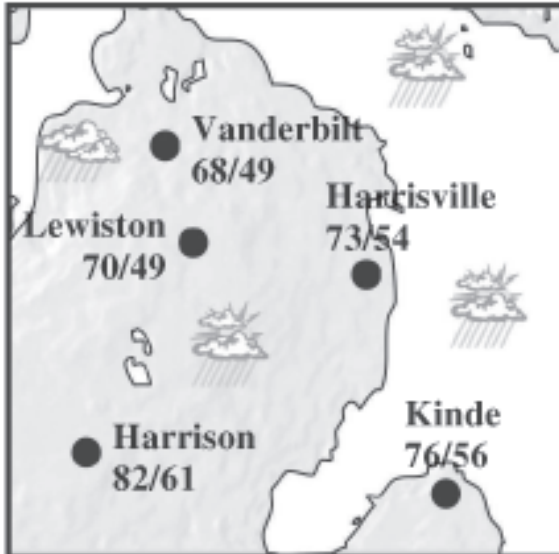

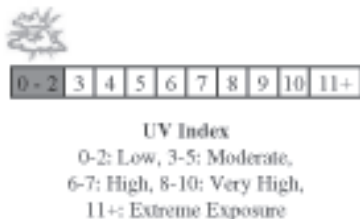

#### StarWatch By Gary Becker - It's Just Another Day on Mars

I admire Peter K. Detterline's attitude. He is the lead astronomer and visionary for the Mars Desert Research Station Robotic Observatory. Moravian has a 25 percent telescope timeshare in this endeavor, and Pete is gearing up to teach an online astronomy course about observational techniques this fall. When trouble arises, Pete says, "It's just another day on Mars," and in a realistic way it could be much worse. If we were on ruddy Mars, now shining brightly low in the south around 11 p.m., we'd have to suit up before going outside to fix some of these problems; whereas at MDRS all we have to do is open the hatch. On an even brighter note, the sun pushed temperatures into the low 100s on this August 1 day, but the robotic observatory seemed to be functioning properly with the clamshell dome opening and closing remotely and the cooling fans of the cameras humming and whirling confidently. That was before the power loss, but we brought everything back online again this morning. On that first night, we slept outside. When I awoke around midnight, the moon was up, and ruddy Mars was shining brightly in the south. Two hours later, still conscious and now getting cold, I popped back into the habitat and finished the night in my bed, a little uncomfortable because of the heat, but okay enough to sleep. The next morning, things did take a turn for the better. With the sun now shining, the solar power returned, but the system was not charging. We checked the fluid levels and tested the backup power generator. It started, and then ran continuously for the next six days. There are support people from the Mars Society on call when problems arise, and they respond quickly with good advice. We also managed to get the swamp box operational, an evaporative device that circulates air through a moist, water-absorbing material, cooling the habitat's interior by at least 20 degrees Fahrenheit. It works exceptionally well in low humidity areas like deserts, and is similar to the way you feel after emerging from a swimming pool on a windy, summer afternoon. ## Moments In Time

Of the 398 registered voters on the city's current voter list, 171 voted in this election. A very big thank you to the city's election inspectors, Marjory French, Debra Halsey, Valerie Bakker and Karen Wingate, for a job well done in making election day a success. Mayor Dobis advised council as to the millage levy for water/ Sewer for December (winter) taxes. The 2018 millage rate for the general fund will be 6.0032 mills, which is the maximum allowable by law. The water millage was 1.5000 mills and has been paid off. The new bond improvement rate will be 3.300 mills, which is lower than the maximum allowable by law. These levies are subject to review as revenue figures become available. Council will be informed of any changes that need to be made. Mayor Dobis presented to council a request from Ryan and Sandy Mendyka for permission to organize and hold a Labor Day Parade on Sunday, Sept. 2. Motion by Baird, support by Kaiser, for Ryan and Sandy Mendyka to go ahead with plans for this year's Labor Day parade. Motion carried: 5-0. City tax assessor Randy Thompson discussed how valuations of property are calculated for property taxes and that a property owner with commercial property in the City of Harrisville and Harrisville Township has filed a protest with the state as to the valuation of his property. Any resident has the right to file a protest and a petition to appear before a tribunal judge as to the request for a ruling on that petition. Motion by Luenberger, support by Peterson, to hire a lawyer to represent the City of Harrisville and to litigate the grievance filed by the property owner. Motion carried: 5-0. Reports: Clerk Pierce reported the Summer Concert Series had to cancel one scheduled concert this season because of the

weather. A thank you to the volunteers who helped collect the donations offered by the audience, and a contribution from the Greenbush Chamber of Commerce. Many positive comments were received as to the variety and quality of entertainment this year. A special thank you to the members of the Alcona High School Spanish Club for supplying our audience with popcorn and refreshments in your effort to raise money for the upcoming club trip to Peru. Thank you. Treasurer Keerl reported there will be a budget adjustment to the minor street account for the street work to be done on Second Street. Michael Baird informed council this boating season is going well even with dock construction continuing throughout the season. A letter was received from a boater who has done the "loop" trip from Ft. Lauderdale, Fla., up the Atlantic Coast, through the St. Lawrence Seaway and into the Great Lakes to Harbor Springs. He complimented the harbor crew for their professionalism, their knowledge of boat handling, and their appearance. A special thank you was given to our Harbormaster Jim Ferguson for his management of the harbor. The letter also stated that this boater would highly recommend Harrisville Harbor as a place to stop and that it was the best port of all his stops on his entire trip. Well Done. Planning Commission Chairperson Pizer reported the commission is continuing with work sessions focusing on reviewing the zoning ordinances. A member of the DDA from the state will meet with the commission in September to continue work on the RRC proposal. Tree Board member Luenberger reported on the list being kept as to trees in the city which need attention. County Commissioner Johnston reports the Headlee proposal lost in the county vote and a referendum will be placed on the November general election ballot for a county mileage proposal to offset the monies unavailable from the Headlee loss. Because of the Headlee loss, county cuts in revenues will go into place this month. Fire chief Klukowski reported three new volunteer fire fighters have joined the department. Also, a new door has been replaced on the fire department hall. Mike Baird stated that a new joint fire agreement has been written by the members of the fire board which include two members of Harrisville City Council and two Harrisville Township trustees. This agreement now goes to the City of Harrisville City Council and Harrisville Township Board of trustees for a vote. August 15 is the next fire board meeting. Comment cards: Guest Patty Thomas addressed the tax valuation question, and the trees at the airport. Councils last comments: Alderman Kaiser reported that the city compost yard is being very well kept and is easily accessible. Alderman Baird reported that after 42 years of organizing the Children's Parade for the Fourth of July, Mary Lou Webb has decided to retire and will no longer be available for this event. Mary Lou Thank You for all these years of a very special event which is looked forward to eagerly by the community. You will be missed. Mayor Dobis moved meeting to be adjourned. ## Three ways to use your lawn to improve curb appeal

Returns on home improvement projects vary. In its annual Cost vs. Value Report, Remodeling magazine notes the projects that yield the best returns on investment in a given year. But a host of factors, including the type of market (buyers' or sellers') and the region where the home is being sold, ultimately combine to determine if homeowners' investments in home improvement projects will provide the returns they were hoping for.

Though there's no way of guaranteeing a home improvement project will yield a great return, real estate professionals often cite improving curb appeal as an excellent way to attract prospective buyers and potentially get the asking price or more when selling the home. Improving curb appeal makes even more sense in today's real estate market, when many people do their own searching via real estate websites such as Trulia or Zillow. When using such sites, buyers will likely be less inclined to click on a listing if exterior photos of the

property are not eye-catching.

Various projects, including tending to lawns and gardens, can improve curb appeal. An added benefit to focusing on landscaping to improve curb appeal is it promotes spending time outdoors in spring and summer. In addition, many lawn- and garden-related home improvement projects need not require professional expertise.

### 1. Maintain a lush green lawn.

Lawns that fall into disrepair may not give buyers a correct impression about how homeowners maintained their homes. Lawns with multiple dead spots and grass that appears more brown than green may lead many buyers to assume that the home's interior was equally ill-cared for. Maintaining lush green lawns is not as difficult as it may seem. Applying fertilizer and aerating at the appropriate times of year (this varies by region) can promote strong roots and healthy soil, making it easier for grass to survive harsh conditions like drought. When watering in summer, do so in early morning or evening so as little water is lost to evaporation as possible.

### 2. Address brown patch.

Even well-maintained lawns can fall victims to brown spots. According to the lawn care professionals at TruGreen, lawns in regions with hot temperatures and high humidity can be infected with brown patch, a common lawn disease that is caused by fungus, which can produce circular areas of brown, dead grass surrounded by narrow, dark rings. Penn State's College of Agricultural Sciences notes that removing dew that collects on grass leaves each morning, which can be accomplished by mowing or dragging a water hose across affected areas, can be an effective way to reduce brown patch. Homeowners without much lawn care experience can consult professional landscapers to address the issue. But those looking to sell their properties should note that buyers often walk the grounds of homes they are considering buying. So addressing any issues on the lawn should be a priority for sellers.

### 3. Confine dogs to certain areas.

Dog owners may want to let their pets roam free in their yards. But homeowners about to put their properties up for sale may want to confine their four-legged friends to certain areas. That's because dog urine can be high in nitrogen. Nitrogen itself is not harmful to lawns, but in high concentrations it can contribute to yellow or brown spots. Also, highly acidic dog urine may even adversely affect pH levels in the soil.

Curb appeal can go a long way toward helping homeowners sell their homes, and a lush lawn can be used to catch the eye of prospective buyers. GT184855
