## Hope Shores Alliance provides support to help end domestic violence

October is Domestic Violence Awareness Month, a time for communities to work together to bring hope, help and healing to afflicted victims.

Domestic violence has no boundaries, it affects people regardless of their sexual orientation, gender, race, religion, or socioeconomic status. A domestic violence household distresses everyone in the home, including children and family pets.

To bring awareness of the prevalence of pet abuse in homes where there is domestic violence, Hope Shores Alliance has been painting communities it services purple by placing purple pom-poms on trees in parks and county courtyards and recently held a Paws in the Park fun day in Alpena.

Hope Shores Alliance is a private, nonprofit agency that provides safe shelter and supportive services to victims of domestic violence and sexual assault serving Alcona, Alpena, Iosco, Montmorency and Presque Isle counties, according to Jeanine Kaltz, education and impact manager for Hope Shores Alliance.

She explained that abusers often threaten or kill animals to establish power and control in a domestic violence dynamic.

The National Coalition Against Domestic Violence explains that batterers frequently threaten, injure, maim, or kill their partner's pets or children's pets in conjunction with domestic violence. Nationally, 71 percent of pet owners entering domestic violence shelters reported their batterer had threatened, injured or killed a family pet.

"Domestic violence is about power and control with the abuser exerting all of it. Talking to survivors it's shocking how many animals are hurt, threatened and killed. When we think about the relationships we have with our own pets, it makes sense. Pets bring us love and comfort. Abusers use this as leverage to control. If an abuser hurts a child, there is probably going to be a ramification, but if they hurt a pet, there are much fewer ramifications," Kaltz said.

She explained many survivors of domestic violence feel unable to escape because they are afraid of what will

happen to their pets when they leave. Kaltz was very thankful the Pet and Women Safety (PAWS) Act was signed into law last December.

The PAWS Act provides a grant program for domestic

violence shelters to enable them to better meet the housing needs of survivors with pets and service and emotional support animals. The law also provides additional tools for protecting victims

from their abusers with the inclusion of pets in personal protection orders.

Kaltz explained even before the law came into effect, Hope Shores Alliance was

## How to identify physical and sexual abuse

Physical and sexual abuse, or threats to commit them, are the most apparent form of domestic violence and are usually the actions that allow others to become aware of the problem.

However, regular use of other abusive behaviors by the abuser, when reinforced by one or more acts of physical violence, make up a larger system of abuse. Although physical assaults may occur only once or occasionally, they instill threat of future violent attacks and allow the abuser to take control of their partner's life and circumstances.

Very often, one or more violent incidents are accompanied by an array of other types of abuse which are less easily identified, yet firmly establish patterns of intimidation and control in the relationship including:

**Coercion and threats:** Making and/or carrying out

threats to do something to hurt a partner. Threatening to leave, commit suicide, or report the partner to welfare. Making the partner drop charges or do illegal things.

**Intimidation:** Making the partner afraid by using looks, actions and gestures. Smashing things. Destroying the partner's property. Abusing pets. Displaying weapons.

**Emotional Abuse:** Putting the partner down. Making the partner feel bad about themselves. Calling the partner names. Making the partner think they are crazy. Playing mind games. Humiliating the partner. Making the partner feel guilty.

**Isolation:** Controlling what the partner does, who they see, talk to, what they read and where they go. Limiting the partner's outside involvement. Using jealousy to justify actions.

**Minimizing, denying and blaming:** Making light of the

abuse and not taking the partner's concerns about it seriously. Saying the abuse didn't happen. Shifting responsibility for the abusive behavior. Saying the partner caused it.

**Using children:** Making the partner feel guilty about the children. Using the children to relay messages. Using visitation to harass the partner. Threatening to take the children away.

**Economic abuse:** Preventing the partner from getting a job. Making the partner ask for money. Giving the partner an allowance. Taking the partner's money. Not letting the partner know about or have access to the family income.

**Male privilege:** Treating the partner like a servant. Making all the big decisions, acting like the master of the castle, being the one to define men's and women's roles.

## Alcona breezes by Coleman

A strong defensive effort. A season high offensive output.

The Alcona varsity football team had both occur last Friday night, allowing the Tigers to claim a non-conference win 44-6 at Coleman.

"This was a great team win," said head coach Jason Somers. "We finally saw both sides of the ball together on one night. I was very excited for this group of kids, they worked hard, had fun and played with passion."

The game was scoreless after the first quarter, but Alcona put in a pair of scores in the second to take a 14-0 lead at the half. The Tigers scored two more touchdowns in the third quarter to take control of the game. They were ahead 28-6 entering the fourth, where they scored two more touchdowns and added a pair of two-point conversions.

"The big advantage that showed through was playing with emotion and determination," Somers said. "I think that our kids showed more resilience than in the past, their ability to stay focused and stick to the game plan played a big role in the success they found."

The Tigers were led by Mason Clark who had 169 yards and three touchdowns on 14 attempts. Dominic Howe ran 10 times for 91 yards and one score. Michael Basner added the team's other offensive touchdown.

Logan Witham led the defense with 11 tackles and an interception and Jakob Tanner added 10 tackles and picked up a fumble and returned it 50-yards for a score.

"The big momentum shift came on the scoop

## Help aging parents manage their medications

What tips or tools can you recommend that can help seniors and their caregivers keep up with medications? My 82-year-old mother, who lives alone, is supposed to take several different medications at various times of the day but often forgets.

Dear Working,  
Anybody who juggles multiple medications can relate to the problem of forgetting to take a medication, or not remembering whether they already took it. This is especially true for older adults who take medications at varying times of the day.

Here are some different product and service solutions that may help.

### Simple Medication Helpers

Getting organized and being reminded are the two keys to staying on top of a medication schedule. To help your mom achieve this, there are a wide variety of pillboxes,

medication organizers, vibrating watches, beeping pill bottles and even dispensers that will talk to her that can make all the difference. To find these types of products, the best source is Epill.com, where you'll find dozens to choose from.

You can also help your mom stay organized by creating a simple medication list that breaks down exactly what she should take and when she should take it. To help you with this, go to SafeMedication.com – a resource from the American Society of Health-System Pharmacists – and download and print a copy of “My Medicine List.”

### Smart Pill Boxes

There are also a variety of “smart” pill boxes on the market today that will remind your mom when she needs to take her medicine and will send family members and caregivers notifications if she forgets to take her pills, or accidentally takes the wrong ones.

Three to consider here include Tricella (Tricella.com, \$95), which uses Bluetooth connectivity but requires that your mom have a smartphone with data service or tablet with Wi-Fi; PillDrill (PillDrill.com, \$279), a comprehensive system ideal for strict medication schedules but requires home Wi-Fi; and MedMinder (MedMinder.com, \$40 per month), that operates off a cellular network (no phone line or Wi-Fi necessary).

### Convenient Packaging

Another way to help simplify your mom's medication use is to get her prescriptions filled in single-dose packets that put all her medications (vitamins and over-the-counter drugs can be included too) together in neatly labeled packets organized by date and the time of day they should be taken. This does away with all the pill bottles and pill sorting. One of the top providers of this type of service is PillPack.com, an online pharmacy owned by Amazon.

### Apps and Calling Services

If your mom has a smartphone, there are apps she could use to help her keep up with her medication. One of the best is Medisafe (MyMedisafe.com), a free app works on Apple and Android phones. Medisafe will organize your mom's pills in one place, send her timely notifications to take her meds, and send her reminders to fill her prescriptions.

Caregivers can also connect with the Medisafe app to get notifications about when it's time for their loved one to take their medication – and they can see whether or not

it's been marked as taken. If your mom doesn't use a smartphone, there are also calling services, like Care Call Reassurance, which provides medication reminding calls – see Medication-Reminders.com. This service will call your mom's phone at the scheduled times she needs to take her medication as a reminder, and if she fails to answer or acknowledge the call, a family member or caregiver will be contacted. This service runs between \$15 and \$20 per month.

## Glenn Roberts dead victim of war gas

Was Among the First to Go to Europe  
Suffered Many Months

**October 23, 1919** ~ Glenn J. Roberts died at 3:15 o'clock Monday afternoon, Oct. 20, at the home of his mother, Mrs. Andrew W. Nevin of Harrisville Township.

Glenn's death adds another to the long list of patriotic Americans who gave up their lives in the great struggle for Democracy and Right. He was among the first to volunteer after the declaration of war and as a member of the 16th U. S. Engineers was with the first troops to go to Europe in May, 1917. He was in France nine months and 25 days. He was gassed shortly after getting into action and at different times thereafter until he was invalided and sent to hospitals in France. He was returned to the States in the winter of 1918 and was sent to various government sanitariums. In August 1918, he came home for awhile and later was sent by the govern-

ment to New Mexico and South Carolina in the hope that a change of climate would effect a cure. He suffered pneumonia and attendant ailment due to the gas and finally developed tuberculosis, from which disease he died.

Glenn would have been 23 years of age next November 1st. He was born in West Branch and he was yet a babe when his parents moved to AuSable. He lived there until the big fire of July, 1911, destroyed the town; when the family came to Harrisville.

They lived here a year, Glenn attending the public school, and then moved to Onaway, where the father died.

He was in Detroit when war was declared and enlisted there a few days later with the 16th Engineers, regular army. Besides the mother, there are four brothers surviving: William of Everett, Wash., Clyde of Oscoda, Edward of Flint, and Harold at home.

Funeral services were conducted Tuesday at the home by the Rev. John Pacey. The remains were taken on the morning train Wednesday to Bay City, for burial in the family lot in Greenside Cemetery.

## In the service

**October 26, 1944** ~ David A. Peterson son of Mr. and Mrs. Nels Peterson of Harrisville, is with a Paratroop division, now in France. A brief summary of his experiences appears below.

Cpl. David A. Peterson writes to his folks that he is now in South France and finds it a treat after the siege of Italy where his force became quite famous through their achievements on the Anzio Beachhead and at Cassino.

This First Special Service Force is unique in that it is a U. S. Canadian unit, the only one of its kind, for it was created by none other than Winston Churchill (who paid them a special visit in Italy) and General Marshall.

In David's last letter to his folks, he says: "On October 28th, I will have been in Europe a year. It seems like ten."

Lt. W. Arnold Cummings is the eldest son of Mr. and Mrs. Wm. Cummings of Mikado, is located in France. A letter to his folks appears below:

Dear Folks:

I have been up on the front line for several days and now I have a chance to write. I came back night before last. Yesterday I washed my hair, shaved and took a bath, all in 10 qts of water. Not bad, is it?

My job is to adjust fire of the cannon Co.s on targets, and really had some juicy

ones.

I can tell you, now, that I am in the Third Army. If you watch the papers you can tell what we are doing.

We landed at the Omaha Beachhead, went to Carenton, LeManc, Charter, Paris and the place I can tell you about is Verdun.

We have a radio rigged up here and we heard the first game of the world series last night, it was quite a thrill. As the band played the National Anthem on the radio, our battery fired and we got shelled by the Germans, and "Rocket's red glare, and bombs bursting in air" really came true. It was quite amusing.

Still have had no mail. God Bless you all and please keep writing.

Pvt. Pyne has one arm in a cast as a result of shrapnel wounds. He was returned to this country a short time ago. Mr. and Mrs. Pyne daughter, Miss Betty, and Mrs. H. MacDermaid visited him upon his arrival at Battle Creek, and he accompanied them home for a short visit.

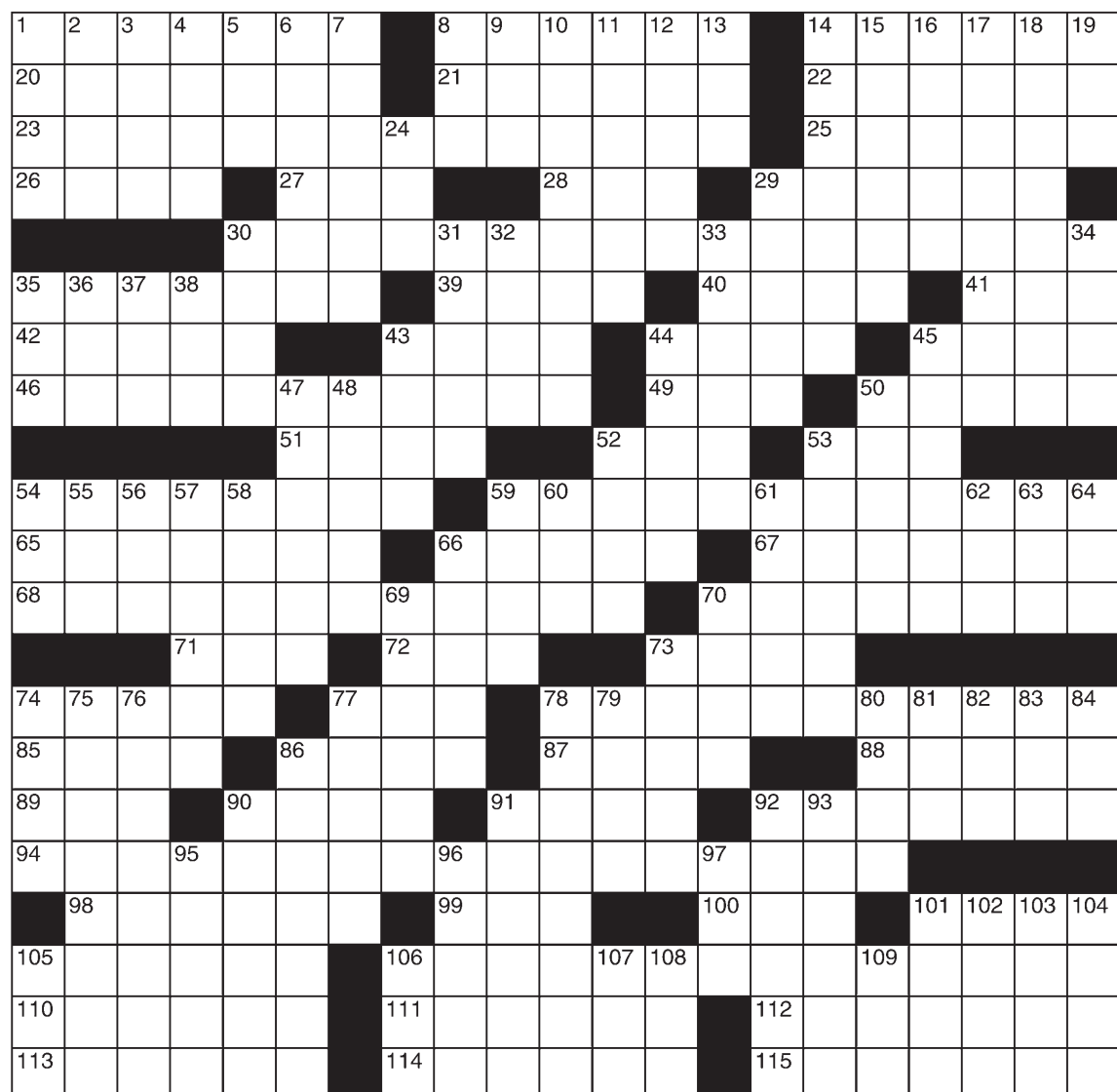

- On Nov. 6, 1528, the Spanish conquistador Alvar Nunez Cabeza de Vaca is shipwrecked on a low sandy island off the coast of Texas. Starving, dehydrated and desperate, he is the first European to set foot on the soil of the future Lone Star state.
  - On Nov. 10, 1775, a resolution, drafted by future U.S. president John Adams, creates the Continental Marines and is now observed as the birth date of the United States Marine Corps. The motto of the service is Semper Fidelis, meaning "Always Faithful" in Latin.
  - On Nov. 7, 1914, while World War I rages in Europe, a new weekly magazine, The New Republic, is first published in the United States. Though its first issue sold only 875 copies, after a year the circulation reached 15,000. The New Republic still operates today as a weekly journal of opinion.
  - On Nov. 8, 1951, Yankees catcher Yogi Berra is voted the American League's most valuable player. He went on to be the league MVP twice more, in 1954 and 1955.
  - On Nov. 5, 1968, in one of the closest elections in U.S. history, Republican challenger Richard Nixon defeats Vice President Hubert Humphrey. Because of third-party candidate George Wallace, neither Nixon nor Humphrey received 50% of the vote.
  - On Nov. 4, 1979, student followers of the Ayatollah Khomeini send shock waves across America when they storm the U.S. embassy in Tehran. The radical Islamic fundamentalists took 90 hostages.
  - On Nov. 9, 1989, East German officials open the Berlin Wall, allowing free travel from East to West Berlin for the first time since 1961. The next day, celebrating Germans began to tear down one of the ugliest and most infamous symbols of the Cold War. The wall was built to keep a flood of refugees from fleeing Communist East Germany to the West.

working on getting memorandums of understanding with all animal shelters in its service area. It was important to know who to get in touch with at the shelter and what the shelter would require from them such as pet vaccination records and when the family could visit the pet.

"It's important for any survivor thinking of leaving a domestic violence household to make sure they have their pet's vaccination records hidden away the same way they would birth certificates, Social Security cards and any other important documents for themselves and their children," Kaltz said.

She explained the number of survivors Hope Shores Alliance is helping is increasing rapidly, but that is not necessarily a bad thing. "When we talk about our numbers being up, that doesn't mean the numbers of abuse have risen. It means more people are reaching out to us for help," Kaltz said.

In fiscal year 2017/2018, Hope Shores Alliance helped 36 clients in Alcona County alone -- 23 were adults and 13 were children. In fiscal year 2018/2019, it helped 40 clients -- 25 adults and 15 children. In 2017 Hope Shores Alliance worked with over 290 survivors of dating and domestic abuse throughout its five-county area.

Kaltz explained over the past few years, the number of qualified staff at Hope Shores Alliance has grown significantly. The result has given the organization the ability to do outreach educa-

tors.

No two survivor situations are exactly alike, according to Kaltz, and Hope Shores Alliance does all they can to tailor the support to what the needs are.

"Not all survivors can leave their home situation immediately. It may take time to get things in place before it is safe for them to remove themselves.

"They may need months of counseling, guidance and support to get to the point they can leave. We will meet with them safely wherever they need to. We can provide

tion in service area schools and communities through events and media. It has also been able to strengthen relationships with law enforcement and prosecutors' offices.

Through the Sexual Assault Demonstration Initiative (SADI) program it has been able to expand services, specifically to sexual assault including teenage dating violence and stalking survivors.

"We are working hard to make every person who is fearful in their relationship feel that Hope Shores Alliance is a safe place for them to turn to. When someone goes to a friend saying things are bad at their home, perhaps they don't know where their money is or their partner is threatening to take the kids, the friend will understand it could be domestic violence and tell them to call our confidential 800 number," Kaltz said.

According to Kaltz, Hope Shores Alliance believes everyone has the right to be safe, believed and supported. To do this it provides a multitude of free and confidential services including a 24-hour help and support line advocacy, counseling, supportive listening, emergency shelter and long-term housing for female and male sur-

a safe house for them in Alpena, but if someone has no transportation and lives far away from the safe house or perhaps has a child with special needs such as sensory issues, it may not make sense for them to move to a safe house where other families are living. We figure out what makes sense for each survivor," Kaltz said.

Funding for Hope Shores Alliance comes through many forms including grants, federal and state aid, but Kaltz explained much of those funds have limitations on what they can be used for. Funding from general donations and its thrift store in Rogers City, however, goes into the general fund and has no limitations, which works best to tailor fit necessary needs for survivors.

In addition to donations, Hope Shores Alliance relies on many volunteers to help with a variety of duties including volunteer help at the thrift store, at events, and by fostering animals.
