Local charity reopens for residents who need help

After eight months without a place to operate, a local charity will be opening its doors again next month in the same location it served the public prior to its closing.

My Brother's Hope, a free store which invites Alcona County residents in need to "shop free" for clothing and personal care/hygiene items, will reopen on Saturday, Feb. 8 from 9 a.m. to 1 p.m. at 76 N. Barlow Road, also known as "the blue house" across from Alcona High School just north of M-72.

The organization had to close last May because the blue house was slated for demolition over the summer.

The building, which is owned by Alcona Community Schools, is an older home with newer rooms attached to the north end and was once used as satellite class-

"We finally got the call that we could reopen in January, which we were ready to do on the eleventh, but the weather was uncooperative. We rescheduled for January 18 and again another snow day kept that from happening. We will try again in February," Potter said.

Potter explained since the charity can no longer use the main house for storing items, it had to scale down items it carries considerably.

'We used to have all types of household items available. Now we will have to be much stricter on what we can and cannot take in donations," Potter said.

The group will only accept in-season clothing, bath and

rooms for alternative education.

After some attempts at fixing the roof and making other repairs on the older home section of the building, the school board hired an architect and a contractor early in 2019 to assess what it would take to fix all the problems with the property.

After the assessment it was felt repairing the building would not be a sound investment of school finances. The board voted to demolish the older house section, but keep the two northern, newer-addition rooms intact. The board offered those rooms to My Brother's Hope, providing it shut down temporarily while the demolition was in progress. The school board expected the work to be completed before school started last August. "Unfortunately, no bids came in for the demolition," said Dan O'Connor, Superintendent of Alcona Community Schools. Barb Potter, spokesperson for My Brother's Hope, said the charity patiently waited for word on the demolition, "We had so many people calling us in need of clothing and other items and we just didn't know what to tell them. We

bed linens and personal hygiene items. Those items will only be collected from the public on Wednesdays between 11 a.m. and 1 p.m.

"Please, please only bring those items in on Wednesday during that time to My Brother's Hope. There are no other collection sites and do not leave garbage bags or boxes of items at the door at times we are not collecting," Potter said.

Currently, the items the mission most needs are winter clothing in any size and bath towels. Since the nonprofit does pay for utilities at the site and purchases some personal hygiene items to give to those in need, monetary donations are always appreciated. O'Connor said they have apologized profusely to the charity for making them wait so long to use the space available, "It couldn't be helped. We had hoped a bidder would come forward and get the job done last summer. We are

Not only was 2019 a significant year for his career, but also for his marriage. He and his wife, Muriel, celebrated 45 years of matrimony in December as well. He is a life-long resident of Alcona County. The Goddards raised their three children, Rachel, Michael and Ashley in Alcona County and they are now raising six grandchildren in the county.





How to choose the right hospital for you

Dear Savvy Senior,

I need to get a hip replacement, and want to find a good, safe hospital to have it done in. What resources can you recommend for evaluating hospitals? I don't currently have a doctor.

Shopping Around

Dear Shopping,

Most people spend more time shopping for a kitchen appliance or flat-screen TV than choosing a hospital. But selecting the right one can be as important as the doctor you choose.

Here are some tips and resources to help you research the hospitals in your area.

Hospital Shopping

While you may not always have the opportunity to choose your hospital, especially in the case of an emergency, having a planned procedure can offer you a variety of choices.

When shopping for a hospital, the most important criteria is to choose one that has a strong department in treating your area of need. A facil-

ity that excels in coronary bypass surgery, for example, may not be the best choice for a hip replacement. Research shows that patients tend to have better results when they're treated in hospitals that have extensive experience with their specific condition.

In order to choose a hospital that's best for you, it is important to discuss your concerns and alternatives with the doctor who is treating you. Some doctors may be affiliated with several hospitals from which you can choose.

Or, if you've yet to select a doctor, finding a top hospital that has expertise with your condition can help you determine which physician to actually choose.

Another important reason to do some research is the all too frequent occurrence of hospital infections, which kill around 75,000 people in the U.S. each year. So, checking your hospital's infection rates and cleanliness procedures is also a smart move.

Free Researching Tools

There are a number of free online resources that can help vou evaluate and compare hospitals in your area, including:

• Medicare's Hospital Compare (Medicare.gov/Hospital-Compare): Operated by the Centers for Medicare and Medicaid Services, this tool has data on more than 4,000 U.S. hospitals.

• Why Not The Best (WhyNotTheBest.org): Created by the Commonwealth Fund, this is a private foundation that provides performance data on all U.S. hospitals.

• The Leapfrog Group (LeapfrogGroup.org): This national, not-for-profit organization grades more than 2,000 U.S. hospitals on quality and safety.

These websites use publicly available data to rate hospitals on various measures of performance like death rates from serious conditions such as heart failure and pneumonia, frequency of hospital-acquired infections,



patient satisfaction and more.

On these websites, plug in your location to find hospitals in your area. You can then check to see how well or poorly each hospital manages patients in various conditions.

Two other good sites that can help you choose a good facility include U.S. News & World Report (USNews.com/ best-hospitals) and Healthgrades (Healthgrades.com).

U.S News & World Report is an online publication that publishes a hospital ranking in 17 medical specialties like cancer, orthopedics and urology, and rates common procedures and conditions, such as heart bypass surgery, hip

and knee replacement and COPD. They also rank hospitals regionally within states and major metro areas.

And Healthgrades, which is a private for-profit organization, provides free hospital ratings on patient safety and medical procedures, and scores hospitals using a 5star scale. They also provide comprehensive information on most U.S. doctors including their education and training, hospital affiliations, board certification, awards and recognitions, professional misconduct, disciplinary action and malpractice records, office locations and insurance plans.

New MSU Extension instructor brings fitness background to nutrition position

By combining a passion for helping people become physically fit and eating healthy, the new Michigan State University Extension (MSUE) nutrition instructor is eager for whatever challenges may come her way.

Michelle Luttrell grew up in Oscoda. She graduated from Oscoda High School in 2005 and graduated from Northwood University in Midland, Mich. with a bachelor's degree in business administration with a triple major in advertising, marketing and management.

As a child, Luttrell was active in sports and played soccer with the American Youth Soccer Organization (AYSO). She also played soccer in high school and during her first year at Northwood.

Her love of fitness began to pay off after her dad, George Morse, phased out of owning a fast food restaurant to owning and operating the Michigan Fit Club in Oscoda a few years ago.

Luttrell was inspired by her father to teach others to become physically fit. She became a certified personal trainer and staff member of the club. "I was working with clients and doing group training which I really enjoyed," Luttrell said.

Although she has only held the nutrition title with MSUE for a few weeks, Luttrell recently told the Alcona County Board of Commissioners she has already begun scheduling nutrition classes. With this full time position split between Iosco and Alcona counties, her main office is in Tawas and she is glad to live in Oscoda, which is halfway between Tawas and Harrisville.

Luttrell said she is excited to start working with the community and has plans to bring healthy eating and exercise ideas to all ages including a Cooking Matters for Adults class in Lincoln, has talked to the new director of the Alcona County Commission on Aging (ACCOA) about setting up classes for seniors and will be talking to teachers of Alcona Headstart and Alcona Elementary School about the best time to set up classes for youth.

Cooking Matters for Adults meets for two hours once a week on Tuesdays for six weeks at the Alcona Health Center in Lincoln. Luttrell has two series of classes scheduled, one beginning February 11 running until March 17 from 9 to 11 a.m. and one beginning March 14 running through May 19 from 2 to 4 p.m. There is no cost for the class which is funded by SNAP-Ed and Walmart Healthcare grants.

Cooking Matters for Adults is a participation nutrition program that teaches healthy eating, cooking and grocery shopping on a limited budget. Participants will work to

gain skills and confidence by making healthy, budgetfriendly meals. Participants will receive the necessary groceries they need to practice the recipe learned in class at home.

"One of the lessons will include a grocery store tour concluding with each registrant receiving \$10 for a shopping challenge to make a healthy meal. They then get to take those groceries home too," Luttrell said.


She explained that MSUE requires at least five minutes of physical exercise to be implemented into each class she teaches. "I'm not sure vet how that will fit into the Cooking Matters class, which really doesn't require physical activity, but MSUE likes to do it. I will probably try and incorporate an activity when we transition from the lesson to actually cooking. I'll get the people up and moving around a little bit," Luttrell said.

Mischelle Warner, MSUE District 4 director, said they are ecstatic to have Luttrell join the MSUE team. "Her experience and ongoing passion to help our residents lead healthier lives will have a positive impact on our community. From school-age youth to seniors, Michelle will provide nutrition education in person, via print materials and utilizing our Face-Book page."

Since Luttrell's husband, Jessie, is a veteran, she is also interested in bringing nutrition classes to veterans and has begun discussion with the VFW post in Oscoda.

As an energetic and active mother of three, Audrey, 9, Claire, 7 and Madison, 3, Luttrell thrives on keeping busy and feels this is the perfect career choice for her, "I'm excited to get to work with the communities here and teach. "I'm passionate about nutrition and health and I have good communication and organizational skills that will suit this position. I'm loving it so far and I'm planning on this being my career choice for a long time. I'm from the area, my husband is from the area, we have family here and we just bought a house here.
