# Lincoln resident faces charges for pharmacy break in

A suspect in the break in of a Lincoln business has been arrested and charged with three felonies following his arraignment on October 1.

According to the Alcona County Sheriff's Department, William David-Howard Hjorth, 31, of Lincoln has been lodge in the losco County Jail and charged with breaking and entering a building with intent, larceny in a building and malicious destruction of property.

an investigation by the sheriff's department that began on September 18 at approximately 6 p.m. when an alarm at Snyder's Lincoln Pharmacy was triggered. Deputies found a side door damaged where Hjorth allegedly entered the business. A search of the building found no one inside.

On Friday, Oct. 1, while assisting officers from the Oscoda Township Police Department contact a suspect living in the Village of Lincoln

These charges stem from in an unrelated investigation, Alcona deputies recognized items that were allegedly related to the break in of the pharmacy. Following the execution of a search warrant to search Hjorth's residence, the items were retrieved as evidence.

He is lodge in the Iosco County Jail and is also facing charges in an investigation by the Oscoda Township Police Department involving an alleged stolen vehicle. His bond is for \$25,000 cash/ surety.

# Remains found in missing teenager investigation

Acting on a tip, the Michigan State Police (MSP), Alpena Post, executed a search warrant at 1630 West Naylor Road in Alpena Township on the morning of Tuesday, Sept. 28. During the search, human remains believed to be of Brynn Bills were found buried on the property. The remains were taken to West-

charges of unlawful imprisonment and felonious assault from an incident that allegedly occurred during the week of September 27 and is unrelated to the disappearance of Bills.

She was last seen in early August in the Alpena area. Bills, 18, was last seen wearing black leggings, black kneehigh boots, and a black windbreaker jacket. The ongoing investigation is a collaborative effort between the MSP, Alpena City Police Department, and the Alpena County Sheriff's Department. Numerous resources have been utilized during this investigation including the MSP Grayling Crime Lab, MSP canine teams, MSP Aviation Unit, MSP Seventh District Fugitive Team, MSP Emergency Support Team, detec-



ern Michigan University for an autopsy at the direction of the Alpena County Investigating Coroner.

According to the MSP in a press release, the cause of death has yet to be determined, and MSP investigators have ruled her death as suspicious.

The property belongs to Joshua Jay Wirgau, 34, who is a person of interest. He is currently being held without bond in the Alpena County Jail on separate **Brynn Bills**



Whether it comes as an 11man or 8-man contest, it seems that when Alcona and Rogers City meet up on the football field, it is going to be a close battle.

This held true last Friday night, when the two teams met for the first time as 8man teams. The hosting Tigers let an early lead slip away however and fell 30-24 when a late desperation pass was intercepted.

"We played pretty well; played a more mistake-free game but we had a couple drives that we made mistakes (on) and turned the ball over a couple times," said head coach Jason Somers. "A couple things we would like to have back, but all-in-all I thought the kids played a really good game."

The Tigers led the game 6-0 after the first quarter, thanks to an early 61-yard touchdown pass from Garrett Somers to Gavin Walker. They still led 12-8 at the half, with their second quarter touch-down coming in the form of a Michael Basner 22-yard touchdown run.

Somers connected with Jeremiah Bullis for a 47-yard touchdown pass in the third quarter, but the Hurons swung ahead 24-18 entering the fourth.

Somers tossed his third touchdown of the night, this time to Basner for 62-yards, but Rogers City scored the game-winning touchdown with about two minutes to play and intercepted an Alcona pass in the closing seconds to escape with the win. Despite the loss, Somers was pleased to see how his squad faced off against the Hurons, who have yet to lose a game this season.

"It was good to see our guys rise to that occasion, after dropping a pretty tough one last week to compete with a team that was 5-0 was pretty good to see," Somers said. "We had a shot to win it or tie it at the end, that is all we could hope for."

# Could I have COPD and not know it?

Dear Savvy Senior,

I have struggled with shortness of breath for several years now. I just thought I was getting old and fat, but a friend recently told me about COPD. So, my question is could I have COPD and not know it?

Huffing and Puffing

#### Dear Huffing,

Yes. COPD, or chronic obstructive pulmonary disease, is a progressive lung disease that affects an estimated 30 million Americans, but about half of them don't know they have it.

Many people mistake shortness of breath as a normal part of aging, or a result of being out of shape, but that's not necessarily the case. COPD - a term used to describe a variety of lung diseases including emphysema and chronic bronchitis - develops slowly, so symptoms may not be obvious until damage has occurred.

Symptoms can include an ongoing cough or a cough that produces a lot of mucus, lack of energy and/or shortness of breath especially during physical activity, wheezing and chest tightness, blue lips or fingernails, or swelling in your feet, ankles or legs.

Those most at risk are smokers or former smokers over age 40, and people who have had long-term exposure to other lung irritants like secondhand smoke, air pollution, chemical fumes and dust. There is also a rare genetic condition known as alpha-1-antitrypsin, or AAT deficiency that can increase the risks.

If you're experiencing any of the aforementioned symptoms, you need to get tested

by your doctor. A simple carpets clean; run the exbreathing test called spirometry can tell if you have COPD, and if so, how severe it is. Early screening can also identify COPD before major loss of lung function occurs.

If you do indeed have COPD, you need to know that while there's no cure, there are things you can do to help manage symptoms and protect your lungs from further damage, including:

• Quit smoking: If you smoke, the best thing you can do to prevent more damage to your lungs is to quit. To get help, the National Cancer Institute offers a number of smoking cessation resources at SmokeFree.gov or call (800) QUIT-NOW. Or ask your doctor about prescription antismoking drugs that can help reduce your nicotine craving. If you smoke marijuana for a medical condition, talk to your doctor about edible versions.

• Avoid air pollutants: Stay away from things that could irritate your lungs like dust, allergens and strong fumes. Also, to help improve your air quality at home, remove dustcollecting clutter and keep

haust fan when using smelly cleaning products, bug sprays or paint; ban smoking indoors; and keep windows closed when outdoor air pollution is high (see AirNow.gov for daily air-quality reports).

• Get vaccinated: The coronavirus and flu can cause serious problems for people who have COPD, so if you haven't already done so, get vaccinated for COVID-19 and get a flu shot every fall to help avoid getting sick. Also, ask your doctor about getting the pneumococcal immunizations for protection against pneumonia.

• Take prescribed medications: Bronchodilators (taken with an inhaler) are commonly used for COPD. They help relax the airway muscles to make breathing easier. Depending on how severe your condition, you may need a short-acting version only for when symptoms occur, or a long-acting prescription for daily use. Inhaled steroids may also help reduce inflammation and mucus and prevent flare-ups.

# The show would go on...if it could

It would have been happening about this time. If circumstances would have allowed, some 50 people would have boarded a yellow school bus for one of two, whole-day excursions to be tourists in their own backyards.

The long-running and everpopular Alcona County George Byelich Memorial Fall Color Bus Tour, for the second year is postponed like so many other events, due to COVID 19.

"In 2020, it was a nobrainer to postpone the tour with the virus seemingly in full swing," said organizer Marlena MacNeill. "It was a little more difficult to make that decision for 2021."

Planning for the tour typically begins immediately on the heels of the current tour with evaluation and assessment of the tour just completed. The planning then picks up again in earnest in the early part of the year to ensure every "I" is dotted and every "T" crossed for a successful tour historically scheduled for the beginning of October.

This year, not knowing what the "prognosis" would be, the planning committee agreed rather than spend all year planning the tour and then have to postpone, it would be best to put it on the shelf for 2021.

Tours showcasing the treasures, resources, and opportunities hidden in plain sight in Alcona County started over 30 years ago under the auspices of the Michigan State University Extension Service, and was the brainchild of then director, the late George Byelich.

Carrying on the Byelich tradition, a volunteer committee took on the hosting role and continued to offer the tour for 11 years, until, of course, the last couple of years.

"I am hopeful the tours are only on hiatus," MacNeill said. "I had been fortunate to have been on several of the original Byelich tours and I have been thrilled to be able to keep them going."

Over the years the tours have circled in and around Alcona County, and in addi-

tion to scenic vistas, they introduced tourists to entrepreneurs, civic organizations, natural resources, farms, gardens, bees, horses, water, cows, and even ghosts. Tours also offered sightings of "famous" musicians, some notso-famous theatrical performances, corny jokes, miraculous driving skills demonstrated by the school bus drivers, and a ton of historical and current information about Alcona County.

"My favorite tour destinations are those that take us behind the scenes," reflected MacNeill. "We've been to a world-class horse farm, entered a water tower, gotten up close and personal with an energy plant, stood looking up in awe at the county's main radio communications tower, learned how honey is extracted, and discovered how many different types of beans are grown here—and that's just a short list of the many interesting facets of Alcona County." MacNeill said permission is always sought for access to sites not traditionally open to the public. "I am always amazed at how willing and generous most owners

are in sharing." She is also amazed, but more gratified, when she hears tour participants say "I never knew that place existed," or "I never knew that about Alcona County."

There is still a glimmer of hope for the bus tour to be offered in the future. For now, tourists willing to do a selfguided tour to view some of the public vistas showing off the fall colors might consider the following:

• AuSable Scenic overview\* on Bamfield Road about four miles west of Glennie.

• High banks overview\* on Aspen Alley Road/AuSable Road about seven miles south of M-65.

• Mt. Maria Road 1.5 miles west of Hubbard Lake Road.

• Robinhood Road\* one mile south of Hubbard Lake Road off Bennett Road.

• Alcona Road just east of US-23.

• Sucker Creek Road from US-23 to McGregor Road.

• Sucker Creek Road between F-41 and Hubbard Lake Road (warning: several miles of dirt road).

• Poor Farm Road from M-72 to F-30.

• Reid Lake foot travel\* area on M-72 at Kohler Road. • Crooked Lake Road north

thefts happened over the course of 27 months. How, we would like to know, could someone be allowed to walk out with \$8.2 million in drugs in her bag without being stopped by security?

In Georgia, a VA employee pleaded guilty to stealing \$1.9 million in medical equipment and then reselling it. Using his VA credit card, he bought hundreds of items and sold them to a company in another state for eight years.

The U.S. Attorney had a big day in arresting 16 people in a massive kickback-and-bribery scheme that included vendors and employees at two Florida VA hospitals. The \$20 million in thefts started in 2009 and wasn't discovered in audits. Their methods of theft and the charges were numerous and varied: inflating the cost of goods sold or shorting the orders, paying

kickbacks, making purchases with VA credit cards, receiving bribes, healthcare fraud and ordering from companies that didn't exist. The last of the band of thieves was recently sentenced.

In a smaller but equally important scheme, a Washington landlord admitted to scamming \$16,000 for HUD-VA housing for a homeless veteran. Not only was he billing the government for the monthly rent, but he was collecting from the veteran as well, a clear violation of the HUD-VASH program. For this he will get nailed for three times the amount he stole. The formerly homeless veteran will share in this and get a settlement of \$4,000.
