## Alternative education available this fall

To ensure all students are actively engaged in a successful path beyond high school, the Alcona Community Schools will be opening Claw Academy, an alternative education program this fall.

For over a decade, the school has been without any alternative education options. Alternative education is akin to the old concept of co-op education, where technical education or work-based learning students attended school for part of the day and then went to technical school or worked in a chosen career field for the rest of their school day.

Superintendent Dan O'Connor explained that alternative education students will, in every way, still be considered Alcona High School students with the same benefits such as bus-sing, meals, sports, clubs, counselors and access to

demands of online learning. Bullis is the school's work base learning coordinator and the school's athletic director.

"Shelly and Joy have a special ability to work with students and understand their needs and desires long past their education at Alcona High School, which makes them perfect for alternative education. Just graduating high school isn't enough, we need to connect students for success after graduation," O'Connor said.

He explained Claw Academy will provide a very flexible learning space for high school students who may not feel successful in the normal school setting for a variety of reasons such as not being on track to graduate; new students who may not feel comfortable at the high school or are in a different place in their education; students who need flexibility for schedules to allow time for a technical programming or work-based learning; or students who may

school success and mental health services. They will also be expected to meet the same credit requirements to graduate as other students.

"Claw Academy was a name decided on by the marketing students of Alcona High School giving connection to the Alcona Tigers," O'Connor explained.

The difference is Claw Academy students will take their core classes online through Edgenuity and/or Graduation Alliance and will meet during the school week at the "Blue House" across from the high school with mentors Joy Bullis and Shelly Hoffmeyer where they will have quiet workspace and support.

Hoffmeyer, the school's online learning specialist since 2020, has built strong relationships with students and understands the needs and

have mental health issues or anxiety in a normal high school setting.

"Based on individual progress, Claw Academy students may have to be at the school more or it could allow less time needed to attend. It's personalized to the student's needs.

"We are trying to emphasize employability skills and, although we haven't required it, we are strongly encouraging Claw Academy students to spend either the morning or afternoon of their school day enrolled in either career technical programming or work-based learning.

"The academy's emphasis is on creating employable young adults. Maybe college isn't for them. The academy will try and find experiences for the students to set them

## Community Foundation awards more than \$440,000 in scholarships

Two-hundred nine students from the Community Foundation for Northeast Michigan (CFNEM) and its affiliate foundation service areas have been awarded scholarships this year. Of that amount, 106 awards totaling \$303,850 were awarded to students in the four-county region of Alcona, Alpena, Montmorency, and Presque Isle counties.

"Across all nine counties served by the foundation, our students have received \$440,138 in scholarships in 2023," said CFNEM Program Director Jennifer Dingman. "Most of these awards are for the 2023-2024 academic year, and many are multi-year awards that will support students beyond just their freshmen year."

"All of these scholarship funds reflect someone's legacy in action," said CFNEM Executive Director Patrick Heraghty. "Because people who care about our communities and those who live here chose to give back, the foundation was able to award nearly a half million dollars

in scholarships this year, speaking volumes about our communities, our donors, and the incredible gift it is for these students to be cared for in this way by generous people they may never even meet."

Heraghty said one of the unique aspects of the CFNEM scholarship program is that many of its scholarships are not just determined by academic achievement, but with a strong emphasis on extracurriculars and service. Each scholarship reflects the intentions of the donor, and in some cases, that means the emphasis is placed on student interests such as farming, a trade such as welding or plumbing, the arts, or healthcare.

He explained that all area students planning to attend college are encouraged to apply for scholarships, regardless of whether they plan to attend a trade certification program, community college or a four-year university.

Students receiving scholarships are from across the Community Foundation's

nine-county service area, which includes Alcona, Alpena, Cheboygan, Crawford, Iosco, Montmorency, Ogemaw, Oscoda and Presque Isle counties. This service area includes CFNEM and three affiliate foundations: Iosco County Community Foundation, North Central Michigan Community Foundation, and Straits Area Community Foundation.

It is an Equal Employment Opportunity (EEO) complaint, which is an allegation of discrimination because of race, color, religion, national origin, sex (including sexual harassment and sexual orientation), age, physical or mental handicap. The Equal Employment Opportunity Commission, a federal department, will review the complaint. If the agency doesn't dismiss the complaint, it will conduct an investigation. The agency has 180 days from the day a complaint is filed to finish the investigation. The agency will issue a notice giving a complainant two choices: either request a hearing before an EEOC administrative judge or ask the agency to issue a decision as to whether the discrimination occurred. Other steps can follow, depending on the decision and what the complainant decides to do. The Review apologizes for this error and any inconveniences it may have caused.)*

**Planting alstroemeria**

Also known as Peruvian lily plants or "Lily of the Incas," alstroemeria like well-draining soil and lightly filtered sunshine. Whether you are adding these plants to your garden or placing them into a container, place them so that the soil level on the root ball is even with the surrounding soil. Alstroemeria plants tend to be a bit thirsty and produce the greatest number of flowers when given generous amounts of water.

**Homecoming at Haynes church - July 7 & 8**

The Haynes Community Church Homecoming will be held July 7th and 8th. The congregation reckons its history from 1880, when the people first organized as the First Presbyterian Church of Alcona (Township). That year Alcona had 187 houses, four schools, two churches, a lighthouse and three post offices. The lumbering business was at its height in the "cove," shipping long timber, shingles, and other products all over the world. Good wages were \$30 per month. Fishing, too, was a major industry.  
 Presbyterians in the village, wanting a church of their own, contacted the Church Erection Board of General Assembly and, for a mortgage, they were loaned \$466 to build a house of worship, on September 22, 1880.  
 The church was erected and clear of all indebtedness. They were in the Saginaw Presbytery. Rev. D. D. Van Dyke was the minister when the first church was built.  
 The first trustees were: Donald MacNeil, president; Joseph Yuill; Thomas Johnston; William Ritchie; Thomas Stichson; and James Martin. Witnesses were A. Z. Roberts, D. D. Van Dyke, F. E. Beard, notary.  
 A mortgage was recorded November 3, 1880, by Reuben Z. Roberts, attorney. P. W. Marble was Register of Deeds. This mortgage was released September 19, 1924, when fire destroyed their second

edifice.  
 Alcona Township became Haynes in 1893, the year Beard's Saw Mill burned. This tragedy was the beginning of the end of the Village of Alcona.  
 In May 1886 a deed to the present site was given by Thomas and Eliza Johnston. The old church, torn down, was rebuilt by Wm. Thorner. New trustees were Joseph Yuill, George H. Lee and Thomas Johnston; witnesses: David Mulholland and Wm. Johnston. It was recorded on May 24, 1886, by E. Jameson, Register of Deeds.  
 A manse was moved from Alcona in 1894 by Joe and John Miller and used by at least one pastor. A 200 pound bell was purchased in 1896. This church burned in 1924 when Rev. Boyce was putting new "hanging lamps" in the high ceiling. There was only a ramp, good roof, steel windows with clear cathedral glass, and pews salvaged from the fire, and also the furniture loaned by the East Tawas Church, which was stored in the home of Percy Somers.  
 Then services were held in the Odd Fellows Hall which was purchased December 19, 1924.  
 Services were discontinued for a while and in 1930 John C. Campbell, Noble Ferguson and Wesley Jack were appointed as a building committee to see that a new church was built. Mrs. Roy

Campbell was treasurer of funds solicited by several people.  
 In 1932, in the "Johnson School" where some women had started a Sunday School, a meeting was called to decide whether to build on a new site or on the old one.  
 The decision was close, but the old site of 1886 was chosen.  
 Trustees then were John Cook Sr., Lawrence Cook and Abner MacGregor. They selected Russell Ritchie to supervise the building, to be erected of stone as was the old edifice, using volunteer labor and materials from the Odd Fellows Hall. The structure was opened to the public July 6, 1934, for the funeral of Mrs. C. W. Goodsell with Rev. Miles A. Freeman pastor. New trustees were Lawrence Cook, Melmourne Johnston and

Russell Ritchie; new elders were Clerk John Yuill, Lizzie Ritchie and Flora Shaw.  
 The Church School, women's group and young people's society kept raising funds. During Rev. Wm. Vincent's- pastorate we were changed to the Petoskey Presbytery and a few years later to the Mackinac Presbytery. On November 7, 1969, Mackinac dissolved our relationship.  
 The Church was then, as now, a nice stone edifice, in good repair with no monetary problems.  
 Since that time the Session has kept the Church going. Not one Sunday have we been without services, - under the name of Haynes Community Church. The doors are open wide to all - each Sunday at 10 o'clock. Our pastor is Rev. Herbert Stevens.

up for immediate employability, not just a job, but a career line," O'Connor said.

He explained in the past, alternative education was considered a separate school where students would not have the same access to the school's counselors, success workers, sports and clubs where the Claw Academy program is very inclusive. Students may even be able to take part in some high school classes.

"We have been working behind the scenes for three years to find a way to open up an alternative academy. Our students have been asking for it and as a community school it is our job to figure out a way to bring it to life," O'Connor said.

Currently, there are 10 students enrolled without advertising the program. O'Connor expects that number to grow.

# Day camp encourages imagination

About 40 of Alcona County's youth enjoyed the beginning of their summer actively working their imaginations and creativity in a variety of mediums at a three-week day camp at Alcona Elementary School.

As 20 messy pairs of hands worked making dot paintings with Q-tips, styled after George Seurat, a French post-impressionist painter, another 20 were actively engaged in a foraging survival game taking place in the school's library.

The students and their instructors were happy to be inside on a rainy day, and all were engaged in their creations and findings.

The day camp was made possible thanks to part of a \$70,300 Michigan Department of Education reimbursement grant awarded to Inspiration Alcona for out-of-school programs designed to tutor and enrich youth from January to the end of September of 2023.

An additional three-week day camp will be offered from July 31 through August 10. Alcona Community Schools Superintendent, Dan O'Connor said that camp will be based on a learn-and-go theory of learning about a place close by, such as Lumberman's Monument, Sturgeon Point Lighthouse or local parks and then visiting the locations with fun activities before, during and after the field trip.

Kyla Avery, teaching survival skills, explained before class, she and her assistants hid plastic eggs, marbles, and multi-colored popsicle sticks around the school library for the youth to find. The eggs represented shelter and heat, the marbles represented water and the popsicle sticks represented food.

"During the first week, we were outside and set up a way to collect rain water and learned about transpiration - getting water from leaves. Last week we learned about shelter building, today, because of the rain we are inside. Each student has a family, so they must find enough to make sure their whole family survives," Avery said.

During art, taught by Autumn Bilson, elementary-age

students seemed to be happily getting more paint on themselves than the paper while Bilson showed off clay owls the students crafted a few days before.

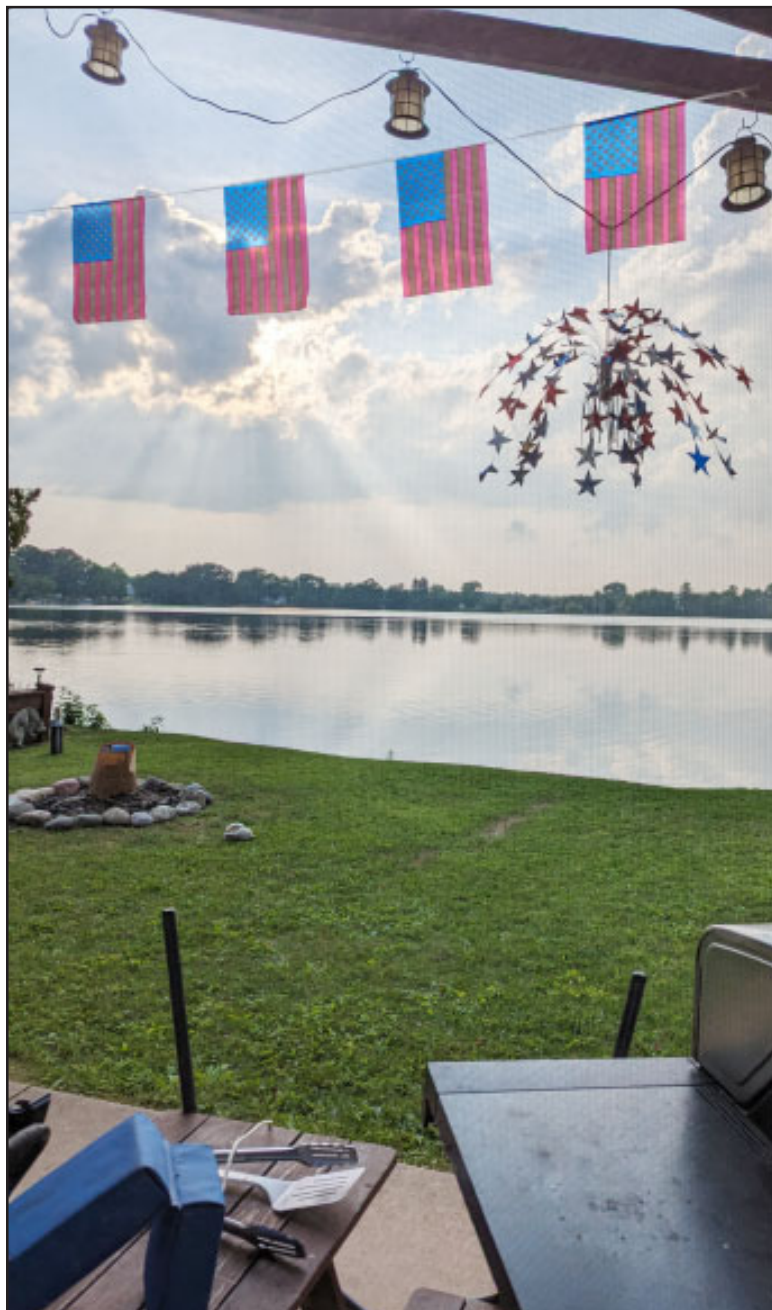
Other activities during the 9 a.m. to 1 p.m. Monday through Thursday day camp included a garden club taught by Jenny Schroeder, outdoor cooking with Tracy Davidson and sports camp with Lenny Avery. Day camp assistants include Trudy Whitford and Lorenda Thomas.

O'Connor said they had hoped to be able to bus students back and forth from home to the day camp for both the June and the August session, but that hasn't turned out to be feasible since most of the day camper's parents wanted to drive the students to and from camp. Breakfast and lunch are provided for day campers.

Additional funds from the grant were used during the school year for tutoring and unique clubs such as running and gaming from January to May. The funds will continue to be used after day camp with back-to-school tutoring planned before the start of the 2023/2024 school year and throughout September.

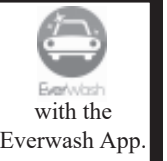

# How to cover dental care in retirement

Dear Savvy Senior,

I had dental insurance through my work for many years but lost it when I retired and joined Medicare. Where can retirees find affordable dental care?

Dear Al,

Unfortunately, about two-thirds of U.S. retirees don't have dental insurance today. Without coverage from traditional Medicare, and with private dental insurance typically costing too much to be feasible, most seniors are stuck paying full out-of-pocket prices every time they visit a dentist. While there's no one simple solution to affordable dental care there are a variety of options that can help cut your costs. Here's where to look.

• **Medicare Advantage:** While dental services are mostly excluded under original Medicare, many Medicare Advantage plans do provide

coverage for dental care, but it's usually very limited. Medicare Advantage plans are government approved health plans (usually HMOs and PPOs) sold by private insurance companies that you can choose in place of original Medicare. To shop and research Advantage plans in your area visit [Medicare.gov/plan-compare](https://www.medicare.gov/plan-compare) or call (800) 633-4227.

• **Dental insurance:** If you have gum problems and need extensive dental care, a dental insurance plan may be worth the costs versus paying for care yourself. Monthly premiums for individual plans range from about \$20 to \$80. A typical plan includes two or three cleanings and check-ups per year, but these plans will likely have a waiting period – anywhere from a few months to a few years – before coverage for more expensive procedures kicks in. To find dental plans in your area, see [eHealthInsurance.com](https://eHealthInsurance.com).

• **Dental savings plans:** While savings plans aren't as comprehensive as insurance, they are a good option for those who don't have dental insurance. How this works is you pay an annual membership fee – around \$80 to \$200 a year – in exchange for 10 to 60 percent discounts on service and treatments from participating dentists.

To find a savings plan, go to [DentalPlans.com](https://DentalPlans.com) (or 888-632-5353) where you can search for plans and participating dentists, as well as get a breakdown of the discounts offered.

• **Veterans' benefits:** If you're a veteran enrolled in the VA health care program or are a beneficiary of the Civilian Health and Medical Program (CHAMPVA), the VA offers a dental insurance program that gives you the option to buy dental insurance through Delta Dental and MetLife at a reduced cost. The VA also provides free den-

tal care to vets who have dental problems resulting from service. To learn more about these options, visit [VA.gov/dental](https://VA.gov/dental) or call (877) 222-8387.

• **Cheaper dental care:** Because prices can vary by dentist, one way to ensure you get a good deal on your dental care is to call multiple providers and compare prices. To get an idea of what different dental procedures cost in your area, see [FairHealth-Consumer.org](https://FairHealthConsumer.org). If you're paying cash, it's also perfectly reasonable to ask your dentist for a discount.

There are also a number of

health centers and clinics that provide low-cost dental care to those in need. And all university dental schools and college dental hygiene programs offer dental care and cleanings for less than half of what you would pay at a dentist's office. Students who are supervised by their professors provide the care. See [TeethWisdom.org](https://TeethWisdom.org) to search for a center, clinic or school near you.

### CALEDONIA TOWNSHIP ORDINANCE NO. 23-01

#### PARK PROPERTIES ORDINANCE

The Township of Caledonia, County of Alcona, State of Michigan

#### ORDAINS:

ORDINANCE NO.: 23-01

Adopted: 6-14-2023

Effective: 8-2-2023

AN ORDINANCE to amend Ordinance No. 1 of 2017 regarding the regulation and use of Township park and recreational properties, and particularly with respect to Holcomb Creek Park; to provide for a private cause of action in the event of any violation thereof; and to repeal all ordinances and/or parts thereof in conflict herewith.

#### Section 1. Purpose

The purpose of this Ordinance is to provide for the use, protection, regulation and control of the public parks, park facilities, ingress and egress thereto, and other issues concerning recreation, conservation, education, historic and scenic areas.

#### Section 2. Protection of Property

A. Destruction of buildings, markers, monuments, etc., shall be prohibited and no person shall:

1. Willfully destroy, deface, alter, change or remove any monument, stone marker, bench marker, stake, post or blaze, marking or designated boundary line, survey line or reference point.

2. Cut, break, mark upon or otherwise damage any building, equipment, dock, bridge, drain, wall, fountain, lamp post, fence, gate, hedge, or other structure.

3. Deface, destroy, or remove any authorized placard, notice or sign, posted or exhibited within or on park property.

4. Appropriate, excavate, damage or destroy any historical ruin or any object of antiquity, unless authorized in writing by the Township Board.

B. Destruction of plant life and natural surroundings shall be prohibited, and no person shall:

1. Cut, remove, or destroy any tree, sapling, seedling, bush or shrub, whether alive or dead, or chip, blaze, box, girdle, trim or otherwise deface or damage any tree or shrub, or break or remove any branch, foliage, flower, or any tree or shrub, or pick, gather, uproot, remove or destroy any flower, plant or grass, unless authorized by the Township Board.

2. Remove or cause to be removed any sod, earth, humus, peat, boulders, gravel, or sand, unless authorized in writing by the Township Board.

#### C. Fires on Park Property:

1. No person shall willfully set or cause to be set on fire any tree, woodland brushwood,

grassland or meadow within or on park property.

2. No person shall build a fire on park property except within the fireplaces, fire pit receptacles or open spaces approved and designated by the Township Board for such purposes.

3. No person shall drop, throw or otherwise scatter lighted matches, burning cigars, cigarettes, tobacco paper or other flammable materials within or on park property.

4. No person shall leave a fire unattended and shall extinguish such fire before leaving the immediate vicinity.

D. Glass containers: In the interest of safety, glass containers shall not be permitted in boat loading areas or along the shore.

#### Section-3. Protection- of Wildlife

No person shall hunt, trap, or harm any wildlife on park property, except as, and in locations, designated by the Township Board.

#### Section-4. Overnight Camping

Overnight camping is prohibited on park property.

#### Section 5. Traffic and Parking

A. No operator of a vehicle shall stop, stand or park a vehicle in any place marked as a passenger or loading zone, other than for the expeditious loading or unloading of passengers.

B. No operator of a vehicle shall stop, stand or park a vehicle upon any roadway or parking area, which obstructs traffic.

C. No person shall park a vehicle in an area designated as a prohibited parking area.

D. No person shall operate a vehicle in or on park property, which is used for recreational purposes, unless otherwise allowed by this Ordinance.

E. A reasonable amount of time shall be allowed to launch and retrieve boats at a boat launching site and all vehicles and trailers must be parked in the designated parking area.

F. ORVs shall be restricted to parking areas only.

Section 6. Sports, Games, Activities, Etc. Sports, games, activities, etc., are restricted from picnic table areas to prevent injury to people utilizing these areas.

#### Section 7. Motor-Driven Vehicles

A. No person shall operate a motor-driven vehicle of any kind except on roads or designated parking areas.

B. No person shall operate a motor-driven vehicle on any park road in excess of the posted speed.

C. No person shall operate a motor-driven vehicle on park property in a careless or negligent manner likely to endanger any person or property.

D. No person shall operate a motor vehicle on park property, which results in excessive noise or disturbs the peace, quiet or tranquility of the area.

E. The Township reserves the right to remove any illegally parked or abandoned vehicle, trailer, boat or shanty at the owner's expense.

F. All Michigan laws shall be complied with to operate a vehicle on park property.

#### Section 8. Trespass

A. No person shall peddle or solicit business of any nature, or distribute handbills, or other advertising material, or post unauthorized signs on park property, unless authorized in writing by the Township Board.

B. No person shall fence, enclose, or obstruct a person from entering, leaving or making full use of park property.

C. No person shall interfere with or, in any manner, hinder an employee of the Township performing official duties.

#### Section 9. Holcomb Creek Park

The following rules and regulations shall additionally apply to Holcomb Creek Park and that non-public portion of Cedar Drive contiguous thereto:

a. No ORVs, RVs or Golf Cart Use of Cedar Drive. It shall be unlawful for Off-Road Vehicles (ORV), Recreational Vehicles (RVs), and/or Golf Carts operating on, over, or using the non-public portion of Cedar Drive to access the Holcomb Creek Park property.

Other than signs posted by owners of property(ies) at the west entrance to Cedar Drive notifying the public that ORVs, RVs, and/or Golf Carts are strictly prohibited, as well as the speed limit provided hereinbelow, all signs to this effect shall be posted by the Township. This shall not prevent members of the public from trailering ORVs and/or shanties to the Property for the purpose of ice fishing.

b. 15 Mile Per Hour Speed Limit. Motorized vehicles shall not exceed a speed of 15 miles per hour (mph) when using said portion of Cedar Drive, or the Township's ingress/egress easement to access the Township-Holcomb Creek Property.

c. Park Hours; Dusk to Dawn. The Holcomb Creek Park property shall be closed to the general public from dusk to dawn every day and throughout the year.

d. Signage. Other than as specifically set forth hereinabove, all signage pertaining to Cedar Drive's and the Holcomb Creek Park's usage shall be posted, and pursuant to sign standards and specifications adopted or approved, by the Township.

#### Section 10. Prohibited Conduct

a. No person shall be intoxicated or impaired

by alcohol or controlled substances, or engage in any violent, abusive, loud, boisterous, vulgar, lewd, wanton, obscene or otherwise unreasonably disorderly behavior, or otherwise disturb or annoy others while in or on park property. Further, no person shall unreasonably annoy, disturb, obstruct, impede or impair the rights of the public to peaceably use and enjoy the park property and/or in the course of ingress and egress to and from the same. Similarly, no person shall unreasonably annoy, disturb, obstruct, impede or impair the peaceable use and enjoyment by the owners and/or guests of private residences situated along access roads and rights of way to and from park property.

b. No person shall conduct any form of gambling, lottery or game of chance while in or on park property.

Section 11. Loudspeaker, Public Address System, Amplifier

No person shall use a loudspeaker, public address system or amplifier within or on park property unless authorized by written permit issued by the Township Board.

#### Section 12. Fireworks

No person shall fire, ignite, detonate or discharge fireworks within or on park property.

Section 13. Littering and Pollution

No person shall discard, deposit or discharge any substance, matter or item in or upon any park property, or in any water-courses, lakes, ponds, or sloughs located within, upon or adjacent to part property, except in designated receptacles provided and/or established by the Township. Further, no person shall deposit household or commercial trash in trash receptacles.

Fines and/or Fees may be assessed for excessive trash or the need for additional receptacles or cleanup.

#### Section 14. Violations; Nuisance per se; Private Cause of Action

a. Violations a Nuisance per se; Fines. Remedies. etc. Any violation of this Ordinance shall constitute a Nuisance per se, and shall be enforced pursuant to the Township Municipal Civil Infraction Ordinance. In addition to possible costs, restitution and/or injunctive relief, including removal from park property and/or being banned and prohibited from re-entry, the first violation shall result in a fine of not less than \$100. A second offense shall result in a fine of not less than \$250; third and successive offenses shall result in a fine of not less than \$500. Each day on which a violation persists shall be deemed a separate offense.

b. Notice to Violators; Prohibition From Using Park Properties. Identified violators

will be notified and provided with a first warning, and thereafter if a subsequent violation occurs, the person or persons will be prohibited from using park properties, in addition to applicable fines, costs and other available remedies, unless and until the Township permits re-entry upon terms and conditions deemed appropriate under the circumstances.

c. Private Cause of Action. In addition to the right of enforcement reserved unto the Township hereunder, any person or entity suffering special harm as a result of any violation of this Ordinance shall have a private, Circuit Court cause of action as against the person or persons alleged to have committed such violation, and to abate or enjoin such violation and/or future such violations, in addition to such other legal or equitable relief deemed appropriate in the Court's sound discretion, including without limitation an award of reasonable attorneys' fees.

#### Section 15. Rules

The Township Board may from time to time promulgate and adopt Rules and regulations further to and/or in order to effectuate the intents and purposes of this Ordinance.

#### Section 16. Severability

If any section, subsection, clause, paragraph or provision of this Ordinance shall be adjudged invalid by a Court of competent jurisdiction, such adjudication shall only apply to the said portion thereof adjudicated invalid, and the remaining portions or part of this Ordinance not affected thereby shall remain in full force and effect.

#### Section 17. Repealer

All prior park and/or other Ordinances or parts thereof in conflict herewith are, to the extent of such conflict, hereby repealed.

#### Section 18. Effective Date

This Ordinance shall become effective thirty (30) days after publication.


